things. He said this had been a banner year in Kentucky—the women had over \$400.00 more than ever before for the United Offering; the Bishop's League had been formed for extensive work in the Diocese; nearly \$1,500.00 had been raised for St. Luke's International Hospital, in Tokyo, and so far over \$5,000.00 had been given for Sewanee, so we were entitled to these words of encouragement, but he found that it was always the same people who responded to all the calls.

After the service we assembled in the Parish House for the business meeting. The Bishop opened the session with prayers and then turned the meeting over to the President.

The Treasurer, as Chairman of the Committee on Credentials, read a list of the branches having paid their assessment to the Diocesan Fund and thus entitled to vote. This list will be found incorporated in her report.

The President then delivered her address in which she paid a loving tribute to Miss Tyler. She wished to put on record our love of her and our hope that others may be raised up to emulate her example.

The minutes of the last annual meeting and of the adjourned meeting at Paducah were read and approved.

Miss Semple read the Report of the Nominating Committee and the names were written on the board. Miss Carpenter, Mrs. Ormsby and Mrs. Poston were appointed tellers. Mrs. Musson moved that the Secretary call the roll of those entitled to vote before each election, so that no one might be overlooked by the tellers. This was seconded and carried. In order to save time, we put a report between the election of each officer so that we might be transacting business while the tellers were out. The Recording Secretary introduced by name all of the out-of-town delegates and asked each one present to consider that she had been personally introduced. The election resulted as follows:

The Recording Secretary read an abstract of the Board meetings and all united meetings of the year. She also read the report sent by the Auxiliary to the Council. This will be printed in the Journal and thus omitted from our report. Mrs. Adams announced that the Bishop had complied with our request to put three women on the Apportionment Committee and that he had appointed Miss L. L. Robinson, Mrs. H. S. Musson and Miss N. H. Winston to serve. Mrs. Dudley expressed our appreciation of this and hopes that we may hereafter pay our apportionment in full as the missionary work of the church must go forward.

Miss Lockett announced that Henderson is very glad to have the Council and Woman's Auxiliary meet with them next spring and earnestly invited all to attend.

The Corresponding Secretary read her report which showed the approximate value of the year's work in money and boxes to be \$4,900.00. While we have fallen off in number our work shows an advance of \$1,500.00.

The Treasurer read her report which showed that she had received \$1,624.78, which had been distributed according to her detailed report published herein. The Auditor read her report, which stated that she had found the Treasurer's books correct.

The hour of noon having arrived, Rev. Mr. Musson led us in the noon-day prayers for missions. The action of the Junior Department in electing Mrs. Chas. Mockridge as their President was ratified by a rising vote. She thus becomes our Third Vice-President.

The roll was called and with the addition of those who came in the afternoon resulted as follows:

This is the largest meeting on record.

The Educational Secretary read her report, which showed that we had had two Institutes and fifteen Missionary Study Classes.

The Secretary of Section B. was unavoidably detained by illness, but sent her report, which the Secretary read.

The President of the Juniors read her report which showed 456 members. The year's work in cash and boxes amounted to \$341.03. She then read a parting word urging a greater co-operation between the Woman's Auxiliary and its Junior Department with three suggestions: an appeal for financial aid, for love and sympathy and for prayer in the Junior Department.

The custodian of the United Offering reported \$1,803.18, which is \$495.17 more than we had three years ago. The Secretary of the United Offering read her report in which she said that 830 United Offering letters had been sent out.

Miss Robinson was elected Auditor by acclamation over her protest.

The Correspondent of the Church Periodical Club sent her report which was referred back to her for correction. It will be published as corrected.

The Corresponding Secretary read the report of the Lenten work. The value of the boxes was \$602.29. She was instructed to write and thank Mr. R. L. McKellar and Mr. C. B. Compton for their kindness in sending these boxes free of charge. She read a letter from Miss Rowe, of Sherwood, Tenn., thanking us for the box.

The hour for adjournment having arrived, the meeting adjourned to re-assemble at 2 p. m. The meeting reassembled at 2 p. m. with Mrs. Woodcock in the chair until Mrs. Dudley arrived. The minutes of the morning session were read and approved.

The Chairman of the Correspondence Branch read her report. This committee is striving to bring isolated church women into touch with the Auxiliary. It is reaching women in eleven sections where we have no church or mission.

The Chairman of the Committee for St. Luke's International Hospital read the report which showed \$1,462.46 which the committee hopes to make \$1,500.00. These reports were all approved and ordered published.

The following Constitutional Amendment was read and adopted having been brought to a previous Board meeting in writing:

ARTICLE V.—SECTION 3.

Starting at the Annual Meeting in 1917, four Diocesan Officers shall be elected each year to serve for 3 years, and shall be ineligible for re-election to that office for the succeeding term. The election shall be as follows: In 1917, the Second Vice-President, the Recording Secretary, the Auditor and the Custodian of the United Offering; in 1918, the Fourth Vice-President, the Treasurer, the Educational Secretary and the Correspondent of the Church Periodical Club; in 1919, the Fifth Vice-President, the Corresponding Secretary, the Organizing Secretary of Section B. and the Secretary of the United Offering. These rules shall not affect the President and First Vice-President, who are always eligible for re-election.

The Corresponding Secretary said that she had announced at the last Board meeting that she would ask to have the Committee on Revision of the Constitution re-appointed and empowered to change the phraseology of the Constitution so that there will be no conflicting sections. The following were appointed: Mrs. Brown, Mrs. Musson, Mrs. Adams, Miss Robinson and Miss Winston,

Mrs. Quin, of the Paducah Branch, wished to express its appreciation of the interest shown by the Diocesan officers in the Western Convocation. The Corresponding Secretary moved that in pursuance with the request from Paducah that the Board meeting minutes be sent to out-of-town parishes; that she be authorized to do this. This was seconded and carried.

The semi-annual United Offering Service will be held at the Cathedral on St. Michael and All Angels' Day, Sept. 29. All women are urged to send in their offering before this date.

Miss Buchanan moved that the names of all Parochial presidents, vice-presidents, secretaries and treasurers be printed in the annual report. Then Miss Winston moved that we send \$10.00 to the Secretary to help defray the cost of printing of the Journal. Both of these were seconded and carried.

The following were elected delegates to the Triennial: Mrs. C. E. Woodcock, Miss Lizzie Robinson, Miss N. H. Winston and Mrs. Clinton Quin. The Alternates are: Mrs. Stanley Adams, Mrs. Musson, Mrs. Sterling Price and Miss Warren.

On motion of Mrs. Meade Robinson, a rising vote of thanks was given to the ladies of St. Mark's and the Rev. Mr. McCready for the charming hospitality and delicious ice cream.

The offering which, with that of the service amounted to \$39.33, was for Diocesan Fund, but this fund was to be made

responsible for the remainder of the pledge to the Foreign Clergyman's Life Insurance.

Miss Matthews, Educational Secretary of Southern Ohio, spoke to us of the Summer Conferences. She said we used to pray that the doors of opportunity should be opened. Now they are opened, we find the emergency is in the church at home and therefore the necessity for the Educational work has arisen. The three watchwords of these conferences are education, recreation and inspiration, and the day is divided into periods along these lines. Here one gets a vision of the whole world waiting for Christ. The prayer life is so strongly developed that it seems the natural thing to take everything to God for His blessing. If we spend this ten days with the Kingdom of God as the first thing in our lives, then it necessarily occupies a large place throughout life. Geneva is a spiritual health resort and Miss Matthews urged many of Kentucky's women to take advantage of it.

Mrs. Dudley expressed our appreciation of Miss Matthew's inspiring talk and hoped many might go to Geneva.

The minutes of the afternoon session were read and approved.

After this Miss Robinson asked that a rising vote of thanks be given the Recording Secretary for writing the minutes during the meeting. This was an experiment, but it has proven satisfactory, so will be done in the future. Rev. Mr. McCready closed the meeting with prayer before our adjournment.

REPORT OF RECORDING SECRETARY.

Regular Quarterly Board Meetings of the Woman's Auxiliary were held on a Thursday in October, December, February and April at the Cathedral House, with an average attendance of twenty. Each of these meetings was preceded by a Corporate Communion in the Cathedral. Our Fifth Vice-President, Miss Glass, of Hopkinsville, sent a note to each of these meetings expressing her regret at not being able to be present, and wishing us much success in our work.

At the October meeting the Treasurer reporting \$514.25 given to the Emergency Fund through the Auxiliary. The President of the Juniors invited the women to attend the Junior Board Meetings, which are held the Third Thursday of alternate months starting with September. A letter was read from Mrs. Quin declining her elec-

tion as Fourth Vice-President, and Mrs. Muscoe Burnett was then unanimously elected. Mrs. Quin expressed Paducah's appreciation of the Auxiliary Institute held there during the Council. It was decided that hereafter the Fourth Vice-President should call a Convocational Meeting of the Auxiliary at the time and place of meeting of the Western Convocation. The question of defraying the expenses of the annual meeting, such as speakers, etc., was discussed and some thought this should come from the Educational Fund, but the Educational Secretary was so opposed to this plan that she volunteered to raise \$40.00, so that the Diocesan Fund could take care of this matter, for the year at least. The Corresponding Secretary was requested to have the letters for the Advent Boxes ready before October 1st, so the branches could begin work at once.

At the December meeting a new branch of Section B, at Hopkinsville, was reported, which has already appointed representatives of the United Offering and the Church Periodical Club. There are new branches of Juniors at Trinity, at the Cathedral and at Hickman. Mrs. Burnett accepted her election as Fourth Vice-President. A card was read announcing the death of Mrs. McKim, wife of the Bishop of Tokyo. The Corresponding Secretary was requested to write expressing our sympathy. It was decided to send our Lenten boxes to Deaconess Mills, Allakakat, Alaska, and to Miss Rowe Sherwood, Tenn., for mountain work. Mr. McKellar will kindly send these boxes free. A resolution was passed recommending each parochial branch to incorporate into its Constitution a clause requiring change of officers, but each branch is to decide for itself whether its officers shall be elected for one, two or three years. Another resolution requested each parochial president to secure typewritten lists of the names and telephone numbers of every woman in any parochial organization in her parish and when any general meeting is to be held each of these women shall be telephoned to and urged to attend such meeting. The Second Vice-President shall notify each parochial president when such meetings are to be held.

At the February meeting it was decided to rescind the vote taken at the annual meeting about sending a resume of the minutes of the Board Meetings to out-of-town parishes. We will not send these, as it was felt that the Auxiliary Column in the Bishop's Letter covered this ground so fully. All parochial presidents are urged to subscribe to the Bishop's Letter. Hereafter the Quarterly Board Meetings will be open to visitors, but without the right to speak or vote. Several Constitutional Amendments were presented at this meeting, so that they might be acted upon at the annual meeting. Mrs. Brown read a paper giving her interpretation of several articles in the Constitution and explaining the difference between absentee voting by proxy and proxy voting, but no action was taken. Mrs. Saunders offered a resolution that two delegates to the Triennial be elected

by the Western Convocation. Mrs. Musson called attention to the fact that all elections must be held at the annual meeting and offered a substitute which called for five nominations from each branch for delegates. This was passed. An announcement was made of the formation by Bishop Woodcock of a Bishop's League for extension work in the Diocese.

At the April meeting, the question arose as to whether the Executive Board has power to rescind action taken at the annual meeting but this was left for discussion at the annual meeting. A committee composed of the President and first two Vice-Presidents was appointed to arrange the order of business for the annual meeting. Notice was received that the branch at St. James', Pewee Valley, has disbanded. The following resignations were presented: Miss Glass as Fifth Vice-President, Miss Anderson as Treasurer, Miss Buchanan as Educational Secretary, and Mrs. Pilcher of Section B. The minutes of the Auxiliary meeting of the Western Convocation were read and filed. It was decided by rising vote to send a request from this Board, signed by all the Diocesan officers, to Bishop Woodcock, asking that three women be appointed on the Diocesan Committee on Apportionment, in accordance with the precedent established in the Diocesan Social Service Committee and Board of Religious Education. The Recording Secretary was ordered to send a report to the Council. The offering at the annual meeting will go to the Diocesan Fund and this fund will be responsible for the remainder of the Foreign Clergyman's Life Insurance Pledge. The Secretary of the Auxiliary of the Western Convocation was present and she was asked to urge the out-of-town members to be more particular in answering letters. Miss Buchanan urged that the subject of volunteers for the field be kept more constantly before our members and young girls. She said Kentucky was getting to be known as the Diocese which works and gives but which fails in securing volunteers.

At each of these meetings there was a report from the Diocesan Committee on St. Luke's International Hospital, Tokyo, Japan.

There was a called meeting of the Board in St. Andrew's Parish House on Thursday, May 4th., at 10:30 a. m., at which arrangements were made for the annual meeting. The Constitutional Amendments were discussed and it was decided to withdraw all but the one relating to the change of Diocesan officers starting in 1917. Miss Robinson presented her resignation as Second Vice-President. It was decided to have the minutes of the Annual Meeting written during the meeting and approved before adjournment, instead of holding over for a year as heretofore. The Committee which revised the Constitution several years ago was instructed to meet and change the phraseology of any sections which conflict with any new amendments passed. The Committee on St. Luke's International Hospital

was instructed to send its final report to the Council instead of to the Auxiliary, as it was a Diocesan Committee. Hereafter a notice will be sent to the Bishop, inviting him to attend our Board Meetings.

An Auxiliary Institute was held in Paducah in May, following the Council. This was conducted by Miss Tillotson of the Church Missions House, New York. The text book was "The Social Aspects of Foreign Missions." Another Institute was held jointly by the Woman's Auxiliary and its Junior Department at the Cathedral House, November 2nd. to 5th. Miss Lindley conducted classes on "The Why and How of Foreign Missions," and on "Modern Heroes of the Mission Field." This was our semi-annual meeting, and the fall collection of the United Offering took place at one of the services.

There was a united meeting in the Cathedral House on December 18th. to hear Mr. Roger Walke tell of his work in Japan.

United Lenten meetings were held on the six Fridays in Lent in the parish where the united services were held. with an average attendance of 123, the best we have ever had. These meetings were all opened with a hymn, the creed and prayers.

At the first, we welcomed the members from a new branch recently formed at St. Stephen's. The Corresponding Secretary read a letter from Miss Emery, expressing her gratitude that Kentucky was to send another box to Alaska. The offering of \$11.05 was for the expenses of the box. Mrs. Atwood Martin read a paper on "The People of the Appalachian Mountains."

At the second meeting, Mrs. Massie from Lexington was with us, and spoke a few words about the growth of Auxiliary work in Lexington and was asked to take a greeting from the Auxiliary in Kentucky to that in Lexington. The offering amounting to \$15.25, was for the Diocesan Fund. The speaker was unavoidably detained, but Miss Buchanan reported what had been done at the meeting of the Bishop's League the night before, and repeated the address she had made there.

At the third meeting Miss Robinson asked if something could not be done to revive the branches which had suspended. Dr. Alsop of St. Elizabeth's Hospital, Shanghai, China, spoke to us of her work there and the offering of \$13.37 was given to her for that work.

At the fourth meeting, we had several letters of appeal but the only one to which we felt we could respond was one from Rev. Mr. Backhurst, of Morristown, New York, to whom we sent \$5.00 from the Diocesan Fund. Deaconess Goodwin, Student Secretary of the Board of Missions, spoke to us of the many opportunities opening up for young women in the mission field, and told of how some of them were being filled by most promising young women. The offering amounted to \$13.11, which was given for the Apportionment.

At the fifth meeting, Miss Linda Neville spoke of the work for prevention of blindness and told particularly of one poor blind girl named Sarah, who had finished her course at the Blind School here and who probably could support herself by weaving rugs if she had a loom, which costs \$30.00. The amount was pledged before the meeting adjourned. The offering was for the foreign Clergyman's Life Insurance Fund and amounted to \$7.61.

At the sixth meeting, Rev. Mr. Wright gave the address on "Hosea, the Evangelist of the Old Testament," which he was prevented from giving at the meeting at the Cathedral House. The chairman of the Kentucky Committee on St. Luke's International Hospital in Tokyo reported that they had 1,313.61 and were very anxious to make it \$1,500.00. The offering was for this purpose and amounted to \$16.50, besides \$6.00 in pledges.

On Friday, April 28th., a post-Lenten meeting was held at St. Andrew's for the packing of the Lenten boxes. Miss Katie Galt Miller spoke on the position of girls and women in China. There were 54 present. The offering was for the United Offering and amounted to \$3.26.

Fourteen Advent Boxes have been sent, valued at \$527.69, while all branches united in the Lenten work.

The approximate value of the year's work is \$4,900.00.

While we have fallen off in numbers, the value of work done is nearly \$1,500.00 more than last year.

I have sent the usual notices for the Board Meetings and have received from the Treasurer \$5 00, which has been expended for postage and stationary.

REPORT OF EDUCATIONAL SECRETARY.

During the past year under the auspices of the Educational Department two Institutes have been held. Both were led by Secretaries of the Woman's Auxiliary from the Church Mission House, New York City. The one at Paducah was held at the time of the adjourned Annual Meeting in May, 1915. Miss Emily C. Tillotson conducted it. In the autumn, Miss Grace Lindley conducted one at the Cathedral House, Louisville. Both were well attended and notable for different reasons, the one at Paducah for being the first work of its kind out in the Diocese and the one at Louisville for being the first one with representation from the Diocese at large. It is our earnest hope that from this small beginning greater things will grow and that our next Educational Secretary will be able to hold Institutes and Normal Classes out in the Diocese.

The Educational Secretary attended both Institutes and accompanied Miss Lindley to Henderson to attend a meeting of the Ohio Valley Conference of Churchwomen. She also attended the first

meeting of the Woman's Auxiliary of the Western Convocation held at Paducah in February. This convocation offers great opportunity for developing the Auxiliary in the Diocese.

The Study Classes consisted of one Normal class and fifteen Parish classes under twelve different leaders. The text book employed was "The Why and How of Foreign Missions."

The Educational Secretary has written one hundred and eighteen letters, secured the speakers for the United Lenten meetings and for the Annual Meeting and also provided speakers for five meetings at Trinity Parish. She served in the Continuation Committee of the Lake Geneva Conference and wrote personal letters to the clergy of the Diocese asking for representation from them at the Conference.

REPORT OF SECTION B.

As we were so uncertain about the life of Section B., we concluded to concentrate our efforts on one branch rather than organize others, as we know how discouraging it is to young people to start a work, and then have it abandoned. We believe we have proven in a satisfactory manner that the age for Section B. work should be between sixteen and twenty—that being the storm and stress time, the psychologists tell us, and therefore more difficult to hold long to any one work. "Demonstrations" or Church Mystery Plays are uplifting and educational, this work is ideal for this age, and it is often the opening wedge which leads to an activity along other lines of church work which may well put their elders to shame.

Using the Church Mystery Play for the "get-together movement" we found our girls more eager to attend Sunday School, intensely interested in two boxes sent to Corbin one with Christmas cheer, the other of a more practical nature.

A Study Class during Lent conducted by Miss Mildred Buchanan was always well attended and we feel sure will develop some leaders. In June this branch will finish their year of splendid work by giving a "Mystery Play" in the interest of St. Luke's Hospital at Tokyo, when we hope to see all who are present today and ask each will consider herself a committee of one to advise this.

REPORT OF JUNIOR DEPARTMENT.

As I've tried to keep you in close touch with the Junior Work during the past eight years, it seems as tho' for a closing word, rather than a detailed report, a short outline of what seems to me—"The Relation of the Junior Auxiliary to the Senior Branch"—would be much more fitting.

And yet, 'tis always just a wee bit of a shock when I find I have this subject to handle from an argumentative stand-point, for to my mind 'tis a self-evident fact, beyond dispute. And what relation is our Junior Auxiliary to the Senior Branch? Why a little daughter, of course, both by birth and by adoption. Just a few more years, and they pass O! so quickly, and this little daughter will be a woman grown, with all the blessings, privileges and responsibilities of the Senior Branch.

Now what of this little natural daughter of ours? How is she cared for? Isn't it only too true that we try, O! so hard, even before she comes to us to mould and to influence the little life to the uttermost of our ability? Calling into play all that is highest and holiest in our lives, and then, when the little one comes, what a constant care and responsibility along with the perfect joy, for scarcely a moment is there, either by day or by night, when the welfare of our child is not uppermost in our minds. A few more years and she has reached the school age, when she must leave mother's protecting care (at least for a time) until she has learned the ways of this great world. O! then how we worry and hope, plan and pray that our little one may be spared the evil influences, in the midst of this busy and naughty world.

A few more years and she has reached what our lectures' term, "the gang age," outside companionship, for a time at least, seems more necessary and more dear, even than mother's friendship. But we are ever watchful and ever hopeful, are we not, that the "bosom friend" should be all that mother could wish?

A few more years, and she has reached the age of sentiment. Beautiful years they are (or should be), but how we, as mothers, guard every thought, word and action, that our influence may always be only of the highest and best. And so the years roll on, and even long after we have reached the age of maturity, Mother feels it her privilege to guide and direct her child. And what is it that prompts the constant watchfulness? Why, the Mother love, of course.

And now, what can we say of the child of the church? The tiny baby is brought to the front, when still but a few days old. There the priest takes the little one in his arms, places the cross upon her forehead, gives her a Christian name and places her again in the arms of the mother, for what? She is now, not only the natural, but the Spiritual guardian. She has taken her babe to the Temple and offered her to God, and the child becomes a member of His Great

Fold. But she is given back to the mother that she may guide, protect and pray for that precious soul.

In the mother's protecting care, we have but the symbol of the love, sympathy and constant watchfulness of one mother, the Woman's Auxiliary. Are we, as Auxiliary members, guarding our motherhood as a blessed privilege, or are we, as an ordinary woman of the world, shirking our duty at every turn?

Let us consider together some of the difficulties that confront the Juniors each year and if we look the matter squarely in the face, we surely would be able to come to a definite conclusion, as to whether we are or are not, doing our duty by them, our children.

These difficulties, like all others, naturally group themselves into three divisions:—The Material, the Mental, the Spiritual. Under the Material comes always a dreadful stumbling block—lack of funds. Not only for the things we would like to do, but for the things we must do. We have no means, and no possible way of obtaining even the little money that is absolutely necessary for running expenses, to say nothing of the many appeals we must discard each year, because there is not one cent with which to meet an appeal.

Is it right that we should be depriving our children of the blessedness of giving. Would we (as natural mothers) feel that we were justified in placing our child in such a position? Not one cent toward their support, not one cent toward their offerings, and still we are expecting them to labor on each year, without our interest, without our sympathy, without our prayers, without our support, and then we wonder why the Juniors are not always enthusiastic over their work and why the Junior leaders, faithful though they may be, are not able to hold the children beyond a certain age. Is it not largely our fault and could not a great deal of the difficulty be corrected by a very tiny effort on our part.

To relieve this part of the situation a tiny bit, what would you think of this suggestion which comes to us from a sister Diocese: \$50.00 is paid each year by the Woman's Auxiliary to defray the expenses of a Junior delegate to the Summer Conference. That would not be a mighty effort, would it, if it were handled in a systematic way?

And then we come to our Mental difficulties.

How we labor to teach our little ones the fullness of the Divine Command: "Go ye"—and with what do we meet? Why, we can't even get the children to attend the meetings. And is it always their fault? The music lessons, the French, the Art, the Dancing, always seem to fall upon the Auxiliary Day and from the numbers we have enrolled, to most mothers, these are far more important. Would not an added interest on the part of our Senior members counteract, at least to a degree, this difficulty?

So here is another suggestion from a sister Diocese:

A committee is appointed in each branch of the Woman's Auxil-

iary to act as hostesses at the Junior meetings. That means that at each of the Junior meetings there is one member who is not only doing everything in her power to show her interest in their tiny efforts, but after the meeting is over, she becomes a real hostess and serves tea and wafers to her little guests. This duty wouldn't come more than once (or perhaps twice) a year to each member, so that wouldn't mean such a mighty effort would it? I can just see the eyes of the Juniors opening wide with eager anticipation, even at the thought of such a suggestion.

And then for the Spiritual difficulties.

How many of us in the Woman's Auxiliary are praying day by day for the extension and strengthening of the work in the Junior Department? And still we say, the Juniors are not growing. I wonder why? If we were to bestir ourself a tiny bit on behalf of this, our little daughter, would not her development be far more to our credit than it is today, and could we not then look for a more perfect development in the Woman's Auxiliary of the future?

Let us repeat then, the three suggestions. We are offering them as a bit of food for thought, trusting that they may develop into something more substantial than suggestions in the months that are to come.

FIRST: Material, or more properly speaking, financial assistance.

SECOND: Love and sympathy in the shape of a manifested interest, to develop us mentally.

THIRD: Just a prayer for our spiritual development.

Surely the natural mother would do as much or more and would then feel that her duty was only just begun.

REPORT OF THE SECRETARY OF THE UNITED OFFERING.

The Annual United Offering Service was held Nov. 2nd, 1915, in Christ Church Cathedral, Louisville, in conjunction with the service for the Institute.

On January 10th., 1916, there was held the Annual Meeting of the Parish Treasurers of the United Offering but on account of the most inclement weather and an epidemic of grip the attendance was so small that a second meeting was called for January 27th. At this meeting it was decided that a letter reminding the women that the Offering would be given this coming October in St. Louis, should be sent every Auxiliary woman if the Board of the Woman's Auxiliary consented. A committee headed by Mrs. Tevis Goodloe was appointed to write the letter. The Board consented and voted that the expense should be defrayed by the Diocesan Fund.

The minutes of this meeting and the action of the Board were sent to each of the out-of-the-city Treasurers. Eight hundred and thirty (830) of these letters were sent out and the expense was nominal through the kindness of a friend—\$2.25 for the stationary and \$0.70 for postage. We are hoping that a large offering this fall will be the result of these letters.

The United Offering play, "The Little Blue Box," was given twice—once at St. Andrew's Church by the Juniors and Section B. of St. Paul's and of St. Andrews and once at St. Mark's by the Juniors and Section B. of that Parish.

A special United Offering service was held at Grace Church, Paducah.

A new branch has been formed at St. Stephen's and the one at

Trinity revived. The Woman's Auxiliary and Section B. of Emmanuel united so the United Offering branches did likewise.

I have spoken to the branches at St. George's, St. Paul's, Trinity and Church of Our Merciful Saviour.

There has been about two hundred and twenty-five (225) boxes given out for distribution since October, 1915, and two hundred (200) for use in the play, "The Little Blue Box."

The report of the Custodian shows the fruit of the hard work of our former Secretary, Mrs. Charles Mockridge.

JUNIOR DEPARTMENT.

MINUTES OF THE ANNUAL MEETING.

May, 1916.

The second Annual Meeting of the Junior Auxiliary was held on Tuesday, May 23rd., at 3:15 p. m., at the Cathedral House. Roll call showed 71 present, ten parishes being represented. The meeting was opened by the President, Mrs. Leslie Brown, with hymn No. 254, the creed and prayers. The minutes of the last regular Board meeting were read and approved, also a resume of the Board meetings held during the year.

The following reports were read: Treasurer, United Offering, Church Periodical, Educational Secretary, Organizing Secretary of Departments 1 and 2.

The Treasurer's report showed \$181.56 collected for apportionment, \$13.75 for Educational Fund, \$3.00 for Diocesan Fund, Gaylord Hart Mitchell Memorial \$12.00, loom for blind Sarah \$1.00, and \$5.00 for Children's Ward, St. Luke's Hospital.

The Auditor reported these books examined and found correct.

From the reports every department seems to be growing and we have every reason to believe that the Junior Auxiliary is doing a good work in training and developing the younger people in the great missionary work of the Church.

The Educational report shows study in nearly every branch, where a few years ago there were only one or two studying occasionally. The Little Helpers are doing fine work. There are two branches holding weekly meetings for these little ones from two to six years of age. There were four services held this year for this, our youngest department. There are 130 members who contributed \$103.40 to the apportionment.

Five amendments in the Constitution which were presented at the last Board meeting were adopted.

The tellers, Miss Semple, Miss Carpenter and Miss Hamilton, not being ready to give their report of the election, a hymn was sung and the Educational Secretary took the chair, she having the program in charge. She announced that the program was arranged so as to give some idea of the work being done by the three departments of the Junior Auxiliary. Miss Berry, of Paducah, told how the branch of "Little Helpers" (Dept. 1) of which she is leader, held weekly meetings and pasted pictures and sewed on quilt pieces. They have a study work at each meeting in the nature of a Missionary story. Their pennies are dropped in their box for the apportionment.

The work of Department 2 was told in the form of recitation by two of St. Paul's girls, one telling the part we have in the United

Offering, the other reciting a poem about St. Luke's Hospital. The poem was written by one of our Junior leaders.

Department 3 was depicted by one of the girls dressed in Japanese costume, who gave most excellently an interesting monologue of her life in Japan; what it was before she knew about the Auxiliary and what it was after the Auxiliary found her, what part it had played in developing her life, and how, through it, she had gained the happiness that can only be enjoyed by Christians and those who know and love our Lord Jesus Christ. Miss Winston, dressed as America, told why we were so deeply interested in the building of St. Luke's Hospital, Tokyo, Japan. She told of the work already done by the Auxiliaries, and in a most interesting way, she turned to the group of children seated on the stage and told them how the children, through the Junior Auxiliary, were trying to furnish the Children's Ward in the International Hospital. She asked them for their interest, their prayers and a sacrifice of some kind that a few more pennies might be added to the sum already in hand. She sent two Japanese girls into the audience for a collection. This collection amounted to \$15.12, which was turned over to St. Luke's. After the singing of hymn 505, the report of the election was read as follows:

Mrs. Leslie Brown, Delegate General Convention.

In returning the Presidency of the Auxiliary over to Mrs. Mockridge, Mrs. Brown read the following:

"Instead of presenting a gavel to our new President, I'm offering a book which contains the records of the work of the Junior Department during the past eight years. May it prove a firm foundation upon which you may build, and may the structure that you place thereon be so straight and tall that it may shine as a Beacon Light into the darkest corner of the Diocese. To the members of the Board may I say in farewell, that it has been my privilege during the past four years to have witnessed the machinery of many Boards and I can conscientiously say that in not a single one have I found the faithfulness, the loyalty and the devotion of the members of this, our Junior Department. Accept my sincere appreciation of this noble effort, for it has meant more to me that words could possibly express, and may God send His richest blessing upon the work of the coming year."

The meeting then adjourned.

A meeting was called on Thursday immediately after the Annual Meeting of the Woman's Auxiliary, to elect Miss Gilmer Robinson as our Educational Secretary, Mrs. Mockridge having seen Miss Robinson, who gave her consent to serve if elected. She was unanimously elected.

It is with much regret that we give up Mrs. Leslie Brown, who has been our faithful and loyal leader and President for eight years, but we are most pleased to welcome Mrs. Chas. Mockridge as our new President, whom we know is so well able to lead us forward in the work we are trying to do.

REPORT OF THE RECORDING SECRETARY.

Regular meetings of the Junior Auxiliary Board were held on the Second Monday in October and the second Thursday in November, January, March and May at 10:15 o'clock. Each meeting was preceded by a corporate communion. At the October meeting it was moved that we change our meeting from Monday to Thursday and also that we hold our first Fall meeting in September instead of October. This was carried. At this meeting Mrs. Fisher was appointed to fill Miss Brandeis' place as Treasurer, the latter having resigned. The Educational Secretary gave a full report at this meeting concerning the Church School of Religious Education. Also her report of the Auxiliary Institute to be held in November from the 2nd. to the 5th. The date for the Junior Day or Semi-Annual meeting was fixed for November 17th.

At the November meeting Miss Winston gave a most interesting talk on St. Luke's Hospital, after which it was resolved that each branch give one program meeting during the year to St. Luke's Hospital and that the prayer for that Institution be used at each meeting. The box committee reported 400 gifts packed in our Christmas box and sent to the Rev. Mr. Allen, Biltmore, N. C. It was recommended at this meeting that each auxiliary state how many boys and girls they would supply Christmas gifts for, in this way avoiding having too many for one and not enough for the other. Was announced that a play, "The Call of the Little Blue Box," would be given by St. Paul's and St. Andrew's branches on February 25th. at St. Andrew's Parish House. An encouraging and steadily increasing report was given at each meeting by the United Offering Custodian and also from Dept. 1. "The Little Helpers." Four services were held this year for the Little Helpers. There are two branches of this department that are having weekly meetings. One branch is working on a quilt for the Christmas box. We have received gifts from several Little Helps branches for several of our Christmas boxes. The report from the III. Vice-President, whose duty it is to stimulate interest in the parishes outside of Louisville, has been most gratifying and the work in the diocese seems to be steadily growing.

At the March meeting the action taken at the November meeting was rescinded and instead of having each branch have a meeting in the interest of St. Luke's it was decided to have the Annual Day program for that object. The educational work in the diocese has grown wonderfully. Nearly every auxiliary having some definite study. Several plays and demonstrations have been given. Several changes in the constitution have been suggested and these will be acted on at this meeting.

ST. LUKE'S INTERNATIONAL HOSPITAL, TOKYO.

While we had the names of twenty-five persons who volunteered to serve on this committee last Spring, there have been only about ten, 3 clergymen and 7 women, who have really attended its meetings and forwarded the work. We have had four committee meetings, arranged a Parlor meeting at Mrs. Blackburn's on October 23rd., and a mass meeting at the Cathedral House on October 24th. Mrs. Pancoast of Philadelphia, spoke at both of these meetings.

As chairman of the committee, I have spoken in its interest 15 times with three more engagements yet to fulfill, have sent an address to Paducah, which was then to be sent to Hopkinsville, Hickman and Henderson, have written between 60 and 70 personal letters and have sent out 390 circular letters. We feel that the response from those who have contributed to this fund have been very generous but we are disappointed that more people have not had a share in it. We have \$1,411.91 paid in or pledged from Louisville, \$4.26 from Paducah with promise of more, \$20.00 from Hopkinsville and \$3.10 from Hickman, making \$1,439.27 in all, of which we have spent \$26.30 on postage and printing. This leaves us \$1,412.97, which will be sent to the National Committee on July 1st. and then our work will be closed. The Juniors will give us the offering at their Annual meeting on May 23rd. and Section B of St. Mark's will have a Japanese Missionary demonstration in Mrs. Wm. Pilcher's yard after school closes at which a free will offering will be taken for St. Luke's.

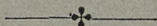

DIRECTIONS FOR PARISH SECRETARIES.



1. When your Branch is ready to begin work, write to the Corresponding Secretary for letters for missionaries, hospitals or schools.
2. When your Branch has "accepted" a letter, that is, has undertaken the work for which that letter calls, let the Corresponding Secretary know at once, the name and address enclosed in such letter.
3. It is of the utmost importance that, immediately after a decision, you should return the rejected letters to the Corresponding Secretary, so that she can, without delay, send them to other parishes.
4. Parish Secretaries must also write at once to the missionary, whose letter has been accepted, stating when and from whom he may expect a box.
5. Secretaries will please send a letter to the missionary, as soon as the box has been dispatched, stating date of shipment. The address of the sender inside the box is always advisable.
6. The Secretary would consider it a special favor if all annual reports were typewritten.
