MINUTES OF ANNUAL MEETING.

The Thirty-third Annual Meeting of the Kentucky Branch of the Woman's Auxiliary to the Board of Missions was held at Christ Church Cathedral on Friday, May 18, 1917, beginning with a Corporate Communion at which the Bishop was

the celebrant. He made an address in which he urged us to look not back, but forward, to see what we may venture for God in the coming year. Our reports are only helpful insofar as they help us to see where we might do greater things for God in the future. The only worthy aim for our work is that of great efforts for great motives and our motive for missions should be God, as it is only as we recognize missions as God's work done at His command that we can really accomplish the work that He intends us to do. We must start from God and then the work will follow naturally; we must measure our work not by what we have done in the past, but by what we can do in the future. We need to keep our vision big enough for our task and to cultivate our faith so that we may ever go forward. The offering taken at this service, as well as the one taken at the afternoon meeting, is for our annual pledge to the Foreign Clergymen's Life Insurance Fund, and all over \$25.00 is to be given to the Apportionment.

After the service, we assembled in Dudley Memorial Hall of the Cathedral House for the business session, which the Bishop opened with prayer. Mrs. Dudley, our President, then took the chair and delivered her address, urging us to try to get more members, particularly that we should train our young girls to take our places.

The Treasurer, as Chairman of the Committee on Credentials, read a list of the branches having paid their assessment to the Diocesan Fund and thus entitled to vote. This list will be found incorporated in her report.

Miss Almstedt read the report of the Nominating Committee and the names were written on the board. Mrs. Rowland and Mrs. Saunders were appointed tellers. In order to save time, we put a report between the elections, so that we might be transacting business while the tellers were out. Before the election of the United Offering officers, the Chairman of the Nominating Committee moved that the order of business be suspended that we might take action upon the amendment combining these two offices. This required a two-thirds vote, but was passed unanimously, so henceforth we will have only one officer for the United Offering and she will perform the duties of both Secretary and Custodian. The election resulted as follows:

The Recording Secretary read an abstract of the Board meetings and all united meetings of the year. She also read a resume of the meetings and activities of the newly-formed Executive Committee.

The Corresponding Secretary read her report, which showed the total value of the year's work to be about \$3,500.00, which is approximately \$900.00 less than last year, but best of all is the fact that this year we have given a life.

The Treasurer read her report, which showed that she had received \$1,221.42, which has been disbursed according to her detailed report published herein. The Auditor stated that she had found the Treasurer's books correct.

The Educational Secretary read her report, which showed that she has held normal classes in Louisville, Henderson and Paducah.

There was no report from Section "B," as we had no Secretary for that department this year.

The President of the Juniors read her report, which showed 286 members. This year's work in cash and boxes amounted to \$304.07.

The Custodian of the United Offering reported \$2,422.00 sent to the Triennial in St. Louis and \$416.62 now on hand for the offering in 1919. The Secretary reported that 243 boxes had been given out and a still larger amount of United Offering literature distributed.

Before the roll-call, Mrs. Dudley announced that the Dio-

cese had suffered a great loss in the death of Mr. Wm. A. Robinson and said that she felt that the Auxiliary would like to put itself on record as expressing this sense of loss and as extending our sympathy to Mrs. Robinson, who was such a devoted member of the Auxiliary and had formerly been a Diocesan officer for years. This was done by a rising vote and the Corresponding Secretary requested to write to Mrs. Robinson.

The hour of noon having arrived, we paused for a few minutes while Miss Robinson led us in the noon-day prayer for missions.

The Correspondent of the Church Periodical Club was prevented from coming by illness, but sent her report, which was read by Mrs. Maury, who also read a letter from headquarters, congratulating us on the increased interest in this work in Kentucky.

The Chairman of the Lenten work read her report. The value of the boxes was \$586.96. She expressed our grateful appreciation to Mr. McKellar and the John C. Lewis Co., who each year render us invaluable assistance. She also read a letter of appreciation from Miss Maddox, to whom the boxes for Virginia were sent.

The Special Treasurer for Convention Pledges reported the \$25.00 pledge to Anvik paid and \$190.54 on hand toward the \$200.00 pledge for St. Agnes' School, Kyoto. There is \$25.00 more promised. She also read a letter from Mrs. Pettigrew,

our Provincial representative on the St. Agnes' Committee, urging us to try to raise more money for this purpose, as there was still \$30,000.00 needed to rebuild St. Agnes' School.

Miss Robinson reported that the Pilgrimage of Prayer had been observed in Kentucky from April 29th to May 6th, we having added one day to our week so as to include the Annual Meeting of the Girls' Friendly Society. There was a combined attendance of nearly 300 at the Communion services and over 650 at the quiet hours. Gratifying reports from the Diocese at large were received, showing that they, too, had participated in the observance of this week.

The two recommendations from the Executive Committee were read and approved without discussion.

The Chairman of the Diocesan Correspondence Branch reported that eleven places are reached through this branch where there is neither church nor mission. She urged us to try to develop this work to greater proportions during the coming year, as it is a very promising opportunity for service. After inviting all to remain, we adjourned for lunch to re-assemble at 2:00 p. m.

The minutes of the morning session were read and approved with slight corrections when we assembled after lunch. The Corresponding Secretary read the annual letter from the Church Missions House. This is our first annual letter from Miss Lindley. It was moved, seconded and carried that this letter be published in our Annual Report, so that we may follow more closely her suggestions. We passed a rising vote to send a greeting to Miss Emery and Miss Lindley.

Mrs. Saunders was appointed Chairman of the Diocesan Correspondence Branch and Miss Edith Campbell was appointed as our representative on the Junior Board.

The report of the Program Committee was accepted after Mrs. Musson had suggested that another topic be added to be devoted to the Church Periodical Club. This was referred to the Program Committee. This program is not given here, as it will be published in the Annual Report.

The Chairman of the Committee on Constitution read the amendments to the Constitution and By-laws and they were adopted as a whole. The Recording Secretary explained that the elections of the morning were for different terms of service

so that we might get our rotation started. The chairman was authorized to have 500 copies of this Constitution printed and circulated through the Diocese.

The Custodian of the United Offering of the Cathedral spoke a few words on how to increase interest in this and urged each woman to try to give ten cents weekly to this.

It was moved and seconded that we give \$10.00 to help defray the expenses of printing our Annual Report, but, upon voting, this was lost.

Mrs. Woodcock asked for a rising vote of appreciation of the work of the Recording Secretary for her nine years of service. This was done and the Secretary tried to express her appreciation of it and bespoke the same courtesy and consideration for the new Recording Secretary as had always been extended to her. The offering was taken and, with that at the service in the morning, amounted to \$25.65.

Mrs. Adams moved a vote of thanks be extended to the ladies of the Cathedral for their hospitality. This was unanimously carried. After several announcements, we sang a hymn. The minutes of the afternoon meeting were read and approved, after which we had an address by the Rev. R. W. Patton.

MINUTES OF ADJOURNED MEETING.

The adjourned meeting was held in St. Paul's Church, Henderson, on Friday, May 25th, starting with a Corporate Communion at which the Bishop was the celebrant. He gave us a motto, which was "to put our creed into our deed" and said then we would be sure to put our prayers into our lives and that is the only way we can do God's work. The business session was called to order in the Sunday-school room by Mrs. Woodcock. Mrs. Price welcomed us to Henderson and struck the key-note of our work in saying that, however small our work may seem when we are discouraged, it always bears the impress of the "spirit of missions" and we realize we are contributing our bit to the great missionary work of the Church. She then introduced Mrs. Woodcock, who presided. The minutes of the meeting held in Louisville were read and accepted.

Mrs. Adams read the President's address after Mrs. Woodcock had expressed the appreciation of the Auxiliary for all that Mrs. Dudley had meant to the work in Kentucky. A rising vote of appreciation was given. The Recording Secretary read her report and Henderson said that they, too, had received the minutes of the Board meetings which had been read at their meeting.

The Corresponding Secretary read the Treasurer's report and the Educational Secretary read her own report. Miss Johnston, director of the Juniors in Henderson, read the Junior report. She also told us something of what the Juniors had been doing in Henderson, showing that they had co-operated in the three-fold aim of the Auxiliary—of gifts, study and prayer.

Mrs. Woodcock read the report of the Correspondence Branch and urged that each one help in this work. The report on Convention Pledges was read.

Mrs. Johnson, of Paducah, read the report from that Branch, and Mrs. Woodcock said that she felt that the growth shown in the branches outside the see city was the fruition of the seed sown by Miss Buchanan. Mrs. Adams read the report of the Program Committee and said that she knew the women who had the topics would be glad to visit any parish wherever possible. Mrs. Woodcock requested that any branch inviting a speaker provide entertainment for her and pay half of the expenses, as our treasury was somewhat depleted. Mrs. Soaper reported progress in the work of the Little Helpers done in Henderson under Mrs. McCravens. The Recording Secretary read the two recommendations from the Executive Committee. Miss Lockett asked to express the appreciation of the reports that had been read, and Mrs. Soaper moved that they all be accepted. The Chairman of the Lenten work read Miss Maddox's letter of appreciation for the boxes sent to Virginia. She also read part of the Constitutional Amendments and explained them, but, as the hour for the address had come, she asked that these be postponed until later if we had the time for them.

Miss Winston then spoke on the Lake Geneva Summer Conference, after she had said a few words about the Appor-

tionment, the Triennial and the Pilgrimage of Prayer at the request of the President and First Vice President.

It was decided to send a letter of greeting from this meeting to Miss Buchanan. The minutes were read and approved before we adjourned for a luncheon at the Country Club.

REPORT OF RECORDING SECRETARY.

Regular Quarterly Board Meetings of the Woman's Auxiliary were held on a Thursday in October, December, February and April, at the Cathedral House, with an average attendance of twenty-two. Each of these meetings, except the April one, was preceded by a Corporate Communion in the Cathedral, but, owing to a change in the hour of service, this had to be dispensed with in April. Mrs. Woodcock presided at each of these meetings.

At the October meeting, we welcomed two new members to our Board, Miss Campbell, as Educational Secretary, and Mrs. Reutlinger, as Correspondent of the Church Periodical Club. As neither of the Junior delegates to the Triennial could go, they had elected at their last Board meeting Mrs. Mockridge as delegate and Mrs. Hamilton as alternate. The Chairman of the Kentucky Committee on St. Luke's International Hospital, Tokyo, reported that she had closed this work during the summer, having sent \$1,503.50, which was gathered from seventeen parishes and missions.

Mrs. Leslie Brown resigned as Organizing Secretary of Section "B" and it was decided to leave this office vacant until after the Triennial, so that we may concur with any action taken there. The delegates to the Triennial were sent uninstructed, as the Board felt it could trust to their discretion about making pledges, but they were requested to bring the matter of a general badge before the meeting. Mrs. Maury reported that Russelville would like to have a Diocesan officer visit them and explain more fully about the work.

At the December meeting, a note was read from Mrs. Craik, expressing her appreciation of the letter of sympathy sent at the time of the Dean's accident, also one containing Miss Lockett's resignation as Fourth Vice President, as she expected to be out of the Diocese most of the year. Mrs. Sterling Price was unanimously elected to fill this vacancy. Miss Winston was appointed special treasurer for the Convention Pledges. The Custodian of the United Offering reported that we had sent \$2,422.00 to the Triennial. A new Junior branch was reported at the Church of the Good Shepherd, Hopkinsville.

The Chairman of the Correspondence Branch reported discouragement, as only 25 of the original 45 had responded. She asked that some of these might be supplied with the "*Spirit of Missions*" through the Church Periodical club, and this has since been done. At this meeting, an Executive Committee was formed, composed of the President, the first three Vice Presidents, the two Secretaries, Treasurer and Educational Secretary, to meet at least once, oftener if necessary, between our Board meetings. The object of this committee shall be to try to arouse greater interest in the Auxiliary and to do constructive work. Mrs. W. W. Locke was elected Secretary of Section "B." The Corresponding Secretary was requested to write Mrs. Quin, expressing our regret that she was to leave the Diocese and wishing both Mr. and Mrs. Quin every blessing in their new work.

Through a mistake, our boxes sent to Allakaket last year went to Nenana instead, but they were needed there, so nothing was done about removing them. Our Lenten work this year will go to an Indian mission in South Dakota and a string of mountain missions near Charlottesville, Virginia.

A most interesting letter was read from Miss Buchanan, our first missionary in the foreign field. We replied to it with a round robin of thanks.

At the February meeting, we had several letters of appeal, but we could do nothing about them, as we had all we could undertake for the present. Paducah and Hopkinsville had each written, thanking the Corresponding Secretary for sending them the minutes of the Board meetings. A letter of appreciation from Mrs. Quin was read and also one of thanks from Mrs. Biller for the ten dollars and eighty cents sent her; she has been able to turn over quite a nice sum to the work in South Dakota after paying the expenses of her trip. The Lenten program and schedule of offerings was adopted. Mrs. Price accepted her election as Fourth Vice President and Mrs. Locke declined as Secretary of Section "B," to which office Mrs. Albert Scheick was unanimously elected. Miss L. L. Robinson was appointed chairman of a committee to make arrangements for our week in the Pilgrimage of Prayer. A Constitutional Amendment was presented by Mrs. Musson, but withdrawn in April, as it was deemed unwise to press the matter at this time. Miss Warren offered an amendment about combining the two United Offering offices, as she felt, after being at the Triennial, that it was better to have both offices held by one person. Action upon this will have to be taken at the Annual Meeting. A Nominating Committee was appointed, composed of Miss Almstedt, Mrs. Califf and Mrs. Maury. Mrs. Reutlinger, Miss Robinson, Miss Campbell and Mrs. Slaughter were appointed to secure a speaker for the Annual Meeting. Mrs. Gilmore, of St. Mark's, read a most interesting letter from Dr. Lincoln, a Kentuckian now doing missionary work in Shanghai, in which he expressed a desire for a trained nurse, but we could not supply this need. A letter was read asking that we give \$1.00 to a rectory to be built in Lexington, Ky. Many felt that we had no right to take this from our treasury, so a collection was taken and \$1.65 sent. The Corresponding Secretary read a letter from Miss Emery, telling of her resignation. We passed a rising vote of appreciation for what Miss Emery has meant to the Auxiliary and pledging Kentucky's hearty support of Miss Lindley.

At the April meeting, a letter from Miss Delafield was read, asking that we express our opinion upon the action taken by the Conference Committee. The report was not read, so no action was taken. The fall United Offering Service will be held in the Cathedral on St. Luke's Day, October 18th, with the Bishop as speaker. Representatives from the Church of Our Merciful Saviour were present and announced that they had forty United Offering boxes out. It was moved, seconded and carried that a message of congratulation be sent to that branch. It was decided to have a "Book Shower" at our semi-annual meeting in the fall and that the books collected be sent to the Church Misions House for Boone Library, Wuchang, China. The Executive Committee recommended that a Diocesan Program with the speakers be published in the Annual Report for the use of any branch which may care to use it. We hope this will encourage all branches to have Program Meetings. Miss L. L. Robinson, Miss Campbell and Mrs. Maury were appointed to arrange this program. The Corresponding Secretary reported that the Lenten work had never been so thoroughly systematized and she extended thanks to Mrs. Terry, Miss Warren and Mrs. Gardner for the able assistance given in packing the boxes. A small sum is left after paying all expenses of the boxes and this will be given to the apportionment. The Chairman of the Committee on Constitution read the sections to be re-worded. The entire Constitution will be read at the Annual Meeting and action taken upon the changes made. Mrs. Scheick declined her election as Secretary of Section "B." This place will be filled at the Annual Meeting. The offering at that time will be for the Foreign Clergymen's Life Insurance Fund and anything over \$25.00 will go to the apportionment.

The Semi-annual Meeting was held at the Cathedral House on Tuesday, November 14th. It was opened by the Rev. Mr. Douglas. All business was dispensed with, as we were to have reports from our delegates and visitors to the Triennial Meeting, held in St. Louis. Our delegates had pledged \$25.00 to repair the United Offering Chapel at Anvik, Alaska, and \$200.00 to St. Agnes' School, Kyoto, Japan, the Woman's Auxiliary special for this year. An offering amounting to \$12.82 was

given to start this fund and each branch was asked to pledge what it could for this purpose. Mrs. Meade Robinson was given a few minutes to present the claims of a Technical High School in Sagada to which she and Mrs. Grinstead had pledged \$500.00 from the Diocese of Kentucky. This can be raised through the parishes, as it is not distinctly an Auxiliary pledge.

A united meeting was held at the Cathedral House on Tuesday, January 16, 1917, at which Mrs. Biller, the widow of the late Bishop Biller, of South Dakota, spoke most instructively of work in South Dakota. There were about sixty present and the offering of \$10.80 was given to Mrs. Biller for work in South Dakota.

On Saturday, January 20th, there was a joint meeting of the Woman's Auxiliary and its Junior Department, held at the Cathedral House, at which time Miss Lindley presented the new Junior plan. The meeting was then thrown open for questions that we might get all the information possible about this new plan. During the singing of a hymn, an offering was taken which amounted to \$6.25. This was given to the Educational Fund, as this fund was to pay Miss Lindley's expenses, except for \$3.00 given by the Juniors. Miss Lindley later gave us an inspiring address on "Prayer."

United Lenten meetings were held on the six Fridays in Lent in the parish where the Lenten services were held, with an average attendance of 125, the best we have ever had. These meetings were all opened with a hymn, the creed and prayers.

The first meeting was held at St. Andrew's, where Mrs. Adams spoke briefly of the two points to which our Lenten work was going, and Miss Winston spoke on "Summer Conferences," particularly the one at Lake Geneva. She urged many to go and each branch to have at least one scholarship. The offering amounted to \$11.25 and was for the expenses of packing the boxes.

The second meeting was held at Grace Church, at which time Rev. Father Huntington, O. H. C., spoke on "The Spiritual Side of Missions," speaking particularly about the Lord's commission as given in the tenth chapter of St. Luke's Gospel. It was reported that Hopkinsville had held an every-

woman canvass for the United Offering. The offering was \$12.50 and was to be applied on the apportionment.

The third meeting was held at St. Mark's, where it was announced that the boxes were to be packed at Calvary on April 10th. Bishop Israel, of Erie, spoke on "Personal Religion," after being most gracious in his congratulations to our Auxiliary. The offering was for the Convention Pledges and amounted to \$15.11.

The fourth meeting was at St. Paul's, where Dr. Duckworth spoke on "The Master's Command." Another appeal was made here for scholarships to send some of our girls to the Summer Conferences. The offering of \$12.00 was for the apportionment.

The fifth meeting was held at the Church of the Advent, at which Mrs. Adams read a letter from Miss Emery, expressing her appreciation of the letter sent from our February Board meeting. It was announced that St. Stephen's was conducting an agency for "The Spirit of Missions." Bishop Partridge, of West Missouri, spoke on "St. Agnes' School, Kyoto," and impressed us with the fact that St. Agnes' would lose its license if the money were not forthcoming to repair its buildings and thus the faithful work of many men and women would be wiped out. The offering of \$15.76 was for our Convention Pledges.

The sixth meeting was held at the Cathedral, at which time one member of the Cathedral promised the money for a Junior scholarship to the Geneva Conference. Miss L. L. Robinson urged the women to pray for the Pilgrimage of Prayer. Dean Massie was to have been the speaker, but was prevented by illness from coming, and Rev. Father Johnston kindly took his place. He spoke on "Personal Service." The offering of \$13.05 was given to the apportionment.

REPORT OF EDUCATIONAL SECRETARY.

The Educational Department feels that this year its greatest work has been done outside the see city. The Educational Secretary has conducted normal classes in Henderson and Paducah as well as in Louisville. Paducah has led the entire Diocese with twenty-one in its normal class and it alone has attained the ideal of a class in each parochial organization. During Lent, it had seven classes with an enrollment of fifty-eight. An officer from Paducah wrote the Diocesan Board that, during the period when they had no Rector, the parish had virtually been held together by its study classes.

In Louisville, she had one normal class with an enrollment of fourteen from six parishes. She also conducted a class on "Missions and Social Service" in the Diocesan School. There were in all eighteen parochial classes with over 200 members. Most of these classes used the text-book of the year, Dr. Gray's "New World," and two classes were on "Prayer."

The Educational Department was responsible for arranging two united meetings, with speakers from a distance, one on January 16th, at which Mrs. Biller spoke on the work in South Dakota. The other one was a combined meeting of the women and juniors on January 20th, when Miss Lindley, our new General Secretary, explained the new Junior plan and made an address on "Prayer." This department was also responsible for the program and speakers at the United Lenten meetings and feels it was very fortunate in securing the men who were conducting the noon-day services to make the addresses.

The Educational Secretary attended the Lake Geneva Conference of the Missionary Educational Movement and has served on the local continuation committee to arouse interest in this Conference for 1917.

The ideal for next year is a study class in every parish and greater co-operation between the Woman's Auxiliary and the Sunday-schools. May we hope for at least one class in every Sunday-school studying "The Why and How of Foreign Missions"?

REPORT OF EXECUTIVE COMMITTEE.

The Executive Committee has held three meetings, at which we have tried to devise some means whereby we can strengthen the Auxiliary in Kentucky. At the first one, we authorized the Treasurer to send \$10.00 to help pay the expenses of our provincial delegate to the Conference Committee Meeting in New York. The Special Treasurer for Convention Pledges was instructed to write to every branch which had not as yet promised anything for this purpose. It was decided that the entire committee would visit each branch in the city and take with us a questionnaire which we hope will enable the officers to see where they can help each branch. Copies of this questionnaire will be mailed to branches out of Louisville. We asked Miss. L. L. Robinson to become a member of this committee and to go with us on these visits, presenting the claims of the Woman's Auxiliary in every parish and urging an every-woman canvass.

At the second meeting, we discussed how best to raise the money for the annual parochial dues to the Church Periodical Club. We made plans for the Pilgrimage of Prayer, which will reach Kentucky April 29th-May 5th. We also arranged to have a program with speakers and subjects published in the Annual Report, which each branch can use or not, as it sees fit.

At the third meeting, the following recommendations were passed to be presented to the Annual Meeting: *Resolved*, That the Executive Committee recommend that every branch at their first fall meeting arrange to have an every-member canvass of women to secure new members and to increase the attendance of those enrolled who do not attend regularly. (2) It is recommended that henceforth the dues of the Church Periodical Club be raised through the parish and not taken from the treasury of the Auxiliary. Action was taken upon the suggestions sent from the Conference Committee of the Auxiliary and replies sent to Miss Delafield, the chairman. Miss Winston will make the address at the adjourned meeting in Henderson, her subject being the Geneva Conference. The offering at this meeting will be for the Junior scholarship to Geneva. The committee, or a part of it, had visited all branches in Louisville and vicinity, except that at the Church of Our Mer-

ciful Saviour, where we hope to go soon. We also hope to arrange for at least one officer to visit all of the branches outside of Louisville next year. Copies of the questionnaire had been sent to out-of-town branches and the following report was submitted as a result of the answers to these questions: Most of the officers read The Spirit of Missions and about half of the members read it; Calvary, St. Mark's and St. Stephen's were the only one reporting "No" to the first question; about half of the officers read the Bishop's Letter, but few branches report their women as reading it. Grace Church reported all as reading it and St. Peter's reports both The Spirit of Missions and the Bishop's Letter as read at meetings. The enrollment of the parishes reporting is 533 active members, thirty-seven honorary members with an average attendance of 281 and 447 United Offering boxes out. Emmanuel is the only branch that has attained the ideal of every woman communicant a member of the Auxiliary. All branches meet monthly, except Calvary, which meets weekly, spring and fall, and St. Agnes' Guild weekly. Several others meet weekly when sewing for a box. Grace Church, Hopkinsville, meets twice a month. Most branches seem to think their members understand the Board of Missions and its methods, but many would like to have further information. All have programs or addresses except Calvary. Hopkinsville did not answer this question. The following have Junior branches and keep in touch with them: Advent, Calvary, Grace, St. Andrew's, St. Paul's, St. Mark's, St. Stephen's; Grace, Hopkinsville; Grace, Paducah, and St. Paul's, Henderson. The following have no Junior branches: Cathedral, Emmanuel, St. George's, St. Luke's and St. Peter's. The following had study classes: Advent (2), Calvary (2), Emmanuel, Grace, St. Stephen's, St. Mark's (3), St. Andrew's (2), Henderson, Hopkinsville and Paducah (5). The following had no study classes: Cathedral, St. George's, St. Luke's and St. Peter's and St. Paul's, although the latter had one in the Juniors. All branches were making preparations for the Pilgrimage of Prayer. Most branches have read or are planning to read Miss Emery's report. Trinity, Louisville; Good Shepherd, Hopkinsville, and Christ Church, Bowling Green, did not return their questionnaires.

REPORT OF JUNIOR AUXILIARY.

In reviewing the year's work, there is much to encourage us and much to be thankful for. Our former President, Mrs. Leslie Brown, had laid a strong foundation for the work and it was only for us to build.

One new branch has been organized at Christ Church, Bowling Green, and one re-organized in Calvary through the Sunday-school. There have been study classes in every branch, most of them using the Junior book, "Nanana"; others some missionary instruction.

Our Christmas box of 600 gifts, sent to the Indians, was the best we have ever sent.

Several of the Sunday-schools have missionary instruction once a month. At the "Quiet Hour" for Juniors, during the week of the Pilgrimage of Prayer, conducted by the Rev. Henry Simpson, there were 150 Juniors present.

Through the kindness of a friend at the Cathedral, one scholarship to the Summer Conference at Lake Geneva has been given to Miss Margaret Bond, of Paducah, Third Vice President. We hope to have another scholarship.

Our greatest weakness and problem is Section III, the older girls. That and the new Junior plan will be our work for the coming year. We should have more branches in the Diocese. As we start our work for the year, let us look forward and not back, keeping always before us, first, the great aim of the Auxiliary, "To know the Living Christ and to make Him known throughout the world," and then the work we must accomplish in the new year of great opportunities stretching before us.

REPORT OF THE SECRETARY OF THE UNITED OFFERING.

The annual United Offering service was held St. Michael and All Angels' Day, September 29, 1916, at Christ Church Cathedral, Louisville. Bishop Woodcock was the speaker. As it was the meeting just before the Triennial, greater interest was shown.

A meeting of the Treasurers of the United Offering was held January 27, 1917. At this meeting it was decided that a letter be sent before the 1st of March to every clergyman in the Diocese, asking him to announce that it was time to open the blue boxes and to explain what the United Offering is. This was a way to bring it before the women who are not connected with the Woman's Auxiliary. The clergy were most kind in acceding to our request.

There was one new branch started at St. Peter's and the one at St. Thomas' united with the one at Advent. I have spoken at Advent and at St. George's.

Two hundred and forty-three (243) blue boxes have been given out since October, 1916, and a still larger amount of United Offering literature has been distributed.

A society of women to help the Board of Missions of the Church to carry out our Lord's command, "Go ye into all the world and preach the Gospel to every creature."

ITS PURPOSE.

The three-fold aim of the Woman's Auxiliary is study of missions, gifts for missions, prayer for missions.

REQUIREMENTS FOR MEMBERSHIP.

"Every baptized woman has been made a member of the Body of Christ, that great missionary society, whose field is the world; participation in the efforts of the Woman's Auxiliary to help the Board of Missions in that part of this work entrusted to it meets the requirement for membership; and this participation may be had in study, in gifts, prayer, but best in a union of the three as each may have ability."

Will you not become a regular member of a parish branch, or, if there is no parish branch near you, will you not become a Corresponding Diocesan member?

To become the latter, you are asked to pray daily for missions and to pay the sum of ten cents a year.

We want *you* in this Woman's Auxiliary and we want you to feel at liberty to ask us any questions that will throw any light on this noblest and most unselfish of woman's organizations.

REPORT OF THE GENERAL SECRETARY.

It has been Miss Emery's custom to send an annual letter to the branches of the Woman's Auxiliary, and I am glad to follow her example so that I may say a few words to you about our hopes and plans for the years we are to work together.

You will remember that one suggestion which the Conference Committee is sending to the branches for their discussion reads: "The General Secretary should be nominated by the Auxiliary, and appointed by the Board of Missions, her term of office to coincide with that of the President of the Board." I want to say to the Auxiliary, myself what Bishop Lloyd wrote the Presidents, that I am personally very thankful that we are planning this. Only Miss Emery could ever have the position which she has had. It was natural that we should want to keep the upbuilder and guide of the Auxiliary for as long as she would let us keep her, but after this the office must be filled by the nomination of the Auxiliary, and no one can be more glad than I, because I want you to have the Secretary you want. It is also a very practical help to me in that it gives me a definite time for which to plan and the purpose of this letter, besides taking my greetings to you and the pledge of my service, is to tell you some of the things we are planning for the time between now and October, 1919.

Miss Emery is occupied with editorial work and Auxiliary leaflets and with the oversight of the Pilgrimage of Prayer.

Miss M. T. Emery, who has cared so wonderfully for all our box work through these many years, continues in charge of the personal boxes, and the Junior boxes are to be in the care of Miss Underhill, who has long been associated with us at the Church Missions House.

The Auxiliary is most fortunate in having Mrs. Biller appointed one of our Secretaries, and her knowledge of the West and her love of the Church's mission are going to mean a great deal to us all.

We are hoping to have Miss Tillotson back next fall to guide our educational work. By that time, too, we hope to be able to announce definite plans for the Junior Department. This winter we have been fortunate in having had the help of one of the New York Junior officers, Miss Dorothy Giles.

Thanks to Miss Emery's care, the Auxiliary exists in every Diocese and missionary district, and it seems to me that most of our work for the future lies along two general lines. First, the strengthening of the organization. We shall make a great mistake if we ever forget the lesson Miss Emery has taught us, that is, to avoid too much red tape. But we can remember that and still perfect our organization. This is the end toward which the Conference Committee and the other committees appointed in St. Louis will work. Second, the present Auxiliary should act as an *educational* force to reach the uninterested and to fill up the ranks. We can not add new Diocesan branches, but anyone who studies the Auxiliary knows that it is imperative that parish branches be strengthened, that we "recruit to war strength." To help in this, I am suggesting the following plans for next year's work:

1. That I go to the Provincial Meetings, not so much to talk as to hear, to know what you are thinking and to find out how we can help each other.

2. That Mrs. Biller spend five months in the sixth, seventh and eighth provinces preparing the way for the holding of institutes.

3. That the Educational and Junior Secretaries follow Mrs. Biller about a month later, holding three or four days' institutes where leaders can be trained.

4. That, between Mrs. Biller's visits and these institutes, committees in the Dioceses where they are to be held do preparatory work.

5. That the aim of the institutes shall be not so much to reach many, but to train a few, preferably one from each parish. In this way we shall plan systematic education and the residence for some time in several of the provinces of some of the Secretaries.

You will see that we have planned these special visits for only three provinces. The others are left out simply because in some places they need less outside help since the educational work is well established, or because, with all our willingness, we can not cover the whole of the United States in a winter; and, while we do not want to announce plans so far ahead, we are hoping to make the other visits the year after next. Be-

side this definitely planned work, I shall be glad to visit Diocesan branches.

So much for visits and educational work. There are a few things in general of which we should speak. Let us finish our Pilgrimage of Prayer as we have begun it, so that it may be the beautiful thing Miss Emery thought for us. Let us avail ourselves of summer conferences. If it is possible, see that your Diocese is represented at one of them, and, whenever it is possible, that the parishes are represented. We enclose a notice of the conference or conferences nearest you. We are doing our best to have the Church Missions House represented at these conferences.

In closing, I wish I could say the word which is surely in all our hearts. No one knows what is before us, but we can not help realizing that we may be at the beginning of very solemn days. If we are to work through war times, we must be faithful. We shall, of course, do our duty as patriotic Americans, but we must see to it that no missionary suffers either in boxes or money gifts. Let us emulate the English missionary societies in making our gifts not less but greater in war times. Let us go further and make a special effort at this time to interest those whose hearts are touched by the suffering caused by the war and seek to make them care also for the suffering caused by the lack of knowledge of Christ. Our hearts may well thrill with the opportunities before us! We may be tested in many ways, but it is certain that our King is willing to use us for the hastening of His Kingdom, and that we may be fit for His use let us learn to draw nearer to Him. Let us pray for each other, that we may more perfectly know Him and the power of His Resurrection.

REPORT OF CONVENTION PLEDGES.

The Kentucky delegates to the Triennial pledged \$25.00 to repair the United Offering Chapel at Anvik, Alaska, and \$200.00 to St. Agnes' School, Kyoto, Japan. At our December meeting, it was decided to send the first \$25.00 collected to Mr. George Gordon King to pay the Anvik pledge. All

the rest we received was to be sent to St. Agnes' School, as the full amount needed was not subscribed at the Triennial. Each branch which contributes is to feel that part of its offering went for both objects. The following amounts have been collected:

THE PILGRIMAGE OF PRAYER.

The devotional week in the Pilgrimage of Prayer quietly progressing from Diocese to Diocese, throughout the Woman's Auxiliary, brought its blessings and its opportunity to Kentucky April 29th-May 5th, inclusive, and extended one day in order that the Girls' Friendly Society might share its benefits. No work purely spiritual in aim ever attains, perhaps, its highest ideals, and the Pilgrimage in our midst, from parish to parish, can not claim to have realized all that may have been hoped in fullness of observance. But neither can spiritual

influences ever be measured in figures, or results visible. Certain it is that the week left on many hearts an impress and blessings long to be remembered.

As regards the number of participants, here in our own city, the Corporate Communion held by each branch in the respective parishes, and thus gathering practically a different group daily, numbered in all nearly 300 women. The Quiet Hour, held likewise in the different parishes and attended by congregations largely diversified, each afternoon brought together a sum total of over 650 women.

From the Diocese at large, gratifying reports have also come, especially from Paducah, where we are told: "With us the Pilgrimage of Prayer was a very solemn and beautiful week. Fifty were present at the Corporate Communion and an average of forty-two at the Quiet Hours, held daily."

Henderson likewise reports an attendance of thirty-eight at the Communion, and two Quiet Hours numbering, respectively, thirty-six and twenty-five.

Hopkinsville, we are very sure, was not without its participation, but has not as yet reported.

MINUTES OF THE ANNUAL MEETING

MAY, 1917.

The Third Annual Meeting of the Junior Auxiliary was held at the Cathedral House on Monday afternoon, May 14th, at 3:15 o'clock. The meeting was called to order by the President and opened with the creed and prayers.

The minutes of the last regular Board meeting were read and approved, also an abstract of the Board meetings held during the year.

The Treasurer read her report, which showed \$153.67 paid towards the Apportionment; \$10.75 towards the Educational Fund; \$5.50 towards the Diocesan Fund, and a \$25.00 special pledge to St. Luke's. The Auditor reported that she had examined these books and found them correct.

The Educational Secretary read her report, which showed much growth along this line.

The Organizing Secretary of Department I reported 226 active members enrolled contributing towards the apportionment \$87.02 and \$1.00 sent for a font in a mission. She also reported that an old branch, which has not been very active recently, has been reorganized.

The Organizing Secretary of Department III reported that, wherever there was no branch, it was due to the lack of a leader. This, we hope, will be overcome in the coming year.

The United Offering Custodian reported that, during the year, \$21.80 has been turned in.

Votes having been cast for the officers to be elected, the teller made her report as follows: Miss Gilmer Robinson, Educational Secretary; Miss Aileen Hamilton, Custodian United Offering; Miss Edith Parker, Custodian Church Periodical Club, and Miss Virginia Semple, Treasurer. On account of Miss Semple being elected Treasurer, the office of Second Vice President was left vacant. This was filled by the Board and Miss Wallace was appointed.

The report of the Box Committee showed the Christmas box, containing 600 gifts, sent to Rev. Wm. Holmes, Sanyee Mission, Nebraska, was valued at \$93.25.

The following report was read on "The Quiet Hour," held for the Juniors during the Week of Prayer: The Quiet Hour in the Week of Prayer, planned especially for the Juniors, was held at Calvary, Wednesday, May 2d, and was conducted by the Rev. Harris Mallinckrodt and Rev. H. J. Simpson, of the Cathedral, making the address. The attendance of 150 was most gratifying and the children displayed a deal of interest and enthusiasm, both in the responses and in the singing of the hymns. The address explained most clearly the wonderful power possible through a consecrated early service. The speaker dwelt particularly upon the necessity for a three-fold development, which he gave as follows: First: A firm *belief* in this—Christ's Kingdom on Earth. Second: *Service*, or the living of the Christ-life, as our part toward the strengthening of that Kingdom. Third: Earnest and constant *prayer* for the perfection of the Kingdom.

The President made the announcement that a scholarship had been given the Juniors for the Summer Conference at Lake Geneva. This scholarship is to go to some one outside of Louisville. There were only seventeen present at this meeting, but we feel that this small number was due to the fact that on the following night the play, "Its Radiant Hem," was to be repeated.

The report from the Chairman of the Extension Committee was read and it showed a growth in the Juniors in the other cities. Every effort has been made to start branches where there were none, some with success and some without.

The President spoke of the good work that had been done during the year and how all had stood together in trying to accomplish the work set before us. She asked that our prayers this summer be especially for the development of Section II, that a leader may be found for these older girls, who will guide and direct them in the right way. Also that we pray for the new Junior Plan, that it may be put into effect in every Sunday-school in the fall. She expressed her anticipation of great results along this line, as several of the older girls are going to a summer conference and one to a summer school in the East.

There being no further business, the meeting adjourned.

At our January meeting, Miss Lindley spoke to us, explaining the new Junior Plan as adopted at the General Convention in St. Louis. It was conceded a most excellent plan and all promised to do what they could towards adopting it in Kentucky.

In February, rehearsals were begun under the direction of Mrs. Hamilton for a play, "Its Radiant Hem." This play was given at the Cathedral House on February 17th; the offering was for the Junior pledge made at the Convention in St. Louis. All branches, with the exception of one, was represented. The music was under the direction of Mrs. Malinckrodt and Mrs. Whitney and was most excellent, adding much to the program. The play was decided the best thing of the kind ever given by the Juniors in Louisville.

A Normal Class, led by the Educational Secretary, was held the six weeks before Lent. This class was well attended and through it we were able to send a leader to New Albany when they asked for one.

At the March meeting, Miss Robinson was appointed chairman of a committee to discuss plans and arrange for the putting of the new Junior Plan into all the Sunday-schools.

The Chairman of the Extension Committee has sent excellent reports to each Board meeting and through her much interest has been stimulated in the branches outside of the see city.

At the last meeting, it was decided to repeat the play given in February. It was voted that the offering at this play go towards a scholarship to Lake Geneva.
