MINUTES OF THE ANNUAL MEETING.

The Annual Meeting took place Tuesday, January 22d, at 11:00 A. M., in the Cathedral House.

This meeting was preceded by a Corporate Communion in the Cathedral with the Bishop as celebrant.

The Bishop proved to us that now was the time in the history of the world when we were to be loyal to the missionary cause of the Church; to give our gift of comfort and cheer to those who need it.

The Bishop opened the meeting with the creed, prayers and a message of encouragement, and Mrs. Woodcock presided until the arrival of Mrs. Dudley.

Miss Anderson, Chairman of the Credential Committee, read a list of parishes entitled to vote.

Miss Winston moved that, owing to the change in the Church Year, every parish should have its vote, whether they had made their payment to the Diocesan Fund or not. Motion carried.

Mrs. Foster, Chairman of the Nominating Committee, read the names of the nominees.

The election resulted as follows:

President—Mrs. T. U. Dudley.

First Vice President—Mrs. C. E. Woodeock.

Fourth Vice President—Miss Virginia Lockett, Henderson.

Treasurer—Mrs. Mason Barret.

Educational Secretary—Miss L. L. Robinson.

Correspondent Church Periodical Club—Miss Mary Youngman.

The office of Auditor becoming vacant by the election of Mrs. Barret, Mrs. Albert Reutlinger was elected Auditor to fill Mrs. Barret's unexpired term.

Mrs. Dudley having arrived, she took the chair.

Miss Winston, Second Vice President, reported the two united meetings with an attendance of eighty-four and one hundred and sixty-eight.

The Recording Secretary then read an abstract of all Board meetings and united meetings, also a resume of the work of the Executive Committee.

The Corresponding Secretary begged leave to give her report later, all reports not yet being in.

The report of the Treasurer showed a balance in the Apportionment of \$703.85, in the Educational Fund \$64.97, and in the Diocesan Fund \$27.15.

The report of the Auditor showed all postings correct and vouchers correct as far as they had been returned from the Church Missions House.

The Third Vice President reported one new Junior Branch formed, three boxes sent and the New Junior plan being successfully tried out in St. Andrew's Parish, and mission study classes will be held in all branches.

The report of the Custodian of the United Offering showed a balance of \$412.52 received since last May.

The Educational Secretary reported two Normal Classes with eighteen members, these members to be leaders of study classes during Lent.

There was no report from the Chairman of the Diocesan Correspondence Branch.

The President then gave her Annual Address, stressing the fact that, now that we have no Section B, we should try to interest the younger women in the Woman's Auxiliary and to educate our children in the work for missions.

Miss Winston reported the offering at the end of the Pilgrimage of Prayer as \$143.34, St. Agnes's School, Kyoto, the beneficiary.

The hour of noon having arrived, Mrs. Dudley led us in the noon-day prayer for missions.

The Correspondent of the Church Periodical Club reported five boxes and one barrel sent out and one hundred and thirty-nine magazines sent regularly through the club.

The Corresponding Secretary read a letter from Mrs. Barrett, thanking us for our note of condolence.

The Lenten work was then discussed.

Miss Winston moved that we accept no independent appeal. Motion carried.

Mrs. Woodcock moved that we rescind our action taken on the box to Ft. Hall, Idaho. Motion carried.

Miss Robinson moved that we accept the box to Wind River, Wyoming. Motion carried.

Miss Robinson then presented a tentative program for the United Lenten Meetings and stated that the speakers had not yet been selected.

Miss Winston moved that we present both offerings, which amounted to \$18.25, to the Clergyman's Life Insurance Fund. Motion carried.

Miss Winston then explained the Central Fund in a very clear and concise manner.

Miss Semple offered the following resolution:

"Resolved, That Section B as a separate department of the Woman's Auxiliary be abolished."

This resolution was adopted.

Mrs. Adams announced that, though her letter to the Clericus had not been read, the Clericus had agreed to hold United Lenten services at 4:00 p. m. during this coming Lent.

Mrs. Keisker offered the following resolution:

"St. Andrew's Branch of the Woman's Auxiliary moves the adoption of the following resolution:

"Resolved, That, in appreciation of her thirty-one years of faithful service as Treasurer of the Diocesan Branch of the Woman's Auxiliary, Miss Fanny C. Anderson be made a life member of the Diocesan Board."

This resolution was adopted by a rising vote.

Mrs. Adams offered the following resolution:

"Resolved, That those officers whose terms expire in 1918 remain in office until May, at which time the officers elected at this meeting shall be installed."

This resolution was adopted.

Miss Winston then announced that the leaflets, "Bible Readings for Meditation" and the "Cycle of Prayer," were on the President's table for sale.

We then adjourned for luncheon.

Immediately after we reassembled, Mrs. Adams moved that one of the Lenten offerings be applied to make up the deficit in the Clergyman's Life Insurance Fund. Motion carried.

The Secretary then read the minutes of the morning session, which, after a slight correction, were approved.

Miss L. L. Robinson then gave us a most wonderful and inspiring talk, and her subject was, "Is Christianity a Failure?"

The meeting then adjourned.

REPORT OF THE RECORDING SECRETARY.

Regular quarterly Board meetings were held during the past eight months, on a Thursday in October and December, with an average attendance of seventeen.

Both of these meetings were preceded by a Corporate Communion held in the Cathedral.

Mrs. Woodcock presided at the October meeting and Miss Winston in December.

At the first meeting several letters of appeal were read from various Missions, from St. Luke's, Tokio, and St. Agnes', Kyoto, but nothing could be done for these.

Miss Winston announced the coming of Deaconess Hart for our semi-annual meeting, and that Miss Lindley would visit us in January to give lectures on "Missions in the Bible."

A very grateful as well as amusing and interesting letter was read from the Indian Catechist to whom one of our Lenten boxes was sent.

A report of the Missionary Conference, held at Lake Geneva last summer, showed that one-third of all Episcopalians there, twenty-four in number, were from Kentucky and it was urged that more parishes will give scholarships for next summer.

The Board decided to continue to foster the work of the Church Periodical Club through the Woman's Auxiliary, allowing each parish branch to raise the dues as it saw fit.

The Church Periodical Club has sent out many magazines as well as boxes of books to soldiers and others.

At the December meeting, a motion was made to send Miss Lindley ten dollars to help pay her expenses incurred during her visit to the city.

The Annual United Offering Service was held St. Luke's Day, October 18th, in the Cathedral House. The Custodian reported a balance of \$816.67 in bank.

The Organizing Secretary of Section B offered a resolution in writing:

"Resolved, That Section B as a separate department of the Woman's Auxiliary be abolished."

The Chairman of the Diocesan Correspondence Branch asked the Board for suggestions for extending the work. It was decided to send out, besides the usual card asking for a small contribution, a personal letter and the two leaflets, "Bible Readings for Meditation" and the "Cycle of Prayer." Answers to these letters were requested stating what benefit had been derived from these leaflets.

The Educational Secretary announced that Normal Classes would be conducted this year by Miss L. L. Robinson, the subject to be "Missions in the Bible."

The Diocesan and Educational Funds were combined to form a Central Fund, available for all purposes, Miss Winston's plan to increase this fund and to provide a fixed income for the Diocesan Board was approved.

In this plan, each parish was assessed on a basis of what it had given before and what it could be expected to give.

All parishes were divided into classes formed on this same basis.

The payment of this assessment will be compulsory in 1919, after a parish has accepted a class. The vote of each parish branch at the Annual Meeting will become contingent on the payment of this sum.

Mrs. Adams, Mrs. Gardner and Mrs. Maury were appointed a committee to consider the necessary changes in the Constitution.

The Nominating Committee was appointed, consisting of Mrs. Foster, Mrs. Saunders and Miss Warren.

The Semi-Annual Meeting was held November 24th and was opened by Dean McCready with a hymn, the creed and prayers.

No business was transacted, all the time being given to Deaconess Hart, of St. Phoebe's Training School, China. Deaconess Hart is a co-worker of Miss Buchanan and gave us an interesting talk on the work in China. An offering of \$15.00 was taken and given to Deaconess Hart to use as she wished.

At this meeting we held our Book Shower when many books were brought and sent, through the Church Periodical Club, to Boone Library, Wuchang, China.

On Friday, December 7th, a United Meeting was held, which was opened by the Rev. Mr. Hardy.

Miss Grace Lindley, General Secretary of the Woman's Auxiliary, who was here studying the Every-Member Canvass, gave us a wonderful talk on the "Gospel Revelation."

This was the largest meeting we ever had, one hundred and sixty-eight being present, of whom twenty-eight were visitors from other Dioceses and other communions.

JUNIOR DEPARTMENT.

MINUTES OF THE ANNUAL MEETING.

On account of the very severe weather, the Annual Meeting of the Junior Auxiliary, held on Monday, January 21, 1918, at the Cathedral House, was very poorly attended.

There was very little business, as a regular Board meeting had been held only a few days before, but the following reports for the last eight months were handed in.

The Treasurer's report showed \$56.45 collected towards the Apportionment; \$12.15 has been sent to Mr. King, leaving a balance, January 1st, of \$44.30; balance in the Educational Fund, \$4.77; balance in the Diocesan Fund, \$3.90; \$25.00 was paid toward a Lake Geneva scholarship.

The Secretary of Department I handed in the following report:

“On account of the short year, the only money to report is \$3.00 from St. Andrew's Little Helpers. However, the Henderson Branch sent a box of clothes, belonging to a Little Helper who had died, which was forwarded to the Rev. Wilson Hartzel, of Vineland, N. Y. As he has three girls, I am sure they will be greatly appreciated.”

The United Offering Custodian reported \$12.03 collected.

The following officers were unanimously elected:

Recording Secretary—Miss Almira S. Parker.

Treasurer—Miss Virginia Semple.

Auditor—Miss Fanny Anderson.

Secretary Department I—Mrs. Ed. Morton.

Secretary Department II—Mrs. H. S. Fagin.

Secretary Department III—Mrs. Phil. Crutcher.

The report from the Box Committee showed that the three Christmas boxes sent were valued at \$108.55. This is the largest valuation the Juniors have ever had.

The Educational Secretary gave her report as follows:

“The report of the Educational Department for this year is necessarily short, as it is only an eight months year and included the summer vacation. We are planning a normal class with eight members to be held before Lent. The members of this class will lead classes in the various parishes during Lent on “The Call of the King.” Efforts are also being made

to form an inter-parochial class of girls, between 16 and 20, to study "Simon Peter, Rock," during Lent, which the Educational Secretary will lead."

One parish has already started the new Junior Plan as a model for the Diocese and we hope that the details of this plan will be so worked out by next fall that we can try it in every parish. In the meantime we would suggest that every church school have a mission study class for its teachers during Lent.

The President gave her message as follows:

"You have heard the reports and you must find much to encourage you that, in the stress of these times, we have gone forward. Our Christmas boxes were the best we have had. One new branch, at St. James', Pewee Valley has been formed. The Junior Plan has become a reality, and definite work among the young girls and boys will soon begin. This has been accomplished through prayer and faithfulness of the leaders. May God's blessings be upon each one of you. May we enter into this year of great opportunities with renewed trust and faith."

REPORT OF THE RECORDING SECRETARY.

The Junior Auxiliary has had only three regular Board meetings since the last Annual Meeting.

The first one was held in September, at St. Paul's Church. The most important thing at this meeting was the President's word of greeting to the new officers. She also spoke a few words on the work of the Auxiliary for the coming winter, urging more earnest prayers and that the work of the Church would not suffer on account of the many other calls upon our time.

The Educational Secretary's report at this meeting dealt entirely with the plans for the "New Junior Plan." A study class for church school teachers was discussed.

The date for our semi-annual meeting was decided upon and two new officers elected: Mrs. Ed. Morton as Secretary of the Little Helpers, and Mrs. Phil Crutcher as Secretary of Section III.

At the November meeting, the Christmas box was the important subject. This box having been packed a few days before, Mrs. Mockridge spoke of the lovely gifts in the two boxes sent from Louisville. A third box was being packed in Paducah from the branches outside of Louisville.

The Educational Secretary reported she would lead a normal class on "The Call of The King"; she also reported that the Board of Religious Education would co-operate in the work of the Juniors in any way possible.

Miss Edith Parker told of plans she had by which she hoped to increase the interest in the Church Periodical Club. It was decided at this meeting that we must always have a Lake Geneva scholarship, the means of raising this fund to come up later.

The third meeting, which should have been on January 14th, was postponed, on account of the weather, until January 18th. At this meeting Miss Robinson told of the work that had been begun at St. Andrew's, that is, the organizing of the church school along lines of the new "Junior Plan." Many questions were asked and Miss Robinson was asked to have typewritten copies of the way in which it was being worked out to be placed in the hands of each rector and superintendent. Mrs. Crutcher told of plans she and Mrs. Mockridge had discussed and were hoping to put into effect, that is some way in which we can interest and hold the older boys and girls. Their plan is a very excellent one and along the same lines that are meeting with great success in another Diocese.

Two boxes for 1918 were decided upon, one to the mountains of Kentucky and another to a mission in North Carolina.

The semi-annual meeting, or Junior Day, was held on November 23d. The gifts for the Christmas box (400 lovely ones) were on display. This was 200 more than the number asked for. Mr. Douglas opened the meeting and introduced Deaconess Hart, of China, who gave a most interesting address on her work in China. She read several letters from Chinese children which seemed to amuse and interest our children very much.
