## MINUTES OF THE ANNUAL MEETING.

---

The Annual Meeting of the Woman's Auxiliary took place Friday, January 23rd, beginning with a Corporate Communion in the Cathedral, at which the Bishop was the celebrant. His address bade us go forth in the new work with courage in our hearts, our work being witness of our strong purpose.

The business meeting followed immediately, convening in Dudley Memorial Hall and was opened by the Bishop, with the singing of Hymn 586 and proper prayers.

In his opening address he spoke of coming to Kentucky, a stranger in a strange land, saying that he had given us fifteen years, the best of his life and it was we who made it so; that there is no regret from us to him and that he was bound to us with unbreakable ties. In closing he called on the four charter members of the Auxiliary present to rise, as they had been members since February 26th, 1884, when the Diocesan Branch was organized.

He paid a most beautiful and loving tribute to our late beloved President, Mrs. Dudley, who had been President for so long, telling us that our great loss was her great gain.

He spoke of her beautiful life and of the many untold, quiet and unobtrusive gifts which had made so much happiness where help was so greatly needed. Was there a Clergyman in distress or a mission in need, when it was mentioned to her, it was found already done. Truly a worthy stewardess of what God had given her.

Resolutions of love and respect on the entering into Paradise of our President, were read by Miss L. L. Robinson as follows:

### RESOLUTIONS PASSED BY WOMAN'S AUXILIARY ON THE DEATH OF MRS. MARY E. A. DUDLEY.

It can but be with emotions of peculiar sadness that The Woman's Auxiliary of Kentucky would voice its sorrow in the sudden removal by death of its President, Mrs. Mary E. A. Dudley, who for nearly forty years has been its faithful, generous, and devoted head. Of all the many and varied lines of service to which her large heart and willing hand so freely responded, widely was it known that in the great missionary cause, in

general, and the Woman's Auxiliary in particular, was her interest unfalteringly centered. To her wide range of vision, truly the world was the field, and she knew no limits to that vision short of the Master's own, even "the uttermost parts of the earth." "Faithful unto death" may in very deed be said of her; likewise, in very truth we know that unto her has been given "the Crown of Life."

Conscious, therefore, of her unspeakable gain, even amid the tears of those who loved her, with united hearts we can say that:

Whereas it has pleased the Lord of the Harvest to call from the field of her earthly service this His faithful servant and our fellow-worker, be it

*Resolved:* That we sorrow only as they who share her own sure hope of unending Life, a glorious Resurrection, and the glad fruition of earthly service. That in looking back upon her life in this afterglow of its passing day, gladly we look to the sun-rise of a yet brighter morn. That seeking to follow her example in faith and devotion, we strive more earnestly to further the Cause she loved, and with her, in God's good time, share the abundant joys of His Harvest Home.

*Resolved*, furthermore, that a copy of these resolutions be sent, in loving sympathy to her household. Also that they be spread upon the Minutes of our Organization, and a copy sent to the Diocesan Paper for publication.

These were adopted by a rising vote and prayers by the Bishop.

Miss Robinson also read the following greeting:

"The Woman's Auxiliary assembled on this day of its Annual service, wishes to send to our beloved Bishop on this fifteenth anniversary of his work among us, our greetings, our warm love, our full confidence and our ever grateful appreciation of his faithful and untiring service. We can not put our message into words, we hope we may feel it instead. To this we would also add our loving appreciation, and our value of our dear fellow worker and leader, our dear Mrs. Woodcock.

It is our hope and prayer that God may richly bless both and spare them to a yet longer term of fellowship and service."

Adopted by a rising vote.

The Chairman of the Committee on Credentials read a list of branches which had paid their assessment to the Central Fund and were entitled to a vote.

Miss Winston, in her report as Second Vice President said she had presided at meetings when the President and Vice President were either ill or away, but that the Executive Committee had little progress to report and recommended that the new First Vice President should work to establish branches at Fulton, St. Thomas', Louisville, Trinity and Owensboro. She also stated that this is the first year in a long time that Kentucky had really paid her apportionment, as Mrs. Dudley had so often made up the deficit.

In her report of the Juniors, the Third Vice President, Miss Gilmer Robinson said that the Christmas boxes had amounted to \$115.00 and were sent, one to a colored mission in Georgia, one to Wind River, Wyoming, and one to a mission school in Cuba. She announced the appointment of Mrs. Joseph Burge, Jr. as the new Junior President, she herself having resigned.

The Annual Report of the Recording Secretary was read and with a slight correction approved.

In the report of the Corresponding Secretary, twenty-two branches were reported, a gain of one; though impossible to give an accurate number of members, there has been a gain of fifty-six; 189 notices have been sent, fifty-nine to the Clergy; twenty-four typewritten minutes sent out to branches in the Diocese; 190 reports sent out; total money given, \$4,907.14.

Mrs. Woodcock asked us to give Mrs. Adams a rising vote of thanks for a long and loving service to which Mrs. Adams replied that we all knew what the Auxiliary had meant to her, and that she hoped that the friends she had made during her service would always be her friends.

In the report of the Treasurer, which is printed in detail elsewhere in this Report, Mrs. Barret gave totals as follows:

Apportionment, \$950.62; Central Fund, \$88.59; American Church Institute for Negroes, \$682.39; For the Lenten Box Expenses, \$145.62.

The Treasurer then read a postal from Trinity Parish saying that their branch had been discontinued and asking that it be made known.

The following resolution was read and adopted:

*Resolved:* That unless other instructions are issued later by the Church Missions House, that all Auxiliary Funds for Diocesan Expenses for General Missions shall be sent by the Parish Auxiliary Treasurers to their respective parish treasurers with the request that the amount be sent promptly to the Diocesan Treasurer of the Woman's Auxiliary, with a memorandum stating to what fund the amount is to be credited.

The Auditors Report showed all accounts correct on examination and checking.

The Educational Secretary reported a normal class of ten, from which went out eight leaders, fourteen Mission Study Classes, one Interparochial class, one Girl's Friendly Class and one Boy's Class. She also announced the Lenten Program and Speakers.

The report of the Custodian of the United Thank Offering showed a total of the Offerings for the three years to be \$3,317.-78. Many blue boxes and letters and leaflets into the thousands sent out into the diocese.

We paused at this time for the Noonday Prayers.

During the taking of the Offertory the Secretary called the roll, sixty-nine were present.

Miss L. L. Robinson then made an appeal for the Chapel to be built at St. Hilda's School, Wuchang, China. Of the \$10,000.00 needed to build the Chapel, \$1,000.00 is yet to be raised, could not Kentucky raise this as a tribute to our own Miss Buchanan, who is serving there?

The Correspondent of the Church Periodical Club being ill, no report was heard.

The Chairman of the Correspondence branch reported Nation Wide Campaign Literature sent to fifty-seven names. It was decided to turn all moneys over to the United Thank Offering.

The new Constitution was then offered for consideration.

On motion several sections were referred back to the Committee for correction.

On motion of Mrs. Musson part of the Constitution relating to the election of officers was adopted.

Miss Winston asked that we spend a few minutes in prayer that we might be sure that it was God's will that we elect wisely.

Mrs. Maxon moved that each President appoint delegates in the place of those absent. This was carried.

We proceeded to the election of officers.

While the tellers were out, Mrs. Woodcock asked for volunteers to entertain delegates to the House of Church Women, and named Mrs. Adams chairman of the Hospitality Committee.

The tellers announced the election of Miss Winston as President.

We then adjourned for Luncheon.

#### MINUTES OF THE AFTERNOON SESSION.

Miss Winston's first official act as President was to offer at the luncheon table, a vote of thanks to the women of the Church of the Advent for their luncheon and charming hospitality.

After luncheon, on reassembling, the minutes of the morning session were read and with a slight correction, approved.

The Chairman of the Constitution Committee moved to rescind the action taken in the morning concerning the Constitution. Carried.

The Constitution as amended was then read and adopted.

While the tellers, Mrs. Homans, Miss Gilmer Robinson and Miss Anna McDowell were out, Mrs. Adams gave the report of the Lenten Work of 1919. Boxes were sent to St. Michael's, Wind River, Wyoming, and Penland, N. C., total value \$906.54.

Boxes for 1920 will go to Seluda, N. C., and Monterey, Tenn. Final report of the 1918 United Advent box to Mr. Rugge was \$408.25.

Letters were then read from the Missionaries to whom our United Boxes had been sent.

Mrs. Saunders, of the Correspondence Branch, read a letter from Mrs. David Johnson, Clinton, Ky., who lives sixteen miles away from the nearest Parish, expressing her willingness to co-operate with the work and sending a dollar for the Bishop's Letter.

Pledges for St. Hilda's, Wuchang, were received as follows: Advent, \$100.00; Calvary, \$100.00; St. Andrew's, \$200.00; St. Peter's, \$5.00; Emmanuel, \$5.00; Grace Church, Paducah, Tuesday Branch, \$5.00.

The following resolution was read and adopted:

*Resolved:* That prior to the next Annual Meeting all Auxiliary Branches who have the privilege of the vote by the payment of their fee to the Central Fund shall send a list of delegates and alternates (to the Annual Meeting) to the Diocesan Secretary.

The following notice was also read:

I have been requested by the Assistant Treasurer at the Church Missions House to ask for a list of pledges from each Auxiliary Branch to be sent by the Diocesan Treasurer to the Church Missions House as it will greatly assist in making proper credits. Please let me have all pledges as soon as possible, making your pledge to the Central Fund as large as possible, as there will be increased expenses and we would be glad to mark each annual meeting with the advancement of several branches into a higher class.

Mrs. Adams then read a letter of thanks from Mrs. Musson, thanking the Diocesan Branch for the beautiful cross of flowers and many expressions of sympathy.

The tellers reported the election as follows:

Mrs. Califf then took the chair, conducting the conference on the subject so close to our hearts.

In her introduction of the speakers Mrs. Califf said that a recent issue of the Spirit of Missions had stated that the Woman's Auxiliary had awakened more missionary spirit than any other agency. She bespoke our interest in these young women who were for the first time, to give us their point of view. All the speakers proved to us that our younger Auxiliary women are to be our "strong right arms" and that when we can no longer serve, our places will be capably filled. On motion of Mrs. Maury, the meeting gave the speakers a rising vote of thanks.

Afternoon roll call showed eighteen additional present, making the attendance of the day eighty-seven.

The offerings at the service and meeting were \$28.40, \$25 of which will be sent to the Foreign Clergyman's Life Insurance Fund, less than last year, owing to bad weather, which caused a poor attendance.

The total amount of all Auxiliary work done in the Diocese, (not including St. Andrew's John K. Mason Memorial and the Junior work) was \$5,088.75.

After the afternoon minutes had been read and approved the meeting adjourned.

## REPORT OF THE RECORDING SECRETARY.

Regular Quarterly meetings of the Diocesan Board of the Woman's Auxiliary in the Diocese of Kentucky were held in the Cathedral House on the second Thursdays of February and April. The dates of the October and December meetings were changed, the October date until after the Triennial; the December in order to hear the latest reports from the Church Missions House concerning Kentucky's payment of her apportionment. Each of these meetings was preceded by a Corporate Communion in the Cathedral; Miss Winston presiding at the February and April meeting; Mrs. Woodcock at the October and December meetings. The average attendance was twenty.

At the February Meeting letters were read from the Fourth and Fifth Vice Presidents signifying their willingness to organize any branch in their districts.

The Correspondence branch reported an increase of 163 names of isolated women, these names secured during Miss Winston's trip through Western Kentucky, in the interest of the Advent Call.

Two important committees were appointed, the "Auxiliary Extension Committee and the Committee to raise funds for the American Church Institute for Negroes, a Bishop Dudley Memorial; the work undertaken by these two committees to be the follow up of the Advent Call. Plans for the United Lenten box were discussed and the articles needed named.

Six United Lenten Meetings were held in the Parishes where the United Lenten Service were held, with an average attendance of 123. The total of the offerings amounted to \$91.61 and was given to the Lenten Box; United Offering; American Church Institute for Negroes; Apportionment; and the Summer Conference Scholarship.

The value of the Lenten Box was \$906.54 and was sent to the Mission for the Arapahoe Indians at Wind River, Wyoming and the Appalachian Industrial School, Penland, N. C.

Speakers at the Lenten Meetings were the Rev. Mr. Maxon, Miss Youngman, Mrs. Allen R. Hite, Mrs. Gazlay Hamilton,

Mrs. Musson and Mrs. Fletcher, of Paducah. At the meeting held in St. Andrew's Parish House, the children of the Church School gave the Mystery Play "The Little Pilgrims and the Book Beloved." At these meetings reports were heard from the Educational Secretary, (who for the first time reported a class of boys) from the Apportionment Committee and the Committee on the Fund for the American Church Institute for Negroes.

At the April Board Meeting Mrs. Fletcher, of Paducah, was with us, signifying her readiness to go to Fulton to organize a branch there whenever they wished her to come.

The Educational Secretary reported a Normal Class of ten; fourteen Lenten Study Classes with a total of 176 members.

At roll call each Parish President reported what her Parish had given to the Apportionment and all were urged by the representatives of the Committee to work to pay up Kentucky's Apportionment.

Miss L. L. Robinson announced that St. Andrew's Woman's Auxiliary had completed its \$1,000.00 Memorial to the late Rev. John K. Mason, the interest of this fund to be used for Missions out in the Diocese.

The Program for the Triennial at Detroit was read and a letter of thanks was voted to be sent to Miss Corey for her courtesy.

The United Offering Service, September 29th, St. Michael's and All Angels, was followed by a special called meeting of the Woman's Auxiliary. This was an open meeting with an attendance of fifty-seven, called to hear the report of the Offering. At this meeting the Correspondent of the Church Periodical Club stated that she had sent a Diocesan barrel of literature to Tennessee to be distributed and the Chairman of the Correspondence branch offered a motion to apply the funds of this branch to the United Offering.

Mention was made of the two great honors conferred upon our Second Vice President; that of being made representative of the Fourth Province on the National Committee of the Nation Wide Campaign and of leader of a Study Class during four days of the Convention.

The result of the United Offering was announced by the Custodian; \$3,127.43 being Kentucky's contribution to be laid

on the Triennial Almsbasin in Detroit. Besides this we have something far greater to offer, one life, that of Miss Edith T. Parker, who will enter St. Faith's to study next September.

After singing the Doxology, the Bishop gave us his blessing.

A Post Convention meeting was held in November, the delegates to the Convention being the speakers, giving us talks on "Joint Sessions," "United Offering Service and Mass Meetings" and "Classes and Business Conferences," Attendance of sixty-eight.

At the October Meeting, a letter of thanks from the Rev. Mr. Ruge, Dahlonega, Ga., to whom our last United Advent Box was sent, was read, telling us of the great good our box had wrought. This letter was later printed in the "Living Church."

Completed returns of the United Offering for Kentucky showed that the women of this Diocese had given the sum of \$3,317.78 to be used for the spread of the Kingdom of Christ throughout the world.

Miss Winston in giving the report of the Apportionment Committee, stated that \$2,000.00 was needed to complete the payment of Kentucky's Apportionment but that pledges had been made to pay in full.

The Board determined also to push the work of publishing Miss Robinson's lectures on the Old Testament, "The Birth of A Nation" as a token of appreciation of her many years service to Kentucky in the work of the Woman's Auxiliary.

Three United Advent Boxes were chosen, to be sent to Mission Schools, various parishes contributing to make each of these boxes well worth while. The Woman's Auxiliary was also asked to take over the publication of the Bishop's Letter, working up a larger circulation in the Diocese. Mrs. Woodcock was authorized to provide an Editor in chief, provided we assumed the responsibility of publishing it.

At this meeting Miss Winston gave a brief talk on the Nation Wide Campaign and pointed out to the women of the Auxiliary their part of the work.

At the December Meeting, the Treasurer's report showed that \$950.62 had been paid on the Apportionment by the Auxiliary, and that the final amount raised by the Committee

for the American Church Institute for Negroes was \$680.39.

The report of the Executive Board of the National Organization was read by Miss Winston describing the way the Box work had been reorganized along Red Cross Lines.

Plans for the United Lenten Work were discussed, two boxes were chosen, one to be sent to Seluda, N. C. and one to Monterey, Tenn., both Mission Schools.

*Resolved:* "That the Committee appointed to draft the Constitution be authorized to recommend to the Annual Meeting that the Executive powers of the Diocesan Board, be entrusted to an Executive Committee of Seven Officers and that the quarterly meetings be inspirational and educational for all members, especially Parish Officers."

This was adopted.

It was decided to assume Class B to finance the National Committees and to pay the Annual assessment of fifteen dollars to the Province.

Committees were named to arrange for the Annual Meeting and the Lenten Meetings.

We take pride in knowing that Kentucky is once more on the honor roll, feeling that this is largely due to our strenuous efforts to have Kentucky pay her Apportionment in full.

## REPORT OF CORRESPONDING SECRETARY.

Number of branches, twenty-two, a gain of one. The Norton-Mason branch of St. Stephen's having organized last March. It is almost impossible to give the accurate membership because, this year, only eleven of the branches stated the number of members, notwithstanding the question is asked on the Report Blanks. But, from those branches reporting, leaving the other eleven as reported last year, we have gained fifty-six members.

189 notices sent to Parish Presidents.

59 notices sent to the Clergy.

24 typewritten minutes sent out in the diocese.

190 reports sent out—these being Lenten lists.

Miss Lindley's Report and Annual Report Blanks.

From a financial standpoint the past year has been an unusually good one. Adding the Apportionment, United Offering, Central Fund, Lenten and Advent boxes, American Church Institute for Negroes, Diocesan, Domestic and Foreign Missions, the Church Periodical Club, two Scholarships and a small additional amount on the Advent Call, the sum totals \$4,907.14.

Received from Treasurer, \$10.00 for postage and stationery. The Woman's Auxiliary contributed \$1.52 in postage to the Nation Wide Campaign.

## REPORT OF THE JUNIOR AUXILIARY.

---

The Juniors here present their last report as a department of the Woman's Auxiliary, because the Convention in Detroit reorganized it as a Junior Auxiliary to the Board of Missions, or as it is now, to the Presiding Bishop and Council, so that it may more logically include boys.

Our work this year has been very encouraging.

The Board has met four times during the past year with an average attendance of five.

The usual Junior Day was given up because the time was filled with various meetings of the Nation Wide Campaign.

The Christmas boxes, valued at \$115.00 in all, were sent to a colored mission at Griffin, Georgia, one to Wind River, Wyoming and one to a mission school in Cuba. These boxes consisted of 700 presents.

During Lent, Mission Study classes were held in the respective parishes and proved most successful.

Last May a play, "Just Plain Peter" was presented at the Cathedral House, and the proceeds of this, together with the offering of one of the Woman's Auxiliary Lenten Meetings were used to pay half of the expenses of two delegates to Summer Conferences, one at Racine and one at Sewanee.

The delegate who went to Sewanee was from Henderson. As the result of giving her this scholarship, we succeeded in interesting six others, who also attended the Conference. These six became so enthused that they arranged an Educational Conference in Henderson in October, which had a wide-spread influence.

The branch at Hopkinsville has been revived under Miss Glass.

Owing to expected absence from the city, the President has resigned, and the Bishop has appointed Mrs. Joseph Burge, Jr. in her place.

Let me bespeak the same hearty cooperation and interest from the Auxiliary to the new President, as has always been accorded our presidents in the past.

The Junior Auxiliary is in a transition stage and it is

only through the prayers and help of those who are trying to extend the Kingdom of Jesus Christ, that the results of the mission work may be brought to our children.

Though we may now work as separate organizations, we have the same ideal—that of making Christ known throughout the world as Our Lord and Master.

#### REPORT OF THE EDUCATIONAL SECRETARY.

---

Early in the year a Normal Class was held at the Cathedral House, in a six weeks course on Bishop Burleson's book, "Our Church and Our Country," the text-book recommended by the Educational Department of the Board of Missions. From this class, numbering ten, eight went forth as leaders of parochial classes during Lent. Fourteen such classes were held in the various parishes, including one Inter-parochial class led by Miss Winston, one class of the Girl's Friendly Society of St. Andrew's Church, led by Miss L. L. Robinson, and a Boys' Class at St. Mark's Church, with a total enrollment of 176.

St. Mark's Branch again led in the number of parish classes, four having been conducted by leaders supplied by their own branch. They also sent a leader to St. James' Church, Pewee Valley.

Another class deserves special mention, as conducted by Mrs. H. L. Maury of the Church of the Advent, in the Church of Our Merciful Savior with appreciation on the part of the members and an interest most gratifying.

Three classes were reported from other parts of the diocese, Paducah, Hopkinsville and Hickman.

Other work along Educational lines has been accomplished, such as the Monday Morning Bible Class, under the leadership of Miss L. L. Robinson and from which all other educational work receives its inspiration.

In view of the many meetings held in connection with the Nation Wide Campaign and the work it entailed, the committee

thought it wise not to have a Normal Class, but to center all efforts on two inter-parochial classes to be held during Lent, one a Bible Study Class led by Miss Winston, and the other on "Neighbors," the text-book recommended by the Educational Department of the Board of Missions, led by Miss Almstedt. All wishing to enroll please send their names to the Educational Secretary.

The Educational Committee has also arranged a tentative program for the United Lenten Meetings of the Woman's Auxiliary. The dates of the various topics have not been definitely settled. The program as arranged is as follows:

This report would not be complete without mentioning the honor that was conferred upon the Woman's Auxiliary of Kentucky through one of its members, Miss Winston, who, at the invitation of the Educational Department of the Board of Missions, very successfully conducted a class on the "Nation-Wide Campaign" at the General Convention in Detroit.

As this was the first time the Auxiliary had met as a body since the recovery of our beloved Bishop Woodcock, Dean McCready had prayers of thanks for this blessing. The Dean also told the Bishop how grateful we were to have him back with us and what he meant to us. He spoke of our great regret that the illness of her daughter prevented Mrs. Woodcock from being with us. The Bishop, before his address, expressed his deep appreciation of our thought of Mrs. Woodcock and himself. He then gave us a splendid talk, full of help, commendation and cheer. The offering was the largest one we have ever had.

In 1916 we set as our goal for 1919, \$3,000.00, but after we received word from the Mission House that this was to be a

Victory Offering, the goal to be \$500,000.00, we determined to go over. We did. The offering was \$3,317.78.

As the Nation Wide Campaign was the first part of December and that meant the Treasurers were busy, the annual meeting was postponed until the 9th of January. A plan was made for bringing the Offering before the churches in March.

One new branch was formed during the year, the John Norton Mason Branch, St. Stephen's. This promises to be a very strong branch.

On account of illness, I had to cancel several engagements to speak about the offering, but I did so at St. Peter's and to the John Norton Mason Branch, St. Stephen's. I also brought back a report of all concerning the United Thank Offering to the Post-Convention meeting.

Many boxes, letters and leaflets were sent out to the various branches.

## BOXES.

Three Advent boxes were sent, one to the Rev. Alexander Mitchell and family, Charleston, S. C. The articles were contributed by St. Mark's to the value of \$50.00, Cathedral, \$60.00 and St. Paul's \$69.00. Total, \$179.00.

The second box went to Miss M. M. Proffe, Brown's Cove, Va. Four branches contributed, Advent, \$150.00; Calvary, \$55.00; the senior branch at St. Stephen's gave \$7.85 and the Norton-Mason Branch, \$7.00.

The third box was sent to the Rev. George Smith and family, Ponsford, Minn. St. Andrew's donated \$50.96, Emmanuel, \$15.00, Grace Church Branch, \$60.10. Total, \$126.06; making the three boxes \$524.91.

The Lenten boxes for 1919 were sent to St. Michael's Mission, Wind River, Wyo., and to the Appalachian Industrial School at Penland, N. C.

The total value of the two boxes was \$906.54. When the articles were apportioned the Wyoming box was valued at \$586.54 and the North Carolina box at \$320.00. With the exception of a check for \$19.76 the North Carolina box was all second hand clothing. Letters of appreciation were received and will be read. A more detailed report will be found in the Annual Report.

The boxes for 1920 will be sent to the Mission of the Transfiguration, Seluda, N. C. and Raphael Institute, Monterey, Tenn. You will hear something of these two stations at the first Lenten meeting.

You will remember that the box for the family of the Rev. Ferdinand Ruge was not completed until February of 1919.

Received since the last Annual Meeting from St. Mark's, \$17.00; total, February 1st, 1919, \$44.32; spent after February 1st, \$23.90, leaving \$20.32 which was given to the Treasurer for the Lenten Box.

Since the last report articles valued at \$101.85 have been sent. Cathedral barrel of second hand clothing, \$50.00; Cal-
