## FOREWORD FROM THE BISHOP

The Woman's Auxiliary in the Diocese of Kentucky has had, I believe, one of its very best years. The meetings held at the Cathedral last February; in Grace Church, Paducah, in May; and again at the Cathedral in October were exceedingly well attended and were indicative of a growing interest in the enterprise of the whole Church on the part of an increasing number of women in the Diocese. Perhaps the best meeting of all was the one which has just been concluded, the Annual Meeting for 1939.

It may be trite, but it needs to be repeated often, that there can be little life in the Church separate from a conscious loyalty and devotion to the Great Commission, "Go ye into all the world and make disciples of all nations". That the Diocese of Kentucky has not only continued its fine missionary tradition, but seems to be bringing it up to a higher level, is due in no small part to the splendid program in virtually every field which is being carried on by the Woman's Auxiliary in this Diocese.

I know of no way in which you can serve your Bishop, and therefore your Diocese, better than to enlarge the number of men and women and children who are aware of the fact that their baptism into the Church means also their membership in its missionary society. More correctly, it should be said that the Church is a Christian missionary society. When it ceases to be that it ceases to be Christian.

May God's blessing rest upon you and upon all of us who profess to be the disciples of Christ.

## MINUTES OF THE ANNUAL MEETING

---

The fifty-fifth Annual Meeting of the Woman's Auxiliary, Diocese of Kentucky, was held Tuesday, January 24, 1939, beginning with a Corporate Communion in Christ Church Cathedral at ten o'clock. Bishop Clingman was the Celebrant and was assisted by Dean Haines, Canon Clarke, and the Rev. Mr. Hunter. About 200 were present. The Bishop remembered at the altar those of our members, who, during the year, had been called to the Larger Life.

As the speaker, Dr. Arthur Sherman, could stay only until noon, the principal address of the day was given at this time. Dr. Sherman, of the Forward Movement Commission, and for many years a Missionary in China, gave a most masterly address on the subject of Christian Unity. He said there were two questions we must face—"What is the condition of the World," and "What is the Church ready to do about it?" The World, with its economic distress, industrial dislocation, social unrest, wars and fears of war, is struggling with a desperate hope to find a way out. Communism, Fascism, and many other experiments are failing and we must look to Christ as the only way to Peace.

Is the Church ready to meet the challenge? Until Christian people are willing to let God work through them with healing power, and until they conform their wills to His will, His great work of Redemption cannot be accomplished. Each individual follower of Christ must learn to live in closer comradeship with Him. Dr. Sherman said that it must be a great sorrow to our Lord to find His greatest foes in His own Household. The world cannot function effectively until men learn to put Christ at the center of their lives.

Dr. Sherman said that during the last decade a light of hope had appeared in the horizon. He spoke of the great strides toward unity among Christians which have been made in our day; and called to mind the world conferences at Edinburgh, Lausanne and Oxford, from the first of which, our own Bishop Brent caught the vision which resulted in the appointment of a Commission on Faith and Order. The thought coming from these conferences is the need of a united Christianity, if we hope to change the world. A united front will give the Christian Churches new power in our day.



Dr. Sherman said our own immediate concern was to study and confer together about the task of uniting the "Broken Body of Christ," to have discussion, but no controversy. He warned that pride is the great stumbling block to the fulfillment of our Lord's dream, "That His people may all be one."

The business meeting followed immediately, convening in Dudley Memorial Hall at twelve o'clock. Hymn 538 was sung. The president, Miss Winston, presided and opened the meeting with prayer. She said that we were running a half hour behind, but she was happy over the reason—the large number of communions made.

The Treasurer, Mrs. Renneberg, as Chairman of the Committee on Credentials, reported that all branches had paid their pledges to the Central Fund, and were entitled to vote.

The Secretary called the roll of officers and delegates, all officers answered roll-call, and all branches, with the exception of Grace Church, Hopkinsville, and Grace Church, Paducah were represented. A rising vote of welcome was given to the three delegates, representing the new branch at Trinity Church, Russellville. St. Paul's, Henderson, had four delegates present.

The President then read her address. In it she gave the watch word for the year, "Forward with Christ." She said that a study of parochial reports showed an increase in membership, in the value of Supply work, and Social Service Work. The theme chosen for 1939 is Christian Unity, about which the entire Christian World is thinking and praying. She urged us to take courage and go forward to do larger and better things for Christ and His Church, "strong in the strength which God supplies through His Eternal Son."

Mrs. Musson, as First Vice-President, said she had presided at three meetings in the absence of the President and had been present at all but one meeting.

As representative of the Woman's Auxiliary on the Executive Council, she said that she had attended all meetings of the Council and had contributed what she could to its deliberations.

The Second Vice-President, Mrs. Roy Morningstar, told of her visit to Christ Church, Elizabethtown, and asked that we give them all the encouragement possible. She also had written to Princeton where there are a few members of the



Church. She was present at the organization meeting of Trinity Church, Russellville, and reported a very enthusiastic membership.

The Secretary's report followed and showed twenty-two active branches with a total membership of 1,034, an increase of 150. The total value of the year's work amounted to \$7,559.27, an increase of nearly \$1,000.00.

Mrs. Renneberg, the Treasurer, announced that copies of her detailed report had been distributed. She gave the receipts from all sources, \$2,499.39. Balance in the Central Fund \$268.58. She urged that we strive to "pray fervently, labor diligently and give liberally to make Christ known." Her books had been examined by Mr. H. S. Fagin and were correct.

A motion carried to send a note of thanks to Mr. Fagin for his services.

Mrs. Renneberg called for pledges to the Church's Program and the Central Fund, resulting in \$1,499.50 being pledged to the Church's Program and \$182.00 to the Central Fund.

At this time the President interrupted the program to introduce Mrs. J. M. Wilson, one of our own missionaries, at home from China, on an emergency furlough. In a few intimate word pictures Mrs. Wilson described conditions in China. She said that the last year had been a practical demonstration, that Christians are different, and that those who had stood up through the terrible conditions of the past year were Christians. She closed with a story of a Japanese officer, a Christian, who had protected Chinese women from his own men.

Mrs. Edw. Wilder, Jr., then gave her report as Supply Secretary. Boxes during Lent were sent to Holy Cross Mission, Bontoc, P. I., Mission of the Good Shepherd, Splashedam, Va., and the Bishop Randall Hospital, Lander, Wyoming; total value \$790.00. In Advent, the new policy of sending cash rather than clothing to the Missionaries, was adopted and greatly appreciated by the recipients, the Rev. Norman C. Duncan, Asheville, N. C., and the Rev. James Opie, in Idaho. Cash was also sent for a suit of underwear for Catechist Antoine Zephier in South Dakota, and Christmas boxes to foreign women missionaries. Total value, \$285.00 making the total for the year \$1,075.00.



She said she had received very appreciative letters from the Rev. Messrs. Duncan and Opie. She announced that the Lenten boxes would go to Epiphany Mission, Sherwood, Tenn., St. Andrew's School, Puerto Rico and St. Luke's Hospital, Shanghai, China.

The report of the United Thank Offering Treasurer, Mrs. Richard Almstedt, followed. Her report showed the Ascension Day offering to have been \$1,140.71 from 772 givers, and the All Saint's Day offering to have been \$1,354.56 from 987 givers. Total for year—\$2,495.27.

Adjournment for luncheon followed.

---

### Afternoon Session

The afternoon session of the Annual Meeting reassembled in Dudley Memorial Hall at two o'clock. After the singing of Hymn 468, Miss Winston opened the meeting with prayer. The minutes of the morning meeting were read and approved.

Miss Winston announced that the offering for the day would be given towards a fund for a rectory in Owensboro, where a new rector will soon be called.

The Educational Secretary, Mrs. Merrill Russell, in her report called attention to the fact that the name "Department of Religious Education" had been changed to "Department of Christian Education," and to the statement of the Presiding Bishop, Dr. Tucker, that the Church must stress the Christian idea, that God's purpose is to take the Kingdoms of this world and transform them into the Kingdom of God. She said that the co-operation had been splendid and that nearly every Branch now has an Educational Secretary, and that, although few branches have gotten down to real study, most do listen to a talk presented in a pleasing manner. She gave a resume of the year's meetings and the speakers. She said ten from the Diocese had attended the Adult Division of the Sewanee Summer Conference, and one delegate had attended the International Convention on Christian Education. She said that the Speakers Bureau had been of great service and gave a list of those still available.

Mrs. Alex Galt Robinson, director of the Church Periodical Club, said that her report was compiled from the reports of 18 branch secretaries, and that of her own. 98



periodicals were sent regularly through the mail. Bibles, Prayer Books, religious and secular books, magazines, scrap-books, cards, etc. were distributed in large numbers to thirty-four institutions in the Diocese, and seven outside of the Diocese. She announced the opening of a Circulating Library, the "Lizzie Robinson Memorial Library" at Grahamton, in the spring. \$50.00 was contributed to the Endowment Birthday Fund; and \$87.46 to the Library Fund.

Miss Parker, Christian Social Relations Secretary, said that the work had grown and covered a wider field. Work was being done at city and county institutions and was much appreciated. Thanksgiving and Christmas baskets were provided and families given assistance. Sewing for Red Cross, City Hospital, and Norton Infirmary, and visiting and survey work done on the Point was included in the report. Valuation of the work done was \$219.80 and \$533.00 was given in cash.

Mrs. C. V. Williams reported for the Leper Work. Total given for the year, \$137.65. She said that all contributions hereafter will be sent to St. Timothy's Hospital (Epis.) Cape Mount, Liberia. She said the ladies of the Church Home were contributing the sum of \$18.00 for the building of a cottage at Cape Mount to be called "The Church Home Cottage."

Mrs. Chas. E. Craik, Jr. presented an excellent report of the meeting of the 16th Synod of Sewanee held at Winston-Salem. She said the entire program was one of exceptional quality. The Presiding Bishop's address at the opening service struck the key-note of the Synod. He said that Christian America is like a city built upon a hill and that today, individuals must exemplify Christ in their lives, if the power of Christianity is not to become a spent force. She said the whole program was a rich harvest culled from Bishops, Clergy and laity, both men and women. Of these she chose three addresses for a few high spots. First, the report of Mrs. Fred Ramsey, Provincial President, to the joint session which contained a forceful and impressive presentation of practical truths and dealt with the part that women should take in the work of the church. She asked that women be given the privilege of serving side by side with the men, in the building of Christian faith. Second, that of the Rt. Rev. E. P. Dandridge, Bishop Co-adjutor of Tennessee who spoke on Church Unity and the Forward Movement. He said that in the ability to hold together as one household, lies the greatness of the future; and that



practical Christianity consists of worshipping God instead of one's self, loving people you don't like, and doing cheerfully things you don't want to do. Third, the address of the new Vice-Chancellor of the University of Sewanee, Dr. Alexander Guerry, who outlined the aims of the institution he has come to guide. Before adjournment, Mrs. Craik said a beautiful tribute was paid to the late Gardiner L. Tucker, in whom the true Sewanee spirit was so eminently manifest.

Mrs. Wm. H. Langley, new Diocesan President of the Girl's Friendly Society, told of the plans for a closer co-operation between the Girl's Friendly Society and the Woman's Auxiliary. She announced the coming to the Diocese of Miss Margaret Jefferson, a Field Secretary of the National Girl's Friendly Society.

Miss Winston announced that a meeting of the Diocesan Board of the Woman's Auxiliary will be held Thursday, February 2, at which time Miss Jefferson will be the speaker. She asked each President to bring one other member with her to this meeting.

She also said that an adjourned Annual Meeting will be held April 25th, in the Cathedral House, with The Rev. Charles W. Welch, Litt. D., Moderator of the Presbyterian Church, U. S. A., as the speaker.

Mrs. H. L. Maury, chairman of the Constitution Committee now presented the Constitution, as amended by the Executive and Diocesan Boards, to the Annual Meeting for Adoption.

At 3:45 the President interrupted the proceedings for the meditation on Christian Unity, by the Rev. J. Wilson Hunter, Rector of St. Andrew's Church. Mr. Hunter read from the 12th Chapter of 1st Corinthians. He said that the Churches must come to consider their differences and combine them, making of them, joints of strength. As soon as Christians realize their need of each other, they will work for unity and it will soon come. The world is increasing in every form of unity and cannot understand a divided effort. Forces of evil are becoming more and more threatening and only a unified Christianity can be of any avail against them. He closed with the prayer that the Church being made one again may draw all nations into unity.

After taking the offering which amounted to \$71.26, the adoption of the Constitution was completed.



Motion carried that the Constitution Committee be given power to edit it, and that it be printed in the year book.

The resolution from the Executive Board regarding the discontinuance of the United Lenten Meetings was adopted.

After the benediction by the Bishop, the meeting adjourned.

## ADDRESS OF THE PRESIDENT

---

Women of the Auxiliary:

A year ago I asked you to look forward to the opportunities that lay before us rather than back at what we had done or left undone. Again our watchword shall be "FORWARD"—forward with Christ into this troubled world and yet it seems only fair to tell you that we have gone forward in 1938. A study of parochial reports shows that our membership has grown, our Supply Work has increased one third, more women are giving to the United Thank Offering, our Social Service Work is much larger, and I believe, more efficient and our educational work is on a better basis than ever before. I also urged you to assume a fair share of the increase that the Diocese had undertaken for the National Council. You have done that splendidly. I believe we have a right to be grateful for this growth. As president I most assuredly thank you for the splendid response you have made in your loyalty to the cause and to your Executive Board. Today you will again be asked to make pledges to the Church's Program and to the Central Fund. I trust that whenever it is possible these pledges will be increased over those for 1938 for Bishop Clingman is trying very hard to have Kentucky bear its share of the missionary work both within our own Diocese and throughout the world. The need for increasing the Central Fund will be apparent when we tell you that for several years we have spent more from that fund than we have collected for it. Our balance here will soon be eaten up if we do not pay enough to equal our disbursements.

We have chosen as our theme for 1939 that about which the entire Christian world is thinking and praying today—CHRISTIAN UNITY. Your Bishop and Executive Board gave much time and thought to securing the best possible presentation of this subject for our meeting today. Let us not only learn about Christian Unity and pray earnestly for it but let us really practice it in our own Parishes, in our Diocese and Church as well as with our fellow Christians of other names. I know of no better place for us to begin than right here today when we will discuss and later adopt our new Constitution, about which there are grave differences of opinion. This has been before our membership for a year and while we hope that each one will feel free to express her opinion on any section, we do trust that all will



be done in true Christian charity, always remembering that however much we may differ, we all have the good of the Church at heart. We have asked for the guidance of God's Holy Spirit. Let us believe that we have such guidance, not hesitating to state what we think is right but always willing to listen to the other side and finally to adopt the rule of the majority with good grace. Then when this Constitution is adopted and becomes the rule under which we will work, I ask each one to support it loyally until such time as it may be wise to revise it or make further changes. This may seem to some a small phase of Christian unity to stress at such length, but sometimes it is the small things that are most difficult of accomplishment.

Branching out into the larger field, let us avail ourselves of every opportunity to learn more about what is being done to bring about a better understanding among Christians of various names. It seems to me that there are two reasons, among many others, which should impel all Christians to concern themselves with this great movement which is making such strides in our day—first, our Lord's own high-priestly prayer "that they may all be one—that the world may believe that thou hast sent me" and secondly, it is only as Christians present a united front to the world that we can make any great impress upon the forces of evil abroad today.

I commend you for what you have done in the past and bid you thank God, take courage and go forward to do larger and better things for Christ and His Church in the years that lie ahead, "strong in the strength which God supplies through His eternal Son" . . . Jesus Himself tells us, "Without me ye can do nothing" but "with God all things are possible."

### REPORT OF THE SECRETARY

The Executive Board of the Woman's Auxiliary during the past year has held four meetings in the Cathedral House, each preceded by a Corporate Communion. Miss Winston presided at all of them.

At the meeting held on December first the following motion was unanimously adopted: "The Executive Board recommends to the Annual Meeting that the Friday Lenten Meetings be discontinued, because of the increased number of parochial meetings made necessary by the Unit Plan of organization."

On March tenth, The Diocesan Board met with the Constitution Committee in an all day session for the consideration of the new Constitution. Bishop Clingman was present for part of the morning. The Constitution as amended by the Executive and Diocesan Boards is to be presented to the Annual Meeting for adoption.



Five United Lenten Meetings were held with an average attendance of fifty. In the absence of the President, Mrs. H. S. Musson, First Vice-President, presided at two of them. The total offerings amounted to \$103.01.

The Semi-Annual Meeting was held on Oct. 17 in the Cathedral House. The Rev. Hector M. Thompson, missionary to the Arapahoe Indians in the Missionary District of Wyoming, was the speaker. There were 125 present and the offering of \$35.13 was given to Chinese Relief Fund.

The adjourned Annual Meeting was held Tuesday, May 17, in Grace Church, Paducah, at the time of the Diocesan Convention. 125 attended, with representatives from Bowling Green, Hopkinsville, Henderson, Hickman, Fulton, Louisville and Wickliffe. Mrs. Harold Woodward of St. Louis, spoke on the "Challenge of Today for the Women of the Church."

Armistice Day, Nov. 11, was observed in the various Parishes and Missions as a Day of Intercession for Peace.

Four accredited delegates attended the Provincial Meeting held in Winston-Salem.

## ANNUAL REPORT OF THE EDUCATIONAL SEC'Y

---

First let me tell you that the name has been changed from Religious Education to Christian Education. Now Dr. McGregor is chairman of the Department of Christian Education.

The Presiding Bishop, the Right Rev. H. St. George Tucker, in opening the meeting of the National Council in December, reminded the Council of the spiritual leadership it is expected to give. "People get impatient" he said, "when the Church gives all its attention to matters of money and business, unless in it there is the Christian idea that God's purpose is to take the Kingdoms of this world and transform them into the Kingdom of God."

It was in keeping with this statement that the name Department of Religious Education was changed to "Department of Christian Education." In looking forward to our work for the coming year, may we prove worthy of our name.

In making any annual report, we always do two things, look back over the past year, see how far short of the goal we have fallen, then looking forward to the next year try to see where we can rectify these mistakes.

In looking back over the past year, it makes one very humble to realize how little was accomplished in the face of such opportunity. Though we have fallen far short of what we wanted to accomplish, there is much that is gratifying. In looking over the Diocese as a whole, the co-operation has been splendid. Nearly every Branch now has an Educational Secretary and I hope from now on they will be called Secretaries of Christian Education. Though few of our parishes have gotten down to real study, most of us are polite and will listen either when a book is interestingly reviewed or facts which some one else has worked over, are presented in a pleasing manner.

As a matter of record I want to enumerate some specific things that have been done in the past year to further Christian Education:

At the 54th annual meeting of the Woman's Auxiliary Mrs. Harper Sibley of Rochester, N. Y. was the principal speaker the subject was, "The Church Moves Forward Into a New Day." She said that the Church was today faced with



opportunities greater than ever before, but the question is "Are we ready to take part?"

"My first premise is," she said, "that when women think at all, they are the most progressive element in the world. Up to the present time women have had nothing to do with the status quo, either ecclesiastical, political, social or economic. Their chief occupation has been in bringing the next generation into the world. They face the future always, and work for its improvement for their children. Their concern is with individuals and individual development." Her great plea was for a United Christendom which could only be accomplished by working together, studying together and worshipping together.

The Woman's Auxiliary co-operated with the Churchwomen's Federation in the World Day of Prayer the first Friday in Lent. On successive Fridays the United Lenten meetings were held in the Cathedral House. The speakers were: The Rev. Chas. W. Sheerin, Rev. B. W. Hummel, Rev. J. T. Schieffelin and Mrs. Elwood L. Haines. At one of these meetings the Auxiliary had a shower, not of cold water, but of materials and equipment to be used in Daily Vacation Bible Schools.

The 110th Annual Convention of the Diocese met in Paducah, May 17th and 18th. The Diocesan Board made a visit to Henderson enroute to Paducah. A meeting was held in the Parish House of St. Paul's Church Monday evening, May 16th. Short talks were made by the Louisville visitors, followed by informal discussion of the work of the Auxiliary.

At the meeting in Paducah on the following day, Mrs. Harold Woodward of St. Louis, member of the National Executive Board spoke on "The Challenge of Today For The Women of the Church."

In every possible way the Woman's Auxiliary has tried to co-operate with the Clingman Conference for young people at K. M. I. June 10th, 11th and 12th, and with Camp Woodcock June 16th-25th at the Boy Scout Camp.

One delegate from the Diocesan Department of Religious Education, Mrs. Wm. G. Birchett, attended the International Convention on Christian Education held the last week in June in Columbus, Ohio.

At the Sewanee Conference, Adult Division, there were ten from the Diocese of Kentucky. The Woman's Auxiliary awarded two scholarships.



At the meeting of the Churchwomen's Federation held September 30th in the Fourth Avenue Presbyterian Church our Auxiliary furnished not only a goodly part of the audience, but of the speakers as well.

At the Provincial Synod, held in Winston-Salem, North Carolina, there were four delegates and two visitors from the Diocese of Kentucky.

At the Semi-Annual meeting October 17th, held in the Cathedral House, the Rev. Hector M. Thompson of St. Michael's Mission, Ethete, Wyoming, took the audience on a most interesting journey through his mission at Laramie and Ethete, made very real by splendid pictures made by the son of the late Bishop Burleson for the Society of Visual Religious Education. He gave a most graphic description of his work among the Arapahoe and Shoshone Indians.

With many of our parishes using the Unit Plan, our Speakers Bureau has been of great service.

---

This is one line of work that it is hard to report on for so much is done that can't be given in words or money. Personal contact with the less fortunate means so much. I have heard a great deal of the pleasure and cheer given men and women at the Home of the Aged and Infirm. Some twelve or more women have as many names to whom they send cards and small gifts on special occasions. In Bowling Green the Episcopal Church has one month when they visit the County Farm, other denominations each taking a month.

Here in Louisville several families have been given assistance and are now able to go it alone.

Much visiting and survey work has been done on the Point and in neighborhood of the Cathedral.

Sewing has been done for Norton Infirmary, Goodwill, and City Hospital, also clothing sent to latter place. Sewing and knitting and cash sent to the Red Cross.

Thanksgiving and Christmas baskets were distributed, trees decorated at City Hospital and Sunshine bags made.

The valuation of the work done amounts to \$219.80, and \$533.00 was given in cash.

I feel progress has been made along this line and more parishes are co-operating and the field of work has been broadened.

In Louisville, to the Home for the Aged and Infirm, Orphanage of Good Shepherd (now called Woodcock Hall), Family Service, Goodwill Industries, Susan Speed Davis Home, Ormsby Village, Workhouse, Church Home, Home of the Incurables, Cook Benevolent Institute, Church by Mail, Old Folks Home, the Norton Infirmary, City Hospital, Marine Hospital, Red Cross Hospital, Colored Department of Waverly Hills, Hazelwood. In the vicinity of Louisville, Fort Knox Hospital, Lakeland, County Farm at Jefferson-town, Pewee Valley Sanitarium, Woman's Prison, at Henderson and Vacinity County Home, Nursery School and N. Y. A. Center; at Hopkinsville Western State Mental Hospital, Chapel of Good Shepherd; at Paducah, Friendly, Friendly Home and Day Nursery; at Bowling Breen, City Hospital, City Welfare Home, County Jail and County Poor Farm, also worthy family, children and friends.

Outside the Diocese magazines and books, etc., were sent to Molly Starks Sanitarium in Ohio, Salvation Army and Goodwill in Ohio, to Deaconess Bedell in Florida, Miss Lillie Hill, Leakville, N. # **CONSTITUTION AND BY-LAWS**

## **WOMAN'S AUXILIARY, DIOCESE OF KENTUCKY**

---

### **CONSTITUTION**

---

#### **ARTICLE I**

##### **Name**

The name of this organization shall be the Woman's Auxiliary to the National Council of the Protestant Episcopal Church in the Diocese of Kentucky.

#### **ARTICLE II**

##### **Object**

The object of this organization shall be to enlist all the women and girls of the Church in order to carry forward the Missionary, Christian Education and Christian Social Relations work of the Church in the Home, Parish, Community, Diocese, Nation and World through Prayer, Study, Work and Gifts.

#### **ARTICLE III**

##### **Membership**

Section 1. Any woman or girl willing to further the object of this organization may be a member.

Section 2. The members of a parish or mission, together with any other co-operating women, shall constitute a Branch.

Section 3. Any group of women approved by the Bishop may co-operate in the work of this organization.

Section 4. Each Branch co-operating shall make an annual report to the Secretary on a blank provided by her.

#### **ARTICLE IV**

##### **Officers and Elections**

Section 1. The Officers of this organization shall be a President, two Vice Presidents, a Secretary, a Treasurer, a Supply Secretary, a Christian Education Secretary, a Treasurer of the United Thank Offering and a Christian Social Relations Secretary.

Section 2. Officers shall be communicants of the Church.

Section 3. These Officers shall be elected at the Annual Meeting preceding the Triennial, for a term of three years and no officer shall serve a consecutive term in the same office.

Section 4. Names for all offices and for five delegates and five alternates to the Triennial shall be presented by the Committee on Nominations at the Annual Meeting preceding the Triennial. Names of four delegates and four alternates to the Provincial Meeting shall



be presented at each of the other Annual Meetings, the President or her appointee being the first delegate in accord with the Provincial By-Laws.

Section 5. Three names for the representative of the Woman's Auxiliary on the Executive Council shall be nominated by the Executive Board and presented at the Annual Meeting preceding the Triennial by the Committee on Nominations. She shall become an ex-officio member of the Executive Board. This representative shall not serve a consecutive term.

Section 6. Voting shall be by ballot. If there is no majority on the first ballot, all names shall be dropped but the three having the largest number of votes. No vote shall be cast by proxy.

Section 7. No officer shall have a separate vote.

## ARTICLE V

### Meetings and Representation

Section 1. There shall be an Annual Meeting and a Semi-Annual Meeting, the time and place of each to be determined by the Executive Board.

Section 2. Special meetings may be called at the discretion of the President or by her upon the request of any three Branches.

Section 3. One-fifth of the Branches shall constitute a quorum.

Section 4. Each Branch shall be represented by three delegates (or their alternates) whose names have been sent to the Secretary prior to the Annual Meeting. Each Branch shall be entitled to one vote.

## ARTICLE VI

This Constitution may be amended at any Annual Meeting by a majority vote provided due notice of such amendment or amendments has been given in writing to every Branch in the Diocese at least two months prior to the Annual Meeting.

---

## BY-LAWS

---

### ARTICLE I

#### Duties of Executive Board

Section 1. The Executive Board shall consist of the Officers, the representative of the Woman's Auxiliary on the Executive Council, the Diocesan President of the Girls' Friendly Society and the Librarian of the Church Periodical Club, who is appointed by the Bishop.

It shall be entrusted with the general direction of the work and present to the Auxiliary plans of the National Board of the Woman's Auxiliary. It shall be fully authorized to act for the organization and shall fill any vacancy in its membership.



## ARTICLE II

### Duties of Officers

The President shall have general supervision of the work throughout the Diocese; shall preside at all meetings and appoint all chairmen of Committees. She shall be an ex-officio member of all committees.

The First Vice President shall have supervision of the formation of new Branches. She shall preside at meetings in the absence of, or at the request of the President.

The Second Vice President shall have supervision of the work in the Paducah Convocation, shall stimulate the activities of the Branches and preside at all Convocational meetings therein.

The Secretary shall keep a record of the proceedings of all meetings of the organization and of the Executive Board; issue notice of all meetings and conduct the correspondence; keep a record of the Officers of the Branches and prepare the Annual Year Book. In the absence of the President and Vice Presidents she shall call the meeting to order and preside until a temporary Chairman is elected.

The Treasurer shall receive all monies (except the United Thank Offering) and shall deposit same in the name of the Woman's Auxiliary in such bank as she may choose with the approval of the Executive Board; keep an account of all receipts and disbursements; prepare a tentative budget in consultation with the Executive Board and make a report at each meeting. She shall be bonded and her accounts audited.

The Christian Education Secretary shall have the general direction of the educational work of the Auxiliary and try to stimulate interest in mission study in each Branch. She shall be responsible for monthly articles in the Bishop's Letter and she shall co-operate with the Educational Secretary of the National Board of the Woman's Auxiliary.

It shall be the duty of the Treasurer of the United Thank Offering to increase knowledge and deepen interest in the same so that every woman in the Diocese may participate therein; supply and distribute Blue Boxes; provide appropriate literature and in every way possible bring its purpose to the attention of all Church women. She shall keep a list of all offerings; deposit same in a bank chosen by herself and the Executive Board; conduct a yearly conference of Branch United Thank Offering Treasurers and notify them of the proper dates for presentation of the offering. The offering shall be taken twice a year.

The Supply Secretary shall have charge of the Supply Work; receive allotments from the National Supply Secretary and re-allot same to the Branches.

It shall be the duty of the Christian Social Relations Secretary to plan a suggested program for the Diocesan Auxiliary and the Branches; to co-operate with the Department of Christian Social Relations of the Executive Council of the Diocese; to arouse interest in Diocesan Institutions and to co-operate with community social service agencies.

All officers shall present a brief report in writing at the Annual Meeting.



### ARTICLE III

#### Boards

Section 1. The Executive Board shall meet the second Thursday in January, May, October and December.

Five members shall constitute a quorum.

Section 2. The Diocesan Officers and the President of each Branch shall constitute a Diocesan Board which shall meet the second Thursday in February and November.

Ten members shall constitute a quorum.

Section 3. Special meetings of either of these Boards may be called at the discretion of the President or by her upon the request of any three members. The date of a regular meeting may be changed.

### ARTICLE IV

#### Standing Committees

Section 1. There shall be a Committee on Nominations composed of a Chairman and two other members, appointed by the President.

It shall be the duty of this Committee to present two or more names for each office and names for delegates and alternates to the Triennial and to the Provincial meetings.

Nominating blanks shall be sent out by this Committee to every Branch at least two months prior to the Annual Meeting, and the Committee shall meet at least one month before the consideration of the submitted names.

Section 2. Each Branch is requested to send a list of its outstanding women eligible for office to this Committee by December 1st.

Section 3. There shall be a Constitution Committee whose duty it is to receive proposed amendments; to write or amend the Constitution and By-Laws, presenting them for consideration to the Executive Board before adoption.

### ARTICLE V

#### Finance

Section 1. The running expenses of the organization shall be met by the annual payment by each Parish and Mission Branch, of the sum assigned to the class that any Branch decides to enter, the expectation being on a sliding scale: CLASS "A," \$50.00; CLASS "B," \$25.00; CLASS "C," \$15.00; CLASS "D," \$10.00; CLASS "E," \$5.00; CLASS "F," \$2.50; CLASS "G," \$1.00. The amounts contributed shall form the Central Fund, out of which shall be paid all the running expenses of the organization.

Section 2. The vote of each Branch at the Annual Meeting shall be contingent upon the payment of this sum.

### ARTICLE VI

#### Fiscal Year

The fiscal year shall be from January 1 to December 31.

### ARTICLE VII

These By-Laws may be amended at any Diocesan Meeting provided the proposed amendment or amendments have been submitted in writing at a previous meeting.
