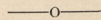

## FOURTEENTH ANNUAL REPORT.

---

For the first time in the history of this Association our anniversary is held amidst new scenes and surroundings. For thirteen years the life of the Association was nourished and housed by dear St. Peter's. Hospitality was given without grudging, not only year by year as we met to celebrate the bright anniversaries, but month by month as we gathered to transact the business of the Association steadily growing in volume and importance. Whatever changes as to place of meeting, time and this increased volume of work may necessitate, we can never forget that the Association had its germ in the parish of St. Peter's and was so fostered there by the active interest of its earnest workers as to ensure its stability and permanence. The necessary change was made with sincere regret; but since the necessity was felt, let us hope to continue our growth and prosperity under the cordial hospitality we now enjoy. Our warmest thanks are due to the Rector of St. John's for his generous offer of the Chantry for our monthly meetings and of the Church for special occasions.

The year that has passed since the last bright anniversary has been marked by few changes. Year by year the work grows, but by such slow degrees as develops first the bud and then the flower. We can recall with pleasure the out-stretched hand of helpfulness to many, not only in our own land, but to those in the islands of the sea and in regions beyond the sea. The "Holy Catholic Church" has a very real meaning in the light of this daily endeavor.

The Diocesan work shows the most marked change in the completion and occupation of the beautiful memorial house of St. Phebe's Mission. This child of the Association is rapidly approaching maturity and self-dependence. The work has grown so amazingly that the reports necessary for a proper understanding of the needs and demands of the Mission can hardly be compressed within the limited time allowed at our monthly meetings. The Italian Mission has received some, but far from adequate help. It



is to be hoped that during the coming year its claims will be more fully recognized. As was urged a year ago, the provision for the personal needs of the missionary is certainly obligatory on this Association of church-women banded together for missionary work. The remainder of the Diocesan work has not been forgotten. Aside from the institutions assisted, many homes have been brightened by skilful fingers and loving thought, and several gifts bestowed to aid in the fuller and more harmonious rendering of the services of the Church. One parish reports the generous gift of \$400 to a feeble mission within the city limits,—a sum secured by the unassisted efforts of the women of the parish.

A review of our Domestic work affords great encouragement. We have sent aid to schools and chapels, homes and hospitals. By the zeal of a special committee the sum of \$212.06 was raised for Bishop Elliott's school for girls. In aiding this branch of missionary effort we hope to see happy results in the efficiency of the Church workers of the future. The training of the young is the most hopeful way of obtaining future strength in the Church. Touching appeals were made on behalf of the destitute and ignorant in Eastern Tennessee, but too late for anything to be accomplished. Let us hope that they will be remembered during the coming year.

Our Indian brethren have been remembered and the sum of \$80 raised for Bishop Hare's school work. In consideration of the Bishop's protracted ill health owing to the faithful discharge of his duties, great pleasure was felt in the work of this special committee. Response was made to the earnest appeal of a layman for assistance at the Mission at Shoshone. St. Ann's sent her usual liberal box to Hope School, Dakota. St. John's School, Fort Bennet, received boxes from several parishes.

By subscriptions of small sums the salary of a teacher among the Freedmen was raised, and in accordance with the wishes of the General Secretary of the Board of Missions the disposal of it was left to the Board. Assistance was given to the work in Virginia, Alabama, Georgia, Tennessee and Florida. As rapidly as this work is developed in the different Dioceses so rapidly is assistance given. Another exemplification of the saying "The Lord helps those who help themselves."

In the Foreign department, Japan, China, Africa and Mexico have been assisted. Here again the special committees have done



good work, proving the advantage of that method. St. John's Hospital, Tokio, received \$100; and the Mission work in Mexico, \$50. It is certainly earnestly to be desired that this latter mission shall be placed on a more satisfactory footing. Since our work is Auxiliary to that of the Board of Missions, it would seem wisest for the Board to take the initiative.

The claims of the General Fund of the Board of Missions should also be brought into prominence. As the Board is the chosen representative of the Church at large, so its action is in reality that of the Church, and should be sustained. And as we claim no independent existence, but are merely one branch of the large body "Auxiliary to the Board of Missions," so is it our plain duty to provide for its appropriations by the annual payment of a certain proportion of our receipts.

As a summary of our year's work, we would report eighty-six boxes valued at \$3,101.69 and cash amounting to \$55.25, for Diocesan work. Forty-eight boxes valued at \$4,250.99 and cash \$285.92, for Domestic. Four boxes valued at \$371.82 and cash \$150, for Indian. Nineteen boxes valued at \$752.35 and cash \$86, for Freedmen, and two boxes valued at \$50 and cash amounting to \$422.03, for Foreign work. A total of 169 boxes valued at \$8,466.85 and cash amounting to \$1,145.01.

What shall we propose for our work for the coming year? First, let us foster the work already opened in our own City and Diocese, and be ready to improve the opportunities for new work, which are constantly presenting themselves. Second, let us be earnest in endeavoring to shed light upon the dark places of this great country, whether by the payment of missionary stipends, teachers' salaries, or the endowment and sustenance of scholarships. Third, the care of the sick and education of the young in this and foreign lands. And last in the words of our Reverend Father in God spoken at our first anniversary, let us "pledge ourselves before the Altar that our hands shall not rest nor our eyelids slumber, until we have striven, as we have not, to bring the Kingdoms of this world into subjection to the Kingdom of our Lord and His Christ."

# REPORT.

(*Abridged.*)

The Fourth Annual Report of St. Phebe's Mission shows the year to have been eventful in more ways than one,—pre-eminently in the gift and occupation of the New Memorial Mission House with its facilities for greatly increased work; the promise of support from several additional parishes, and the individual contributions far outstripping those of any previous year. The work has been in a great degree simplified and systemized, giving a good record in past and present, and a happy outlook for the future. We would impress upon all minds the fact that the work of St. Phebe's Mission is only limited and restrained by the amount of supplies and money provided wherewithal to carry it on, and *must* not be allowed to languish for want of sustenance, when so many are crying aloud for help.

Our new commodious Mission House requires much to maintain it, and its manifold emanating charities. In Hospital ward, in the prisoner's cell, in refuge of the aged and infirm, as well as in garret and cellar of the city-poor, and among the erring and the fallen, the St. Phebe Associates pursue their loving ministry, bringing forth the fruits of good works among those who are "afflicted or distressed in mind, body and estate;" their time is fully occupied in the faithful discharge of duty, in the house as well as outside; the work is unceasing and laborious, but nothing is neglected or omitted which can be done to mitigate the sorrows and sufferings of those applying to the Mission for relief.

The appointment of Dr. C. Ellis Stevens to be responsible for House-ministrations, providing for a service weekly at the Mission House, and for the performing of clerical duties there, personally or through others, and of the Rev. Cornelius L. Twing as Chaplain to the Public Institutions, has greatly obviated the pressing need of a Chaplain solely devoted to St. Phebe's work, although thanks are due eighteen other clergymen for clerical ministrations; notwithstanding which it has happened in several cases that



baptized churchmen have been laid away without any service, or had the prayers read over them by the Associates, who have also baptized the dying when unable to procure a minister in time.

As the existence of *two funds* in the work of the Mission gave rise to misunderstanding in the mind of the general public, all money contributions during the past year have passed through the hands of the Treasurer and will be found in her report.

#### GUILDS, SOCIETIES AND CLASSES.

Recognition is very gratefully made of the valuable aid rendered by St. Phebe's Mission Guild in all the work of the Mission. Over four hundred dollars have been raised, paying the telephone rental, for burials, for more than three hundred prescriptions, besides other medicines and medical appliances. A committee from the Guild meets every week at the Mission House to mend and put in order garments sent in for the poor, as well as to make new ones, and has undertaken to clothe a young girl, protegee of the Mission, who has the promise of a liberal education at a church boarding school. It is not only for what the members provide, but for willing service of



hands and feet, as well as purse, that the Mission is thankful to the Guild. May God make it more and more a power for good !

The Jamaica Branch of St. Phebe's Mission Guild, and St. Paul's Guild, Flatbush, have rendered very material aid and assistance, furnishing boxes every month containing liberal donations of fruit, vegetables, groceries, delicacies for the sick, clothing, books, papers, flowers, etc.

#### FESTIVALS.

By means of liberal donations of poultry, vegetables, fruit and money, from the Jamaica and Flatbush Guilds, as well as from individual friends, the Mission was enabled to furnish substantial dinners to nine (9) families at Thanksgiving, and at Christmas to twenty-three (23) families, also to all the hospital patients in the Penitentiary.

Through the kindness of friends, the association and their co-workers afforded a bright Christmas to a large number of people in extreme poverty, illness, or loneliness. The tree and gifts provided by the Infant Class of Holy Trinity was enjoyed by more than three hundred persons at Flatbush, including sixty children of the County Nursery, every one receiving tea and sugar, or fruit and candy, the children toys and books. At the County Hospital the tree was furnished by St. Paul's Guild, Flatbush, the gifts provided largely by the children of the Sunday School. Over four hundred persons received each a pretty bag containing an orange, an apple, a cake and Christmas card ; while to the children were given books and games. At each place there was a brief service, and singing of carols, with short addresses by the Chaplain, assisted by the Rectors of Holy Trinity and St. Paul's.

At the Mission House a beautiful tree was prepared on the evening of Holy Innocents for about forty (40) children, who were delighted with their gifts, and listened attentively to interesting little discourses given them by two of the gentlemen present.

The religious services at the Institutions during Easter week, were somewhat interrupted by the confusion attendant on moving into the new Mission House ; still twelve hundred eggs, and over seven hundred Easter cards were distributed by the Associates.

Following close upon the Easter Festival dawned a day destined to be ever memorable in our annals, and regarded with joy and



thankfulness by all who love and work for St. Phebe's Mission, the day which gave us the noble Stately House, built by loving parents "in memoriam" of their daughter, our first president, Miss Harriette Low.

On Wednesday, May 5, 1886, the new St. Phebe's Mission House was formally opened, and dedicated to its work. The services were solemn and impressive, the Bishop of the Diocese presiding and about twenty clergymen present, a number assisting in the service. The music was furnished by the vested choir of St. Paul's Church, Brooklyn. The spacious rooms were taxed to their utmost capacity, many turning away for want of space. The Instrument of Donation was presented by Mr. Low, and accepted for the Board of Managers by the Bishop in a few well chosen words. The magnificent gift consisted of the House completely furnished, the ground on which it stands, and fuel for a year; policies of insurance on the house and furniture for three years, and a Bond of the City of New Brunswick, N. J., as the nucleus of an endowment fund.

The letter of acknowledgment and gratitude prepared for the Board by Mrs. Ivins, was read by Dr. Snively, of Grace Church. It was handsomely engrossed on parchment paper, and presented to Mr. Low by our President, Miss Cornelia King.

The Bishop's beautiful address epitomized the work of St. Phebe's Mission, from its concentration by Sister Eliza through the efforts to Miss Low and others, to its culmination in to-day's glorious gift, one well worthy of her for whose monument it has been planned and erected. If the knowledge that earnest faithful workers are ever carrying forward the work she loved when on earth, can reach her where she now is, then must new joys await her in the realization of hopes fulfilled.

In summing up the records of the past year, many of which are too briefly mentioned for want of time and space, our work seems to have been signally blessed, "God hath done great things for us, whereof we are glad." CONSTITUTION AND BY-LAWS  
OF THE  
**Long Island Branch <sup>of</sup> <sub>the</sub> Woman's Auxiliary**  
to the Board of Missions.

---

CONSTITUTION.

ARTICLE I.

This Association shall be called the LONG ISLAND BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

ARTICLE II.

Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions, the field being co-extensive with the Church, Diocesan and General.

ARTICLE III.

The Association shall consist of all persons who shall contribute to the treasury thereof, annually, at least the sum of one dollar. Any one may be constituted a Life Member by the payment at one time of the sum of one hundred dollars.

ARTICLE IV.

The officers of this Association shall be a President, Vice-President Secretary, and Treasurer.

There shall be at least two, and not more than five, delegates from each Parish to be represented in the Association.

There shall be, moreover, a Board of Managers, consisting of the above named officers and of the delegates, whose duty it shall be to regulate its affairs, and under the supervision of their Rectors, to further the work of the Association in the Parishes to which they respectively belong. The methods by which the end of this organization can be promoted are the raising of money for the support of Missionaries and Teachers, for the education of those who may be preparing for the work, and for other benevolent purposes connected with Missions; the making, collecting and transfer of clothing, and other material aid, and the circulation of papers and leaflets that may serve to stir up a public interest in the Missions of the Church.



## ARTICLE V.

It shall be the duty of the President to preside at the business meetings of the Association, and of the Board of Managers, to call special meetings of the same when occasion shall arise, to countersign all drafts upon the Treasurer and to obtain fresh information from Missions, to be read at the stated meetings of the Board.

## ARTICLE VI.

It shall be the duty of the Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, to keep minutes of the proceedings of the Association and of the Board of Managers, to send out all notices of the stated and special meetings of same, and to keep a fair record of all Missionary Box Reports; also, to prepare an Annual Report.

## ARTICLE VII.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association, to pay all drafts upon the funds when countersigned by the President, and to present an Annual Report.

## ARTICLE VIII.

The Constitution shall not be altered, except at an annual meeting of the Association—notice of the proposed change having been given at a stated meeting of the Board of Managers.

---

BY-LAWS.

## I.

There shall be an annual meeting of the Association on the second Thursday of June in each year, at such hour and place as the Secretary, with the advice of the President, shall indicate.

## II.

The election of Officers and of the Board of Managers shall take place at such meetings, and they shall continue in office for one year, or until their successors shall have been appointed.

## III.

In case of the vacancy of any office, by the death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers; and any one so appointed shall continue in office until the next annual meeting of the Association.



## IV.

The stated meetings of the Board of Managers shall be held on the second Thursday of each month, except that of the November meeting shall take place on the first Thursday of the month.

There shall be no stated meetings in July, August or September.

## V.

In all matters of importance, a resolution shall be brought before the Association and the Board of Managers to be deferred to the next meeting for decision, unless passed by a unanimous vote.

## VI.

At a meeting of the Board of Managers, any number present shall constitute a quorum for the transaction of business; and, at the annual meeting of the Association, a number of delegates, equal to one-half of the number of Parishes represented therein, shall constitute a quorum for the transaction of business.
