## SEVENTEENTH ANNUAL REPORT.

---

In preparing the report of the works done by this Association during the past year, two facts have made themselves strongly felt. We have grown in numbers and in work accomplished. We have now 60 parishes represented by 243 delegates, while a year ago we had representatives from only 58 parishes. This year we report 237 boxes, valued at \$12,084.12, and cash, \$2,338.59, an increase of \$3,074.33 in the value of boxes, and \$549.22 in cash. But the fact in this connection to which your attention is called, is that this work was done by two-thirds of the parishes represented, and these two-thirds do not exclusively include the strong parishes. Two have in their weakness stretched out the right hand of good fellowship to their weaker brethren. The work in a third parish has been entirely done by a children's society. Another fact, to which your attention is called, is that but five parishes are working under the pledge system. But judging from the success attendant on this system in those parishes, it can be but a matter of a short time when all will adopt it. The attention of the rectors is respectfully called to this matter.

No apology can now be needed for the existence of the Woman's Auxiliary. It has established its right to exist, and has certain duties assigned to it to perform. Those duties cannot be satisfactorily performed unless recognized as duties, and unless the means for discharging them be placed in the hands of the members.

Of the work undertaken a year ago, report can be made of the satisfactory completion of Rebecca Cole's education as a

teacher among the Freedmen. All through the three years that she has received our care she has proved herself most worthy, and has grown both spiritually and mentally beyond the fond anticipations of the most sanguine. Now that she has, as hoped for, received the position of teacher in the school where she was herself educated, her future may be considered assured. Still, there are many ways in which a continued interest may be manifested. Her wardrobe will, of course, often need replenishing and slight tokens at the holidays will still remind her of the kindly remembrance in which she is held.

Money has been raised for the salary of a teacher in Africa; for a teacher of dressmaking in the Normal School, Raleigh, N. C.; and for still another teacher among the Freedmen, in Petersburg, Va. Money has been sent to the mission in Alaska; to a hospital in Montana; to assist Rev. Mr. Nies in building a church in Anaconda, Montana; to St. Mary's School, Dallas, Texas; and, traversing the breadth of the continent, to the Mission of the Holy Comforter, in Brooklyn.

In this wise have we read the meaning of our Constitution—"the field to be co-extensive with the Church, Diocesan and General."

A year ago mention was made in our Annual Report of the active response made by some ladies to Rev. Mr. Darlington's appeal for workers in the part of Brooklyn known as "Little Germany." This year we report the erection of the chapel, through the unfailing kindness of some good friends of mission work, and the pledge of the Auxiliary to raise in five years \$1,000. A part of this sum has already been paid, and no fear is felt as to quickly raising the remainder, when the importance of the object is more generally made known.

New work has been most successfully organized, under the skilful superintendence of one of our delegates, in the name of the Long Island Altar Society. A detailed report (for nine months) is appended hereto. Your careful attention to it is asked, and your kindly co-operation solicited. Thanks to the advice and kind interest of the sister and pioneer society in Mas-

sachusetts, no time was lost in the preliminary formation of this department.

Still another department has been equipped—the Church Periodical Club—and is succeeding admirably under the wise management of the superintendent. Thanks to her indefatigable zeal, branches have been established in 25 parishes, and 455 books and 610 periodicals, and innumerable cards, etc., have been regularly dispersed in 16 Dioceses.

No reports of our labors can be complete without an acknowledgment of the splendid work done by the committees. To their faithful discharge of the duties assigned them, our growth and prosperity are largely due. If their efforts could be seconded by the systematic working of each individual parish, the result would astound the most hopeful. The Secretary begs to acknowledge the unfailing courtesy of the Rectors of the parishes, in response to the many demands she has been compelled to make on their time. Happily, the appointment of "chairmen" has lessened this necessity, to the content of all concerned.

As a summary for the year we report thus as the work of 39 parishes: 104 Diocesan boxes, valued at \$3,835.65, and cash, \$492.05; 94 Domestic boxes, valued at \$5,611.35, and cash, \$384.00; 9 Indian boxes, valued at \$813.58, and cash, \$88.00; 30 boxes for Freedmen, valued at \$1,582.24, and cash, \$473.27; 8 Foreign boxes, valued at \$191.30, and cash, \$532.58; an average of \$348.47 to a parish. So that, if the other ten had reported, our total would have amounted to \$17,423.81.

Our work for the coming year is partly arranged, namely, the completion of the Fund for the Mission of the Holy Comforter, by the Auxiliary at large. Three parishes have promised the salary of the teacher in Raleigh, N. C., for seven months and a half, leaving two and a half months still to be provided for. Perhaps three parishes may to-day feel stirred to pledge the necessary \$45. And, as an entirely new departure, we have with the endorsement and advice of the Bishop, undertaken the work in Mexico, under Rev. Mr. Gordon's supervision. His

appointment, by the Presiding Bishop, decides the vexed question of how best to assist the faithful few in that distant land.

Since our last meeting we have sustained a most serious loss in the death of one of the most active members of this Association. Since its earliest days of trial and striving, Mrs. Annan's name has been synonymous with zeal, enthusiasm, and unfailing liberality. Perhaps the department of work that most keenly stirred her interest was that last mentioned, and your committee hopes, this year, to receive your cordial co-operation in making its work a fitting memorial of her.

And so, on the verge of another working year, we bid you Godspeed, and trust that such of us as were privileged to attend the Triennial meeting of the Auxiliary, lately held in New York, may be stimulated to increased energy and hearty zeal in discharging the duties laid upon us.

# CONSTITUTION AND BY-LAWS

OF THE

## Long Island Branch of the Woman's Auxiliary to the Board of Missions.

### CONSTITUTION.

#### ARTICLE I.

This Association shall be called the LONG ISLAND BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

#### ARTICLE II.

Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions, the field being co-extensive with the Church, Diocesan and General.

#### ARTICLE III.

The Association shall consist of all persons who shall contribute to the treasury thereof, annually, at least the sum of one dollar. Any one may be constituted a Life Member by the payment at one time of the sum of one hundred dollars.

#### ARTICLE IV.

The officers of this Association shall be a President, Vice-President, Secretary, and Treasurer.

There shall be at least two, and not more than five, delegates from each Parish to be represented in the Association.

There shall be, moreover, a Board of Managers, consisting of the above named officers and of the delegates, whose duty it shall be to regulate its affairs and, under the supervision of their Rectors, to further the work of the Association in the Parishes to which they respectively belong. The methods by which the ends of this organization can be promoted are the raising of money for the support of Missionaries and Teachers for the education of those who may be preparing for the work, and for other benevolent purposes connected with Missions; the making, collecting, and transfer of clothing and other material aid, and the circulation of papers and leaflets that may serve to stir up a public interest in the Missions of the Church.

#### ARTICLE V.

It shall be the duty of the President to preside at the business meetings of the Association and of the Board of Managers, to call special meetings of the same when occasion shall arise, to countersign all drafts upon the Treasurer, and to obtain fresh information from Missions, to be read at the stated meetings of the Board.

## ARTICLE VI.

It shall be the duty of the Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, to keep minutes of the proceedings of the Association and of the Board of Managers, to send out all notes of the stated and special meetings of same, and to keep a fair record of all Missionary Box Reports; also to prepare an Annual Report.

## ARTICLE VII.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association, and to pay all drafts upon the funds when countersigned by the President, and to present an Annual Report.

## ARTICLE VIII.

The Constitution shall not be altered, except at an annual meeting of the Association--notice of the proposed change having been given at a stated meeting of the Board of Managers.

## BY-LAWS.

## I.

There shall be an annual meeting of the Association on the second Thursday of June in each year, at such hour and place as the Secretary, with the advice of the President, shall indicate.

## II.

The election of Officers and of the Board of Managers shall take place at such meetings, and they shall continue in office for one year, or until their successors shall have been appointed.

## III.

In case of the vacancy of any office, by the death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers; and any one so appointed shall continue in office until the next annual meeting of the Association.

## IV.

The stated meetings of the Board of Managers shall be held on the second Thursday of each month, except that of the November meeting shall take place on the first Thursday of the month.

There shall be no stated meetings in July, August, or September.

## V.

In all matters of importance, a resolution shall be brought before the Association and the Board of Managers to be deferred to the next meeting for decision, unless passed by a unanimous vote.

## VI.

At a meeting of the Board of Managers, any number present shall constitute a quorum for the transaction of business; and at the annual meeting of the Association, a number of delegates equal to one-half of the number of Parishes represented therein, shall constitute a quorum for the transaction of business.
