## EIGHTEENTH ANNUAL REPORT.

---

Another year has quickly sped since we assembled in this dear old Mother Church to listen to our Reports of work accomplished, and to derive, from the earnest words and no less earnest appeals of many active workers on the frontier, new strength and ardor in our efforts to advance Christ's Kingdom. The year has been distinguished by a steady increase both in activity and in gifts.

At the time of our last anniversary the General Convention had just gathered up the threads of the hundred years work of the Church, and our hearts were deeply stirred as we considered the marvellous increase with which God had blessed the small beginnings of our fore-fathers. The lesson for us all was plain—not to despise small things, but to be well content, if convinced in our own hearts that we have used in the past and are using in the present, to the best advantage, the means at our disposal.

When we hear so many instant appeals for assistance both at home and abroad, it is difficult, indeed, to take to heart the lesson, "one step enough"; and to take that "one step," not knowing *when* or *how* the next can be taken, is oftentimes no mean test of faith.

At the triennial meeting of the Diocesan Officers of the Auxiliary, it was decided that, as the "special" work of the Auxiliary at large, the sum of \$5,000 should be raised for the furnishing of the Auxiliary rooms and the Chapel in the New Mission House. A committee, appointed to consider the work of the children of the church, reported a recommendation that a Junior Auxiliary should be formed, but that the corpor-

ate societies should retain their respective names. This winter this important work will, we hope, receive the attention it so richly deserves and be organized on the firm foundation of sound Church principles. Several children's societies already organized provide a satisfactory nucleus for the work. The third action taken was regarding the advisability of the establishment of Training Schools for Missionaries. Thanks to individual generosity, two such schools are now in operation, destined, we trust, to be the first links in a chain that shall reach from ocean to ocean. The triennial offertory was voted to a Chapel at Anvik, Alaska, and to the outfit and salary of a teacher in Japan.

Of the work proposed last year as that to be done by us, the women of Long Island, we are glad to report, as a supplement to the more general and routine work:

- (1.) The payment of the teacher's salary in Raleigh, N. C.
- (2.) The establishment of a scholarship in Mexico.

(3.) The partial payment of the pledge towards the fund for the Mission of the Holy Comforter, Brooklyn. Though five years was the time agreed upon for the redemption of this latter pledge, it would seem to be well, in view of the importance of the work and the pressing necessity for its permanent establishment, that we should make a strenuous effort at once to redeem the pledge in full. It may be well, perhaps, to refresh our memories as to what the work of the "Mission of the Holy Comforter" is, and as to how it was undertaken.

Three years ago, the clergyman, invited to speak on Diocesan Missions, at our Anniversary was requested to propose some definite practical work in the way of Church Extension in our own City. As some of you remember, he described most graphically and pathetically the utter spiritual apathy and ignorance in a great ward of this city known as "Little Germany." He asked for volunteer workers from the Auxiliary with a view to the establishment of a Sunday School. His appeal was not in vain, and from that small beginning a parish

has been organized, a Church edifice erected in which there has been for the past two years not only a well-attended Sunday School but regular Church services, which promise fruitful results. It is needless to dwell upon how great a stimulus and encouragement it would be to those faithful workers, who have borne the burden and the heat of the day, if we should this year give practical evidence of our appreciation of their labors by paying our pledge in full.

This Mission Chapel possesses a further interest to us all in being a memorial of that learned and revered Priest, who for so many years urged from the Chancel of this Church the claims of Missionary work and who taught in action as in utterance that "it is more blessed to give than to receive."

Our Branch of the Auxiliary grows slowly, but surely. We now have a representation from sixty-one parishes, including nearly all the parishes in Kings and Queens and some most efficient representatives from Suffolk County. The roll-book contains the names of 250 delegates, but the average attendance, in spite of the attendance at one meeting of 119 persons, has been only 86, a deplorably low average, that may, perhaps, be attributed to the unusual prevalence of sickness during the last winter.

Death too has been busy and has taken from our ranks some of our most faithful and earnest workers. The sight of their vacant places, while touching our hearts with profound sadness, should but incite us to greater zeal, to the end that "they being dead, may yet speak" through our redoubled efforts.

The year has been marked by the retirement, from the office of President, of Mrs. Seaman, for ten years a most faithful and efficient officer. To her executive ability and unswerving devotion much of the success of the work of the L. I. Branch is due. To new hands have been confided the arduous duties of the presiding officer; and let it be our pleasant task to see that her hands are strengthened and her efforts seconded in the work she has undertaken at our call. No report can be complete without reference to the admirable work of the com-

mittees. Much great interest is apparent in the different departments now, thanks to their efforts. By their instrumentality all the parishes represented, are reached and made acquainted with the work of the Auxiliary, while their co-operation is solicited.

The Long Island Altar Society presents its second Annual Report to-day, and with undiminished zeal to increase its usefulness, asks that it be not forgotten by us in the arrangement and allotment of our winter's work. So quiet and unobtrusive is its work, and so modest its claims, that it is only through its report that we recognize the essential importance of its labors.

The Church Periodical Club also evidences steady growth, and, thanks to the indefatigable energy of Long Island's correspondent, we continue to lead the other dioceses in this admirable work. No further guarantee of its usefulness and the necessity for co-operation, can be needed than the earnest words of the Missionary Bishops a year ago, two of them declaring that they considered this society one of the most efficient agencies for good they possessed.

The preparation of "boxes" has continued and increased to such an extent, that this year we report 377 against 237 last year, an increase of 140. Notwithstanding some objectionable features in the system, this method of help, if used aright, can be made one of the most efficient instruments for good within our power. In the first place, the "box" should not be regarded as a "gratuity," but a "payment in kind" of the missionary stipend. Secondly, it should be sent as an evidence of the brotherly love existing between the members of Christ's Household—the Church. Until the liberality of the Church is sufficiently awakened to provide a proper stipend for her missionaries, this work must be done. And it is our duty to see that it is properly done.

With the opening of a new year, let our watchword be: "Lord, what wouldst Thou have *me* to do?" Work sufficiently varied to suit the capacities and tastes of all has been

suggested by the Board of Missions and our General Secretary. For those who feel, that it is through the Providence of God, that the colored race remains on our shores, there are schools to maintain, hospitals and chapels to build, the young to train and the old to care for. Others may feel a keener interest awakened by the work among the Indians. Let them remember that there are still many tribes to whom the Gospel of Christ is, as yet, unpreached that there are schools, hospitals and churches yet to be built; while further help is needed for those already established, for the education and advancement, material and spiritual, of these "wards of the Nation."

From the brethren of our own blood in the far West, the sunny South, the stern North and in our own ocean girdled diocese, demands for additional help are being constantly received. The young, the sick, the infirm are everywhere waiting to be taught and ministered to.

From Africa, with its dauntless few working in the face of appalling obstacles, from Japan, where "the day-dawn" of "the truth as it is in Christ Jesus" seems slowly breaking to eager eyes, from China, where our Christian outposts staunchly hold the ground so hardly won through the free libation of the "blood of His saints," there comes to our ears the appealing Macedonian cry: "*Come over and help us.*" Shall there be any half-hearted answer?

Trusting that by God's help our efforts may meet full fruition and that of His infinite power He will make our weakness strength, this eighteenth annual report is

## CHURCH PERIODICAL CLUB.

---

The Church Periodical Club aims to circulate Church and other suitable periodicals, books, etc., among all worthy clergymen and lay people.

Since January tenth, 1889, this department of missionary work has been incorporated with this branch of the Auxiliary; and by its wonderful success, testified to by bishops, clergymen and many others, is placed in the front ranks for prominence and usefulness.

Forty-three parishes of this Diocese have organized branches of this Club, and are now in systematic working order, sending literature into 52 Dioceses and Missionary Jurisdictions, also to Japan, Newfoundland and Nova Scotia.

Two hundred and sixty-five periodicals and 56 Sunday School papers are being sent regularly for the current year. 1,449 books, Sunday School books, Bibles, Testaments, Prayer-books and Hymnals, have been sent, also over 7,000 Sunday School cards, lesson papers, Easter cards, catechisms and tracts, 17,067 odd numbers of periodicals and magazines.

The President of the Club has congratulated us upon this very satisfactory record, and, therefore, ranks us as the banner Diocese. Parishes wishing to establish branches of the Club, and any one desiring further information, will kindly communicate with the correspondent.

# CONSTITUTION AND BY-LAWS

OF THE  
LONG ISLAND BRANCH

OF THE

## Woman's Auxiliary to the Board of Missions.

### CONSTITUTION.

#### ARTICLE I.

This Association shall be called the LONG ISLAND BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

#### ARTICLE II.

Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions, the field being co-extensive with the Church. Diocesan and General.

#### ARTICLE III.

The Association shall consist of all persons who shall contribute to the treasury thereof, annually, at least the sum of one dollar. Any one may be constituted a Life Member by the payment at one time of the sum of one hundred dollars.

#### ARTICLE IV.

The officers of this Association shall be a President, Vice-President, Secretary and Treasurer.

There shall be at least two, and not more than five, delegates from each Parish to be represented in the Association.

There shall be, moreover, a Board of Managers, consisting of the above named officers and of the delegates, whose duty it shall be to regulate its affairs, and, under the supervision of their Rectors, to further the work of the Association in the Parishes to which they respectively belong. The methods by which the ends of this organization can be promoted, are the raising of money for the support of Missionaries and teachers for the education of those who may be preparing for the work, and for other benevolent purposes connected with Missions; the making, collecting and transfer of clothing and other material aid, and the circulation of papers and leaflets that may serve to stir up a public interest in the Missions of the Church.

#### ARTICLE V.

It shall be the duty of the President to preside at the business meetings of the Association and of the Board of Managers, to call special meetings of the same when occasion shall arise, to countersign all drafts upon the Treasurer, and to obtain fresh information from Missions, to be read at the stated meetings of the Board.

## ARTICLE VI.

It shall be the duty of the Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, to keep minutes of the proceedings of the Association and of the Board of Managers, to send out all notes of the stated and special meetings of same, and to keep a fair record of all Missionary Box Reports; also to prepare an Annual Report.

## ARTICLE VII.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association, and to pay all drafts upon the funds, when countersigned by the President, and to present an Annual Report.

## ARTICLE VIII.

The constitution shall not be altered, except at an annual meeting of the Association—notice of the proposed change having been given at a stated meeting of the Board of Managers.

 B Y - L A W S .

## I.

There shall be an Annual Meeting of the Association on the second Thursday of June in each year, at such hour and place as the Secretary, with the advice of the President, shall indicate.

## II.

The election of officers and of the Board of Managers shall take place at such meetings, and they shall continue in office for one year, or until their successors shall have been appointed.

## III.

In case of the vacancy of any office, by death or removal of its occupant, the same may be filled at a stated meeting of the Board of Managers; and any one so appointed shall continue in office until the next annual meeting of the Association.

## IV.

The stated meetings of the Board of Managers shall be held on the second Thursday of each month, except that of the November meeting which shall take place on the first Thursday of the month.

There shall be no stated meetings in July, August or September.

## V.

In all matters of importance, a resolution shall be brought before the Association and the Board of Managers to be deferred to the next meeting for decision, unless passed by a unanimous vote.

## VI.

At a meeting of the Board of Managers any number present shall constitute a quorum for the transaction of business; and at the annual meeting of the Association, a number of delegates equal to one-half the number of Parishes represented therein, shall constitute a quorum for the transaction of business.
