Rev. J. M. BLANCHARD, of St. James', Philadelphia, delivered the morning address.

Rt. Rev. M. N. GILBERT, S.T.D., presented Domestic and Indian Missions.

REV. G. F. FLICHTNER presented Work in Mexico.

REV. E. A. BRADLEY presented Diocesan Missions.

Rev. Mr. TUNNELL presented Work among the Colored Race.

NINETEENTH ANNUAL REPORT.

As we look back over the past year, we can see many reasons to encourage, and on every side a token of the Power of the Living God and His Church.

Appeals come from so many directions, and each one of such weight, we are at a loss oftentimes to decide which must be met, and if not all, where the need is greatest, and how we can best respond.

In China and Japan we have not accomplished as much as we ought; these fields are alike interesting, and we hope this year to aid them more substantially.

Our domestic committee report three hundred and ninety-one dollars, collected and distributed.

In Mexico, we have paid our pledge of two scholarships.

In our own diocese our pledge to the Mission of the Holy Comforter is nearly satisfied.

Beside the work of the Indian Committee, the Auxiliary has assisted in the salary of Miss Willis.

Freedman Committee have collected and paid the salary of a dressmaker in Raleigh, North Carolina; a former delegate has been assisted in her work among colored children; her appeal asked for aid in establishing a Sunday-School, this was responded to generously, and received grateful acknowledgment.

We hope to increase our offerings this year. Our work advances in the quiet systematic way that our dear Church teaches, with honest purpose of sending good tidings of great joy to all people.

The custom of box sending we still maintain. Notwithstanding it has received a good many hard knocks it remains for us to prove that some of the errors are insufficient to persuade thoughtful workers to voice against this method of aiding the Board of Missions. At the same time, we must not forget in preparing these offerings, the admonition coming over and

over again to this effect, sending only what is specified, and being accurate in the details. In addition to our boxes we have added materially to the Contingent Fund, and answered Bishop Gilbert's urgent appeal for help among his Indians in Minnesota.

In the lives of two of our dear associates gone home to Paradise, we have examples of self-abnegation and fidelity which should move us to higher zeal and greater effort.

Sixty-two churches are represented, with an average attendance of 87.

Individual parishes have kept pace with the delegation at large, and unless signs mislead there is a wholesome readiness to discuss the issues belonging to us, that shows life and activity, withal a harmony most emphatic. The Church Periodical Club has advanced under the able management of our correspondent, who is now forced into another diocese. This is one of the regrets that meet us at the beginning of a new year. Fortunately this interruption has not stopped Long Island's work, proving that well organized enterprise has always reserved strength.

The growth of the association necessitated some changes in our Constitution and By-laws. With this end in view, a committee was appointed, whose careful action, in accord with the entire society, resulted in the desired corrections. The Long Island Altar Society present their third annual report.

The committees have discharged their duties with prudence and fidelity, rendering the officers unwavering support, making the result, not perfect, by any means, but more effective.

For the year now beginning let us pray we may be able to extend our work, that there may be more earnest interest in Missions, and a faithful rendering of money to sustain the same, and to God be the Glory, and the Honor, and the Praise.

Since January 10, 1889 this department of missionary work has been incorporated with this branch of the Auxiliary, and by its wonderful success, testified to by Bishops, Clergymen, and many others, is placed in the front ranks for prominence and usefulness.

A large number of parishes in this Diocese have organized branches of the Club, and are now in systematic working order, sending literature into 52 Dioceses and Missionary jurisdictions, also to Japan, Newfoundland and Nova Scotia. Three hundred and ninety periodicals and 146 Sunday-school papers are being sent regularly for the current year; 2145 books Sunday-school books, Bibles, Testaments, Prayer-books, and Hymnals, have been sent, also over 3561 Christmas and Easter cards, Sunday School Cards, Catechisms and Church Tracts, and 27,824 odd numbers of periodicals and Magazines.

It is earnestly desired by the correspondent, that before another Anniversary rolls around, every parish represented in this branch of the Auxiliary may have taken up the work of this Club, thereby doing a large amount of Missionary good through The Church Periodical Club.

CONSTITUTION.

ARTICLE I.

This Association shall be called the LONG ISLAND BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

ARTICLE II.

Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions, the field being co-extensive with the Church, diocesan and general. The methods by which the ends of this organization can be promoted, are the raising of money for the support of Missionaries and teachers for the education of those who may be preparing for the work, and for other benevolent purposes connected with Missions; the making, collecting and transfer of clothing and other material aid, and the circulation of papers and leaflets that may serve to stir up a public interest in the Missions of the Church.

ARTICLE III.

The Association shall consist of all delegates representing parishes in the diocese, said delegates being appointed by the Rectors of such parishes, each delegate paying an annual due of one dollar. There shall be at least two, and not more than five, delegates from each parish.

ARTICLE IV.

The officers of this Association shall be a President, Vice-President, Secretary and Treasurer.

There shall be, moreover, an Advisory Board, consisting of the above named officers and five delegates, appointed by the President.

ARTICLE V.

It shall be the duty of the President to preside at the business meetings of the Association and of the Advisory Board, to call special meetings of the same when occasions shall arise, to countersign all drafts upon the Treasurer, and to obtain fresh information from Missions, to be read at the stated meetings of the Association.

ARTICLE VI.

It shall be the duty of the Vice-President to preside, in the absence of the President, over the meetings of the Association and of the Advisory Board.

ARTICLE VII.

It shall be the duty of the Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, to keep minutes of the proceedings of the Association and of the Board of Managers, to send out all notices of the stated and special meetings of the same, and to keep a fair record of all Missionary Box Reports; also to prepare an Annual Report.

ARTICLE VIII.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association, and to pay all drafts upon the funds, when countersigned by the President, and to present an Annual Report.

ARTICLE IX.

Any parish in the diocese too remote for representation, shall, on the annual payment of not less than two dollars, be entitled to report its work to this Association.

ARTICLE X.

The Constitution shall not be altered, except at an annual meeting of the Association—notice of the proposed change having been given at a stated meeting of the Association.

BY-LAWS.

I.

There shall be an annual meeting of the Association on the second Thursday of May, in each year, at such hour and place as the Advisory Board shall direct.

II.

The election of Officers shall take place at such meeting, and they shall continue in office for one year, or until their successors shall have been appointed.

The election of officers shall be by ballot; nominations to be made in writing and delivered to the Secretary by the delegates at the annual meeting. Only those persons so nominated shall be eligible for election, the two receiving the largest number of ballots to be the candidates.

III.

In case of the vacancy of any office, by the death or removal of its occupant, the same may be filled at a stated meeting of the Advisory Board, and any one so appointed shall continue in office until the next annual meeting of the Association.

IV.

All persons contributing to the treasury annually, at least the sum of one dollar, shall be members of the Association but not entitled to a vote.

V.

The stated meetings of the Association shall be held on the second Thursday of each month, except that the November meeting shall take place on the first Thursday of the month, the second Thursday being the Anniversary. Place of meeting to be determined by Association.

There shall be no stated meetings in June, July, August or September.

VI.

In all matters of importance, a resolution shall be brought before the Association to be deferred to the next meeting for decision, unless passed by a unanimous vote.

VII.

At a meeting of the Association any number of delegates present shall constitute a quorum for the transaction of business; and at the annual meeting of the Association, a number of delegates equal to one-half of the number of parishes represented therein, shall constitute a quorum for the transaction of business.

VIII.

At the monthly meetings of the Association the order of business shall be: 1. Devotional services. 2. Calling of the Roll. 3. Minutes of the last meeting. 4. Treasurer's report. 5. Intermission. 6. Reports of Parishes and Committees. 7. Unfinished business. 8. Miscellaneous business.
