## Twenty-first Annual Report.

---

Perhaps it would be well on this, the Twenty-first Anniversary of the Long Island Branch of the Woman's Auxiliary to the Board of Missions, for us to remember just how this Association originated which we are distinctly told, "is composed of those women who by virtue of their baptism are already members of the Missionary Society, and who recognizing the responsibilities such membership entails, wish to take an active part in this Association also" the first touch towards making woman's work an important factor in the great plan of the Foreign and Domestic Boards was made at the General Convention in Baltimore, October, 1871, and the result has been beyond the most sanguine hopes of that committee, bishops and clergy, from Maine to Mexico, from New York to San Francisco, from the islands in mid-ocean and from far across the sea, have borne unvarying testimony to the invaluable assistance the Woman's Auxiliary has been to their work. More than one has told that in many instances a field must have been abandoned and the workers utterly discouraged had it not been for the help rendered by this Auxiliary. January 1st, 1872, the first General Secretary was appointed in New York and just eleven months after, Long Island had the honor and privilege of forming the first Diocesan Branch, the present Bishop of the Diocese being its founder and head, and the Very Rev. Dean Cox its firm friend then as now. This Long Island Branch took for its corner-stone the Missionary Creed divided into three parts, first, that there is a message to carry, second, that the Church has the charter to carry it, and third, that she must strive with every power she possesses to do so. Inscribed upon this corner-stone those words "The women who came with Christ

from Gallilee followed after and by the Grace of God builded wisely and well, taking for its watchword this motto, 'In essentials unity, in non-essentials liberty, in all things, charity.'

At the meeting December 10, 1872, the first Board of Officers was appointed, Mrs. John A. Paddock, President; Mrs. A. N. Littlejohn, Vice President; Mrs. D. E. Moran, Secretary; Mrs. Edward De Selding, Treasurer. The fact that the Constitution and By-laws then adopted remain essentially unchanged is *prima facie* evidence of the admirable framing. Mrs. Paddock served for nine years, and then Dr. Paddock, having resigned the rectorship of St. Peter's to assume the duties of Missionary Bishop of Washington Territory, she left Brooklyn full of interest in her new work, the building and furnishing of a hospital in Lacoma. A cheerful greeting came back from the summit of the Rocky Mountains, followed by the sad announcement of her death, in sight of the Territory in which she had so heartily determined to consecrate herself anew to the service of her Divine Master, and yet before the border land had been passed, "their works do follow them." The hospital built out there as her memorial, is defined against the western horizon, a fitting tribute to a noble unselfish woman. On the 14th of April, 1881, Mrs. Adrian Seaman, who had served the association well as Secretary, was unanimously elected President. That her term of office was a successful one, was expressed by the delegates when she declined to be re-elected in "1890." "her talents have been given to the advancement of the interests of the Auxiliary, with the happy results of increased influence and a corresponding gain in missionary enthusiasm and contributions. Curiously enough Mrs. Seaman also served nine years, during which the number of parishes enrolled increased from twenty-two to sixty-two. At the May meeting, 1890, Mrs. Samuel Cox, our present beloved officer, was unanimously elected to the chair.

We have only time for a sketch of what our earnest workers have accomplished during these twenty-one years of Grace. St. Phebe's Mission, through the indefatigable zeal of Sister Eliza and the noble generosity of Miss Harriette Low has become the vital centre for the

mission work of our city. The Church of the Holy Comforter tells a story of gratitude to the Association, St. Martha's Sanitarium was assisted in its growth, St. Giles' House for Crippled Children was established as a necessary Church Institution, and the hands of many other missions in the Diocese have been strengthened. In the Domestic Field we have come into touch more and more with those missionaries who are striving against great odds in their loneliness to to feed the hungry souls about them, to pronounce the marriage blessing, to reverently lay away the dead and to receive the little ones into Christ's fold. We have taken a wider, deeper interest year by year in the schools and hospitals and responded more intelligently and generously to the earnest appeals of the Missionary Bishops of the West and South.

Our sympathies have been more and more enlisted in the cause of the Freedman, "the race that through the Providence of God has been brought here to be taught the truth as it is in Christ, and enabled to be in its turn the teacher of others living in the darkness of a heathen land," St. Augustine's school at Raleigh, Hampton University, King Hall, and many other institutions bear testimony to what we are striving to do. From the Indian Field we receive more and more encouraging reports as the years go by. Weak sentiment, hand in hand with gross injustice have been replaced by practical teaching and wiser legislation, making it possible for our clergy and teachers to write the truth of Christ upon the tablets of the hearts of this red people and to show to the rest of the nation that the Indians are not ungrateful and that they do appreciate kindness. We hope to hear from Miss Carter herself, the good results of the \$360 we sent for salary of a lace teacher at Red Lake last year.

To those people far south of us, who are so far advanced in the arts and sciences as to be compared to the Ancient Egyptians, we have been able to send a ray of light which we hope to strengthen until it becomes a search-light. Many argue that we have no right to send missionaries to a country which is under the government of the Roman Church, we can only quote the voice of one and it is the echo of

many, "Romanism and vice were introduced by the Spaniards into Mexico, and the two have become so allied that the conscientious ones among the Roman Priests have sought for light." Mrs. Hooker, that saintly woman to whose care the children in the orphanage owe so much, has passed away. Santa Hooker she is called by the church people in Mexico. The institution is to be known hereafter as the Hooker Memorial Orphanage. The Rev. Mr. Forrester, formerly of New Mexico, has undertaken the charge of the Mexican work, and those who know, say his hand will be a strong one at the helm. For Alaska we have been able to do very little. It has been impracticable to send a woman missionary to that field heretofore. One who has been training for the work will probably go out there this year.

As for the Foreign Field, if there has been an amelioration of the condition of human life, where a Christian mission is planted, if the whole moral condition of life is improved, if the position of woman is somewhat elevated, there is surely something to be thankful for, to be welcomed as a preparation for the setting up of His Kingdom. Bishop McKim of Japan, and Bishop Graves of China are hard at work. St. John's College and St. Mary's Hall have gladly welcomed Mr. and Mrs. Pott Rome, and Mrs. Twing will bring us news of them, and of the many other workers in that far off land, now that she has returned from her long journey. Miss Brierly is still faithful to her duties at Cape Mount, Africa, and has come to America to tell the story of her trials and progress and Bishop Holly is upholding the Cross against cruel odds in Haiti. May God give all these noble men and women strength for the battle.

That most excellent work, the Church Periodical Club has so steadily grown that we have librarians in thirty-four parishes. We regret the resignation of Miss Leverich, and trust that the librarians will give faithful encouragement to the new correspondent, Mrs. Heinigke of Bay Ridge. The report of the Long Island Altar Society speaks for itself. It can be made an active agent for good and we trust to see fresh impetus given to it this year. We have sixty-nine parishes in our roll call, there having come to us during the past year Trinity

Church, Roslyn; St. George's Church, Hempstead; and Caroline Church, Setauket; but we should not be satisfied while there are forty more, still unrepresented, in the diocese. The united offering must be constantly borne in mind, we must remember that all we can do for this means that a missionary jurisdiction will be endowed, and that a bishop will be able to remain in his diocese encouraging his clergy, and influencing his people instead of constantly begging in the East for funds with which to carry on our work. A word to our enrolled delegates, they should come to the monthly meetings, from city or country, brimful of thoughts and suggestions, by the interchange of which they would infuse fresh zeal and fire into one another. If prevented from coming in person, they should communicate their interest by letter. In reviewing the work of the past twenty-one years, we have every reason to believe that the Church-women of Long Island, have, in a measure awakened to their responsibilities; but when we think of what was accomplished in the Judaistic twilight do we not shrink with dismay at the comparative weakness and selfishness of our efforts when viewed in the strong light of the Christian noon-day? Let us cultivate the spirit of self sacrifice and ardent enthusiasm, the true missionary spirit. Let us cast parochial narrowness aside, remembering that parish churches are God's given centres from which to discharge the duties of our stewardship, not luxurious comfortable places in which nineteenth century Christians are to meet week by week to be reminded of their spiritual duties and self-imposed mortgage indebtedness. Whether we believe in missions or not, the command has been given and we have no option in the matter. The responsibility is ours and we must give an account for the manner in which we have accepted or obeyed it.

Sweet thoughts are theirs, that breathe serenest calms,  
Of holy offerings timely paid,  
Of fire from Heaven to bless their votive alms  
And passions on God's Altar laid.

New hearts before their Saviour's feet to lay,  
This is their first, their dearest joy,  
Their next from heart to heart to clear the way,  
For mutual love without alloy,  
Never so blest as when in Jesus roll  
They write some hero-soul  
More pleased upon His brightening road  
To wait, than if their own with all His radiance glowed.

## Report of Altar Society.

Authorized by the President of the Long Island Woman's Auxiliary, the Chairman sent an appeal in behalf of this Committee to each Parish delegation. Ten parishes have contributed to our work. We have five working members and have sent forth, a Cassock and Surplice to the Rev. James S. Russell, Laurenceville, Virginia. A Surplice has been made by a member of the Committee for St. Matthew's Church and a Suplice for the Rev. Isaac Houlgate, Nebraska. A set of Altar linen is being made for the Rev. Mr. Russell, a Colored Priest in Virginia who is in charge of several mission stations. Mr. Russell writes, "I have two Churches in which they have no Communion sets or even linen, I have either to take the Altar linen from Laurenceville or use a large towel on the Altar. When I ask for Altar linen I do not mean anything costly, but plain cloths, with napkins for a change."

Rev. Mr. Applegate of Tacoma has asked for Altar linen and Surplices, for use in his Mission Chapels. A Surplice is being made and we hope to send at least one set of Altar linen. We need both money and workers.

## Church Periodical Club.

The "Church Periodical Club," of the Diocese of Long Island approaches the close of its fifth year with the following record.

746 Current Magazines, sent regularly; 914 Sunday-school Books; 75 Bibles; 25 Testaments; 416 Prayer Books; 145 Hymnals; 624 Tracts; 304 Pictures; 110 Service Leaflets, sent regularly; 266 Sunday-school Papers for current year; 80 Sunday-school Lesson Papers for current year; 1099 Sunday-school Cards; 3551 Christmas Cards; 990 Easter Cards; 123 Catechisms; 106 Christmas Carols; 155 Easter Carols; 2984 Books and 65,354 odd Magazines and Periodicals.

All members of the Woman's Auxiliary by this time understand that the object of the "Church Periodical Club" is to supply Missionary Clergymen and worthy, but poor parishioners with religious, or improving literature; sometimes it is a Reading Room by means of which Christ's Ambassador, who must be wily as a serpent, through harmless as the dove, strives to gain an influence over those who have withstood all efforts to win their attendance at the services of the Church.

One Missionary Bishop declared that his most potent assistant was the "Free Reading Room," and how shall it be established unless we supply the material. It will be remembered that the Motto of the Club is "Gather up the fragments that nothing be lost," and when the Lord of Heaven, even in the midst of a multitude sated with the abundance provided by an Omniscient Power, gave this injunction of carefulness in regard to the fragments, how it must grieve him to witness the daily hoarding or destruction of that for which so many of his faithful servants are longing and hungering.

We only ask for what, at which in all probability, you will never again, even glance. In one Rectory in Maryland, every Magazine there received, is loaned in turn to thirty-five families; think of the possibilities for good wrought by one of these Periodicals, which in time become cumberers of our households. Are they not most emphatically the "cup of cold water," which we all have it in our power to offer, the neglect of which may draw down on us that saddest of all reproaches, "inasmuch as ye did it not unto one of the least of these my brethren, ye did it not unto me."

Will not every Parish in the Diocese, before the close of this our Jubilee year of '93, establish a Branch of this work in their midst? will not Librarians offer their services? there is nothing arduous in the task; it is a privilege to be engaged in a work which garners such returns of thankfulness, it is one of those fruitful vineyards where the toiler receives "a thousand fold in this present life."

# CONSTITUTION AND BY-LAWS

—OF THE—

## LONG ISLAND BRANCH

—OF THE—

### Woman's Auxiliary to the Board of Missions.

---

#### CONSTITUTION.

##### ARTICLE I.

This Association shall be called the LONG ISLAND BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

##### ARTICLE II.

Its object shall be to work in connection with the Woman's Auxiliary to the Board of Missions, the field being co-extensive with the Church, diocesan and general. The methods by which the ends of this organization can be promoted, are the raising of money for the support of Missionaries and teachers for the education of those who may be preparing for the work, and for other benevolent purposes connected with Missions ; the making, collecting and transfer of clothing and other material aid, and the circulation of papers and leaflets that may serve to stir up a public interest in the Missions of the Church.

##### ARTICLE III.

The Association shall consist of all delegates representing parishes in the Diocese, said delegates being appointed by the rectors of such parishes, each delegate paying an annual due of one dollar. There shall be at least two, and not more than five, delegates from each parish.

## ARTICLE IV.

The officers of this Association shall be a President, Vice President, Secretary and Treasurer.

There shall be, moreover, an Advisory Board, consisting of the above-named officers and five delegates, appointed by the President.

## ARTICLE V.

It shall be the duty of the President to preside at the business meetings of the Association and of the Advisory Board, to call special meetings of the same when occasion shall arise, to countersign all drafts upon the Treasurer, and to obtain fresh information from Missions, to be read at the stated meetings of the Association.

## ARTICLE VI.

It shall be the duty of the Vice President to preside, in the absence of the President, over the meetings of the Association and of the Advisory Board.

## ARTICLE VII.

It shall be the duty of the Secretary to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary, to keep minutes of the proceedings of the Association and of the Board of Managers, to send out all notices of the stated and special meetings of the same, and to keep a fair record of all Missionary Box Reports; also to prepare an Annual Report.

## ARTICLE VIII.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association and to pay all drafts upon the funds, when countersigned by the President, and to present an Annual Report.

## ARTICLE IX.

Any parish in the Diocese too remote for representation, shall, on the annual payment of not less than two dollars, be entitled to report its work to this Association.

## ARTICLE X.

The Constitution shall not be altered, except at an Annual Meeting of the Association—notice of the proposed change having been given at a stated meeting of the Association.

## BY-LAWS.

## I.

There shall be an annual meeting of the Association on the second Thursday of May, in each year, at such hour and place as the Advisory Board shall direct.

## II.

The election of Officers shall take place at such meetings, and they shall continue in office for one year, or until their successors shall have been appointed.

The election of officers shall be by ballot ; nominations to be made in writing and delivered to the Secretary by the delegates at the annual meeting. Only those persons so nominated shall be eligible for election, the two receiving the largest number of ballots to be the candidates.

## III.

In case of the vacancy of any office, by the death or removal of its occupant, the same may be filled at a stated meeting of the Advisory Board, and any one so appointed shall continue in office until the next annual meeting of the Association.

## IV.

All persons contributing to the treasury, annually, at least the sum of one dollar, shall be members of the Association, but not entitled to a vote.

## V.

The stated meetings of the Association shall be held on the second Thursday of each month, except that the November meeting shall take place on the first Thursday of the month, the second Thursday being the Anniversary. Place of meeting to be determined by Association.

There shall be no stated meetings in June, July, August or September.

## VI.

In all matters of importance, a resolution shall be brought before the Association to be deferred to the next meeting for decision, unless passed by a unanimous vote.

## VII.

At a meeting of the Association any number of delegates present shall constitute a quorum for the transaction of business; and at the annual meeting of the Association, a number of delegates equal to one-half of the number of parishes represented therein, shall constitute a quorum for the transaction of business.

## VIII.

At the monthly meetings of the Association the order of business shall be: 1. Devotional services. 2. Calling of the roll. 3. Minutes of the last meeting. 4. Treasurer's report. 5. Intermission. 6. Reports of Parishes and Committees. 7. Unfinished business. 8. Miscellaneous business.
