## “Bring them hither to me”

The Woman's Auxiliary asks the prayers of the Church on the Festival of the Transfiguration of Christ (August 6th), the Auxiliary's “Altar Day.”

The following resolution was unanimously adopted at the Annual Meeting of the Woman's Auxiliary, St. John's Church, Los Angeles, May 24, 1898, and endorsed the following day by the Diocesan Convention, with the addition that where practicable the offerings be devoted to the General Fund of the Woman's Auxiliary, viz.:

*Resolved*, That we set apart the Feast of the Epiphany for an Auxiliary Day, and that, as members of the Auxiliary, we consider it not only a privilege but a duty to attend the services held on that day in the parish to which we belong; and further,

*Resolved*, That should the appointment of this day meet with the approbation of the clergymen of the Diocese, they be requested to offer, at the celebration of the Holy Eucharist on the Feast of the Epiphany, special prayers for the work of the Auxiliary.

## Report of the Twenty-eighth Annual Meeting.

---

ST. JOHN'S CHURCH,  
Los Angeles, January 29, 1924.

The Twenty-eighth Annual Meeting of the Woman's Auxiliary of the Diocese of Los Angeles opened with a celebration of the Holy Communion at 9:00 a. m. The celebrant was the Right Rev. Joseph H. Johnson, the Bishop of the Diocese. He was assisted by the Right Rev. William Bertrand Stevens, the Bishop Coadjutor, and the Rev. George Davidson, D.D., the Rector of the Parish.

At the close of the service the meeting was called to order by the President, Miss Helen G. Magill.

Miss Magill, before calling for the reports, spoke with keen regret of the resignation of the Recording Secretary, Mrs. Franklin Dill Simons, who, because of illness in her family, has been obliged to give up her work and is at the present in Honolulu, where, it is hoped, her loved ones will be restored to health.

Mrs. Josiah E. Cowles was asked to read Mrs. Simons' report of the year's activities and Mrs. Page Brown to serve as Recording Secretary *pro tem.*

Following the reading of the Secretary's and Treasurer's reports which were accepted, reports were submitted by the District Vice-Presidents and other Diocesan Officers which showed increased interest in all departments. The two most notable being the Educational work under Miss Rebekah L. Hibbard's direction, and the United Thank Offering, the Treasurer, Mrs. C. W. Stockton, tells us, far exceeds any previous year.

Other reports of interest were read by Mrs. Spencer H. Smith for the Seamen's Church Institute; Mrs. W. Bertrand Stevens for the Girls' Friendly Society; Miss Anne Patton reading the Rev. J. M. Yamazaki's report of St. Mary's Japanese Mission, especially interesting, because it represents the completion of ten years' work in that Mission.

Upon motion, all reports were accepted.

The taking of pledges followed; 308 delegates from 51 parishes responded to roll call.

Attention was called to the presence of two visitors, Mrs. Charles S. Williams, of Michigan, and Miss Maurice, Directress of the Church

School Service League. These visiting members were cordially greeted by the President.

Notice was called to the meeting of the Provincial Synod in San Jose, from May 21st to 25th, with the request that as many as possible attend. Also a meeting of the Interdenominational Missionary Prayer Society on March 7th in this city.

Announcement was made that two recently returned missionaries, Miss Velma Wood from China and Miss Ruth E. Reynolds from Honolulu, were available as speakers; Miss Wood being reached through the Rev. Stephen Clark, Jr., Pomona; Miss Reynolds, the Deaconess House, 542 South Boyle Avenue, Los Angeles.

The President announced that a National Committee to promote interest in the *Spirit of Missions* had been appointed and that she had been placed in charge as National Representative of the Eighth Province. Miss M. E. Elliott appointed by her to represent this Diocese.

A letter from the Provincial President, Mrs. Wilson Johnston, was then read by Mrs. Josiah E. Cowles.

Dr. Davidson announced a luncheon prepared by St. John's Woman's Guild would be served in the Parish House during the noon hour. The Deaconesses of the Diocese were invited to be guests of the Auxiliary and the Clerica the guests of Mrs. Joseph H. Johnson.

Attention was called to exhibits in the Parish House of Altar linens and furnishings, arranged by the Altar Directress, Mrs. Robert Carr Block, and of books and Church literature in the interest of the Educational Department, arranged by Miss Rebekah L. Hibbard.

Noon-day prayers were read by Dr. Davidson.

At 2:00 o'clock the meeting was again called to order by the President.

Dr. Davidson then greeted the Auxiliary most happily and cordially. Continuing in a more serious vein, he reminded the members of their responsibility as Auxiliary women to uphold and help the Field Department of the Church, that is, in emphasizing the need for each parish meeting its full apportionment toward the Nation-Wide Campaign.

The annual address of the President was a clarion call to arms, not only along the line of material accomplishment, but for a deeper, more spiritual life and a closer observance of the special Auxiliary days—Quiet Day, The Feast of the Epiphany and The Festival of the Transfiguration of Christ, days so often overlooked in the stress of present day life.

Mrs. W. A. Holt gave an interesting talk on "The Home for the Aged," which this year shows a real achievement in, that nine persons

have found a "haven of rest" in a real home. This number to be shortly increased to twelve, and as funds permit, others out of a long waiting list will be cared for.

Deaconess Julia Clark, who shortly returns to China, told of her work in Wuchang. Particularly interesting was her description of an annual meeting of the Woman's Auxiliary where all the delegates were Chinese women.

Dr. Reifsneider, President of St. Paul's University, Tokio, Japan, gave a most comprehensive and illuminating review of the work accomplished by the Church through her schools, colleges, hospitals and other avenues of expression. With all that has gone before, Dr. Reifsneider tells us our task has just begun as the Church's purpose in Japan is to develop a native Church—Christianity, to become the national religion of Japan, must be accepted by strong national leaders and interpreted by them to their own people, and our task is to educate and develop such leaders, which we can best do through our own institutions. "The American Church's Christian opportunity and privilege then is to so strengthen the missionary area of the Japanese Church and that the vision of the Japanese Church officered by native bishops and priests will become a reality."

Bishop Johnson, following, spoke of the peculiar ties binding us to Japan through the faithful services of two of our own women, Mrs. Hubbard and Miss Patterson, who in the past did so much for our own Japanese Mission. Dr. Reifsneider, the new Bishop-elect of Japan, Bishop Johnson says, in a way belongs to us, and in whom we deeply rejoice.

Before appointing the officers for the ensuing year Bishop Johnson spoke with great regret of having to accept the resignation of the Recording Secretary, Mrs. Simon, whose faithful service for the past ten years has so endeared her to us all. Her successor has not been appointed as yet. Mrs. George Edward Swan succeeds Miss Josephine E. Wheelock as Church Periodical Secretary. Miss Wheelock, though resigning last year, has been most kind in keeping the work together until her successor was appointed.

With these exceptions, the Bishop reappointed all officers.

The offering for Dr. Reifsneider's work amounted to \$112.05.

The meeting closed with the Bishop's benediction.

There have been held, during the year, eight regular business meetings of the Woman's Auxiliary; six Diocesan meetings, and the Advent Quiet Day.

The first Diocesan meeting of the year was held at St. John's Parish House, February 13.

The devotional service was conducted by the Rt. Rev. William Bertrand Stevens, Bishop Coadjutor of the Diocese.

It was a very great privilege to have the Auxiliary addressed by the Rt. Rev. G. O. Mosher, Bishop of the Philippine Islands. "The field for service," said Bishop Mosher, "is limitless. Money is scarce and workers few. Despite these two great handicaps, a marvelous work among the Igorotes has been accomplished in twenty-five years, and the work of the Church is forging ahead."

The Diocesan meeting of March 13 was held in St. John's Parish House. Deaconess Julia A. Clark, Missionary to China, gave an exceedingly interesting talk on the "General Work of the Church in China." Of special interest was a report of a wonderful work carried on at St. Elizabeth's Hospital. "The success of the work of the Church in China depends on the interest, thoughtfulness and liberality of the English speaking peoples."

The April meeting was held at St. Mary's Japanese Mission and proved to be one of the most inspiring and enthusiastic meetings of the year. The chapel services occupy a distinct place in the training and development of the Japanese children. A group of Japanese boys and girls sang several missionary hymns, the sweet young voices carrying the melodies true and clear.

After the meeting was adjourned, the Japanese women served tea and rice cakes.

June 13, the Diocesan meeting was held in St. John's Parish House.

The Rev. Robert L. Windsor conducted the devotional service.

After several months' absence, Miss Helen G. Magill presided at the meeting and was most cordially greeted by the Auxiliary.

The President suggested for summer reading, "The Church's Program."

It is a great pity that more could not have heard the earnest address of Mrs. Grafton Burke, Missionary to Alaska. It was a most

thrilling and picturesque story of devoted work. The Hospital and Mission at Fort Yukon, the special work allotted Dr. and Mrs. Burke. The story of the solarium and its use in many cases of tuberculosis reads like a miracle and the visits of the Doctor to a patient five hundred miles away makes one realize that this is still a world of heroes.

October 9, the Diocesan meeting was held in SS. James' and Barnabas' Parish House.

The devotional service was conducted by the Rev. Geo. Churchill Rafter, Assistant Rector of SS. James' and Barnabas' Church.

The Rev. Mr. Rafter spoke briefly of the Japanese Emergency Relief Fund, saying, in part, "The Board of Missions has sent out a call for \$500,000.00 to be used in Japanese relief work. The important thing to remember is that our effort to give immediate relief must of necessity be followed later on by the hard and steady work of rebuilding in worthy form, all the agencies the Church has lost."

The Rev. Harold Kelly made a short address on the "Seamen's Church Institute at San Pedro."

The work had its beginning in an old abandoned residence with a marvelous marine view.

"The port of Los Angeles is visited by from 500 to 700 vessels every month, employing from 10,000 to 25,000 seamen.

"The Seaman's Church Institute means safety, comfort and inspiration, for it extends to all seafarers a hearty welcome regardless of nationality or creed."

The benediction was pronounced by the Rev. Mr. Rafter.

The meeting of November 21 was held in St. John's Parish House. The meeting was opened by the singing of the hymn, "Jesus Shall Reign." Following the Rector of St. John's Church, the Rev. George Davidson, D.D., conducted a short devotional service.

Miss Grace Lindley, National Executive Secretary, addressed the Auxiliary, speaking briefly of the several departments of the general work of the Church. Miss Lindley was most enthusiastic in expressing her gratitude for the wonderful response to the call for Japanese Emergency Fund.

"God has a plan, and the women of the Auxiliary are the agents to carry out the plan. The Auxiliary has always stood for the fact that the whole world is kin."

Miss Anne Wilson Patton gave an interesting report of the Provincial meeting held in Fresno, October 17 to 21.

Dr. Davidson pronounced the benediction.

The annual Advent Quiet Day was held in St. Matthias' Church, Tuesday, December 11. There was a celebration of the Holy Communion at 9:30 a.m., the Rt. Rev. Joseph Horsfall Johnson, the Bishop of the Diocese, celebrant, assisted by the Rector of St. Matthias' Parish, the Rev. Irving Spencer.

A short recess followed, so those who desired might accept the general invitation to breakfast, served in the Guild Hall.

The meditations conducted by the Rector of St. Matthias' Parish touched a note of rare spiritual quality. The text from St. Paul, "My Helpers in Christ," was developed to a most beautiful completeness.

It is with some satisfaction your attention is called to the Japanese Emergency Relief Fund.

The first day of October the Secretary sent notices to every branch of the Woman's Auxiliary in the Diocese requesting them to call special meetings and to give this urgent need immediate consideration.

The Diocesan officers were gratified with the very generous response, over \$2,000.00 was sent to the Treasurer in less than one month.

The reports of the Secretaries show increased results in every department of the work.

Let us strive to make the next year's work definite and spiritual, and filled with enthusiasm and faith. Divine love and sympathy in our hearts, we may go forth with spiritual power to accomplish all things, keeping in mind this thought, "The steady upward pull of good lives is the greatest force in the world."

## Report of Box Work.

"Marching on" is still the watchword for the capable branch of the Woman's Auxiliary of this Los Angeles Diocese. The efforts show wonderful results of your labors. The shipment for Alaska was sent on its way to the north in May, partly by freight and partly parcel post, to Allakaket, St. John's-in-the-Wilderness; for we had such a goodly supply we deemed it wise to share your generosity, for Deaconess Thayer's work at Allakaket. For the packers it made the work more difficult; as the shipment to that point could not go by freight; so forty-five bundles were sent parcel post. We also sent to that mission a box of candy. To Eagle, Alaska, were given thirteen bales of clothing, including house supplies and knitted articles, a box of medicine, a box of mop sticks, one of candy, one of toys, and shoes. In that shipment we also sent to the five daughters of a miner, living near the mission, at Eagle, complete outfits. Four of our branches making up these outfits for the young women. The total valuation of the Alaskan output was \$5,792.07. One of the branches as their Lenten work prepared five thousand gauze compresses, which we sent to Dr. Fullerton, in charge of St. Elizabeth's Hospital, Shanghai, China, valued at about \$120.00.

The work for Advent is equally as splendid. Fourteen of our Diocesan missionaries have had every wish gratified; and besides, we have done better than last year, for instead of three, we have taken four missions outside of our Diocesan limits. One going to Idaho, one to Spokane, one to Utah, and one to a returned missionary from Japan. Ten branches prepared full boxes. Two of them, not only gave one, but two each, showing a beautiful Christmas spirit of sharing joys with others. But as one of the recipients expressed it, "She felt that the love which had prompted the gifts would warm her heart for the rest of her life." To quote from a letter from another missionary not in the Diocese, "How can I ever thank the ladies for their kindness and generosity in sending me such a wonderful box; please convey to the members of the Auxiliary my warmest thanks, I wish I could thank each one personally." So we feel that the year 1923, owing to your efforts, has come nearer to fulfilling our ideals than in former years. I, as your custodian, am most grateful for making our Auxiliary so worth while.

## Report of the Altar Department.

---

Since last January the Altar Department of the Woman's Auxiliary has given furnishings and vestments to the various Missions, as follows:

To St. Luke's, Calexico, an altar.  
To St. Mark's Mission, East San Diego, an altar, priest's stand and chair.  
To National City, hymnals.  
To Mission at Chula Vista, hangings, linen, burse and veil.  
To St. Andrew's, Fullerton, linen, eucharistic lights.  
To Trinity, Orange, cassock, surplice and girdle, with a pledge of \$12.50 to assist in purchase of eucharistic lights.  
To Trinity, Escondido, dossal, vases and linen.  
To El Monte, litany desk.  
To Fr. Ruggles' work, cross and light for nurses' chapel at hospital; cruets for Olive View Sanitarium; lights, linen, cottas, hymnals, Bibles and Prayer Books for County Farm.  
To work of the General Missionary, silver and linen for St. Paul's, Lancaster; linen for the Mission at El Serena.  
To St. Peter's, Santa Maria, eucharistic lights.  
To St. Barnabas' Mission, Pasadena, hangings and linen.  
To Deaconess Clark's work in China, set of linen.

The Altar Department hopes soon to be in possession of a portable altar, such as was used by the chaplains in the army. This altar will be loaned to newly organized Missions for a definite time, thus making possible a reverend and orderly service until the Mission is properly housed, and is able to provide somewhat for its own maintenance.

There has been a decided decrease in the gifts and pledges this year. Only thirteen parishes have responded with gifts of furnishings and linen. The fact that three of the largest parishes are in the act of building has possibly had some effect. They have promised to especially remember the Altar Department when their new churches are completed. There is encouragement in the fact that three Altar Guilds organized during the year are not only doing beautiful work for their own parish, but giving of their labor to the new Missions. Would it not be possible for each Altar Guild to make one gift of work during the year. The pledges provide the purchasing power for supplying the large needs, but it is the personal work which brings us in closer touch and gives the enthusiasm which makes it a privilege and joy to provide for the reverent service of the Altar.

The Directress wishes to especially thank Mrs. Evans for her kindness in giving such helpful information about the work of the Department, and also for the carefully thought out and complete arrangement of books and papers.

### Report of the Educational Secretary.

---

Nineteen hundred and twenty-three has been a full year for the educational work, the following parishes and missions responding with a finer spirit of co-operation and understanding than ever before:

**Study Classes or Discussion Groups**—Anaheim, Carpinteria, Corona, Hemet; Los Angeles: St. Athanasius', SS. James' and Barnabas', St. Paul's Pro-Cathedral (three classes—one St. Perpetua's Guild), and Mission of the Redeemer; Pomona, Redlands; San Diego: St. Paul's and All Saints' (two Bible groups); Santa Ana, Santa Barbara (three groups), and Santa Monica.

**Program Meetings**—Carpinteria; Los Angeles: St. Athanasius', SS. James' and Barnabas', St. John's, St. Luke's, and St. Thomas'; Ontario; Pasadena: All Saints'; Pomona, Redlands, Riverside, Santa Barbara, South Pasadena, and Upland.

**Reading Circles**—Eagle Rock, La Jolla; Los Angeles: St. Athanasius'; Montecito, San Bernardino; San Diego: St. James' and Chula Vista; Santa Barbara, Watts and Wilmar—the last two so ably cared for by Deaconess Miller.

This makes a total of twenty study classes, fourteen program meetings, and ten reading circles; and represents the work of thirty-two parishes and missions—ranging all the way from the new branches at St. James' and Chula Vista, San Diego, to the banner branch at Santa Barbara, which reported three study groups, program meetings, and a reading circle. The subjects used last winter were "Wanted

Leaders! A Study in Negro Development," the Bible, and Current Church Topics; followed this fall by "The Story of the Program," and the fascinating and compelling text-book for this year, "Creative Forces in Japan," by Galen M. Fisher.

In regard to this book twelve branches are already prepared for its study, and I hope that many others will consider this not only a Lenten duty, but a Lenten privilege. As Miss Tillotson, National Educational Secretary of the Woman's Auxiliary, wrote from New York, "It seems, in a very real sense, providential that our new subject this year should be Japan. We shall be studying it in company with most of the other Communions in this country, as well as those in Canada and England. It should mean much to stricken Japan and to the struggling Japanese Church that so great a body of Christians will be attempting to understand their problems better and praying for them in this hour of their especial need. We hope that more study classes than ever before will be held; also that there may be a sale of the text-books and the supplementary books among men and women who may not be in the study groups. Let us pray more fervently, remembering Phillip Brooks' beautiful words, that we may have, not 'tasks equal to our powers,' but 'powers equal to our tasks.' "

## Report of St. Mary's Japanese Mission.

---

Since Miss Lenox, our former missionary teacher, left us last June, I presume there has not been any report on St. Mary's Mission presented before the Woman's Auxiliary, so allow me to write you a few lines of a brief account of how the works in our Mission by the earnest support of your Auxiliary are getting on.

The first thing I want to report with gratitude is that we were fortunate in getting the service of Miss Mabel Morehouse to succeed Miss Lenox. Miss Morehouse is a trained nurse and is a good musician. So she is fitted to take care of those children who come to our kindergarten, whose ages vary from two and one-half to five years. She makes calls regularly on mothers of the children, and the mothers' meeting we hold once a month has an attendance of from 30 to 40 Japanese mothers. We provide a good program with music and lectures on the subjects of religion, education, hygiene and Americanization, using for illustration moving pictures and various charts prepared by the United States Government.

We now have thirty-five children in our daily kindergarten and thirty-four in our afternoon Parish School. The result of this school work is not only to prepare the children in English, but it opens the way for children and their mothers to come to the Church. Our Sunday-school receives its new scholars continually from the kindergarten, and it has now 135 pupils enrolled, with average attendance of 110 every Sunday. We have two American teachers and eight Japanese teachers in our Sunday-school. To one of the American teachers (Mrs. H. Ivor Thomas) who has voluntarily taught our primary class for three years, we owe much of our success.

Above all I am very thankful for the generous aid given to our work by the Woman's Auxiliary during the last year. I have not acknowledged individually to each branch of the Auxiliary the sending to us of pledges through Mrs. Leonard, so I take this opportunity to thank the members of the Auxiliary who sent us their help to keep up and improve our work. I am very happy to tell you that by the help of your Auxiliary we have made a great improvement in our Parish Hall which is used for a school room. We hear no more complaints from either teachers or scholars. Such remarks as "it's too cold to teach in such a place," or "it's cruel to keep children in such a hot

place," can never be heard now. We have two large gas heaters of the best type costing us \$130.00; a double roof on the hall, \$376.00; walls plastered and playground spread with gravel. So you can imagine how glad I am to have these things added—to carry on the work efficiently.

As to our workers, we have besides Miss Morehouse, and Mrs. Yokota, who is an assistant to Miss Morehouse, another Japanese worker, Mr. Hayashi who teaches the afternoon class, drives the Ford to gather and send back kindergarten children every day, does some janitor work in the Church and serves as lay-reader. His salary, together with running expenses of the school and the Ford, must be met by the members of St. Mary's Mission, who are not yet strong both in number and finance. Besides we have work other than the educational, *i.e.*, visiting the sick, helping new comers and strangers, and general rescue work of both men and women. We are looking forward to distributing the tracts of Christian religion and the Church instruction. These works are done besides my regular parochial duty. Do you not think this is a worthy cause which deserves the support of your Auxiliary?

So, pray accept my sincere thanks to you and to all the members of the Woman's Auxiliary for their full-hearted support given to St. Mary's Mission to enable me to continue this worthy work carried on in His Name for the people who need His Gospel most.

Again, let me thank the members of the Auxiliary for their earnest support and great interest given in the welfare of St. Mary's Mission and of myself, for I am very happy to tell them that I have completed my ten years' service after my ordination in the Church in the Diocese of Los Angeles, and the Woman's Auxiliary has for these years stood by me.

The Girls' Friendly Society does some of its Box work through the Woman's Auxiliary. This year that for Alaska was valued at \$127.85. Work was also sent to Ketchikan, Alaska, by the Branch at the Church Home for Children, value \$30.00, and to Besao, P. I., valued at \$40.00.

Total value for Box Work for the Diocese .....\$250.56

"Missionary Pennies" are collected each year, for a bed at St. Luke's Hospital, Phoenix, Arizona. For this fund in 1923 was collected \$95.20.

Total Missionary Gifts.....\$ 705.66

Total Social Service Gifts..... 596.54

Total Gifts to Lodge..... 1,014.55

These figures have had to be made up with two Branches not yet heard from. The gifts mentioned for the Lodge are only those really

earned by the Branches, not money given by individuals, such as Associates or others, for the credit of the Branch.

The opening of the Lodge in June has been the great outstanding event of the past year.

The Lodge is located at 1422 West Third Street, on the highest point of Crown Hill, with a beautiful view of the mountains, with plenty of fresh air and sunshine, surrounded by lovely old trees and an old-fashioned garden. The grounds are spacious enough to allow of any possible extension for future needs. The property is valuable, and becoming more so every day, as that part of the city is developing rapidly.

There are two buildings on the property, one the old Witmer residence, remodelled to meet our needs, accommodating twelve girls and the housemother. The second, the old stable, just nearing completion, which has been remodelled into sixteen single and four double rooms, and to this is to be added a laundry, as all the girls wish, and in fact, have to do their own laundry work.

The Lodge is for employed girls, over sixteen years of age and under thirty-five and unmarried. All girls may stay at the Lodge, no matter what their religious affiliations, only that the Girls' Friendly Society member has the preference. The rates are \$9.00 per week for room and board.

The Home is under the care of a Housemother, acting under a Board of Managers, which in turn acts under the Diocesan Council of the Girls' Friendly Society of the Diocese of Los Angeles.

The Lodge carries itself in so far as its running expenses are concerned, which does not however include taxes, new buildings, interest on the mortgage, payments on the principle or insurance.

## CONSTITUTION.

---

I. This Society shall be called THE LOS ANGELES BRANCH OF THE WOMAN'S AUXILIARY TO THE PRESIDING BISHOP AND COUNCIL.

II. The object of the Society is: By systematic and united effort, to diffuse missionary intelligence, to increase missionary activity among the women of the Diocese, to promote the study of missions, and to encourage prayer for missions.

III. The Church itself is the great Missionary Society, and every person, by baptism, becomes a member of this Society; therefore, every baptized woman in the Diocese is a member of the Woman's Auxiliary. But terms of membership in any parish branch shall be fixed by that branch.

IV. All Parish Societies that so desire may become branches of this Auxiliary, first obtaining the consent of the Rector or Clergyman-in-charge, by appointing a Secretary and notifying the President of their intention to work in unison with the Auxiliary.

V. A President, a Vice-President-at-Large, a Vice-President, a Vice-President over such divisions of the Diocese as the Bishop may counsel, a Corresponding Secretary, a Recording Secretary, a Treasurer, a Directress of the Altar Department, a Correspondent of the Church Periodical Club, a Secretary of the Missions Classes, and an officer over any other department that may be formed, shall be appointed by the Bishop.

VI. The Annual Meeting shall be held at the time of the Diocesan Convention, and Quarterly Meetings on such dates and in such places as the President may appoint. General meetings may be arranged by the Vice-Presidents, in their respective districts.

VII. An Annual Quiet Day shall be held during the season of Advent.

---

## BY-LAWS.

---

1. The duty of the President shall be to preside at the meetings of the Society, and have general charge of the work, under the direction of the Bishop. The Vice-President shall act for the President in her absence, and assist her in the care and oversight of the work.

The duty of the other Vice-Presidents shall be to preside in the absence of the President at the general meetings held in their several charges, and to co-operate with the President in the supervision of the work of the Auxiliary in the sections to which they respectively belong.

2. It shall be the duty of the Corresponding Secretary, under the direction of the President, to correspond with the General Secretary of the Auxiliary and the various branches of the Diocese, to furnish them with work, to collect their reports, and to prepare an annual report.

3. The duty of the Recording Secretary shall be to give notice of meetings, to keep a record of such meetings, and to prepare an abstract of the minutes for the annual report.

4. The Treasurer shall keep an account of all moneys received and expended, and make a report at the Annual Meeting.

5. The Directress of the Altar Department, the Correspondent of the Church Periodical Club and the Secretary of the Missions Classes shall superintend their several departments, in consultation with the other Diocesan Officers.

6. The Secretaries of Parish Branches are required to correspond with the Diocesan Officers, who *alone correspond* with the General Secretary and the Secretaries of the Board of Missions, and to transmit to them all moneys.

7. Each Parish Branch shall make an annual pledge, according to its ability, to the current expenses and work of the Diocesan Branch, and also to the Bishop's Missionary Fund for Diocesan work.

8. At the Annual Meeting each branch represented shall be entitled to but one vote on business of general import.

9. All moneys collected for the United Thank Offering Fund shall be paid to the Diocesan Treasurer of that fund, and by her paid to the Auxiliary Treasurer.

*This Constitution and By-Laws may be amended by a motion made at the Annual Meeting, and voted on the following year.*

## President's Address.

---

*To the Presiding Bishop, Council and Officers and Members of the Woman's Auxiliary:*

There are many things I am asked to speak of, and much I would like to say, but our time is short, and we have interesting speakers for the afternoon, so I will only say a few words. I think the time has come when we ought to have a two-days session, then we could have some discussion classes, and officers' conferences, and be less hurried, and so make our annual meeting of real practical help to us. That is something to think about, and I hope, during the coming year, you will talk it over, and let us know if you think such meetings would be valuable. I want to express at this time my gratitude to all the Diocesan officers for the kind and efficient way in which they took up my work last winter, adding my work to theirs and doing it so well that all anxiety was taken away from me. I also want to thank you for your sympathy and for your loyalty to the work while I was so long unable to do my part. Another year has slipped away and we have the same report to make, of work accomplished, pledges paid, and new workers taking their places among us. The officers' yearly reports and treasurer's figures that you heard this morning tell what has been done, and now with a clean slate before us we are ready to begin again. What shall we plan for the coming year? Of course, we mean to do all that we have done before, and a little more we will never feel satisfied, unless each year sees a little more accomplished, a little more of ourselves given to the work and a greater desire to be a more helpful Auxiliary than we have ever been. It is now nearly a year and a half since our last Triennial and here in this Diocese we have done nothing about the "Auxiliary Special." This has not been your fault, various things happened to make us put the Special in the background, but now the time has come when we must give it consideration. Most of you know I feel sure of what I am speaking, but there may be some new members here not yet quite familiar with our work, so I will give a brief explanation. At every Triennial meeting the Auxiliary takes something new to work for during the following three years, this is called the "Auxiliary Special," as it is over and above everything else we do.

This triennium we are trying to raise \$75,000.00, or more, to start two Church Houses, one for white and one for colored women. These houses are to be for women who volunteer for Church work where they may live, and under the direction of a trained educator, prepare themselves for their work. Missionaries home on furlough may also stay there while doing special work. The home for colored women will probably be in Raleigh, North Carolina. There living together under Christian influence, they will be directed and trained, so that they may be well fitted to work among their own people. The other house will be in New York, near the Church Missions House, where in such a missionary atmosphere they may receive inspiration for the work they are preparing themselves to do. This "Special" will be in loving memory of the Rt. Rev. Daniel Sylvester Tuttle, D.D. Its object is twofold, "first, to show our love and appreciation of him, who did so much for the missionary work of the Church; and secondly, to further develop the work to which Bishop Tuttle gave his life by making it possible for our women workers to secure more efficient training than in the past." We ought in this Diocese to raise about \$1,500.00 toward that fund, more if possible. Mrs. Frederick N. Blick, 798 Stevenson Avenue, Pasadena, is the representative of that fund in this Diocese. Write to her for further information.

Now I want to say a few words about something greater than money. In one very important matter, indeed, in the most important part of our work I sometimes feel that we are not doing as we ought. I fear we are letting our work take first place in our hearts, forgetting that it is required of Auxiliary members that they pray as well as work and give. Our constitution demands that we have in Advent of each year a "Quiet Day" when we may go apart for prayer and meditation, thus emphasizing the spiritual life and gaining strength and wisdom for the work we have to do. We have that "Quiet Day" each year, but I regret to say that year by year the attendance at that service grows smaller and smaller. The Feast of the Epiphany and the Festival of the Transfiguration are days when the Auxiliary especially asks the prayers of the Church for her work. Have we forgotten that also? Let us remember this year that prayer comes first, and doing and giving follow.
