## “BRING THEE HITHER TO ME”

The Woman's Auxiliary asks the prayers of the Church on the Festival of the Transfiguration of Christ (August 6th), the Auxiliary's “Altar Day.”

The following resolution was unanimously adopted at the Annual Meeting of the Woman's Auxiliary, St. John's Church, Los Angeles, May 24, 1898, and endorsed the following day by the Diocesan Convention, with the addition that where practicable the offerings be devoted to the General Fund of the Woman's Auxiliary, viz.:

*Resolved*, That we set apart the Fast of the Epiphany for an Auxiliary Day, and that, as members of the Auxiliary, we consider it not only a privilege but a duty to attend the services held on that day in the parish to which we belong; and further,

*Resolved*, That should the appointment of this day meet with the approbation of the clergymen of the Diocese, they be requested to offer, at the celebration of the Holy Eucharist on the Feast of the Epiphany, special prayers for the work of the Auxiliary.

Grant that to many hearts may go the call of opportunity to serve Thee in this work, in the bearing of others' burdens and the fulfillment of the law of Christ. In what they think and do, enable them to hear the voice of Thy Son to guide and strengthen them. And in all the means of grace in Thy Church, and more especially in the Holy Communion at Thy Altars, help them to see Him Who is invisible, that in their aims and difficulties and trials they may have the abiding faith that all things are possible to them that believe. We ask this for the merits of Him Who came not to be ministered unto, but to minister, Thy Son, our Saviour, Jesus Christ. *Amen.*

## Report of the Thirty-first Annual Meeting

---

ST. PAUL'S CATHEDRAL,

Los Angeles, January 25, 1927.

The Thirty-first Annual Meeting of the Woman's Auxiliary of the Diocese of Los Angeles, was held Tuesday, January 25, at St. Paul's Cathedral and opened with a celebration of the Holy Communion at 9:30 a. m. The Rt. Rev. J. Bertrand Stevens, D.D., Bishop Coadjutor celebrated, assisted by the Very Rev. Harry Beal Dean of the Cathedral, The Rev. Dean Maimann and the Rev. M. Kane. Following this service the business session was held in the Cathedral House, Miss Magill presiding, Hymn 271 was sung and the Auxiliary prayer said in unison. It was the largest meeting in the history of this Auxiliary.

The Recording Secretary's report of the past year was read and accepted, then followed the reports of the Vice-President at Large. Mrs. Josiah Evans Cowles and the District Vice-Presidents, Mrs. Spencer H. Smith for Los Angeles and vicinity, Miss Jane Rouse, for Santa Barbara and vicinity. Mrs. G. A. Hanson, Riverside and vicinity and Mrs. H. W. Sinclair, San Diego and vicinity, were unable to be present. Their reports were read and accepted. Then came the reports of the different secretaries showing a marked growth in each department. The Treasurer's report was very fine, showing an increase of \$3000 over last year. Upon motion these reports were accepted. The time being very limited it was necessary to defer some of the reports until afternoon in order that the roll might be called and the pledges made. Several new branches have recently been formed and made their pledges for the first time. The noon-day prayers were read and the meeting recessed until 1:30 p. m.

The afternoon session opened promptly, Dean Beal made an address of welcome and spoke of the Bishops' Crusade. A resolution from the floor was offered that a message of sympathy be sent to Mrs. Johnson, expressing sorrow at the Bishop's illness, and regret that they could not be present. There was a rising vote, the resolution was adopted and the Corresponding Secretary instructed to write to Mrs. Johnson. The President made her address and spoke of the fine work achieved during the past year. Especially did she stress the work of the Country Parishes and Missions. In conclusion she said that the years that she had served as President

of the Auxiliary had been very happy ones. The first speaker of the afternoon was the Rt. Rev. Nathaniel S. Thomas, D.D., Missionary Bishop of Wyoming, whose work is among the Indians, and who painted a very vivid picture of their unjust treatment. By this time the meeting had grown so large people were being turned away, and at the suggestion of Bishop Stevens the meeting adjourned to the Cathedral where, during the singing of Hymn 268, the offering was taken up, which was to be divided between the two visiting Bishops for their work. We then had the pleasure of listening to the Rt. Rev. Peter Trimble Rowe, D.D., of Alaska, for whom the Auxiliary has worked so many years. He expressed his appreciation of what we had done, then told us of some of his recent work; the building of a school at Nenana, half of which will be paid for by the "Corporate Gift," and of a hospital at Wrangle. Following Bishop Rowe's address came the reports, for which there had not been time in the morning. Before appointing the officers to serve for the coming year, Bishop Stevens spoke with regret of the resignation of Miss Magill as Diocesan Auxiliary President and paid a tribute to the splendid work she had accomplished in the past six years of devoted service, the result of which was shown by the day's fine meeting of over 800 women. The Auxiliary gave her a rising vote of thanks. Bishop Stevens made the following appointments: Miss Rebekah Hibbard to succeed Miss Magill as President of the Auxiliary, Mrs. Harry Beal to succeed Miss Hibbard as Educational Secretary, Mrs. C. N. Henderson to succeed Mrs. Sinclair who resigned after many years of faithful and efficient service as Vice-President for San Diego and vicinity, Miss Mary S. Lynne as Assistant Directress of the Altar Department. All the other officers were reappointed. Miss Hibbard, Mrs. Beal, Mrs. Henderson were called upon to make a speech accepting their new offices which they did very briefly and graciously.

Mrs. Collins, a visiting Auxiliary President from Seattle, Washington, gave this Diocese a very cordial invitation to the next Provincial Synod. Meeting which will be held in Seattle this coming May.

All the business of the day being finished Bishop Stevens pronounced the blessing and the meeting adjourned.

## Report of Box Work

---

Last year, 1926, the Diocesan Lenten work was sent to the Mission of Our Savior, Tanana, St. Mark's Mission, Nenana, and the See House, Sitka, Alaska; we also sent to Deaconess Bedell, St. Andrew's Mission, Stephen's Village, Alaska, the medical supplies she had urgently pleaded for. Our generous Branches saw to it that we were supplied with sufficient funds to carry out her request and sent to her the entire list she asked for. Total valuation of the Alaska shipment, \$6,125.42. To St. Elizabeth's Hospital, Shanghai, China, was sent hospital supplies given by St. James' Branch, South Pasadena. The packing for Alaska was never done so expeditiously and satisfactorily as in April, 1926. Our efficient U. S. A. Army could not have done better with trained men to carry out the orders. The supply officers were more than grateful at the results of our wonderful packers sent out to us from the nearby Branches.

In June, Miss Wright of St. Mark's Mission, Nenana, wrote she did not have overalls enough to keep her boys in good condition and well clad for work and play. Could the Diocese of Los Angeles help her? We found fifteen boys needed six overalls for each age, ages from eight to sixteen. We had some cash left in our Alaska fund and sent to St. Mark's 100 overalls, costing \$125.00; a letter of great gratitude came later from Miss Wright. Also during Christmastide a Christmas card of greeting came from St. Mark's which the entire Diocese must share, as we owe to our branches the source of supply.

The Advent Work has been wonderful; we have supplied the needs for fourteen of our Diocesan missionaries, and outside the Diocese we have sent a box to South Dakota, and one to Oklahoma, also gave to a Catechist at Pine Ridge Agency, South Dakota, his suit and underwear, and to our woman missionary at El Paso, Texas, a Christmas present consisting of a subscription to two magazines she had asked for: Schibner's and The Home Journal. Seven branches took full boxes; two of them sending each, two boxes, one for our Diocese and one outside; St. Paul's at San Diego, and Branch B, All Saints, Pasadena. Fifty branches gave us cash to supply the articles for boxes not taken by any one branch, enabling us to get for our worthy missionaries clerical suits, shoes, etc.

This year our Lenten efforts are to be made for Alaska, as usual, namely, St. Timothy's Mission, St. Timothy's, St. Andrew's Mission, Stephen's Village, and for the Memorial Hospital at Ft. Yukon to uphold the work under Dr. and Mrs. Burke.

We have also been approached by the Missions House, New York, if we can help Dr. Teusler, at St. Luke's Hospital, Tokio, Japan. Last year the Diocese to which that appeal was assigned, fell down completely on the linen, and reported the matter so late that headquarters were unable to secure it elsewhere. Mrs. Wade wonders if we can manage to help out. Dr. Teusler writes they are sorely in need of blankets and must have at least one hundred single white blankets for adult beds, and he is also very short on bath towels and needs fifty dozen of these in good size. Can you not see that all your help in supplying what we need in carrying on this work makes you co-workers with us, and your part is the most important one, because our part is dependent upon you. We must not skimp Alaska, but can we not give St. Luke's a few dozen blankets, and not rob Peter, to pay Paul? Give a steady upward pull. Our big branches, think it over.

### Report of the Altar Department

Mission of the Good Shepherd, Hemet, candles.  
St. Phillip's, Los Angeles, surplice \$30.00 toward stoles for candidate for priest's orders.  
St. Barnabas' Mission, Pasadena, fair linen, crochet lace superfrontal, frontal, dossal, curtains, linen chalice veil.  
St. Cross, Hermosa Beach, linen, chalice veil, communion silver, cassock.  
Mission at Compton, fair linen.  
Brawley, El Centro and Holtville (Imperial Valley), frontal hangings, fair linen, silk burse and veil.  
St. John's, Sawtelle, set of linen.  
Mission at Torrance, lights.  
El Monte, baptismal bowl and shell, fair linen.  
Needles, cassock and surplice for lay reader.

Growth in the spiritual side of the work was shown by the number of women present at the Quiet Hour, October 27th, and their appreciation of the meditations given by Father Robertson and the inspiration which they brought. Nineteen parishes responded to the suggestion that members of Altar Guilds in the Diocese unite in special intersession on Thursdays for the Bishop's Crusade.

The Directress wishes to express to Miss Lynne grateful appreciation of the untiring care given the work during her long absence.

A class in Altar Guild work and ecclesiastical embroidery which meets at the Cathedral every Wednesday has given assistance to five missions and several parishes. With the rapidly developing country the missions are increasing and the demands are many, of your generosity, will you not remember them?

### Report of the Educational Secretary

---

During the year 1926 fine work has been done in the Educational Department, forty-one parishes and missions responding. Latin America was studied last winter by the following twenty-six

branches: Anaheim, Corona, Eagle Rock, Glendale, La Jolla, Long Beach, Los Angeles—Church of the Redeemer, Grace Memorial Mission, St. Anthanasius', St. James', St. John's, St. Paul's Cathedral, and St. Thomas'; All Saints', Pasadena; Pomona, Redlands (two groups), Riverside (two groups); St. Paul's, San Diego; San Gabriel, Santa Barbara, Santa Monica, South Pasadena, Upland and Venice. Classes on the General Church Program and other subjects were held at Coronado, Elsinore, East San Diego; Los Angeles—Chapel of the Advent, St. Matthias' and St. Stephen's; Ontario, Tujunga, Watts, Wilmar and Compton, the last four being under the leadership of Deaconess Miller.

Seventeen of the above branches, as well as Chula Vista, also had monthly Program Meetings or outside speakers on Current Church Topics. Reading Circles were held at St. Luke's, Los Angeles, and San Pedro; and Bible Classes at the Church of the Angels, St. Matthias', and St. Paul's Cathedral, Los Angeles. This makes a total of thirty-five Discussion or Study Classes, eighteen Program Meetings, two Reading Circles, and three Bible Classes. The Secretary wishes to thank all her co-workers, both leaders and members of classes, for making this record possible—especially Mrs. Cooper and Deaconess Miller, who went outside of their own branches, and Miss Dunlop for her work on the Speaker's Bureau.

A profitable Educational Conference was held at the Diocesan Summer School in June, thirty-seven attending. One member, Mrs. Cooper, also attended the National Educational Conference at Racine in September. The Educational Committee, consisting of Mrs. Cooper, Miss Dunlop, Mrs. Ruggles and Mrs. Vallat, has met for business the second Tuesday of each month at the luncheon hour. The Educational Department is also co-operating with the Diocesan Board of Christian Education in arousing interest in Parish Libraries. The following parishes reported libraries through the Woman's Auxiliary—Long Beach, St. Matthias', Los Angeles; Redlands, Santa Monica, South Pasadena and Whittier.

\$169.52 worth of books and leaflets passed through the hands of the Secretary during the year. A discount of 25 per cent was given on most of the material from the Church Book Store, New York, leaving a balance of \$32.00. This was used for postage, leaflets and other expenses. A Mission Study Offering, purely voluntary, of \$86.90, was made by the following branches—La Jolla, \$18.00; Long Beach, \$3.00; St. John's, Los Angeles, \$5.00; Redlands,

\$25.00; and Santa Monica, \$35.90. Long Beach and Redlands sent their offering to Bishop Colmore for work in Porto Rico.

The subject for study this winter, the Rural Problem in the United States, has been well called "the greatest neglected missionary field of today." Seventy-five copies of the textbook "Beyond City Limits" have already been sold and many branches have made plans for Epiphany and Lenten classes. Miss Laura Boyer, one of the National Educational Secretaries of the Woman's Auxiliary, will be in the Diocese the week of March 13th, and is planning to hold one day Institutes in each Convocation. A year of great promise and activity lies before us.

### Report of St. Mary's Japanese Mission

---

The noteworthy progress made in St. Mary's Japanese Mission, Los Angeles, during the year last past is first the progress of Sunday School enrollment from 185 to 250, pretty large Sunday School for a small Mission. There is no chapel to gather them all at one time, not enough class room and more teachers needed. Still we manage some way or other; every available space in the Mission and Rectory is used for Sunday School Class Room. One class of 16 is taught in our school bus. The Bible and Prayer Book Society of New York gave us 100 copies of both the New Testament and Book of Common Prayer, and St. James' Branch of Los Angeles Woman's Auxiliary, gave us 100 new Hymnals and 15 Hymnals with music; added to these gifts St. James' Branch gave us the complete choir vestments for six boys and six girls. These gifts enabled us to have, for the first time in our Mission, real Episcopal service with prayer book and hymnal in each pupil's hand who is permitted to enter the Chapel for worship. Our Chapel has capacity for 100 children, the rest of them are kept in the Parish Hall.

We keep up our Kindergarten, always with 45-50 daily attendance. One of the reasons why we have so many pupils in our Sunday School is because we have this daily kindergarten. Those who come to our Kindergarten, naturally come to our Sunday School and keep on as they grow up. There are eleven other Christian church missions for Japanese in the City of Los Angeles, and St. Mary has the largest Sunday School among them all. Japanese Union Church (Congregational and Presbyterian United) with best equipped church building at a cost of \$100,000, has only 150 pupils, and Christian Church with \$60,000 church building, has 200 pupils, M. E. Church with \$45,000 church building, has 180. So you can realize what good results are being obtained by your support of our Mission.

With the Junior girls we have formed a candidate class of the Girls' Friendly Society and Girls' Reserve, and with the Junior Boys we have organized Boy Scouts of America Troop No. 33 in our Mission. We have now 15 tenderfoots with a very able Scout Master who became an American citizen after being very honorably discharged from the American Expeditionary Army to which he volunteered at the time of the Great War.

So with your warm support we are doing continual good work for Christianization and Americanization of our people in this country.

During the past year we received the help through Mrs. Ray O. Miller, Treasurer, from the following branches:

St. Paul's, Los Angeles; St. Paul's, S. P. G.; St. Luke's, Long Beach; All Stains' Branch B, Pasadena; St. Mary of the Angels; The Messiah, Santa Ana; All Saints' Riverside; Trinity ,Santa Barbara; St. Matthias', Whittier; St. Thomas, Hollywood; St. Paul's, San Diego; Holy Trinity, Alhambra; St. Mark's, Upland; St. John's, San Bernardino; Good Shepherd, Venice; St. James', Los Angeles.

## CONSTITUTION

---

I. This Society shall be called THE LOS ANGELES BRANCH OF THE WOMAN'S AUXILIARY TO THE PRESIDING BISHOP AND COUNCIL.

II. The object of the Society is: By systematic and united effort, to diffuse missionary intelligence, to increase missionary activity among the women of the Diocese, to promote the study of missions, and to encourage prayer for missions.

III. The Church itself is the great Missionary Society, and every person, by baptism, becomes a member of this Society; therefore, every baptized woman in the Diocese is a member of the Woman's Auxiliary. But terms of membership in any parish branch shall be fixed by that branch.

IV. All Parish Societies that so desire may become branches of this Auxiliary, first obtaining the consent of the Rector or Clergyman-in-charge, by appointing a Secretary and notifying the President of their intention to work in unison with the Auxiliary.

V. A President, a Vice-President-at-Large, a Vice-President, a Vice-President over such divisions of the Diocese as the Bishop may counsel, a Corresponding Secretary, a Recording Secretary, a Treasurer, a Directress of the Altar Department, a Correspondent of the Church Periodical Club, a Secretary of the Missions Classes, and an officer over any other department that may be formed, shall be appointed by the Bishop.

VI. The Annual Meeting shall be held at the time of the Diocesan Convention, and Quarterly Meetings on such dates and in such places as the President may appoint. General meetings may be arranged by the Vice-Presidents, in their respective districts.

VII. An Annual Quiet Day shall be held during the season of Advent.

---

## BY-LAWS

---

1. The duty of the President shall be to preside at the meetings of the Society, and have general charge of the work, under the direction of the Bishop. The Vice-President shall act for the Presi-

dent in her absence, and assist her in the care and oversight of the work. The duty of the other Vice-Presidents shall be to preside in the absence of the President at the general meetings held in their several charges, and to co-operate with the President in the supervision of the work of the Auxiliary in the sections to which they respectively belong.

2. It shall be the duty of the Corresponding Secretary, under the direction of the President, to correspond with the General Secretary of the Auxiliary and the various branches of the Diocese, to furnish them with work, to collect their reports, and to prepare an annual report.

3. The duty of the Recording Secretary shall be to give notice of meetings, to keep a record of such meetings, and to prepare an abstract of the minutes for the annual report.

4. The Treasurer shall keep an account of all moneys received and expended, and make a report at the Annual Meeting.

5. The Directress of the Altar Department, the Correspondent of the Church Periodical Club and the Secretary of the Missions Classes shall superintend their several departments, in consultation with the other Diocesan Officers.

6. The Secretaries of Parish Branches are required to correspond with the Diocesan Officers, who *alone correspond* with the General Secretary and the Secretaries of the Board of Missions, and to transmit to them all moneys.

7. Each Parish Branch shall make an annual pledge, according to its ability, to the current expenses and work of the Diocesan Branch, and also to the Bishop's Missionary Fund for Diocesan work.

8. At the Annual Meeting each branch represented shall be entitled to but one vote on business of general import.

9. All moneys collected for the United Thank Offering Fund shall be paid to the Diocesan Treasurer of that fund, and by her paid to the Auxiliary Treasurer.

---

*This Constitution and By-Laws may be amended by a motion made at the Annual Meeting, and voted on the following year.*

## President's Address

*To the Presiding Bishop, Council and Officers and Members of the Woman's Auxiliary:*

As your President, I feel that I should give an account of my stewardship, you listened this morning to so many reports I am sure you are surfeited with figures, so I am only going to touch on a few high points.

The larger number of United Thank Offering Boxes that have been taken, is something to be very thankful for, also the greater interest that has been shown in the General Church work. The amount we pledged, and promptly paid toward the church deficit, showed our knowledge and interest in affairs outside the parish, it is a fine forward step.

I want to say a word of praise to the Auxiliary Branches in the small country parishes and missions, it is really wonderful what they accomplish. I have visited many a Branch of the Auxiliary, in a small parish, where the attendance in proportion to the size of the parish was greater than in a large city parish. Of course I know that in the city there are many distractions, and many calls, but surely the Church's work should come first, "first things first."

We are all of us pledged, through the message we accepted as our own, to try "to awaken the women of the Church, to more effective service for Christ," are we doing all we can? Will not the Bishop's Crusade give us greater opportunities of service in this way?

During the last few years I have had the wonderful opportunity of meeting many of the Auxiliary Presidents and officers of other dioceses, and I feel sure, in comparing notes, that in none of them, is there a happier relationship between officers, and members of the Branches, than right here in this diocese. Nowhere, I think, do the officers visit, and so come into personal relationship with the members more than they do here. Much of our strength and growth, I am sure, has come from our intimate contacts with one another. I hardly know what to say today, my heart is so full, except that the years I have had the honor to be your President, have been most happy ones. I feel sure that in the future this Auxiliary will do more and better work than it has ever done before.
