© CONSTITUTION of the  
*Louisiana Branch.*  
*Adopted December, 1886.*

ARTICLE I.

The name of this Society shall be the  
"LOUISIANA BRANCH OF THE WOMAN'S  
AUXILIARY TO THE BOARD OF MISSIONS."

ARTICLE II.

The object of this Society shall be, by  
means of union and systematic effort, to  
diffuse Missionary intelligence, to in-  
crease Missionary activity among women  
of the Diocese, to unite previously exist-  
ing Societies, and to encourage the for-  
mation of Societies where there are none.

ARTICLE III.

All baptized women belonging to the  
Diocese who desire to be members of this  
Society, shall be so regarded upon the  
payment of twenty-five cents (25c.) per  
annum.

## ARTICLE IV.

The officers of this Society, shall be a President, Vice-President, Treasurer, Corresponding Secretary, Recording Secretary and a Board of Managers.

## ARTICLE V.

The President shall call meetings together, and preside over them.

## ARTICLE VI.

The Vice-President shall preside over meetings during the absence of the President.

## ARTICLE VII.

The duty of the Corresponding Secretary shall be to prepare an annual report for circulation in the Diocese, and to conduct the correspondence of the Society with Missionaries, with the Secretary of the Woman's Auxiliary of the Church, and with the Managers.

## ARTICLE VIII.

The duty of the Recording Secretary shall be to give notice of the meetings, and to keep a record of such meetings.

## ARTICLE IX.

The duty of the Treasurer shall be to keep an account of all money and articles contributed for Missionary purposes by the Women's Societies, or by individual members of this Auxiliary.

## ARTICLE X.

The duty of the managers shall be to increase, especially in their own localities, a Missionary spirit, by rousing the Societies to greater efforts in working for Missionaries, in raising money for the cause, and by diffusing intelligence concerning the past and present Missionary work of the Church. The managers are authorized to hold meetings at such times and places as they please, in their own locality.

## ARTICLE XI.

All Societies who desire it will be considered members of this Auxiliary, and will send their report of money collected and work done to the Treasurer. Also,

delegates from all such Societies will be expected at the general meetings.

#### ARTICLE XII.

There shall be at least two general meetings of the society in each year, at such place and time as shall be designated by the President and Board of Managers.

#### ARTICLE XIII.

Special meetings may be called by the President at the request of three of the officers or Managers.

#### ARTICLE XIV.

The Board of Managers shall consist of one member from each parochial Missionary Society in connection with this Branch of the Auxiliary.

The President, Vice-President, Treasurer, Corresponding and Recording Secretaries shall be ex-officio members of the Board of Managers. Five shall constitute a quorum for business.

THE LOUISIANA BRANCH  
OF THE  
Woman's Auxiliary to the Board of Missions.

The Louisiana Branch of the Woman's Auxiliary to the Board of Missions was organized a year ago in Trinity Church. At that time it is doubtful if twenty of the persons present had ever heard there was such an organization in our Church, though it had been in existence for fifteen years as the Woman's Auxiliary to the Board of Missions, numbered forty-four Dioceses and Missionary Jurisdictions, and the following is the summary of this year's work in the Sixteenth Annual Report to the Board of Missions:

"That \$19,245.61 had been appropriated to domestic missions; \$16,057.81 to foreign missions; special gifts to domestic missions, sent through the treasurer, \$13,356.13; to foreign, \$8,367.33; and other special gifts, amounting to \$40,313.47, making a total in money of \$97,340.35. Two thousand eight hundred and forty-eight boxes, of the value of \$154,362.55, were sent to mission fields, making a grand total of \$251,702.90.

Notwithstanding so much has been accomplished, there are no doubt many of the members who are quite in the dark as to what the work is, and why all are urged to coöperate in it. This will be done in as few words as possible, quoting largely from Miss Emery, the General Secretary of the Auxiliary, on the subject.

It was in 1868, in Grace Church, New York, that an association was organized under the name of Ladies' Domestic Missionary Relief Association. In the first article of its constitution it is stated: Its object shall be the relief of the destitute missionary clergy and their families in such a fashion, that so far as possible the givers and receivers shall know nothing of each other. By the end of the year twenty-five other parishes had taken up the same work, and for three years the work went on, and in the autumn of 1871 occurred the General Convention and the meeting of the Board of Missions in Baltimore.

Enough had been done by the Relief Association to turn the attention of the Board to this, the only general Society of our Churchwomen to be found in the country. Its work was considered, its methods discussed, and it was determined that the women of the Church should have henceforth a recognized part in her mission operations. Heretofore there had been an association in New York organized simply to aid missionaries appointed by the Domestic Committee, now the Domestic and Foreign Committees were authorized to enlarge this association

until it should extend into all the parishes in the land, and give its aid to all departments of missionary work.

The name, "The Woman's Auxiliary to the Board of Missions," was created at that time, October, 1871, and the aims of this enlarged Society were as follows:

- (a.) The increase of the funds of the Board.
- (b.) The circulation of missionary publications.
- (c.) The education of missionaries.
- (d.) The making, collecting, and distributing of articles of clothing for missionaries and their families.
- (e.) The education of missionaries' children."

Such is the work, as the Louisiana branch, we have agreed to coöperate in.

To increase the funds for general missions, members of the Auxiliary are urged to take mite boxes; the boxes must be brought to the semi-annual meetings, where they are opened and the contents forwarded to the Board of Missions.

It is the duty of those interested in missionary work to assist in the circulation of missionary publications such as "The Spirit of Missions." In the August number is acknowledged the sum of nineteen dollars from the Louisiana branch of the Woman's Auxiliary. It is sincerely hoped a larger amount will be found in the boxes when next opened.

Within the past two years more young men than ever before, in the various educational institutions of our country, have declared their willingness to become missionaries, and their education is going on with that purpose in view. They give themselves. The question is: Shall they be sent? Six hundred dollars is considered a liberal support for a missionary and his family; consequently, he can have but little to spend upon clothing and education. Therefore, all are urged to cheer the hearts of these servants of God, who are doing their Master's work under great privations, by sending them boxes of good clothing and anything that will contribute to their comfort.

Each Diocese is a Branch, having its own President, Treasurer, Secretary and Corresponding Secretary. Each Parish is free to decide upon its own special work, handle its own funds, and is only required to make its report to the Diocesan Branch to which it belongs, and the Corresponding Secretary makes a report of the work done in all the Parishes of the Diocese to the General Secretary in New York.

The subscription to the Louisiana Auxiliary is twenty-five cents a year. The amount so raised, after paying for printing, etc., is usually devoted to the education of a missionary or to assist in the support of a mission school, or to help sustain a weak Parish.

The Louisiana Branch of the Woman's Auxiliary to the Board of Missions has no cause to feel ashamed of its first year's weak effort; but can the same be said of individual members of the Protestant Episcopal church and of individual parishes, when the

report is read which was made by the Missionary Board at the recent meeting of the Missionary Council, of the deplorable falling off in this year's receipts as compared with 1886? "There is a decrease of \$17,328; and the number of contributing congregations was 2200 against 2376 the previous year."

Should the last command of our Master be ignored or forgotten: "Go ye, therefore, and teach all nations, baptizing them in the name of the Father, and of the Son, and of the Holy Ghost. Teaching them to observe all things whatsoever I have commanded you: and lo, I am with you always, even unto the end of the world. Matt. xxviii, 19, 20.

Is not that command as imperative *now* as it was in the days of the apostles?

### First Annual Report of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions.

Immediately after the formation of the Louisiana Branch of the Woman's Auxiliary, letters were written to thirteen of the clergy of the diocese asking for the name of one lady in each parish with whom the secretary could correspond on the subject of the formation of parochial branches. Answers were received from eleven. Fifteen letters were written to the ladies designated by the clergy, answers were received from six. The only parishes that felt able to join the Auxiliary, were:

Christ Church, New Orleans; St. Paul's Church, New Orleans; Trinity Church, New Orleans; St. Stephen's Church, Williamsport; Christ Church, Bastrop; Church of the Redeemer, Oak Ridge; Grace Church, St. Francisville; Grace Church, Hammond.
