## PRESIDENT'S ADDRESS.

My Dear Friends:

I esteem it a privilege and pleasure to extend to you greetings of welcome to this, our Twenty-second Annual Meeting of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions.

As we assemble, year after year, to join in our Corporate Communion, with our prayers and offerings, and with renewed consecration to this work of advancing Christ's Kingdom on earth, we are admonished to pause, and thoughtfully consider the progress we have made, both in spiritual and temporal matters.

Since our last Annual Meeting, three new branches have been organized: one, in St. John's Parish, New Orleans; one in St. John's Parish, Minden; and one in New Roads, La. Increased interest has been shown both by work and offerings in almost every Parish. We have exceeded the apportionment asked of us; let us not be content with this, but renew our efforts, until **EVERY PARISH HAS ITS WOMAN'S AUXILIARY, AND SHARES IN ITS WORK.**

We hope this year to revive the work of the Church Periodical Club. "A Society formed for the purpose of supplying books and periodicals to those of the clergy and laity who are unable to procure good literature in any other way."

Special advantages have been given us during the year, in hearing Dr. Correll tell of his thirty-five years' experience in Japan. Rev. Mr. Patton tells of China, and missions elsewhere; and Dr. Lloyd, the General Secretary of the Board of Missions, gives us such encouraging accounts of what the Woman's Auxiliary has done for the spiritual uplift of women in foreign lands. He gave us interesting and touching messages from some who seemed especially grateful for the glorious tidings of the Gospel.

Our Secretary, Miss Emery, has been followed by our prayers during her travels in the Orient, to the Missions, where our thoughts often carry us, acquiring personal knowledge of their needs and opportunities. We hope soon to hear of her safe return, when she will gladly share with us, her store of acquired wisdom and experience. Mrs. Richardson, who has been President of the Louisiana Branch of the Woman's Auxiliary since its organization, and until the past year, continues to aid and strengthen, with her prayers and substance, this work, which she well declares to be "the greatest on earth." We regret that our esteemed Vic-President will not be with us at this time, on account of her absence from the Diocese.

Our thoughts turn to our Bishop, especially at this time, with earnest prayers, that he will soon return to us, fully restored to health.

Let us never forget that our opportunities are our responsibilities as well, and we must go forward with a stronger realization that prayer



is the source of all power. Nothing can take the place of earnest prayer; it is the greatest force that we can wield, and it is the talent that God has given to every Christian. Consider, what the possession of such a power means; do we fully realize the tremendous responsibility that attaches to the possession and exercise of prayer as a power with God? Let us resolve this day to be more real in our prayers, and more faithful in "consecrating our energies to the great work of Christian Missions."

MINUTES.

---

The Louisiana Branch of the Woman's Auxiliary to the Board of Missions held its Annual Meeting, Thursday, April 22nd, 1909, at 11 a. m., in Christ Church Chapel; beginning with the celebration of the Holy Communion by the Rev. C. C. Kramer (priest in charge of Christ Church Cathedral) and including a sermon by Rev. W. S. Slack, of Mt. Olivet, Algiers, La. The sermon was a strong and impressive one on Missions, the text being taken from Acts 16th Chap. 9th Verse, "Come over into Macedonia and help us."

At the conclusion of the religious services, the business meeting was called to order and presided over by the President, Mrs. James McConnell. The attendance was larger than at any previous meeting, the Chapel being well filled. Roll call showed a good representation of delegates from every Branch in New Orleans, and from many Branches throughout the Diocese.

Minutes of last meeting were read and accepted.

Treasurer's report submitted and showed total receipts for the year to be \$1,881.46. Disbursements, \$1,815.56. Balance, \$65.90.

The Corresponding Secretary reported three new Branches organized and several Mission Study Classes. This report showed also that the total contributions to Diocesan Missions (white and colored), to Domestic, Foreign, General Missions; and to dues, amounted to \$1,890.33, which with the valuation of boxes, makes a total of \$3,128.18.

The report of the Junior Auxiliary was presented by Miss Harriette Waters, in the absence of Miss Charles, President. The report showed excellent work accomplished during the past year, with increased membership. Receipts were \$370.89.

The Babies' Branch report was read by Mrs. W. J. Suthon, Houma, La., General Secretary for Louisiana. The report showed a membership of 185 "Little Helpers" contributing \$165.75 to the cause of Missions.



Miss McGraw, Treasurer of the United Offering, reported \$606.62 in bank, to date.

The "Church League of the Baptized," while not on Auxiliary lines, but one to which each member of the Church should belong, submitted its report, through its Secretary and Treasurer, Mrs. Udolpho Wolfe. The "C. L. B." of the Diocese of Louisiana, was organized by Mrs. T. G. Richardson in 1906. There are now eleven Chapters in Louisiana. The receipts from April, 1908, to April, 1909, were \$109.11. This League is "A Woman's Parochial Organization to aid in Securing Pensions for the Clergy and for their Widows and Orphans," and its purpose is to aid in this relief in the same way that the Woman's Auxiliary aids in the missionary field. Its President and Secretary is a Louisianian, Miss Louise W. Koues, now of New York city; and its Treasurer is Mrs. Seth Low, of New York city. Each baptized person becomes a member of the League, by the payment of "ten cents a year."

After all reports had been submitted and approved, Mrs. McConnell read her annual address, expressing her pleasure at meeting the members of the Auxiliary once again to join in Corporate Communion, with prayers and offerings, and to thoughtfully consider the progress made in spiritual and temporal matters; and of our exceeding our Apporportionment.

A letter from Miss Suthon, Kyoto, Japan, was read by the Corresponding Secretary, which told of busy days, with great interest and hope in the work, there being forty stations in her jurisdiction; and of her having as her Assistant, Miss Tetlow.

Regrets were expressed that our much esteemed Vice-President, Mrs. C. L. Wells, could not be with us; her absence was deeply felt and deplored.

In the absence of Bishop Sessums, Mrs. T. G. Richardson, Honorary President, decided that the officers retain their positions; this to be ratified by the Standing Committee of the Diocese. The Corresponding Secretary was instructed to advise the Standing Committee of the same.

The office of Vice-President being vacant, Mrs. J. L. Harris, of Christ Church Cathedral was nominated and elected, a notification of same to be sent to Mrs. Harris.

Affectionate greetings were adopted and ordered sent to Bishop Sessums in Italy, and to Rev. Dr. C. L. Wells, Cambridge, Mass.

Delegates were present for the first time, from three new Branches of the Woman's Auxiliary in the Diocese, from St. John's, Minden, La.; New Roads, La.; and St. John's, New Orleans. A new Branch was reported that day, from St. James, Baton Rouge, La., whose delegate brought the good news.

There being no further business the meeting adjourned with the



singing of the Doxology, after which all repaired to a luncheon served nearby, by a committee of ladies from the several New Orleans parishes.

Annual reports received from nine Branches of the Woman's Auxiliary, also the first report of the "Home of the Merciful Savior," for invalid children, Sacramento, California, to which the Louisiana Branch of the Woman's Auxiliary pledged a sum of money, at the General Convention in Richmond, Va., in 1907.

A sketch of St. Paul's School, Beaufort, North Carolina, has been sent me by Miss Bessie Portner, Kindergartner there (but formerly of New Orleans). The Louisiana Branch of the Woman's Auxiliary sends \$20.00 each year to this school for scholarships.

Miss Postner gives a fine sketch of the school from its beginning; of the good it has done for the mountaineers near there, and of the unflinching loyalty to the work, of its aged Principal, Mrs. Nannie P. Geoffroy.

The Rev. Mr. Betticher, of Fairbanks, Alaska, has sent a letter telling of Bishop Rowe's fine work in the Tanana Valley Missions, and asks that women of the Auxiliary help to take care of a child, in a school which is being put up at Nenana, Alaska, for destitute Indians along the river Missions. The support of a child in this school, Torcella Hall, is \$2.00 a week.

Branches of the Woman's Auxiliary, Juniors and Babies' Branch were asked to contribute (through their own Treasurer), money for a gallon or more of gasoline for the "Pelican," Bishop Rowe's launch. This gasoline is 85 cents a gallon in Alaska.

Leaflets on all lines of mission work of the Woman's Auxiliary, have been received from Miss Emery, and been distributed in the Diocese; also many on Junior Auxiliary, Babies' Branch, and United Offering Work, to assist the officers in these departments of work. Also leaflets on Dr. I. H. Correll's work in Tsu, Japan.



It is hoped that more parishes will have a Babies' Branch and correspond with Mrs. W. J. Suthon, Diocesan Secretary and Treasurer, on its work.

One thousand copies of the Twenty-First Annual Report of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions were printed and distributed. These were sent to the Bishops and Clergy in Louisiana, to each Branch in New Orleans, and outside of New Orleans; and one each to the Secretary of each Branch of the Woman's Auxiliary everywhere.

Three new Branches of the Woman's Auxiliary are recorded, and each has sent a report that shows interest and effort. These are St. John's, New Orleans; St. John's, Minden, La.; and one at New Roads, La.

St. Mark's, Shreveport, and Grace Church, St. Francisville, report each a Mission Study Class; the Church of the Good Shepherd, Lake Charles, reports helpful and interesting Programme Mission Meetings; and so does the Branch in the parish of the Free Church of the Annunciation, New Orleans.

I ask that more Branches begin this work. It means growth and strength.

The Branch at Lake Charles reports sending a box of clothing to the Children's Home, New Orleans, and that, at Mt. Olivet, made twenty-two aprons and four other garments for the Children's Home. May each Branch feel that it should take a warm and practical interest in the Home. I presume, it is understood that work done for it, is not reported as Woman's Auxiliary work, as the Home is not under the care of the Board of Missions.

The Branch of St. Mark's Church, Shreveport, has sent reading matter regularly to St. Matthias' Hospital, Fairbanks, Alaska.

Interest and a desire to know more about the work have been shown by each Branch, and all seem to understand better what it means to give to the "Apportionment," which is the obligation of each Branch: Woman's, Juniors' and Babies' Branch.

The Apportionment is the amount of money asked annually of each Diocese—Woman's Auxiliary, Junior Auxiliary, Babies' Branch and Sunday School—by the Board of Missions of the Church, with which it pays the salaries of missionary Bishops at home and abroad; women missionaries who are not cared for by the United Offering; of lay and clerical missionaries; and to carry on mission work in schools, hospitals and mission stations under the care of the Board. Money given by a Branch to General Missions, or to Domestic or Foreign Missions (not Specials) goes towards the "Apportionment."

The joint Christmas Box, sent by nineteen Branches of the Woman's Auxiliary of Louisiana, to St. Elizabeth's School for Indian boys and girls, Wapala, South Dakota, was a splendid one. The Principal, Mr.



Ricker, wrote that they were most grateful, and were happy and comfortable over its contents.

Four Branches of the Woman's Auxiliary sent useful and varied things to the work of Mrs. D. N. Sharpe, Edneyville, North Carolina, among the mountaineers; and five Junior Branches sent five boxes for the same work. Mrs. Sharpe is a New Orleans woman who is devoting her life to this work.

We are all rejoicing over the good news of the Bishop's restored health, and are glad that he will soon be at home.

We give greeting to the delegates from the Branches outside of New Orleans, and hope they will make themselves known to us.

In April, at the close of the Annual Council of the Diocese of Louisiana the very sad news was received of the death, at his home in Philadelphia, of Mr. George C. Thomas, Treasurer for thirteen years of the Board of Missions.

The Spirit of Missions for May, 1909, says: "To thousands of people in this land, as well as to all the missionary staff abroad, this news brings a keen sense of personal loss. \* \* \* The thought of the personal sorrow will be overshadowed by the recognition of the loss the Church has suffered." From the "Spirit of Missions" for June comes a suggestion from a weekly parish leaflet of Grace Church, San Francisco, as how, practically, to perpetuate the memory of Mr. Thomas, and of testifying to our sorrow and high regard. "Mr. Thomas would himself say, 'If you want to do something for me, dear brethren of the Church, raise this year the whole of the Apportionment for General Missions.'"

The Louisiana Branch of the Woman's Auxiliary has sent to the family of Mr. Thomas, and to the Board of Missions, resolutions "of sympathy, and expressions of their appreciation of his inestimable worth, and the loss to the Church of this representative Layman in the Board of Managers of its mission work, honored alike for his unswerving devotion to duty as a churchman, and munificent benefactions, done with such forgetfulness of self."

A WORD ABOUT THE UNITED OFFERING.

In the spring of 1909, a strong and helpful address to churchwomen was given in Christ Church Chapel, by Rev. Dr. Arthur S. Lloyd, General Secretary of the Board of Missions. As Dr. Lloyd leaves this posi-



tion in the autumn, when he will be consecrated Bishop Co-adjutor of Virginia, it is well, as he has labored for years so untiringly for Missions, and the work of the Woman's Auxiliary, that a quotation be given here from his "Message to the Woman's Auxiliary at Richmond, Va." in 1907, which was also for the Juniors and Babies' Branch. Dr. Lloyd said:

"This United Offering will go around the world and tell what Christ has brought to women. Every woman in the American Church must stop and think what this message will mean to her sisters across the sea.

"I give you one little word that will put a song into your heart. I saw it with my own eyes; I heard it with my own ears; I have felt it in my own heart—that women in every land which I have visited have been lifted up and placed on high, because a sister, whom you have sent, has interpreted by her own life, the Christ. I have seen women with their hearts aglow because of the sister whom you sent in God's name."—(From United Offering Leaflet No. 5.)

The United Offering of 1910 is to be given to the Board of Missions at the general convention to be held in Cincinnati, in October, 1910. It is resolved that this be given for woman's work in the mission field, including the training, sending and support of woman workers. Also the care of such workers when sick and disabled; but that a sum not exceeding \$15,000.00 be devoted to a building, or buildings, approved by the Board of Missions, on the recommendation of the General Secretary, and the Secretary of the Woman's Auxiliary. And \* \* \* that we add our united and earnest prayers that God will put into the hearts of many faithful women to give themselves to the work of the Master in the Mission Field.

There are one hundred and sixty-four United Offering Missionaries at work for 1908-1909, as teachers, nurses, physicians, deaconesses, in the Domestic and Foreign Field.

It gives me great pleasure, as President of the Junior Auxiliary of Louisiana to look backward over a year of increased effort among the



Juniors, towards the object so dear to all hearts—the spreading of the Kingdom among all nations.

The annual meeting was held at Christ Church Cathedral, on the first Sunday in May. The services were conducted by the Rev. J. C. Lamothe, of St. Paul's, New Orleans, and Rev. J. W. C. Johnson, of Lake Charles, La. At these services the church should be crowded, and I would like to urge upon all clergymen that as every baptized child is a member of the Junior Auxiliary, they should endeavor to make these meetings of interest to one and all. The semi-annual meeting was held at Grace Church, Jan. 3, 1909, but owing to the very inclement weather no children were present. The Rector, the Rev. A. R. The joint Christmas box, value \$195.00, was sent to Edneyville, N. C., to Mrs. D. N. Sharpe. Our thanks are again due to Mr. C. A. Pardue for sending the box, free of charge. Rev. E. A. Rennie having returned the buggy belonging to the Junior Auxiliary, it was sent to Rev. Chas. Thorp, Mansfield, La., with a check for \$50.00 with which to purchase a horse.

Circulars have been sent to all the clergy in the Diocese, regarding the work of the Junior Auxiliary.

Miss Delphine T. Charles was elected Corresponding Secretary, as Miss M. Dillard has left the city.

The sum of \$15.50 was given by various Branches of the Junior Auxiliary in Louisiana and sent to Mrs. D. N. Sharpe, Edneyville, North Carolina, to purchase drugs for use in mountain mission work there.

I close my report with the hope that the interest of all connected with the Junior Auxiliary in Louisiana will continue to increase, until all the parishes in the Diocese shall be represented.

## CONSTITUTION.

---

### ARTICLE I.

The name of this Society shall be the "Louisiana Branch of the Woman's Auxiliary to the Board of Missions."

### ARTICLE II.

The object of this Society shall be by means of union and systematic efforts to diffuse Missionary intelligence, to increase Missionary activity among women of the Diocese, to unite previously existing Societies and to encourage the promotion of Societies where there are none.

---

### ARTICLE III.

All baptized women belonging to the Diocese who desire to be members of this Society, shall be so regarded upon the payment of twenty-five (25) cents per annum.

### ARTICLE IV.

The officers of this Society shall be appointed by the Bishop, and shall be as follows: An Honorary President, President, Vice-President, Treasurer, Corresponding Secretary, Recording Secretary, Treasurer of United Offering Boxes. For the Junior Department—A President, Vice-President, Secretary, Treasurer, General Secretary for the Babies' Branch, and two or more managers in each Archdeaconry, and such other officers as may be deemed necessary. These shall constitute a Board of Managers, to which the general management of the affairs of this Branch of the Auxiliary shall be intrusted.

### ARTICLE V.

The President shall call meetings together and preside over them.

### ARTICLE VI.

The Vice-President shall preside over meetings during the absence of the President.

### ARTICLE VII.

The duty of the Corresponding Secretary shall be to prepare an annual report for circulation in the Diocese, and to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary and with the Parochial Branches, and to keep a fair record of all Missionary box reports.



## ARTICLE VIII.

The duty of the Recording Secretary shall be to give notice of the meetings and to keep a record of all such meetings.

## ARTICLE IX.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association, to pay all drafts upon the funds and to prepare a report for each general meeting.

## ARTICLE X.

The duty of the Managers shall be to increase, especially in their own localities, a Missionary spirit by arousing the Societies to greater efforts, in working for Missionaries, in raising money for the cause and by diffusing intelligence concerning the past and present work of the Church. They shall attend all meetings of their Parochial Societies and keep a record of all Missionary work done at said meetings; they shall send a monthly report to the Board and a summary of these shall constitute the yearly report.

## ARTICLE XI.

All Societies, who desire it, shall be considered affiliated branches of this Auxiliary, and will send their report of money collected and work done to the Corresponding Secretary. Also delegates from all such Societies will be expected at the general meetings.

## ARTICLE XII.

There shall be at least two general meetings of the Society in each year, at such place and time as shall be designated by the President and Board of Managers.

## ARTICLE XIII.

Special meetings may be called by the President at the request of three of the officers and managers.

## ARTICLE XIV.

The Board of Managers shall consist of one member from each Parochial Missionary Society in connection with this Board of the Auxiliary.

The President, Vice-President, Treasurer, Corresponding and Recording Secretaries shall be ex-officio members of the Board of Managers.

Five members shall constitute a quorum for business.
