---

*Resolutions adopted by the Louisiana Branch of the Woman's  
Auxiliary to the Board of Missions.*

The members of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions, meeting in Christ Church Chapel, on Monday, May 16, 1910, desire to place on record the profound sorrow and deep sense of personal loss which has come to them in the passing away of Mrs. Ida A. Richardson.

Born in New Orleans in 1830, she lived her life of fourscore years in the fear of God and on the side of Righteousness, and entered into life eternal on the morning of April 10, 1910.

Impressed from her childhood with the obligation to carry out her Master's last command to His Church—to preach the Gospel to every creature—she was deeply interested in every movement for the furtherance of the Gospel. She was instrumental in gathering together a little band of faithful women and organized them into the Louisiana Branch of the Woman's Auxiliary in the year 1886, and was its first and only president until two years ago, when the growing infirmities of age compelled her to resign. From that time she has been its honorary president.

Through all of these years she has been untiring in her zeal, her earnestness, her faithfulness and generous offerings in carrying on the work of the Woman's Auxiliary.

This Society is, indeed, bereft in the loss of one whose help and inspiration have meant so much, and it prays to God that the noble and self-sacrificing example of her life may stir it up to truer efforts, so that the work begun and so long sustained by her may grow to even larger things.

Simplicity, sincerity and sympathy, with a high sense of honor, were the qualities that made her beloved. She fought a good fight. As a good soldier of the Lord Jesus Christ, she was ever found under His banner, fighting for God and Righteousness, and doing everything in her power for those around her.



The officers and members of the Woman's Auxiliary of Louisiana desire to express not only the sorrow and personal loss they have sustained in her death, but, also, their gratitude for all she was permitted to do for the cause of Missions.

*Therefore*, In appreciation of her great worth and long and faithful service:

BE IT RESOLVED, That, in recognition of all that our former President and beloved friend was to this Auxiliary, we render her this tribute of love and respect; and that these minutes be inscribed upon the records of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions, and a copy be sent to the family, and to Miss Julia C. Emery, Secretary of the Woman's Auxiliary to the Board of Missions.

"We yield unto Thee, Oh God, most high praise and hearty thanks for the wonderful grace and virtue declared in this Thy servant, who has been a choice vessel of Thy grace and a shining light in her generation."

ANNUAL ADDRESS OF MISS JULIA C. EMERY,  
Secretary of the Woman's Auxiliary.

*My Dear Friends of the Louisiana Branch of the Woman's Auxiliary:*

This year has added to our many opportunities that of the Intercessory Prayer League. Through this we are furnished, quarterly, with a leaflet of thanksgiving and intercession for each day of the week, which gathers up the special objects for praise and prayer brought to our thoughts in the pages of the "Spirit of Missions" in the three preceding months. The number of individuals who have



taken these leaflets for their daily use is constantly increasing, and no one can doubt that with such gain in united prayer, a sure response will come.

Another cause for thanksgiving is that so many more of us are gaining intelligence as to what to pray for, and for what to give thanks. The number of Study Classes is growing, and the methods of study are becoming more exact; and, best of all, the Bible is coming more generally to be found a storehouse of Missionary incentive and example.

This growing and deepening earnestness in the spiritual life of the Woman's Auxiliary will be our surest help in meeting our difficult problems. When the heart is full of faith and love, it is full of hope; and hope gives courage and enterprise and endeavor. And these are all needed at the present time by every member of the Woman's Auxiliary.

They are needed when we see so few women in our parishes at the parish branch meeting, and sharing in our interests and efforts.

They are needed when we do not find competent and willing leaders for our Juniors. They are needed when we are confronted with the definite work expected of us—our share in the Woman's Auxiliary Apportionment, and the United Offering.

They are needed when we hear what our Missionaries are doing *or would do* if they only had the means—the *Specials* for the *Big Things*, which the upbuilding of Christian nations in un-Christian lands, and the restoring Christ to his forgetful people, demand.

Let us pray distinctly for the spiritual gifts from God which will enable us to cope with and conquer these difficulties.

The *Apportionment*, which is yearly set before us—may be called a gift of duty; the *United Offering*—made triennially, is sure to be our gift of thankfulness; may not our *Specials*—given to meet pressing needs—be known as gifts of *privilege*?

The large *Specials* cannot so well be provided by the same method as the *Apportionment*; they may come more suitably through the large gifts of individuals able to give largely.

Is it not a possible thing to begin to build up in the Woman's Auxiliary "among its members able to do large things," a band of those who shall decide that at least for this next year they will make the selection from among those big works which the Bishops and the Board of Missions together have approved—making there such large gifts as God has given them ability to make?



This work of building up God's Kingdom is a great work. It calls for great love; great faith, great deeds. The members of the Auxiliary do not know how capable they are. By trial they can prove their capacity.

The *Apportionment* and the *United Offering*, both of which might well be doubled for the whole Auxiliary, claim that patient continuance in well doing to which God's word promises a glorious return. So long as *Specials* last, they call rather for the gifts from the few inspired by the loving prayers \* \* \* of the many.

We would not leave you with the thought of money gifts uppermost. It is the heart we want to win, that will think *nothing too much to offer*, even though it be the *gift of self*, to the real work with waiting souls with which only our United Offering of 1910 can become a worthy and fruitful thing.

Hoping that a goodly number of your members may be in Cincinnati in October, bringing there your quota of helpful experience, and returning enriched with the experience of others, I am,

#### THE APPORTIONMENT OF 1909-1910.

---

It was suggested this year that the Louisiana Branch give toward the Auxiliary's \$100,000 for General Missions: The Women, \$800; the Juniors, \$75; the Babies' Branch, \$50; total, 925.

Up to April 9th the Women have given \$486.70; the Juniors, \$3.50; the Babies, \$20; total, \$510.20.

This leaves to be given, including what may come in since the date given, about \$414.80 before September 1st.

#### THE APPORTIONMENT 1910-1911.

---

Of course, the Branch will expect to give next year, at least the amount suggested to them last year; but would it not be possible to



find one or two women in the Diocese, able and willing to do so, to give an equal sum, thus doubling the amount given by the Branch toward the Appropriations of the Board of Missions?

By doing this the Woman's Auxiliary will be taking its place in the "forward movement," which the men, also, are planning.

THE UNITED OFFERING.

---

In Richmond, in 1907, the Auxiliary gave \$224,251.55. Of this, the Louisiana Branch gave \$1,248.70. Your Treasurer can tell you how the Branch stands now, and we all hope that the United Offering to be made in Cincinnati on October 6, 1910, will be greatly in excess of that of 1907.

PRESIDENT'S ADDRESS.

---

NEW YORK CITY, April 9, 1910.

*My Dear Friends of the Woman's Auxiliary:*

It is with a feeling of deep regret that I realize that I am unable to be present with you at this, our Annual Meeting; for, when we meet together in our Corporate Communion, with our prayers and offerings, we again consecrate ourselves to the work of the Master.

More especially, then, I long to be with you.

In reviewing the work of the past year, we find it has been fraught with changes; for, while there are many causes for thankfulness, yet there is a sense of loss for those who have passed beyond.

The sudden prostration and extreme illness of Mrs. T. G. Richardson, who has been our beloved and honored President for so many years, who has labored with prayerful earnestness, so unceasingly for the growth and extension of this important work, fills



us with anxious forebodings. Our constant prayers in her behalf may be answered and her life spared.

Still, if it be the will of our Heavenly Father to call her to Paradise and rest from her life of earnest Christian labor on earth, she will leave with us the inheritance of a noble example of devotion to duty for us to follow.

Some progress has been made in the work of the Auxiliary. The Branches that have been reorganized have new life infused into them, and promise much for the future, and there are three new Branches. \* \* \* We welcome them heartily and hope the time will soon come when *every* parish will have its Auxiliary Branch.

We look to our Juniors to answer the call from the Mission fields, in which young people and children *must* have their share. The Junior Auxiliary exists to bring to them the opportunities of missionary work. As a training school for the future, we *must* turn to our young people and children.

The United Offering is paramount now, in our hearts, for it is to be presented in October in Cincinnati at the Triennial Service of the Woman's Auxiliary, held during the General Convention of our Church. And we must make greater effort to attain success, and so share in the joy of making this Thank Offering, which will help maintain the women who will offer themselves for work in the mission fields.

Try and interest every woman of the Auxiliary to do something and to think of it as a gift of thankfulness for their own Christian blessings.

The lamented friend of the Woman's Auxiliary, Mr. George C. Thomas, late Treasurer of the Board of Missions, will be missed more than ever when this offering is presented and the amount of it announced to the vast throng of expectant women from all parts of the world!

The safe return of our Secretary, Miss Julia C. Emery, after a year's absence visiting the various Mission Stations of our Church around the world, has been heartily welcomed by all of us; and she is ready and willing to give us the benefit of her store of knowledge from her experience.

It is truly a cause for thanksgiving that we are having our own Bishop with us again, restored to health and strength, giving to his people the benefit and enjoyment of his presence, and the ministrations of his Holy Office.



In conducting our work, let us realize the value of earnest prayer, as the great and prevailing force given to every one of us as Christians, by the Master.

We humbly invoke the blessing of God upon each member of the Auxiliary, to aid them in their labors to advance Christ's kingdom on earth.

MINUTES.

---

The annual service of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions was held in Christ Church Chapel, at 10 a. m., on Wednesday, April 13, 1910. The Rev. Dr. William A. Barr, Dean of the Cathedral, officiated and was assisted by the Rev. Dr. J. W. Bleker, of Grace Memorial Church, Hammond, La., who, also, gave the address. The Holy Communion was celebrated and a large number of the clergy and of the women of the Auxiliary communed.

The whole service was in the nature of a memorial, as all felt deeply the passing away—but three days before—of their Honorary President, Mrs. Ida A. Richardson, the organizer, and for many years President, of the Louisiana Branch.

After the service the meeting was called to order by Mrs. W. H. Fitzpatrick, in the absence of the President, Mrs. James McConnell. Roll call showed a large number of officers and delegates from New Orleans, and from parishes outside.

Minutes of last meeting were read and accepted.

The Treasurer, Miss Greenwood, read her report, which showed total receipts to be \$1,759.26. Disbursements, \$1,709.04; balance, \$50.04.

Miss Wharton, Corresponding Secretary, gave an account of all correspondence, number of boxes sent, valuation and destination. Leaflets and much Woman's Auxiliary literature distributed, and explained the Apportionment, "Specials" and "Designated Contributions."



Miss Wharton reported two study classes in the Louisiana Branch—the Apportionment better understood and responded to—thirty-eight branches of the Woman's Auxiliary, including three new Branches. One in St. James' Parish, Baton Rouge; one in Leesville; and one in St. David's Parish, Rayville. Money given in 1909-1910 to Missions in and out of the Diocese, \$1,851.03. To boxes in Domestic field, \$1,374.52, making \$3,225.55.

Miss McGraw, Treasurer of the United Offering, reported that it had then reached \$1,048.26, and urged the generous giving to the United Offering on to September, when she is to collect from all Branches—that she may take it to the Triennial Service of the Woman's Auxiliary to be held in October in Cincinnati—when the United Offering is to be presented.

The report of Miss Elinor May, Treasurer of the Juniors, showed fourteen Branches, which had done splendid work. The address of the President of the Junior Auxiliary, Miss Clemence Charles, was read by Mrs. Fred. Foxley, of St. George's Church, New Orleans. Two new Branches have been organized. One in St. George's Church, New Orleans, and one in St. Andrew's, New Orleans.

Report of Mrs. W. J. Suthon, General Secretary and Treasurer of the Babies' Branch, showed total receipts to be \$114.57. Expenditures the same, from twenty-one Branches.

The Treasurer of the Church League of the Baptized, Mrs. Udolpho Wolfe, had a very good report to make.

The annual address of the President, Mrs. James McConnell, was read by Mrs. W. H. Fitzpatrick, Vice-President.

At the close of the meeting Bishop Sessums addressed the women of the Auxiliary, saying he was glad to be able to express his appreciation of the privilege of being once more with his people, having been so long debarred by illness from his ministrations in the Diocese. The Bishop said that many things pointed to the development of a wide spirit of progress in Missionary work, and that a very noble part of it is being done by the Woman's Auxiliary of Louisiana.

The Bishop had many beautiful things to say of Mrs. Richardson's lofty Christian character and tender heart, and of her religious and charitable work. He thanked the whole Auxiliary of Louisiana both in his own name and that of his clergy, for their steadfast and earnest work.



Before the meeting closed it was moved and seconded that the Vice-President appoint a committee to draw up resolutions on Mrs. Richardson's death, after which the congregation rose and stood a few moments in reverent silence in Mrs. Richardson's memory.

The meeting closed with the singing of the Doxology.

REPORT OF THE CORRESPONDING SECRETARY FROM  
APRIL, 1909, TO APRIL, 1910.

Annual reports for 1908-1909 and 1909-1910, have been received from eleven Diocesan Branches.	

I have received for distribution many packages of leaflets on the work of the Woman's Auxiliary, and its Junior Department (including the Babies' Branch); Mission Study class papers; United Offering, the Apportionment, and about the Church's work in all parts of the world. They have been sent to all branches in the Diocese.

Have received and distributed in Louisiana the Thirty-eighth Annual Report of the Woman's Auxiliary to the Board of Missions.

Compiled and edited the Twenty-second Annual Report of the Louisiana Branch of the Woman's Auxiliary to the Board of Missions, and had one thousand printed. These have been distributed among the thirty-eight branches in Louisiana; also one each sent to each officer and delegate of the Woman's Auxiliary, Junior Auxiliary and Babies' Branch in the Diocese, and to the Bishop and Clergy, and to a few diocesan branches.

I earnestly ask that the members of all Branches, and Church women generally read all of the reports and become familiar with the whole work and not simply the Branch in which she is interested.



I have addressed two Woman's Auxiliary meetings, and three of the Junior Auxiliary, and found much that was encouraging and helpful in their earnest desire to be well posted, and in their own understanding of the work.

As far as I can hear there are three Mission Study classes in the Woman's Auxiliary Branches.

At the request of the Rector of St. Mary's Parish, Franklin, La. I visited Franklin, and was a guest at the rectory, where Mr. and Mrs. Hale called a meeting of members of the Woman's Auxiliary Branch there—that it might be reorganized. It has begun anew, is in earnest and has sent in a good report.

Good work, on Auxiliary lines, has been going on during the year in St. James Parish, Baton Rouge. Mrs. H. Moise, President and Delegate, has worked zealously and met with ready response from the women in the parish. There are sixty-seven members, and they have sent in a report that shows interest. In their request for United Offering Boxes they have made a record, as requiring sixty-seven at the start!

St. David's, Rayville, La., has a Branch of the Woman's Auxiliary, for which its Rector, the Rev. H. R. Carson, has been working for some time. They have begun with the proper officers and plenty of leaflets and the "*Spirit of Missions*," and love for the work, and fourteen members.

Leesville, La., announces a Branch and eight members, begun by a former member of the Branch in St. Peter's, Marksville, La., Mrs. W. H. Lyles. They have also begun with the "*Spirit of Missions*."

Four Branches have not been heard from in the year. We hope to hear from them by April, 1911.

All Branches are doing good work and are growing in knowledge and interest, and the Apportionment is better understood and supported. For 1909-1910 the Woman's Auxiliary of Louisiana has given about \$821; the Juniors about \$90; the Babies' Branch \$46. The Juniors have done excellent work and have new Branches, and so has the Babies' Branch. We extend affectionate thanks to all of them for their hearty co-operation.

The Branch in Mt. Olivet Parish, New Orleans, sent a fine box in September to the storm sufferers near Houma, La., and during Lent made three dozen aprons for the Children's Home, New Orleans. St. John's, Thibodeaux, sent a box to the Home, as did the Branch in the Church of the Epiphany, New Iberia. These boxes



are not reported as Woman's Auxiliary work, but we are glad that the churchwomen of the Diocese are interested to give of their time and means to the Children's Home of the Diocese.

The boxes from Woman's Auxiliary and Junior Auxiliary Branches have made a fine showing in generous and interested giving to the needs in schools, hospitals and chapels in the mission field.

The Church League of the Baptized, is doing good work and growing steadily.

The whole Auxiliary of Louisiana extends an affectionate and glad welcome to our Bishop; greetings to Dr. and Mrs. Barr of the Cathedral, and to Mrs. W. H. Fitzpatrick, the Vice-President of the Woman's Auxiliary. The President, Mrs. James McConnell, sends a message to the Louisiana Branch and her regret that she cannot be with us.

I am sure I voice the regret and sorrow of each one present at the passing away of Mrs. T. G. Richardson, the long time-loved and revered first President of the Louisiana Branch. We shall prize all that we have learned from her and strive to build up and strengthen the waste places, as she would have us do.

## CONSTITUTION.

---

### ARTICLE I.

The name of this Society shall be the "LOUISIANA BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS."

### ARTICLE II.

The object of this Society shall be by means of union and systematic efforts to diffuse Missionary intelligence, to increase Missionary activity among women of the Diocese, to unite previously-existing Societies and to encourage the promotion of Societies where there are none.

### ARTICLE III.

All baptized women belonging to the Diocese who desire to be members of this Society, shall be so regarded upon the payment of twenty-five (25) cents per annum.

### ARTICLE IV.

The officers of this Society shall be appointed by the Bishop, and shall be as follows: An Honorary President, President, Vice-President, Treasurer, Corresponding Secretary, Recording Secretary, Treasurer of United Offering Boxes. For the Junior Department—A President, Vice-President, Secretary, Treasurer, General Secretary for the Babies' Branch, and two or more managers in each Arch-deaconry, and such other officers as may be deemed necessary. These shall constitute a Board of Managers, to which the general management of the affairs of this Branch of the Auxiliary shall be intrusted.

### ARTICLE V.

The President shall call meetings together and preside over them.



## ARTICLE VI.

The Vice-President shall preside over meetings during the absence of the President.

## ARTICLE VII.

The duty of the Corresponding Secretary shall be to prepare an annual report for circulation in the Diocese, and to conduct the correspondence of the Association, especially that with the Secretary of the Woman's Auxiliary and with the Parochial Branches, and to keep a fair record of all Missionary box reports.

## ARTICLE VIII.

The duty of the Recording Secretary shall be to give notice of the meetings and to keep a record of all such meetings.

## ARTICLE IX.

It shall be the duty of the Treasurer to receive and keep account of all moneys contributed for the work of the Association, to pay all drafts upon the funds and to prepare a report for each general meeting.

## ARTICLE X.

The duty of the Managers shall be to increase, especially in their own localities, a Missionary spirit by arousing the Societies to greater efforts, in working for Missionaries, in raising money for the cause and by diffusing intelligence concerning the past and present work of the Church. They shall attend all meetings of their Parochial Societies and keep a record of all Missionary work done at said meetings; they shall send a monthly report to the Board and a summary of these shall constitute the yearly report.

## ARTICLE XI.

All Societies, who desire it, shall be considered affiliated branches of this Auxiliary, and will send their report of money collected and



work done to the Corresponding Secretary. Also delegates from all such Societies will be expected at the general meetings.

#### ARTICLE XII.

There shall be at least two general meetings of the Society in each year, at such place and time as shall be designated by the President and Board of Managers.

#### ARTICLE XIII.

Special meetings may be called by the President at the request of three of the officers and managers.

#### ARTICLE XIV.

The Board of Managers shall consist of one member from each Parochial Missionary Society in connection with this Board of the Auxiliary.

The President, Vice-President, Treasurer, Corresponding and Recording Secretaries shall be ex-officio members of the Board of Managers.

Five members shall constitute a quorum for business.
