## Minutes of the Annual Meeting

The 58th Annual Meeting of the Maine Branch of the Woman's Auxiliary to the National Council was held in the Parish House of St. Luke's Cathedral, Portland, May 25th and 26th, 1936. A Preparation service for the Corporate Communion was held on Monday evening at Emmanuel Chapel by the Rev. James L. Hayes of St. Mark's Church, Waterville. At the early service on Tuesday morning, Bishop Brewster was the Celebrant, assisted by the Rev. Eric Robinson of Newcastle, Rev. Stanley A. Macdonell of Fort Fairfield, and Rev. Robert Merry of Wiscasset.

Twenty-one officers and one hundred and sixty delegates and guests representing thirty-one branches were present. The Minutes of the last Annual Meeting were accepted as printed in the Annual Report, and the Minutes of the last Quarterly Meeting were accepted as approved by the President and Recording Secretary.

The Annual Reports of the Recording Secretary, the Treasurer, Auditor, the Educational Secretary, Supply Secretary, and Assistant Treasurer of the United Thank Offering were accepted, to be placed on file as read.

These were followed by the Address of Miss Ogden, the President.

A Report of the Provincial Meeting held at Portland in October was given by Mrs. Sills.

Reports on groups of young women were given by Mrs. Shaw of Bar Harbor and Mrs. Joseph Flagg of Portland. Miss Audrey White, President of the Diocesan Young People's Fellowship, gave an outline of some of the activities of that organization.

Mrs. George R. Stevens of Augusta, President of the Girls' Friendly Society, gave a brief report calling attention to the Holiday House, Camden, where calls from all Churchwomen would be welcome during the summer.

At the request of the President, Rev. Mr. Akeley spoke of conditions at the House of the Good Shepherd, where fourteen girls are being cared for by Sister Margaret Mary, who seems to be supplied with remarkable energy and inward joy.

Growth in the important work among isolated Churchwomen, and in groups of women in places where there is no church, was reported by Mrs. Odell. She also announced the formation of a new branch at Lincoln.

Miss Teague, Secretary for Rural Education, spoke on the Church School by Mail, which has shown a decided growth in the last two years. Mrs. Emery read a list of contributions which have been given for the Vacation School at Exeter, where the need is great to help forward the work being done there.

Miss Joan Waldron, Assistant Superintendent in the Union Hospital at Fall River, Mass., told with much charm and in a picturesque manner of her experiences during one week at Exeter,

where, working harder than ever before in her life, she was greatly thrilled with the problems of health and hygiene presented to her, and left with a very sincere feeling for the work being done there by our Church. She described a typical day with the youngsters and spoke of the whole-hearted response given to her teaching by the children and marvelled at the wonderful spirit lying behind this group.

Mrs. Cummings, Secretary and Treasurer of the Maine Altar Society, named many articles completed during the year, and hoped to increase the number of associate members.

Mrs. Purves, for the Church Periodical Club, reported growth among the branches in interest and number of periodicals sent.

Mrs. Arthur Sewall II, for the Committee on the Forward Movement, presented a Rule of Discipleship, copies of which could be obtained from her at the conclusion of the meeting.

A notice of Conferences and Scholarships was given by the Rev. Mr. Akeley.

A Report of the Nominating Committee was given by Mrs. J. B. Waterbury, Chairman of a Committee of three,—the other members being Mrs. Fred C. Roberts of Newcastle and Mrs. Edwin Tracy of Northeast Harbor. This was accepted and the Secretary was instructed to cast one ballot for the officers as printed in the front of this Report.

The Chair announced the following Standing Committees:

Quiet Day for Prayer—Mrs. Kendall, Mrs. Martin, Mrs. Beard, Mrs. Burleigh, Mrs. Arthur Sewall II.

Program Committee—Mrs. Hamilton, Mrs. Drake, Miss Teague, Mrs. Flagg, Mrs. Harter, President Ex-officio.

Committee on Rural Work—Mrs. Martin, Mrs. Emery, Mrs. Odell, Miss Teague, Mrs. George R. Stevens, Miss Lottie Coombs.

Forward Movement—Mrs. Arthur Sewall II, Mrs. Roger Snow, Miss Ogden.

The Rev. Victor L. Dowdell, Ph. D., gave a short address on Porto Rico and Santo Domingo, describing each place graphically. He served as Dean of St. Michael's Seminary in Porto Rico, and laid great stress on the need for a native clergy. Life in Santo Domingo he found a decided contrast to Porto Rico, it being a rich and well-governed country.

After luncheon Conferences were held from 2.00-3.20 P. M., the subjects being Presidents, Forward Movement, United Thank Offering, Church Periodical Club, Missions in this Age, Young People, Altar Society, and Educational Program.

Mrs. Sills spoke briefly for the National Cathedral at Washington.

It was announced that on November 11th A QUIET DAY FOR PRAYER would be again observed.

The offering for the day was \$52.32.

It was voted that a message be sent from the meeting to Dean Glasier, expressing regret at his absence and appreciation of the valuable spiritual help that he has given the Auxiliary.

A Committee on Courtesy Resolutions, consisting of Mrs. Macdonell, Fort Fairfield, Chairman, Mrs. Plummer, Sanford, Mrs. Moody, Saco, Mrs. Brown, Bangor, and Mrs. Robinson, Newcastle, expressed appreciation for the hospitality of the Portland Parishes, the Bishop, Speakers, and clergy who assisted, and to the Auditor, Mr. Allan P. Stevens. They also extended the good wishes to Miss Ogden, the President, for her extended leave of absence.

An invitation to hold the fall meeting at Waterville was offered by the delegates from St. Mark's and accepted with anticipation.

The Bishop closed the meeting with prayer and benediction.

### Report of Recording Secretary

The Maine Branch of the Woman's Auxiliary held its fall meeting with St. John's Branch, Bangor, Sept. 30th and Oct. 1st, 1935. Sixteen officers and 99 delegates and guests were present. At the evening service the Rev. E. A. Blaney gave the address, sketching the history of Christ Church, Eastport, and described present conditions there.

At the mid-winter meeting, held with the Branch of Christ Church, Gardiner, on Feb. 4, 1936, 15 officers, 75 delegates and guests representing 15 Branches were in attendance. "Religion in Family Life" was stressed, Miss Teague and Miss Hill presenting the subject. Bishop Brewster conducted a Quiet Hour, the theme of his Meditation being, "The Light of God's Truth," as part of the Forward Movement. Mr. Gasson of St. Paul's School, Concord, N. H., gave an interesting and vivid picture of conditions in Southern Brazil during his four and one-half years of teaching there.

One new branch at Winn has been formed.

Almost all the branches observed the Quiet Day for Prayer on Nov. 11th. Nine branches contributed to the Missionary Crisis Fund.

In October we had the privilege of entertaining the Provincial Branch of the Woman's Auxiliary and Coöperating Women's Organizations.

## President's Address

We are gathered here in the 58th Annual Meeting to appraise our work for the past year, to share our experiences in service for the Master, and above all to enjoy that fellowship which has been characteristic of the saints of God since the First Century.

You have gleaned from the reports of the other officers the statistical signs of progress. I want in your name to thank them for their painstaking and joyful service. Particularly do I appreciate the unselfish devotion of the two officers who in their great bereavement have made it possible for the work of their offices to be continued without interruption.

It is with great regret that we learn of the retirement of Mrs. James W. Sewall. She has been a loyal and efficient officer and we shall miss her help on the Board.

What Mrs. Sewall has accomplished makes me feel that we do not use our District Vice-Presidents as we should. The detail work of the Auxiliary is becoming too much to be cared for satisfactorily at the Central Office. I am confident after much experience, both in this Diocese and in others in New England, that those parishes in a natural Group should meet together more often than our three Diocesan meetings will permit. It would give an opportunity to discuss local problems of the Church, to serve as a distributing center for Supply Work, Study Material, Prayer Leaflets, and Forward Movement Literature. The Diocesan officers could meet these groups and thus preserve the Diocesan contact, and in these district meetings, too, we would be training future Diocesan officers.

A new officer is being added to the Diocesan Board, that of Secretary of Christian Social Service. Her duty will be to give accurate information to Branches who desire it, on matters of civic import in which Churchwomen should be forming Christian opinions.

The action of the Branches in regard to the Missionary Crisis appeal was most heartening. Ten Branches gave in addition to the offering of their churches and one was so well-informed by a weekly Church news system practised by the Branch that they responded to the call before the Diocesan appeal went out. That is really being alive. To this I may add that the Epiphany Offering, which is applied on the Diocesan Quota for General Missions, was twenty-five dollars more than last year. Part of this increase is due, I am sure, to good work done in Epiphany in connection with the hundredth anniversary of the founding of the Spirit of Missions. It proved a starting point for some interesting sessions.

"Missions in this Age" is the third and last subject from the Triennial Program. You may be surprised to find in studying this topic that Missionary work today is not what it was fifty years

ago. It requires a new mental attitude and a new approach. I hope every branch will at least read Dr. Francis Wei's Address given at the Triennial.

The Provincial Meeting will be held in October of this year in the Diocese of New Hampshire. We are happy to record that we were able to contribute \$50 to the New England Provincial Specials for Rural Work and Automobile of the Assistant Secretary for College Work.

The United Thank Offering under the new Diocesan Treasurer is making progress. Although the number of branches using the Blue Box is larger than ever before, the amount of money for the Diocese is less than three years ago. This is not due to lack of money but for an unfortunate interim in appointing the Parish Custodians in some of the larger parishes. The women who are giving in this way are growing in the practice of Thankfulness as an essential element in worship.

I feel that some allusion should be made here to the really fine work being done in this Diocese by the coöperating organizations.

The Girls' Friendly Society, under its new president, is building on a good foundation and trying to adapt itself with skill and sympathy to bring to the modern girl in her own language something of what Christianity can mean in the individual life today. The Girls' Friendly Society does look and I think really should look to the Woman's Auxiliary to provide Leaders and Associates for parish and diocesan branches.

And what is true of the Girls' Friendly Society is true of all the Young People's Societies in Maine. They need Leaders. They need people to work with them who have a tremendous faith in God and are not afraid to look at conditions in the world as they are today, and by the grace of Our Lord Jesus Christ try to help the youth of their parish to bring God into these conditions.

The Altar Society is one of the oldest branches of Auxiliary Work in this Diocese. It has two departments, one of Silk Embroidery and the other of Linen Work. I am sorry to have to announce that Mrs. Charles Johnson of Gardiner, who has been in charge of Linen Work for 34 years, feels she must resign. We shall miss her, not only for her beautiful work, but for her constant devotion to Auxiliary interests.

The Altar Society is now considering the adding of another department to include the training of Junior Guilds in Altar Work. This is in line with the organization of larger Dioceses and will, I think, fill a real need in Maine.

Those of you who have caught the contagious enthusiasm of Mrs. Purves for the Church Periodical Club, realize what a tremendously important work it is carrying on in these days when people cannot spend all they would like to on books and magazines.

It has helped our own Rural Work constantly. If every parish has not a branch of it I am sure you would do well to consider having one.

Our Rural Work has had a large increase in numbers this past year. I want to commend the enthusiastic way that the Auxiliary has stood back of this venture with money and supplies. At the same time I want you to know that Miss Teague could not have carried on as she has done if it had not been for the generous aid given this piece of Church Extension by the Province and by the larger Dioceses of New England.

The Forward Movement has been, I feel sure, the moving force in all our work during the past year. We have had conferences on Discipleship to find out what one may honestly expect of a disciple of Christ,—a baptized member of the Church. From this experience I am led to believe that the women of the Church have come to the point where they want to think out for themselves questions of life and religion. During Lent several parishes used the new course planned by the Women Associates of the Forward Movement called "RELIGION IN THE FAMILY." I wish it might be more extensively used in the Diocese in the coming year, and used as directed for discussion and not as a lecture course. We have here today a new pamphlet, "PROVING PRAYER," a working guide for developing experience by schools of prayer. This course is not intended for information about prayer as much as it is a practice of praying. I am hoping that small groups may be found in many of our parishes to try this course. It will be a developing experience for you. It is only by constantly making use of every spiritual opportunity that comes in our way that we can grow in grace and in power to be worthy of our Christian calling.
