

MINUTES OF THE FOURTH ANNUAL MEETING OF THE WOMAN'S AUXILIARY OF THE DIOCESE OF MARQUETTE.

The Annual meeting of the Woman's Auxiliary of the Diocese of Marquette was held in Grace Church, Ishpeming, on Tuesday, June, 13th 1891. The Holy Communion was celebrated at ten o'clock, the Bishop being celebrant assisted by the Rev. Joseph McConnell.

The afternoon was spent in a business meeting which was called to order by the Bishop at 2:30 and opened with prayer. In the absence of the president, Mrs. Palmer, the Bishop presided over the meeting.

The report of the Church Periodical Club was read by the diocesan correspondent, Mrs. Eldredge.

Bishop Williams spoke of the United Offering of 1898, and requested the Secretary to send to Miss Emery for the blue mite boxes to be distributed throughout the diocese for the collections of the United Offering of 1901. He also spoke of missionary work in various parts of the diocese and suggested work for the Auxiliary.
