MINUTES OF THE ANNUAL MEETING.

The thirty-first Annual Meeting of the Woman's Auxiliary of the Diocese of Marquette was held at Trinity Church, Houghton, on Tuesday, October 26, 1926.

Holy Communion was celebrated at 10 a. m., with the Rt. Rev. R. L. Harris as celebrant. Bishop Harris was assisted by Dean Southworth, Archdeacon Poyseor, Rev. Mr. Attridge, and Rev. Mr. Kirkbride.

Dean Southworth, of St. Paul's Cathedral, Marquette, preached the morning sermon, which follows, in part:

Text, "God sent not His Son into the world to condemn the world, but that the world through Him might be saved."

"I quote from President Morgan, of Antioch College, "The old world of arbitrary authority is passing. A new world of belief and conduct based upon critically tested evidence is ahead. That the new world is a finer and more stable one I have no doubt. Transition from old to new, however, is so fraught with danger that easy going optimism is inadequate equipment for the passage. The old morality may have been arbitrary and ill adapted to modern life, while the new may go far toward meeting human needs; but if a period of no morality intervenes, the wreck of life may be so complete that society may have to climb its slow way again from moral barbarism."

We are, indeed, standing on the threshold of a new world. A reconstruction of society is at hand before which the reformation of centuries ago pales as a candle in the light of the sun. We are today 'hovering between two worlds, the one dead, the other struggling to be born.'

"Upon the youth of the country today, old authorities, old customs and old laws are not binding. There is no doubt that the majority are sincere and seeking for truth, but without definite standards of morality they are hopelessly adrift. It is our duty as Christian men and women to fearlessly face the facts. Unless we wish a reversion to *moral barbarism* some standard of morality must be aggressively set forward to stabilize the youth of our country.

"The attitude of youth toward civil law is not one of respect for the law *per se*, but rather an attitude of 'not to get caught.' Whether the elders are responsible for this attitude today, we must judge for ourselves. The Church and the Bible are politely ignored and the authority of the home is passed with a shrug of the shoulders. What hope is there to present a standard of right and wrong that shall be regarded as binding upon our boys and girls?

"Jesus lived in a day of strict law. A day when law observance resulted in the moral debauch of a pharasee. Hypocrisy we do not want. Jesus summed up the whole duty of man as to the law of His day in the words, 'Love God and love your neighbor. On these two commandments hang all the law and the prophets.' We shall do well if at the present time we promulgate Jesus' interpretation of duty to civil law and the modern prophets.

"The law of love prevents a person taking a course of action that will bring pain or distress to another. What boy would wilfully run over a child with his car? We believe he would first cut off his own right

hand. It is our duty to show him the result of certain courses of action and the pain and misery which follow and then let him make his own decision as to what is right or wrong according to the law of love. If a girl stops to consider that what she is doing would break her mother's heart, the law of love will determine whether her actions are right or wrong. If a man desires to take a drink and thinks of a weaker brother who cannot control his appetite but makes a hell of his home on account of liquor, he will himself refrain, guided by the law of love. So in every crisis of life there is one unfailing standard upon which all the law and the prophets hang and that standard is the Christian law of love.

"It is our privilege and responsibility not to condemn the youth of the present day, but in sympathy and kindly understanding to give them the law of Christ by which to guide their footsteps. To us Christ has given the keys of His Kingdom. We are the ones that have the opportunity to save our boys and girls from moral barbarism and to usher in the new day of the Kingdom of God on Earth!"

The business meeting was called to order at 11:45 a. m. After prayers offered by the Bishop, the President's report, roll call and the report of the Diocesan Treasurer were given.

The President's report follows:

We are meeting today to listen to the report of the work of the past year, and to discuss and adopt ways and means of carrying on the work of the coming year.

In many ways the work of the past year has been very satisfactory; in other ways, it has been somewhat disappointing.

Nearly every parish and mission has met its budget quota, and in a few parishes the membership and interest has been materially increased. I have been very much pleased at the promptness shown in responding to the request of the Supply Department. Nearly every box was on its way early in the year, which is desired by our Secretary at headquarters, and which, of course, is most acceptable to the recipients.

The report of the United Thank Offering is most encouraging; \$479.10 is the amount reported this year — more than a hundred dollars in excess of that of last year. A fine beginning, surely, for the first year of the new triennium.

A number of personal contributors to our pledges have failed us or have reduced the amount of their contributions, so that we must look elsewhere for further assistance in their behalf.

We are sorry to lose from our Diocese one who has devoted much of her life to the cause of missions—Mrs. Austin Farrell. Mrs. Farrell's untiring effort has brought the W. A. of the Upper Peninsula to its present splendid standard of achievement. Our deepest sympathy goes out to her in her recent bereavement, and our prayers will go with her to her new home.

I regret, too, to have to announce to you the resignation of the Correspondent of the Church Periodical Club. Through the devotion and zeal of Mrs. C. J. Shaddick for a number of years, books and magazines have been sent to Africa, China, Japan, Porto Rico, Honolulu, and to many parts of the United States.

Though this work is not properly a department of the W. A., we have

been glad to have these reports given at our annual meetings, showing the excellent work that has been carried on through the Church Periodical Club. It is to be hoped that our Bishop may find some one who will carry on this most important work.

Turning our attention to the work of the coming year, there are a number of projects that must receive our careful consideration at this time.

Under the able direction of our Educational Secretary, Mrs. C. V. Seeber, it is expected that our Study Classes will increase in number and interest this coming year. The book "Beyond City Limits", it would seem, is especially adapted for a careful study in this Diocese, and much practical benefit should result therefrom.

And we must look to the subject of *our pledges*. As stated above, a number of contributions to two of the funds, the Bishop's Emergency Fund, and the Dora Rowe, or Alaskan Scholarship Fund, have failed us, either by removal from the Diocese or by reduction in the amount of their contributions. Either the Parishes should accept a larger budget quota, or new contributors should be found, or both, in order to meet these pledges.

At the time of our annual meeting last year, it was expected that the W. A. would be called upon at the triennial to help meet the deficit of the General Church. Our Bishops, however, made it unnecessary for us to do this. But there was a feeling that much of the work of the General Church that was already under way would be curtailed because of the extra effort put forth by the Dioceses to meet the pledges of the Bishops. After much discussion, a resolution was finally passed to raise a sum of money, \$100,000.00, called a Corporate Gift, to help to carry on the work that was already begun. It is one of our duties today to decide what we can do in behalf of the Corporate Gift.

A provincial project is again before us. At the meeting of the House of Church Women last January it was decided to discontinue the Carry-on Fund. As a sum amounting to \$558.25 had accumulated, the decision was reached to divide this money among four Dioceses in this province, and Marquette was one of the fortunate four. But we must determine what use shall be made of this money before it is forthcoming.

A number of Dioceses have taken up the project of the Gold and Silver Offering. As you know, the proceeds from this offering are to go towards the rebuilding of St. Margaret's School in Tokyo, a school of some 600 pupils, with a staff of 30 to 40 teachers. Since the earthquake in 1923, they have been seriously handicapped for lack of adequate facilities to carry on their work. Cannot the Diocese of Marquette do its part in helping to get St. Margaret's again on its feet?

Among a number of important resolutions passed at the Triennial last October, are the following:

That the W. A. be urged to assist the Diocese in the advance work of the program assigned to that diocese.

That the status of the United Thank Offering be in no way affected by the action taken upon the Corporate Gift.

That we help to find markets in America for the production of handicraft from the various mission fields.

That we promote the circulation of the Spirit of Missions, and appoint a parish representative.

Another important resolution passed at the Triennial, one that should command our careful attention, is this:

Be it Resolved, that we (the delegates) go back to our Diocesan and Parish Branches dedicated and committed to:

1. The payment in full of all general church quotas.
2. The overcoming of lukewarmness by deeper spiritual understanding and greater consecration through prayer and sacraments.
3. The awakening of the women of the church to more effective service for Christ.
4. United parish effort.
5. The strengthening of our rural and foreign-born work.
6. Closer relationship with the missionaries in the field.
7. The carrying out of a constructive program of education for peace, and the use of our best efforts and strongest influence towards the promotion of international and inter-racial good will.

In closing may I thank you for the splendid way that you have come forward this past year, and met the demands that have been placed upon you. In the year ahead of us, I anticipate the same loyal spirit of co-operation.

There is a place in the Master's vineyard for each and every one of us. Shall we not take it and say, "Here am I, Lord?"

The roll call showed ten Parishes were represented by fourteen delegates. Upwards of fifty women, active members of the Woman's Auxiliary, also attended the meeting.

The Treasurer's report was accepted as read, and ordered placed on file. It will be found in detail on the latter pages of this report.

The mid-day prayer was offered at 12 m.

A short talk was then given by the President on the organization and work of the General Church. The President and National Council, the Executive Committee the departments of Church work, the Budget Quota and our obligation to it, were the chief subjects of discussion.

At 12:30 a delicious luncheon was served by the ladies of Trinity Guild. Dean Southworth expressed the appreciation of all present, and asked for a rising vote of thanks, which was gladly responded to.

The afternoon session was called to order at 1:45.

After the regular Woman's Auxiliary prayer was offered, an opportunity was then afforded the Bishop to address the meeting.

"The Menace That Is Creeping Into Our Church", was the subject of his message, and it was listened to attentively by all present.

The book to be used in study classes this year is, "Beyond City Limits". A splendid review of it was given by the Educational Secretary, Mrs. C. V. Seeber. It is hoped that all of the Parishes and Missions will take up the book this year, and that it may be applied, so far as possible, to our own Diocese.

As there were deficits in two of the pledges—the Dora Rowe Scholarship Fund, and the Bishop's Discretionary Fund, a motion was made and carried that certain surpluses from other funds be applied to these def-

icits, and that the parishes contribute enough to make up the balance. Their pledges were as follows: Escanaba, \$3.00; Houghton, \$5.00; Calumet, \$2.00; Negaunee, \$1.00; Iron Mountain, \$2.00; Ironwood, \$2.00; Marquette, \$3.00; Ishpeming, \$1.00; Sault Ste. Marie, \$1.00.

The morning offering of \$24.86 is to be given toward the completion of a Rectory at DeTour.

A motion was made and carried that the Parish and Mission budget quotas be increased enough to meet the pledges.

The subject of the Corporate Gift was discussed and pledges for the triennium were made as follows: Houghton, \$100.00; Marquette, \$150.00; Sault Ste. Marie, \$150.00; Ironwood, \$50.00; Iron Mountain, \$30.00; Calumet, \$24.00; Escanaba, \$15.00; Negaunee, \$25.00. At the annual meeting a year ago, \$600.00 was pledged for this fund. It is hoped that the remaining Parishes and Missions will make their pledges soon, in order that the full amount may be assured. Mrs. William C. Seitz, of Ironwood, is the Custodian.

The possibility of securing a Church Worker from the Field Department for this Diocese was then taken up. The president was given permission to correspond with the executive secretary, Miss Grace Lindley, in regard to securing such service.

As a number of the Dioceses in the U. S. have undertaken, with excellent results, the project of the Gold and Silver Offering, a motion was made and carried that this Diocese also promote this undertaking. The first two weeks of Lent are to be set aside for the carrying out of this project. Mrs. D. B. McIntyre, Escanaba, was appointed general chairman.

A splendid report of the meeting of the House of Church Women, held recently in Racine, was given by Mrs. C. L. Attridge, of Houghton. Mrs. Attridge told us of the work done in Rural Districts in the department of Social Service; of the Periodical Club exhibit; of the Carry-On Fund being abolished; of the joint session of the Synod and House of Church Women, and of the help given to fallen girls.

A motion was made and carried that the National Executive Board Expense Fund be increased from \$20.00 to \$25.00.

Officers for the coming year were elected. A list of the same will be found in the fore part of this report.

An invitation was accepted from Iron Mountain for next year's meeting to be held on the Fourth Tuesday in September. It was the sentiment of the Auxiliary that the Annual Meetings hereafter begin at 9 A. M.

Owing to limited time, further reports were omitted, but will be found on the latter pages of this report.

Interesting accounts of work undertaken by several of the parishes, a few of whom are working in the five fields of service are here given.
