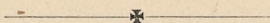

CONSTITUTION

— OF THE —

Baltimore Branch of the Woman's Auxiliary.



ARTICLE I.

This Association shall be known as the "MARYLAND BRANCH OF THE WOMAN'S AUXILIARY" to the Board of Missions.

ARTICLE II.

Its object shall be, by means of individual and corporate effort, to diffuse Missionary intelligence and to increase Missionary activity among the women of the Diocese; also, to unite Societies already in existence, and to urge the formation of such where there are none.

ARTICLE III.

All Parish Societies, and all individuals desiring to be members of the Diocesan Branch, will be so considered.

ARTICLE IV.

The Officers of this Association shall be a President, four Vice-Presidents, Secretary, and Treasurer. The aims to which these officers shall direct the intention of the body, shall be the raising of money for the support of Missionaries and Teachers, for the education of those preparing for the work, and other Missionary objects,—the making, collecting and transferring of clothing and other material aid,—and the circulation of papers and leaflets which may serve to stir up a public interest in Missions—Diocesan and General.

ARTICLE V.

It shall be the duty of the President to preside at business meetings, to call special meetings when occasion shall arise, and together with the Vice-Presidents to obtain fresh information from the Mission field, to be circulated whenever opportunity shall offer.

ARTICLE VI.

It shall be the duty of the Vice-Presidents to enlist the interest and sympathy of the Parishes about them, in the different sections of the Diocese, and to preside over meetings in the absence of the President.

ARTICLE VII.

It shall be the duty of the Secretary to conduct correspondence of Association, especially with General Secretary of Woman's Auxiliary, to keep minutes of the proceedings of the Association, to send out notices of stated and special meetings, to keep a record of Missionary Reports, and to prepare an Annual Report.

ARTICLE VIII.

The duty of the Treasurer shall be to receive and keep account of all moneys contributed to the Diocesan organization, to pay all debts, and to present an Annual Report.

ARTICLE IX.

There shall be an Annual Meeting of the Branch on the Tuesday before the Diocesan Convention in May,—at such hour and place as may seem desirable,—also one on the second Wednesday in November.

ARTICLE X.

Election of Officers shall take place at one of these meetings, and they shall continue in office for one year, or until their successor shall have been appointed. In case of a vacancy in the office of President, the names of persons nominated by the Parishes shall be submitted to the Bishop for his approval and appointment.

ARTICLE XI.

In order to defray necessary expenses for printing, postage, and stationery for use of Association—as well as to meet objects to which the Association may be pledged as a whole—a Central Fund shall be formed by voluntary contributions, the collection to be made in any way the Parish Branches shall find expedient.

ARTICLE XII.

This Constitution may be altered or amended by a two-thirds vote at any semi-annual meeting,—notice having been given at a previous meeting.



Secretary's Report.

The annual meeting of the Woman's Auxiliary was held in Grace Church, Wednesday, November 8th, 11 A. M., opening with a celebration of the Holy Communion. In the chancel were Bishop Paret, the Rev. A. C. Powell and Rev. Wm. R. Turner. The presence of a number of clergymen in the audience testified to gratifying interest in the Auxiliary. In his address, the Bishop reminded the delegates that their coming together was not so much for a business meeting as for a devotional service. He would speak words to stimulate and encourage the Auxiliary to rise up to the needs of the times, and truly and more generously give, proving herself what she had always been, a grand auxiliary to the Board of Missions. Though a stormy day, there was a good attendance of delegates and visitors. At one o'clock luncheon was served in the Sunday School room, and at 2 P. M. the delegates assembled in the chapel.

After preliminary business, the President introduced Miss Stuart, of Virginia. In a helpful address, Miss Stuart outlined the work of the Auxiliary in Virginia. While interested in the useful side of our work, she urged us to cultivate the Divine side, ever remembering its effect upon the spiritual life of the individual member, proving the truth, that "he that watereth shall be watered also himself." Thanking her for kind words, Mrs. Sioussat tendered from the Maryland Auxiliary greeting and sympathy to the Virginia Branch, which was responded to by a rising vote.

Mrs. Sioussat then presented to the Maryland Auxiliary a greeting from the Missionary Council in Chicago. Forty dioceses were there represented, and many women testified to the stimulus given at the meetings in Baltimore in 1892.

The paper prepared and sent by the committee on "Systematic Giving" was read, clearly showing that by concerted action the women of the Auxiliary "can add substantial and reliable help to the ever-increasing needs of the Church;" after which followed general discussion on the ways and means of systematic giving. Our President stated, that, as a body, we had not heretofore given anything outside the Diocese, but she hoped that the offerings would be so increased there would be a fund over and above the \$300 pledged annually for the silent churches, which could be given to the support of a woman in the Foreign field, which suggestion was voted upon and adopted.

A parish report was read by Mrs. M. B. Hammond, of Emmanuel Church, giving a most interesting account of their work.

The meeting adjourned with singing of the Doxology.

During the winter the presence of our President here and there with timely words of advice and encouragement stimulated activity among weaker branches. By invitation she also visited the Diocese of Easton, in her lucid way explaining the aims and methods of the Auxiliary and furthering the organization of new branches.

But one more year is left for the gathering of the united offering to be presented in October, 1895. In the words of another: "The object is far-reaching in its blessings, giving to some of God's people for all time to come the loving care of a Bishop and Shepherd of souls, and saving to the Board of Missions for all time the annual expense of the Bishop's personal support. The entire plan of the united gift is the result of one woman's interest, and the \$2,000 already in hand for the next triennial meeting are the result of the words of a Diocesan officer who used an opportunity to interest a woman, who did not know about it." Let us, then, with quickened zeal, feel it our privilege to kindle interest in this noble work, that Maryland's offering may prove us not unmindful of our rich heritage of Gospel privilege.

At the first meeting of Diocesan officers (a most enthusiastic one) in the Church Missions House, New York, it was

decided, as a thank offering for the new home of the Auxiliary, that they should fit out and pay the salary of three missionary women. They were prepared to go to foreign fields, but the Board had no funds to send them. Fifteen hundred dollars were immediately raised by the ten or twelve dioceses represented, and it will be a privilege to add our mite towards completing the required sum, \$2,200.

The furnishing of the Auxiliary rooms also appealed to our interest, and I hope we have done what we could in forwarding our contribution. Here, daily at noon a prayer service calls aside the busy workers. Dr. Bunn, in his paper on "Prayer and Missions," tells us, "there is probably no other hour of the twenty-four in which so many prayers are ascending and have been from ancient times. The thought that at a definite moment, millions of men of all faiths are praying, the burden of their petition being 'Thy Kingdom come,' is immensely stimulating to friends of Missions."

It was urged by the council that each member of the Auxiliary unite in this world-wide petition at the hour of noon.

The May meeting at Ascension Chapel was fully attended. Opening prayer and words of cordial welcome were given by the rector, Rev. C. C. Griffith.

The re-election of officers made no change. The President resumed the chair with kindling enthusiasm. She spoke with gratification in presenting reports from different branches of Mission work. Mrs. McLane read a report from St. Paul's, showing the Mother Church to be actively working.

Mrs. Currie's report of the Indian Aid Association told of Bishop Hare's visit last autumn, reawakening interest in Indian Missions; she pleading for continued and more general sympathy in their behalf.

Miss Emery's address stirred our hearts to give generously towards the united offering of 1895. She reminded us of the women working in Calcutta, in China, in Alaska, eager with us to make the general offering a noble gift. She spoke encouragingly of the educational work of the Auxiliary and gave a most interesting account of services in the Church Missions

House, giving God-speed to the women going forth to Alaska and Africa, and to a third now fitting herself to join Miss Dodson in China, whose work was briefly sketched. That trained and skilled workers were being sent forth as a thank offering was surely an answer to the prayer for more laborers.

After some discussion, it was decided to divide the surplus in the treasury; giving to the thank offering for sending forth women to foreign fields, \$50; to general missions, \$25; to Miss Ives' salary, South Dakota, \$25.

The amount to be contributed to Central Fund was left optional with the branches.

After singing the Doxology the meeting adjourned.

Tea at the rectory under the genial hospitality of the ladies of Ascension closed a delightful reunion.

Let us carry with us a spirit of more faithful consecration, of earnest prayer for the ingathering of "the fields; for they are white already to harvest."
