JANUARY 23, 1896.

AT the meeting of the officers of the Massachusetts Branch of the Woman's Auxiliary, held February 17, 1896, the following minute was prepared and was adopted at the monthly meeting of the branch, February 19:

The officers of the Massachusetts Branch of the Woman's Auxiliary to the Board of Missions wish to express and put on record their sense of personal loss in the death of Miss SARAH J. CHASE, for nine years the devoted and efficient treasurer of the Massachusetts Branch, and before that time an interested and faithful worker in the Foreign Committee.

Her ability in her work, her excellent judgment, her remarkable accuracy in detail, her quiet, unfailing interest in all that affected the missionary work of the Church, and her loving cordiality, which transformed an ordinary greeting into a pleasure to be remembered, will make her office a difficult one to fill.

An earnest and devoted Churchwoman, her love for her Master found its natural expression in service which often demanded sacrifice of time and strength in her busy life.

It is not difficult, in her case, to listen to the echo of the Master's benediction, which we believe her to have already heard with joy beyond the language of earth:

"Well done, good and faithful servant, enter thou into the joy of thy Lord."

## BY-LAWS.

---

I. There shall be a Public Anniversary of the Society in the Autumn of each year, with missionary addresses or a sermon; upon which occasion a collection shall be taken up in behalf of the Society.

II. There shall be an Annual Meeting of the Society upon the third Wednesday in October, unless otherwise duly notified, at such time and place as the Officers and Standing Committee shall indicate.

III. The election of Officers and of the Standing Committee shall take place at the Annual Meeting, and they shall continue in office one year, or until their successors shall have been appointed.

IV. In case of the vacancy of any office by the death or removal of its occupant, the same may be filled by nomination of the Standing Committee, which nomination shall be approved by the Society at a Stated Meeting; and any person so elected shall continue in office until the next Annual Meeting.

V. Ladies coöperating with the Massachusetts Branch of the Woman's Auxiliary to the Board of Missions, will be considered members of the Society.

VI. Ladies appointed by the ministers, or by the benevolent organizations of Churches working with "The Woman's Auxiliary, &c.," as delegates, shall be enrolled accordingly, and shall be the members entitled to vote at its meetings; Provided, that the number of such Delegates from any church shall not exceed three for each Division of the work undertaken by said church or any of its working Societies. The Officers and Standing Committee shall also be entitled to vote at its meetings.

VII. The Stated Meetings of the Society shall be on the third Wednesday of each month.

VIII. At Stated or Special Meetings of the Society, twenty members entitled to vote shall constitute a quorum; but at the Annual Meeting, members representing not less than one-third of the Churches connected with the Massachusetts Branch of the Woman's Auxiliary, or else, not less than forty members entitled to vote, shall be requisite to form a quorum.

### NINETEENTH ANNUAL REPORT.

---

As we gather once more to listen to our Annual Report, we know that there is so much of a practical nature to be considered that there is scarce time to devote to moralizing, yet can we not spare one moment in which to recall the many blessings which have come to us in the past year? Have we not been given the opportunity, as we have met here from month to month, of hearing from those who are themselves laborers in the great Missionary Field, of the work that has been done and is still waiting to be finished? Should we not stop and think for a while how grateful we ought to be that by this information we are given the channels wherein we can let run our best and purest inclinations? Whether these inclinations lead us to assist those in the South or in the West, or in far off Africa or China, we know that by so doing we are at least making an effort to help one another, and should be thankful that in this way we are taught to forget our own petty selves in the great cause of humanity which asks something from every one of us, old and young alike.

It is not necessary to call your attention to the memorial page which precedes this report, for the dignity and sweetness of Miss Chase's character, as well as her fine capacity of accomplishing so well all work which came under her supervision, made her personality so marked a one that her memory can never be forgotten by those who were connected with her in the work of the Auxiliary.

Two new names are added to our list of officers, that of Miss M. B. Foote as Treasurer, and that of Miss Henrietta Sargent, who has recently been elected to the new office of Assistant Secretary (in charge of the Junior work). For a long time the necessity of having such an officer has been greatly felt, and we are surely to be congratulated in obtaining for the position one who is so full of enthusiasm for the work, and who only needs the coöperation of the children to make the Juniors in Massachusetts as important a factor as they are in many other States.

Of course, much is now being done by the children, but how much more would be accomplished if they were all banded together under the head of the Junior Auxiliary. Surely each child would be more interested to feel that he or she, as the case might be, were a member of an organization which expected yearly to accomplish a certain

amount of work. Then again, does not the Junior Branch fit and train the child for the work of the Woman's Auxiliary?

Will you not give the matter serious consideration, so that by another year we shall not have to dwell upon the advantages and necessity of the Junior Auxiliary, but rather hear with gratification of the many parishes where branches shall have been organized.

Another change we note with regret is the resignation of our Auditor, Mrs. F. A. Fiske. Those who have had charge of the accounts have fully appreciated the prompt care and attention given to the work, and the Massachusetts Branch certainly owes Mrs. Fiske the deepest gratitude for her faithful services during the past eight years. At the May meeting the name of Miss C. F. Neal was proposed and voted upon for Auditor, which position she kindly consented to accept.

The principal event to be recorded in connection with the Worcester District, which is always so alive in doing good, is the Quiet Day, which was held on February 25th, in All Saints Church, Worcester. The readiness of the Bishop of the Diocese in giving his time to conduct this service was greatly appreciated, and the day was considered one of interest and benefit to all who were fortunate enough to be present. Twenty-six dollars, a portion of the offering taken on the occasion, was generously contributed to the general expenses of our Branch of the Auxiliary. Another thing which should be noted in the District is the fact that special parish missionary meetings are much more generally held, as well as more largely attended, than formerly.

When we think that only three brief years have passed since the present Vice-President took up the work of the South Eastern District, we feel more than content with the report that out of the twenty-four parishes there are nineteen doing work through the Auxiliary. This District held a Missionary Conference on February 10th, at Bridgewater. Aside from the interesting account then given on the educational work in Mara, Japan, by the Rev. Mr. Dooman, papers were read by several clergymen of the Diocese, after which the special subject upon which each touched was fully discussed, and in this way not only exchange of thought was gained, but a better understanding of the question in point.

The Berkshire and Connecticut Valley Districts are working well; in the latter a general District meeting was held at Northampton, in February, and was in every way a success.

It seems the duty of the Secretary to remind you of any general object connected with the Auxiliary, so let us remember to begin to save, if we have not already done so, for the United Offering of 1898. Should there be any who have not a mite box for this purpose, will they not procure one at once, so that nothing shall be lost to swell the sum which is so much needed "for the training, sending out and support of women workers in the Missionary Fields."

No doubt many here know that in a few days the Auxiliary at large celebrates its twenty-fifth Anniversary, but there may be those who have overlooked the fact, and it would indeed be a pity to do so. Is

not such an occasion a splendid starting point to take up the work anew, or possibly to give some gift in loving memory of a friend, or yet again a thank offering in recognition of some blessing which may have come to us. While we are speaking of the Anniversary, I would call your attention to the Hand-Book of the Auxiliary, which has recently been compiled by Mrs. Twing, the Honorary Secretary. The book gives a sketch of the organization of the Auxiliary, as well as much valuable and interesting information which is sure to be of use to every officer, as well as member, of the Auxiliary. The price of the book is but twenty-five cents, and it is hoped that it will have as large a circulation as it assuredly deserves.

Thus far we have only looked at the mere outline of our work, but we now are to hear in detail from each Committee, and in listening to these reports let us resolve not only to do as much as we have done in the months that have passed, but redouble our energies, for "the night cometh when no man can work."

#### DOMESTIC DIVISION.

THE Annual Meeting of our Branch of the Woman's Auxiliary has come to us again, and a report of the year's work is expected from our Secretaries. The work of each year is so much like the work of each preceding year that an interesting report, like an "interesting missionary letter," is a very choice and almost a rare article, but as we write the thought comes to us that the year is but poorly crowned if we consider our annual meeting only as a point from which to look back, the thought of writing at such a time would be appalling, but if it is to us the point from which to start afresh, looking for new work, then do we take courage, trusting in the might of the Living God, and in our own might coming from Him, and the report becomes quite secondary and almost writes itself.

The total result of the work for 1895-6, which you will find in the printed Reports, stands a little in advance of last year's. The pledges which the Domestic delegates made have all been redeemed. The Sunday School children have been faithful to their Penny Collection and we wish that every School would join in this offering.

Dr. Forsythe has proved a competent and faithful worker with Bishop Brooke in the Diocese of Oklahoma, and has received the salary which was promised by us. Dr. Forsythe is very happy in her work, and has inspired the people in her own Diocese by her earnest spirit so that a small church has been built and paid for by them. The Hospital is in working order, and has ministered to many sick and injured people who without it could not have had proper care. We have also been able to help Bishop Gray, Bishop Graves and Bishop Talbot in their work.

Miss Turner, the Secretary of the Diocesan Division, reports that the work of this Division has been successfully accomplished. More than the amount pledged has been contributed, but increased interest for the new year is asked.

The Altar Society has been helping on every side with even more than its usual efficiency. The last time that we heard from Miss Parker she said that the great need of the Society was the interest of persons willing to sew on cassocks and surplices.

Surely we all wish to do better work this year than ever before, and we know that hearts, minds and hands given to God for His use will bring the fulfilment of the wish; so let us forget the things, both done and undone, which are behind, and press forward with strong purpose and perfect faith to the mark of the high calling which alone means life.

#### THE INDIAN AND COLORED PEOPLE'S DIVISION.

As we render our Report anew, we wish it were possible to speak, not only of the little we have done, but of the greater opportunities which are constantly opening for effective work among the Indians and Colored People.

Year by year, the Government thinks it worth while to gather and publish extended reports on the progress and needs of Indian education. The Government schools are often in friendly relations with our missions, and we are allowed to supply that which they lack. Our own boarding schools go bravely on. More money would equip them with means for larger usefulness; they are full to overflowing; yet all we can do is to beg our friends to continue and to increase their scholarships, and to send the much needed boxes of supplies of clothing. The Indian scholarships are sixty dollars, but in the southern schools scholarships of from two to twenty-five dollars make possible education for children who would otherwise go untaught. Mr. Deal's cooking school has been entirely supported by us and the success of its students in obtaining situations is its best recommendation.

In Utah, as well as in Minnesota, the Indian women are learning lace making. We may help by direct gifts of money, or by purchasing the lace. The distinct missionary work in Utah and Oklahoma is most hopeful. The Rev. Mr. Sanford, in charge of the work in Oklahoma, longs to train, in that region, native catechists and teachers as Bishop Hare has done in South Dakota. David Okerhater, one of Mrs. Burnham's "boys," is now a helper, yet he is but one.

Mrs. Payne's support makes no longer a part of our responsibility; it has been assumed by the General Board.

Three women are of special interest to us. Miss Wheeler, whose work in Columbia, South Carolina, has been known to many of our parishes, having established that work on a sure footing, has now gone to Southern Pines, North Carolina, a new mission, where she will

begin a work similar to that in Columbia. We desire to consider her still our missionary, and to provide for her support as heretofore.

For Miss Sabine, last year, came not only gifts from various parishes, but the Girls' Friendly Society, of Massachusetts, devoted its yearly offertory—its missionary pennies, more than two hundred and eighty dollars—to the support of Miss Sabine's work in far off Alaska. In her letter to our Auxiliary, written last summer, she says: "It touched me to tears to see in the list of contributions so many from different parishes with my name, so that I might stay up here and go on with my work. And often and often in discouraged days I have thought so many are *praying* for this work at home, that surely it cannot altogether fail, and I have taken new courage and heart to persevere." When next summer our present Annual Report reaches her, is it not good to think of the message of cheer that the girls of Massachusetts send by their gift?

In Oneida, the Indian trained nurse, Lavinia Cornelius, is at work among her people. Already we hear of a three weeks' struggle with typhoid fever in which Mr. Burleson declares that it was the nurse that won the victory; already we hear that a few friends have provided a portable cot that she may not sleep again on the bare ground. Four dollars supports her for one week, and those who so generously gave last year will surely desire to see her work continued. One thousand dollars would fully provide for the support of these three devoted women. Can we not pledge it?

As the members of your committee visit from time to time the parish branches, they wonder more and more that any parish can be content to take no part in our missionary work. In the smallest and youngest parishes there is often the most interest and enthusiasm. A very small sum of money, a very small package of clothing, may be of the greatest assistance. New methods are constantly developing. Whether we in Massachusetts can ever imitate so perfect and economical a plan for fitting out missionary boxes as that of the Albany Storage House Committee, remains to be tried, but that the united counsel and effort of the Churchwomen of Massachusetts can do more than has ever yet been done, we are sure.

As we read the letters of our missionaries or listen as they come to tell us the story of their work, we realize that it is the absorbing purpose of their lives—there are no side issues with them. Whether we think of the women like Miss Francis who have spent their lives in the western wilderness among their Indian children, or of Dr. Driggs, simple, modest, heroic, as he goes back alone to the shore of the Arctic Ocean to minister to the bodies and souls of his half savage people, or of Miss Wheeler, sympathetic, wise and gentle, the friend of her ignorant and affectionate people,—they and all the rest are carrying the good news of God to the poor, the blind, the ignorant, the sinful, as our Lord bade His disciples do—as He did Himself. Let us pray for them that they may be wise and strong and patient. Let us pray for ourselves and for each other, that he will so deepen our love for Himself that we may all serve Him better.

## FOREIGN DIVISION.

LAST year, at the Anniversary Meeting, our three Foreign Bishops laid before us, all two briefly, the needs of their respective missions. Each address was a highly condensed, but thrilling statement of what Christian effort had already accomplished, as well as a most urgent appeal for that home support, without which the work cannot go forward successfully. No doubt we all felt, upon that occasion, that we would willingly make many and most real sacrifices in so sacred a cause. Now another year has passed, and the time has once more come to ask ourselves, with genuine searchings of heart, what we actually have done or striven to do since we came together for our last Annual Reports.

The Treasurer's statement will show you that the sum of gifts is very nearly the same as last year, not taking into account several special donations then for special objects. We have not perhaps fallen off, but are we satisfied with merely this? Does not each one of us feel that she, personally, might have done at least a *little* more? And when we think how many individuals, and even parishes, are unrepresented by any offering whatever, shall we not strive to redouble our efforts for the coming year?

Miss Emery says in a recent letter: "I am always hoping to see the number increase of those who will provide substitutes for themselves in the Mission Field." So far from doing this to any extent, we have never yet, I believe, nearly made up, as a Branch of the Auxiliary, the salary (from six to seven hundred dollars) of a single woman worker, although one member gives individually about a fourth of that amount for the purpose. We desire this year, if possible, to assume the responsibility for Miss Bull in Japan. Is this too much to ask for those whose need of teachers and guides is so great?

From afar we seem to hear the voices of our brothers and sisters calling to us through the darkness that surrounds them, in a thousand varied tones of appeal, "Come over and help us." Some of these voices are more articulate than others, some speak our very own speech, and cry out importunately. "Save! we perish." That this is literally true of our Liberian Mission, we all know. Instead of opposition, we have the most plastic docility and the greatest eagerness to learn. The children come crowding into our schools, and fill them to overflowing, and the parents follow. Very real and lasting results are brought about, and, with a little more effort from us at home, the whole mass of the people would be won to a blessed and permanent Christianity. Since Mrs. Brierley's death, more than a year ago, our devoted Missionary, Dr. Sara Walrath, has been carrying a burden far too heavy for any one pair of shoulders, and she and Miss Woodruff together have accomplished results nothing short of wonderful. But, unless help is given to them, and that soon, they will die at their posts. And in addition to all the material difficulties that surround them, they are still without spiritual ministrations. How sorrowful is their continued but vain pleading for those consolations of religion which dear

Mrs. Brierley had to die without, and debarred from which it is impossible that their converts can be built up as they should be in the Christian life. To add to the spiritual deprivation of the mission, Rev. Keda Valentine, one of the few native Priests, and a most devoted and remarkable man, was killed last July while helping to defend a village against the attacks of a hostile tribe. May God raise up many in the place of this one!

For China, the outlook at present seems a bright one. The work of the Mission goes on with a slow but steady increase of power. The longed-for Training School has been brought to completion and opened under happy auspices. The workers all write most hopefully, and new ones are going out to bring reinforcement and fresh impulse with them—notably Rev. L. H. Roots and Rev. G. F. Mosher, accompanied by his sister, Miss Gertrude Mosher, from the New York Deaconess' School; also Rev. D. L. Huntington has been advanced to the Priesthood. But we must not forget that each new work and each new worker means a new claim on our alms and our prayers, and as the field opens up we must strive to make our home efforts commensurate with the ever fresh demands that are being made upon us.

In Japan, the Bishop's Report this month speaks, almost in one breath, of "a new era of peace and commercial prosperity for Japan," and of cause for "great anxiety as to the religious condition of her people." Our mission grows and prospers well, but the volatile, impressionable Japanese, sensitive to "every wind of doctrine," are suffering just now under that atmospheric wave of rationalism which has wrought so much havoc of late years in our western world. However, our schools seem to be all in a most flourishing condition, and new workers have gone out, among whom must be thankfully noted two Japanese clergymen, Rev. Dr. Motoda, a Priest, and Rev. K. Hayakaena, Deacon, who are now returning to labor among their own people after a term of study in America. Also, Mr. Evans has been ordained Deacon, and the St. Andrew's Brotherhood are sending a new layman to take his place as their representative.

Rev. Mr. Ambler and Miss Suthon are now with us on leave of absence, and will have much to tell us in the coming months.

Finally, must be chronicled, with mingled feelings of joy and sorrow, the departure of another saint to her just reward! Mary Mailes, who went out from our midst a few years past, in the flower of her youth, to give herself wholly to Christ for Japan, came back awhile ago to die among us, and passed away last month in great suffering of body, but in perfect peace and joy of heart. We laid palm branches on her coffin, thanking God for her beautiful, potent life and triumphant death. Once again may we say, for her, as for the others who have gone before her in the same glorious path, with full assurance of faith, "Blessed are the dead who die in the Lord. They rest from their labors and their works do follow them."

## MEXICAN AND HAITIEN DIVISION.

IT is good for us all to have pauses and beginnings in our work. It saves us from feeling that our task is monotonous, it gives us an opportunity of surveying it as a whole, and of taking a new start with fresh courage. And yet these periods of beginning and ending are only artificial. We must remember that all work is a continuous process, and not forget to bind ourselves to the past while we reach out to the future. And what is there in the past of our missions in Mexico and Haiti to which we must link ourselves as we begin a new year? Must we not remember the great goodness of God in His care of these two missions? It has seemed many times that both must fail. The unhappy political condition of Haiti, the revolutions that have racked the country, the fires that have wiped out the visible organization of the Church, the bad management and the bad men who have again and again thwarted our plans in Mexico, the financial distress which has crippled and still cripples it; all these have been met and conquered by the spirit of God working in the hearts of the patient, faithful souls that have served His Church in those two mission fields. Has any other work of our Church been so hampered? Has any other stood more triumphantly the test of Christian loyalty and courage?

In Haiti, Bishop Holly has gathered his people once more in a church building of their own. His sons are active in their coöperation with him. Rev. Mr. Jones, who began last January the first Protestant mission in the town of Aquin, has continued and extended his labors. In all parts of the island the missions are alive and active.

In Mexico, Mr. Forrester stands at his post with unflinching devotion. Every year the problem confronts him anew—how to carry on an ever increasing work with scanty and uncertain remittances from our church. And beside him stand the faithful Mexican missionaries, men and women, ready and glad to sacrifice all but the bare necessities of life to keep up the teaching and preaching of the Gospel of Christ.

Mr. Forrester says of his clergymen that the spirit of consecration which animates them is the one element that makes it possible to keep up the ministrations of the Church; and Miss Driggs, the head of the Orphanage, says of Mr. Forrester: "He has his heart so in this work, and so many discouragements, but despite all how he fights on, trying his utmost to do this duty to which God has called him!"

The educational work of the mission has now been carried on under Mr. Forrester for three years and a half, in the Dean Gray Memorial School. This brings in a new phase of the work. There are now men who are competent to go out and educate their people. Mr. Forrester writes: "It would do you good to see the enthusiasm of the men who are going into this new work. We are occupying three cities, all capitals of states, and within four miles by rail of Mexico. We are going to have a fight, and earth and hell will be against us, but so long as Heaven is on our side we are all right."

Miss Driggs, in the Orphanage, is educating the girls to coöperate in the same way. They go out as teachers, younger, more timidly, with

many backward glances to the safe and beloved home they are leaving, but with earnest purpose, and with their own womanly mission of love and helpfulness. Now are we doing our part in sustaining these devoted men and women? Our diocese has stood well among the rest as a contributor to this mission. Mr. Forrester writes most gratefully of the interest it has shown and the gifts it has forwarded, but for the past three years the amount sent to Mexico has diminished. We remember the financial depression that has visited us; we hope that this explains our lessened contributions, but we cannot help fearing that the lack is due to the absence of any special crisis, any urgent appeals for immediate help such as we have had in the past. Must we rely on exciting episodes in Mexico and Haiti for rousing the sympathy of the parishes? Is it necessary to have a vexed question of church canons considered at a stormy convention and discussed in wordy debate? Must a mortgage on church property be on the point of foreclosure, or a fire or a hurricane wreck the mission buildings in order to stir the hearts and elicit the contributions of our Church people? May not quiet, steady, heroic patience, and lofty though unassuming self consecration appeal to them? What the Church needs in Mexico and Haiti is this and nothing more:—regular contributions, not large, but general and systematic, from all the parishes of the diocese. If these were secured we should have done our part, and could no longer reproach ourselves with neglecting two most worthy and most needy fields of mission work.

As to the events of the past year, they are few.

Miss Driggs has now returned to the Orphanage, after a visit to her home, during which her father, her only living parent, died. Her brother had sailed for the Arctic regions but two months before, and it will be a year before he hears of his father's death. Brother and sister are far apart indeed, and father and mother have been taken away from their earthly labors. But who shall say that they are really separated who are one in God's love and service, whether here for His needy children, or in the Heavenly home?

Miss Driggs, since her return to Mexico, makes appeals for new scholarships in the Dean Gray Memorial School, and in the Orphanage, which will be duly presented to you at the next monthly meeting. But may not this meeting be a time for forming new resolutions to help Mexico and Haiti? Will you not let this report of your missionaries' faithfulness stir you all, as delegates from the parishes of Massachusetts, as well as in your individual hearts and consciences, to renewed effort? Remember the nearness of Mexico. It touches our border. Why should a river boundary, why should a difference in race separate us from cordial relations with our nearest neighbor? Let your hearts go out in love and sympathy to the poor and ignorant in Mexico and Haiti. And may God put it into all our hearts to be more earnest, more loving, and more self denying towards His poor, wherever they may be, in His great needy world.
