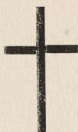

PRESIDENT OF THE MASSACHUSETTS BRANCH
OF THE WOMAN'S AUXILIARY

YEAR — JANUARY, 1921, TO JANUARY, 1922

DEAR FRIENDS AND FELLOW-WORKERS:

Before taking up the record of our work for the past year, it is my sad duty to announce to you the death of Miss Julia C. Emery on January 9th at Scarsdale, N. Y. As many of you know, Miss Emery was the General Secretary of the Woman's Auxiliary for forty years, having retired in 1916. She grew up in Dorchester, and from the parish of St. Mary's she went to the Headquarters of the Domestic and Foreign Missionary Society in New York to succeed her sister in the direction of the Woman's Missionary work of this Church.

Through her devotion and untiring efforts, the Woman's Auxiliary is now organized in every diocese and missionary district and its contribution to the life and work of the Church is too well known to dwell upon here.

Massachusetts is justly proud of this noble woman, whom to-day our Church throughout the world mourns and for whose life, spent so completely in the Master's service, thousands of hearts are filled with praise and blessings.

Let us, who claim her as one of the Massachusetts flock, strive to keep alive and pass on the heritage she leaves, namely, that of a simple life of quiet, unselfish devotion to Christ, which, through love and faith and untiring personal effort, bore witness to the Saviour unto the uttermost parts of the earth.

Let us also offer our thanksgivings to Almighty God for the good example she has set us here and for the victory of life which she has won in the world to come.

One very great joy to us all is that Miss Emery lived to take part in the celebration of our Golden Jubilee, and that she saw practically the completion of the Fund which bears her name.

It has indeed been a great Jubilee, celebrating the fifty years of the Auxiliary's life, and I am glad to say that, as I now take up our own history for the past year, Massachusetts has not only felt the inspiration and impetus of this semi-centennial but has responded with a general advance all along the line. I therefore congratulate you on the results of your

united efforts, and particularly upon the general spirit of good will which is evident throughout the Diocese.

We are living in a time of readjustment, when changes due to expansion and new methods make it difficult for us to see the way ahead very clearly; but may I put it on record now that no Diocesan President could have more cordial support in progressive work than is given here by our older women, such as Miss McIntosh, Miss Loring, Mrs. Soule, Mrs. Quincy, and many others I might name, who for years have been the pillars of the old Auxiliary.

Problems we have, but difficulties are nil, where the spirit of the women throughout the Diocese is one of earnest desire to do whatever is possible to make the work of the Church more effective in spirit and in actual accomplishment. My heart is full of gratitude for the privilege you have conferred on me of leading the finest body of women I have yet to find in the Church. If I am prejudiced, then you have made me so and the consequences must rest with you.

During the past year, we have met with a serious loss in the sudden death of Mrs. David F. Slade on January 31, 1921. Mrs. Slade was one of those rare servants of God, whose life and service was such that, when she passed without warning from active work here to the larger life beyond, the general comment of all who knew her, was that "She was ready." No higher tribute can be paid, and we record to-day our grateful appreciation of all that it has meant to be fellow-workers with her in the service of the Master.

One member of the Board has resigned, Miss Alice Perkins, the Assistant Secretary. Miss Perkins leaves us to be married with the prospect of making her new home in the Far East. We can but rejoice that one of our number who has been an active worker here may help to link us up personally with the people we are trying to reach with the Christian message.

One vacant office has been filled; but the new United Thank Offering Treasurer, Mrs. John Hurd, was already a member of the Board, having served as Vice-Chairman of the Latin-American Committee.

In looking through the list of events since last January, I find that the Quiet Evening and Morning at Trinity Church, lead by the Rev. Thomas A. Conover, helped to set the spiritual note of the year; and yet, when I think of the comparatively small attendance, I am sorely perplexed as to how to reach and interest the great body of our women in this yearly opportunity for inspiration and devotion under some of the finest spiritual leaders of our Church. The evening service is arranged expressly for those who are employed during the day, and yet the evidence is that very little effort is made in the parishes to make this service known and understood by the very people

it is intended for. Any suggestions for making the Diocesan Quiet Day more helpful to all the women will be gratefully received.

One of the two outstanding accomplishments is the work done in connection with the Jubilee, expressed chiefly in the Book of Remembrance, and the Alice R. Thayer Memorial, which was our contribution to the Emery Fund. This all culminated in our Anniversary Service on November 3rd, which I may safely say was one of the greatest services ever held here under the auspices of the Auxiliary. Lack of space forbids too many details, but the Book of Remembrance, which was presented by Miss Loring and dedicated by the Bishop, contains 2,495 names of faithful women of this Diocese whom we hold in loving remembrance for their lives of service in the upbuilding of the Church and the extension of the Kingdom.

One hundred and sixty-nine (169) Parishes are represented in the Book, and we take pride in recalling that in the parish lists are the names of the mother and the three Emery sisters, who founded and carried on the work of the Woman's Auxiliary for over forty years; the name of Mrs. Richard Soule, who started the United Thank Offering; Miss Edson, who founded the Girls' Friendly Society in this country, and Mother Louisa Mary, who was the first superior of the Sisterhood of St. Margaret here in Boston. Many more names are worthy of special mention, but one must turn to the records themselves to really appreciate all that our Book of Remembrance means.

It contains, of course, the record of the Alice R. Thayer Memorial. The final figures are \$9,294.94. Miss Sarah Whittemore presented the check when the Book was dedicated, and the Bishop made the Special Offering at the Altar.

The Book itself was designed and made by Mr. F. D. C. Palmer of the Rose Bindery. Mr. Palmer is a devoted Churchman, and the Auxiliary owes him sincere thanks for the loving labor which he put into this great memorial.

The actual cost of the Book was defrayed by many devoted friends, who made their contribution a veritable act of love. The lists of names from all the Boston churches were printed in by hand by Mr. John C. Clapp, Jr., a vestryman of St. Matthew's Church, South Boston, for whose generous service we are very grateful.

A final item which is interesting to record is that Mr. Wilson, who wrote up the account of the Book and Service for the *Transcript*, is a member of St. John's, Jamaica Plain. Through his courtesy, an excellent picture of the Bishop and Miss Loring was secured, — the photographer, Mr. Davis, being a member of Emmanuel Church, Braintree.

The other outstanding accomplishment to which I referred is rather a process of awakening to the call of world-wide ser-

vice, and an increasing response to the same. Since Bishop Moulton went to Utah hardly two years ago, five women have gone from this Diocese as missionary workers under him, — Alice McDonald, a teacher from Grace Church, Lawrence; Georgie Fitzsimmons, a nurse from Lawrence; Mary Ramsdell, a teacher from St. Paul's, North Andover; Marguerite Knapp, the Bishop's Secretary from the Church of Our Saviour, Longwood, and Clara Watson, a nurse from St. Anne's, Lowell.

During the year just over, four girls have gone to China, — Marian Little of St. Paul's, Newton Highlands; Geraldine Cabot, Church of the Advent, Boston; Mary A. Anderson and Mildred Capron from the Cathedral. One girl, Sarah Caselle, of Christ Church, Quincy, has gone to work among the Indians at the Wind River Reservation in Wyoming. Marian Knight of Framingham is still in training in the hospital, and I am told that there are three other nurses graduating this summer who are seriously considering volunteering for the Mission Field.

There are, as nearly as I can find out, forty-one workers from Massachusetts now in missionary service; five of these are Bishops and thirty are women. May I suggest, that as you hear these facts with satisfaction, you plan definitely to try and increase these numbers by keeping before the members of your parishes the need for workers in the Field, and the splendid opportunity the Church presents for worth-while service.

This is as true for young men as for women; and the need of recruits for the ministry at this time is a subject I commend to every Christian mother when helping sons to decide on life work.

The "Christmas Present Fund" has grown to be such a joyous bit of service, and has meant so much to us here as well as to our friends in the Mission Field, that it seems worth while to mention that \$138 was given in sums from five cents to five dollars. Forty-eight presents were sent, of which twenty-two were stockings filled with small useful gifts, jokes, etc. The letters of gratitude are so touching that it makes us realize what it means to be remembered by the Church at home.

Now a brief space for our year's regular work. The total of our gifts of money for Missions is \$16,854.49, of which \$6,824.37 counted on the Parish Quotas, so that in giving to designated items in our own Budget we have helped meet the Diocesan apportionment as well.

This large sum covers many items for work all over the world, beginning right here in the Diocese of Massachusetts, with contributions towards the furnishing of St. Cyprian's Rectory, hymnals for the new mission at Shawsheen, a piano for a mission church, and general gifts, all going to make the work here more helpful than ever before.

Outside the Diocese, it is interesting to note that all the

pledges for the Colored Work were met, including the salaries for two workers. Automobiles were sent to Bishop Page and Bishop Moulton, and we also did our bit towards helping to rebuild the Indian Church at Oneida, which is almost completed.

Some of the items in the Domestic Field include travelling expenses of Bishop Touret; the summer expenses of two little homeless girls at St. Margaret's School, Boise; the expenses of a missionary in the hospital, and the annual payment for the life insurance of Bishop Thomas.

In Latin-America so many interesting things were done that it is difficult to choose, but we rejoice that a substantial sum was raised for the Rev. John Droste's rectory at El Coto, Porto Rico. From the Charlotte M. Fiske Legacy, the little church in Bigonie, Haiti, has been built, and a bell provided for the Chapel of the Southern Cross School in Brazil.

The Foreign Field represents the largest budget, and covers many kinds of work in different corners of the Field. From China I find such items as the Famine, the new St. Andrew's Church Mr. Cotter is trying to build in Wuchang, a valuable set of surgical instruments contributed by a physician and given to Dr. Leonard as part of her equipment when she left the New England Hospital here to take up work at St. Elizabeth's in Shanghai.

In Japan, Mr. Goto's Mission has been greatly remembered, and among other things in Liberia, Bishop Overs' Trade School has been helped. Gifts for the expenses of a nurse in the Philippines and the salary of a teacher in Honolulu all go to show that in one way or another we are helping to bear witness unto the ends of the earth.

If gifts are one part of our regular work, another large part is covered by our supplies. The Massachusetts allotment was a generous one and carried us into every field and helped us to minister in many kinds of ways.

Clergy and other families right here in Massachusetts have been generously helped, individuals under the care of the hospital and prison chaplains, Diocesan institutions, in fact every appeal that finds its way to the Supply Bureau generally receives some aid through the splendid contribution of new and second-hand articles sent in for the Diocese from the parishes.

Twenty-four hundred dollars (\$2,400) is the value placed on Diocesan supplies, which cover chiefly what is known as Welfare Work.

When we look beyond the Diocese, we find seventeen personal boxes; supplies for mission stations, schools and hospitals; surgical dressings up into the thousands for St. James' Hospital, Anking, and others, and boxes of extra special things for bishops' wives in this country to help in their

personal work. The estimate in value is \$19,363.00, making our total for supply work \$21,763.28. One hundred and forty-eight (148) parishes have taken an active part in filling the Massachusetts allotment.

In my judgment, we have done no better piece of progressive work in connection with the present evolution of the Auxiliary than that which has been accomplished through the Church Service League Supply Bureau.

In connection with the Supply work, it is interesting to know that a report from the Church Service League says that the children in forty-three parishes sent out 2,400 gifts in the Christmas boxes to the Mountaineers of the South.

The Massachusetts Altar Society also reports that Altar furnishings and vestments have been sent to twenty-six dioceses and missionary districts valued at \$1,064.00.

The last work I have to record is the United Thank Offering, and here we have a marked advance in the amount. Twelve thousand five hundred and sixty-five dollars and eighty-eight cents (\$12,565.88) for the year past, which, with the offering of the year before and the interest, makes our account to date \$21,511.57.

At the beginning of our third and last year of the Triennial, we are far ahead of anything we have ever done, and we have before us the opportunity to make a great offering. However, it can only be truly great if it is a real thank offering, and the expression of a great number of thankful hearts.

If this record is to be summed up in figures, then the amount to be set down is \$60,867.09 for the year 1921. But that seems small to me compared to what lies behind the figures. I mean the devotion, the hard work, the fine spirit and purpose to help make this Church of ours reflect the mind and will of the living Christ, who ever works and extends His Kingdom through His followers.

It is because I know the spirit and ability of the women of this Diocese that I am confident of a future worthy of the past. It is perfectly evident that the Woman's Auxiliary is growing into something larger than it has known before. Great changes have already taken place, and in many parishes the whole plan of work is slowly expanding under the ideal of the Church Service League.

Let us realize that new terms and methods of work are but tools for more and better service in the interests of the Church's mission. When I see, as one can today, a parish of men, women and children all helping in the preparation of a Missionary Box for a large family of a priest on the frontier, and then gathering after a Sunday-morning service to inspect and add Christmas presents to the contents before the packing up takes place, I feel that the spirit of the old Auxiliary is bear-

ing fruit a hundredfold, and that in seeming to lose our life we have found it in the fulfilment of all the hopes of the past fifty years.

New England folk are cautious, but they are not apt to make fears a stumbling block to progress. SECRETARY'S REPORT

JANUARY, 1921, TO JANUARY, 1922

Nine meetings of the Massachusetts Branch of the Woman's Auxiliary have been held during the past year; two of these meetings were held in the Cathedral and seven in the Parish Rooms, on the third Wednesday of the month. The average attendance was 175 delegates from 67 parishes. There were ten speakers at these meetings, namely, Right Rev. A. W. Moulton, Utah; Right Rev. F. H. Touret, Idaho; Miss K. L. Cotharin, United Thank Offering; Mrs. George Biller, Field Secretary of the Woman's Auxiliary; Right Rev. H. R. Hulse, Cuba; Mrs. Ramsdell, Utah; Rev. David LeR. Ferguson, Boston; Miss Marion DeC. Ward, on her recent visit to China; Mother Ursula, Shasi, China; Miss Nina Johnson, Wuchang, China.

Eight meetings of the Standing Committee were held in the Diocesan House, Boston, the November meeting having been omitted. The average attendance of officers was twelve.

The Forty-fourth Anniversary Meeting was held in Trinity Church, Boston, November 2, 1921. The Bishop of the Diocese made an address and celebrated the Holy Communion, assisted by the Right Rev. S. G. Babcock, Rev. Alexander Mann and the Rev. John S. Moses. Following this service the Book of Remembrance, commemorating the Fiftieth Anniversary of the Woman's Auxiliary was presented to the Bishop by Miss Abby R. Loring. Miss Sarah Whittemore presented the Jubilee Offering from the women of the Diocese.

At the meeting in the Parish Hall, 104 parishes were represented by 400 delegates. Addresses were made by Bishop Lawrence, Bishop Babcock and Miss Corey. Luncheon was served in the Parish Rooms and at 2 p.m. in the Church, the speakers were the Right Rev. Walter H. Overs, Bishop of Liberia, and the Rev. Artly B. Parsons, who spoke on the work in the Philippine Islands.

The Conference for the South Eastern District was held in St. John's Church, Fall River, November 10, 1921. The speakers were the Rev. George A. Barrter and Miss Marion DeC. Ward. In St. Paul's Church, Peabody, on November 17th, at the Conference for the North Eastern District, addresses were made by the Rev. G. A. Barrter and Mrs. Richard H. Soule.

A Quiet Morning and Evening were held on January 12th and 13th in Trinity Church, Boston. The services were conducted by the Rev. Thomas A. Conover of Bernardsville, N. J.

The Presentation Service of the United Thank Offering was held in the Cathedral on Thursday, May 12th, at 10 A.M. There were 416 present and the offering amounted to \$8,020.32. A Conference for the Parochial Treasurers of the United Thank Offering was held in the Parish Rooms, at 2 P.M. and was led by Miss Corey.

The Annual Provincial Conference for the Diocesan Officers of Province 1 was held in New Haven, October 6th and 7th. There were seven officers and two delegates at large present from the Diocese of Massachusetts.

One hundred and fifteen (115) visits were made by the Diocesan Officers during the past year.

BY-LAWS

ARTICLE I. — NAME

The name of this Society shall be the MASSACHUSETTS BRANCH OF THE WOMAN'S AUXILIARY TO THE PRESIDING BISHOP AND COUNCIL OF THE PROTESTANT EPISCOPAL CHURCH IN THE UNITED STATES OF AMERICA.

ARTICLE II. — OBJECT

The object of this Branch shall be to unite the women of the Church in Massachusetts, by means of prayer, study, work, and giving, in order to co-operate more fully with the Presiding Bishop and Council in making known throughout the world the gospel of the Lord Jesus Christ.

ARTICLE III. — MEMBERSHIP

1. Any baptized woman in the Diocese of Massachusetts, who shall agree to share in the work of the Woman's Auxiliary, shall be considered a member of the same.
2. Wherever possible, and with the approval of the Rector, members shall be organized into Parish Societies.
3. Any group of women in a Parish may co-operate with the Diocesan Branch.
4. Each Parish Society, so co-operating, shall present an annual report to the Diocesan Branch.

ARTICLE IV.

1. The officers of the Diocesan Branch shall be a President, Vice-Presidents, Secretary, Educational Secretary, Treasurer and United Thank Offering Treasurer, with such assistant officers as may be necessary.
2. There shall be committees in charge of the work for Diocesan Missions, Domestic Missions, Indian Missions (Dakota League), Missions among the Colored People, Foreign Missions, and for Missions in the Latin-American Countries. Each committee shall be under the direction of a Chairman and Vice-Chairman.

3. The officers, chairmen, and vice-chairmen of committees, and the secretary of the Church School Service League shall constitute the Standing Committee.

4. The President, active Vice-Presidents, Secretary, Educational Secretary, Treasurer and Secretary of the Church School Service League shall constitute an Executive Committee.

ARTICLE V. — ELECTION OF OFFICERS

1. The officers and other members of the Standing Committee shall be nominated by a committee appointed by the President, and shall be elected, by ballot, at the Annual Meeting, for a term of one year.

2. Offices left vacant during the year may be filled by a nominating committee consisting of the President, Secretary, and chairmen of the committees, with the approval of the Standing Committee and the delegates at the next monthly meeting.

ARTICLE VI. — DUTIES OF OFFICERS

1. The President shall preside at all meetings and have general oversight over all matters pertaining to the Diocesan Branch.

2. The Vice-Presidents shall each have charge of a District. They shall preside at the Annual Conferences in their Districts and shall be responsible for furthering the missionary work of the women of their Districts.

3. The Secretary shall record the proceedings of the Diocesan Branch, inform officers and committees of their election, carry on all necessary correspondence, and present an annual written report to the Diocesan Branch.

4. The Educational Secretary shall be in charge of the missionary education of the women of the Diocese and shall present an annual written report to the Diocesan Branch.

5. The Treasurer shall have charge of all property of the Diocesan Branch; receive all gifts, with the exception of the United Thank Offering, and administer the same; dispense all moneys as directed by the chairman and by the Standing Committee; keep account of receipts and expenditures and present a monthly and an annual written report to the Diocesan Branch and the Chairman of each committee. The annual report shall be audited by an experienced accountant.

6. The United Thank Offering Treasurer shall be responsible for making known to the women of the Church the opportunity of the United Thank Offering, and shall be custodian of the yearly offerings which are presented every three years

at the General Triennial Thanksgiving Services. She shall present an annual written report to the Diocesan Branch; this report shall be audited every three years by an experienced accountant.

7. *The Duties of the Committees.* Each committee in charge of missionary work shall be under the direction of a Chairman and Vice-Chairman who shall jointly present and carry on the work of the committee.

ARTICLE VII. — MEETINGS

1. The Annual Meeting of the Diocesan Branch shall be held each year in January, at such time and place as may be determined by the Standing Committee.

2. The Anniversary Meeting of the Diocesan Branch shall be held in November, at such time and place as may be determined by the Standing Committee.

3. The Monthly Meetings of the Diocesan Branch shall be held on the third Wednesday of each month from September to May (inclusive) unless due notice is given of any change by the Standing Committee.

4. The Standing Committee shall meet on the Monday preceding the third Wednesday of each month from September to May (inclusive) unless otherwise ordered.

5. Members appointed by the Rector, or by the co-operating Parish Society, to act as delegates, shall be entitled to vote at the Diocesan Meetings, provided that the number of such delegates from any one Parish shall not exceed three. The members of the Standing Committee, also, shall be entitled to vote at Diocesan Meetings.

6. At the Annual Meeting, members representing not less than one-half of the Parishes co-operating with the Diocesan Branch, or else not less than one hundred members entitled to vote, shall be necessary to form a quorum. At Monthly Meetings, sixty-five members, entitled to vote, shall constitute a quorum.

In case of a tie the Chairman shall have the right to cast the deciding vote.

ARTICLE VIII. — AMENDMENT OF BY-LAWS

The By-Laws may be amended at the Annual Meeting by a two-thirds vote of the delegates present, provided that thirty days' notice shall have been given.
