Proceedings of the Michigan Branch

—OF THE—

Womans' Auxiliary to the Board of Missions.

On the evening of Tuesday, June 6, the second annual sermon before the Michigan Branch of the Womans' Auxiliary to the Board of Missions, was preached by the Rev. Thomas C. Pitkin, D. D., in St. Andrew's Church, Ann Arbor. The speaker described most eloquently the vast strides made in woman's work in the church during the past seven years, and gave some very interesting statistics, to which many persons listened with great interest.

The third annual meeting of the Michigan Branch of the Woman's Auxiliary to the Board of Missions, was held in St. Andrew's Church, Ann Arbor, Wednesday afternoon, June 7, 1882.

Meeting was called to order by the President, Mrs. C. C. Gray, and the roll called. Fifteen parishes were represented by delegates. Minutes of last meeting were read and accepted. A few suitable remarks were made by the President, principally relating to the retirement of Mrs. Thomas C. Pitkin from the office of President, and her own appointment by the Bishop of the Diocese. The reports of the different Secretaries were then called for in order.

Report of the Hospital Work at Minden, Michigan, done through the Michigan Branch Womans' Auxiliary, for the Relief of the Sufferers from Fire:

On Friday, October 21, 1881, the women of Detroit were called together to hear Miss Sarah Smiley's report of her visit through the burnt regions of Michigan. At the close of her touching account, the Bishop of Michigan called for an action on the part of the Woman's Auxiliary. Miss Smiley was called to the chair, and Miss Adams appointed Secretary. It was resolved to request the President of the Michigan Branch to call a meeting early in the following week when the reports of two ladies, who were requested by the Bishop to visit the burnt regions, would be read, and some immediate action taken. Mrs. J. C. W. Seymour and Mrs. J. S. Conklin, were appointed as such committee. Adjourned.

On Thursday, November 1, 1881, the Michigan Branch Womans' Auxiliary, met at St. Paul's Chapel, Detroit, to hear the reports of the two ladies who had visited the burnt districts. They made the following suggestions: 1. That assistants be furnished to the physicians at Minden and Verona. 2. That departments for hospital stores be established at seven different points. 3. That a hospital be established at Minden. Committees on hospital, surgical instruments, books, and hospital stores, were then appointed by the President, and the meeting then adjourned.

A meeting of the Michigan Branch Womans' Auxiliary, was called at St. Paul's Chapel, November 10, 1881. Reports of the several committees were read, and Mrs. Charles Buncher was appointed Treasurer. Adjourned.

At a meeting of the Michigan Branch of the Womans' Auxiliary, at St. Paul's Chapel, April 20, 1882, the report of the several committees who have been interested in the work of carrying on the hospital at Minden, for the relief of invalids suffering from the effects of the late fires, was presented. The meeting was opened with a short service by the Right Rev. S. S. Harris, and afterwards the Secretary's report was read, stating the fact of the work being an outgrowth of Miss Smiley's urgent recommendation of it to the women of Detroit. Mrs. Emerson then read the report of the hospital committee, which stated that it was not possible to secure a suitable building for the hospital before the end of December, although the work was projected in November, but by the close of December, a house was in readiness, capable of holding 12 patients, bedding, furniture, and utensils, being donated by the general committee. Dr. Healy, of Minden, was

appointed visiting physician, under a fixed salary. A competent nurse was placed in charge, with two persons to assist in the general work. The hospital was visited in January and in March by different members of the hospital committee, and at both times everything was found in good working order. The whole number of patients treated was 18, of whom 10 were chronic cases. Two were operated upon with benefit, and of the acute cases, 6 to 8 were discharged recovered. It was decided to close the hospital by the 15th of April, and the articles which had been supplied by the general committee, were returned to them, with thanks, by vote of the ladies. The treasurer, Mrs. Charles Buncher, reported the receipt of \$1,299 82, of which sum \$850 was the result of Miss Smiley's representation of the cause among her eastern friends; \$100 was the gift of Mrs. Garfield, and the remainder from numerous contributors throughout the entire country. Of this sum \$499 85 was expended for the maintenance of the hospital from December to April, while \$557 48 was used for paying physicians' and nurses' salaries, and for filling physicians' requisitions at several other points. The balance now in hand, \$242 49, is to be devoted to the care and comfort of two or three chronic cases who have been taken back to their homes upon the closing of the hospital. The committee on surgical instruments and books, reported the receipt of \$77, and the disbursement of \$76 94. It was decided to give the drugs remaining in the hospital to Dr. Kay, and to leave the distribution of such articles as were not provided by the general committee, to Mrs. George McDonald, of Minden, who has had a general oversight of the work since its commencement.
