## CONSTITUTION



### ARTICLE I.—NAME.

This Association shall be called the Michigan Branch of the Woman's Auxiliary to The Presiding Bishop and Council.

### ARTICLE II.—OBJECTS.

The objects of this Association are to unite the branches in a common interest; to promote the cause of Missions and Church Extension, Religious Education and Christian Social Service; to collect funds for these various purposes; to encourage the formation of new branches. Work must be done, each year, in the five fields of service, the Parish, the Community, the Diocese, the Nation and the World.

### ARTICLE III.—MEMBERS.

All baptized women of the Diocese who desire to be members will be so regarded.

### ARTICLE IV.—OFFICERS.

The officers of this Association shall be a President, three Vice-Presidents, one to be chosen from each Archdeaconry, a Recording Secretary and General Treasurer, a Corresponding Secretary, a Diocesan Treasurer, a Domestic Treasurer, a Foreign Treasurer, a Treasurer of the United Thank Offering and the Correspondent of the Church Periodical Club, who with the Director of the Church School Service League and the Head of the Little Helpers shall form the Executive Committee.

### ARTICLE V.—FISCAL YEAR.

The fiscal year of the Association shall be from December thirty-first to December thirty-first.

### ARTICLE VI.—MEETINGS.

The annual meeting shall be held on the first Monday and Tuesday in May. Other meetings shall be held at the discretion of the Executive Committee.

### ARTICLE VII.—QUORUM.

At Executive Committee meetings five members and at Association meetings twenty members shall constitute a quorum.

### ARTICLE VIII.—AMENDMENTS.

This constitution may be amended at any annual meeting of the Association by a two-thirds vote of all members present; the proposed amendments having been submitted in writing at a previous meeting.

By-Laws may be adopted, amended or repealed at any regular meeting or annual meeting by a two-thirds majority vote.

## BY-LAWS



### ELECTIONS, APPOINTMENTS.

Section 1. The officers, including the Auditors, shall be elected at each annual meeting. At the meeting preceding the annual meeting an informal ballot shall be given to a nominating committee appointed by the President at said meeting. This informal ballot may be cast by every member of the Association.

Section 2. In case of the absence, resignation or death of an Executive Officer, her place shall be filled by action of the Executive Committee, such action to stand until the next annual meeting.

Section 3. Each regularly organized branch shall appoint two delegates to every meeting of the Association, that each branch may be represented but all the members shall have an equal vote on all questions except the Annual Elections when the APPOINTED DELEGATES ALONE shall vote.

### PLEDGES.

Section 1. At the annual meeting each branch shall signify in writing the amount it will give during the following year, to be paid through the Treasurers of the Woman's Auxiliary.

Section 2. As it seems only reasonable that each branch shall contribute something towards the general expenses of the Society, all branches shall contribute as liberally as possible, the MINIMUM AMOUNT for any branch being ONE DOLLAR a year.

### DUTIES OF OFFICERS.

Section 1. The President shall preside at all meetings, and shall have general supervision of the work of the Auxiliary, and in her absence the Vice-Presidents shall preside in the order of their succession.

Section 2. The Recording Secretary and General Treasurer shall keep the minutes of all meetings; she shall receive and pay out, as necessary, the General Expense and the Extension Funds and such special funds as may be put in her care.

Section 3. The Corresponding Secretary shall give notice of all meetings, both of the Association and of the Executive Committee, and shall conduct the general correspondence of the Society.

Section 4. The Foreign, Domestic and Diocesan Treasurers, the Treasurer of the United Thank Offering and the Correspondent of the Church Periodical Club shall receive the funds and manage the affairs of her own department. She shall conduct the correspondence incident to her own work and shall procure and disseminate missionary intelligence relating to her own department.

### COMMITTEES:

#### EXECUTIVE COMMITTEE.

Section 1. All matters relating to the general welfare of the Society shall be referred to the Executive Committee. It shall appoint the Standing Committees which shall co-operate with it.

Section 2. Seven Standing Committees shall be appointed by the Executive Committee each year after the annual meeting.



A Committee on Missions and Church Extension, a Committee on Religious Education, a Committee on Christian Social Service, a Committee on the Box Work and Bureau of Supplies, a Program and Publicity Committee, a Finance Committee and a Hospitality Committee.

The Committee on Missions and Church Extension shall promote missionary intelligence and missionary activity among the women of the Diocese and shall superintend the work of arranging for meetings in different parts of the Diocese in the interest of forming new branches and strengthening the old ones.

The Committee on Religious Education shall arrange for Mission Study classes throughout the Diocese and give all information regarding the work.

The Committee on Christian Social Service shall co-operate in the work of Christian Americanization, Hospital, Institutional and any other form of Christian Social Service.

The Committee on the Box Work shall supply lists of boxes obtained from the Church Missions House, to parishes wishing them; shall have charge of the preparation of any general Diocesan Box and present the combined annual box report of all the parishes. This Committee shall maintain a Bureau of Supplies.

The Program and Publicity Committee shall make a plan for the meetings of the Association during the year, provide speakers subject to the advice of the Executive Committee, be prepared to advise parish branches who may desire to have assistance in arranging their yearly programs and do all necessary publicity work.

The Finance Committee shall have charge of the raising of all special funds, unless some special committee has been appointed, and shall be charged with any other similar work requested by the Executive Committee.

The Hospitality Committee shall arrange for the entertainment of speakers and delegates attending the various meetings.

#### ANNUAL REPORTS.

Each officer shall present a written annual report, also providing a copy for the use of the Recording Secretary.

All accounts shall be audited before the annual meeting.

## Address of the President

The excellent reports of the Woman's Auxiliary in the Diocese of Michigan, from May to December 31, 1920, which follows, are so comprehensive that the attention of every member is directed to a careful consideration of the work accomplished.

The activities of the Junior Auxiliary, the Church School Service League, The Young Woman's Auxiliary, the Episcopal Young People's Association, and the Little Helpers are all commended, and a review of the progress made is printed in detail, giving cause for rejoicing in the advance made in the reorganization of the work.

The death of Archdeacon A. A. Warren Hastings in Ann Arbor, June 27, 1920, and of the Rev. Paul Faude, rector of St. Joseph's Church, Detroit, on December 3, 1920, have been deeply felt by all church workers in the diocese.

They were both ever most kind and helpful and full of interest and encouragement in the work of the various organizations engaged in promoting the extension of the Church, and a sense of personal loss is felt by all who knew and worked with them.

A tribute to the memory of Archdeacon Hastings is to be given in the Memorial Library, which will first be sent out from Harris Hall, Ann Arbor, throughout the Southern Archdeaconry.

On October 16, 1921, a corporate communion service is to be held in every parish throughout the Church, when a thank offering to be called the Emery Fund will be gathered in grateful appreciation of the valued service of three sisters who gave many years of loyal and devoted service in organizing and promoting the work of the Woman's Auxiliary.

This anniversary marks fifty years of fruitful work, and this trust fund is to be invested and the income used for the benefit of Women Missionaries at home on furlough, for board, for medical care, study, or recreation. It is a great opportunity to show by the gifts we make how much we appreciate the privilege granted to us to serve, and it is confidently expected that we may realize that much is required of us to help to provide for these faithful workers in the mission field when they return to renew their strength for further service.

To every officer, member, and organization herein represented, grateful thanks is given for loyal co-operation and cheerful readiness to serve in putting into effect the new plans for enlarging the work in all departments.

## Annual Report of the Recording Secretary

The forty-first annual meeting of the Michigan Branch of the Woman's Auxiliary was held in St. Paul's Cathedral House on May 3 and 4, 1920. Two hundred and forty were in attendance.

On Monday afternoon the annual reports of the officers and chairmen of committees were given and at the close of this business session an informal reception was held.

On Tuesday morning at nine o'clock the Bishop of the Diocese, the Rt. Rev. Charles D. Williams, D. D., celebrated the Holy Communion in the Cathedral. The Bishop was assisted by the Archdeacons of the Northern and Southern Archdeaconries, the Ven. Edward B. Jermin, and the Ven. A. A. Warren Hastings.

The death of Archdeacon Hastings occurred at Ann Arbor, Michigan, on June 25, 1920. He has been very much missed by the Diocesan Auxiliary, and we shall always remember his interest and his presence at our meetings.

"May he rest in peace and may light perpetual shine upon him."

At the close of the Communion Service the adjourned session of the annual meeting was held in the Cathedral House.

Luncheon was served at twelve-thirty, and in the afternoon the Auxiliary listened to a very interesting lecture on Japan, given by Mr. Charles O. Ford, which was illustrated by pictures taken during the speaker's journey in that country.

At this annual meeting the amended Constitution and By-Laws was adopted. Article V of the Constitution now reads, "The fiscal year of this Association shall be from December 31 to December 31," and Article VI "The annual meeting shall be held on the first Monday and Tuesday in May."

Accordingly a recommendation was made and adopted to make the following year a short one, extending from May 5 to December 31, 1920, and to hold the annual meeting, for this year, on the first Monday and Tuesday in May, 1921.

During the period from May to December, 1920, four meetings of the Executive Committee, four general meetings, a Corporate Communion, and a Quiet Hour were held. Two of the monthly meetings were held in Detroit churches, St. Philip and St. Stephen's, and St. John's; one was held in St. Luke's, Ypsilanti, and one in St. Alban's church, Highland Park.

A Day of Prayer for Auxiliary women was observed during the Advent season, on Thursday, December 2, 1920. On the afternoon of that day a Quiet Hour was conducted by the Rt. Rev. Herman Page, Bishop of the Diocese of Spokane. The Bishop, speaking on "The Spiritual side of the Work of the Woman's Auxiliary," said that each one of us could show this side by our love and co-operation one with another in the Auxiliary work.

The thanks and deep appreciation of the Woman's Auxiliary in the Diocese of Michigan should be extended to its President, Mrs. Frederic B. Stevens, for her continued interest and support of the work of this Society. Mrs. Stevens has taken the journey to New York, every other month, to be present at the meetings of the Executive Board of the National Woman's Auxiliary of which she is a member. In this way the Diocesan Auxiliary has been kept in touch with the important and vital points in the work of the National Organization.

*Resolved:* That the United Thank Offering of 1922 be given to the Board of Missions or any organization which has succeeded, or may hereafter succeed to its functions, for women's work in the mission field, including the training, sending and support of women workers and the care of such workers when sick or disabled—provided that one-tenth of the offering be set aside as a permanent trust fund to be invested and administered by the Board of Missions, or any organization which has succeeded or may hereafter succeed to its functions, the income to be applied to the support of retired United Thank Offering workers,—also provided that the sum of not less than \$10,000 be devoted to the erection, completion or renewal of a building or buildings approved by the Board of Missions on the recommendation of the President of the Board of Missions and the Executive Board of the Woman's Auxiliary.

*Also Resolved:* That to our united gifts shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves or of their substance to the work of the Master in the mission field.

### Report of the Church Periodical Club

May 3 to December 31, 1920

During the year two objects have been most prominent in our minds. One has been the equipment of the Traveling Library which is to be in memory of Archdeacon Hastings, and for the use of the clergy in this Diocese. This Library will first be placed in Harris Hall, Ann Arbor. In December a circular letter was sent to the clergy in this Diocese asking them to suggest books for this Library.

It was gratifying to receive a number of answers and many books were suggested which we shall endeavor to place in the Library.

The other object has been the collection of books for the Library of St. Paul's College, Tokyo, Japan. For this library the National Church Periodical Club has promised to collect thirty thousand volumes before the fall of 1922.



We were fortunate in finding at a second-hand book store in Detroit a number of valuable books which had been asked for but were out of print. Forty-four of these volumes were purchased and will be sent to Japan. We hope that you will keep this Library in mind and try to interest others in it. Especially would we recommend that this object be brought to the attention of classes in the Church Schools. Four Seamen's Libraries were sent. These libraries consist of twenty-five books each, which are sent to Seamen's Institutes, and placed by them on out-going ships, and are thus passed from one ship to another.

This year a large number of splendid books have been given, over one thousand in all. These books have been sent to different places, many to clergymen in the West, who are starting libraries in towns where there are no Public Libraries.

At Christmas over one hundred books were sent by individuals to missionaries or lonely persons. About six thousand Christmas and Easter cards were sent to schools and hospitals. Three hundred and twelve current numbers of periodicals have been sent away regularly to some given address and bundles of odd magazines, too numerous to mention. We have promised to supply the Rev. John Lever, who has charge of the Social Service Work, with magazines for the hospitals, and quantities will be needed for this purpose.

Thanks to our faithful librarians, the usual sale of Church Calendars was most successful—twelve hundred in all were sold.

We wish we could thank each individual and organization that has contributed to this work, but that would be impossible. We thank you one and all.

### NORTHERN ARCHDEACONRY

A wider range of activity has marked the efforts of the Woman's Auxiliary in the Northern Archdeaconry during the year.

At a meeting of the presidents of the Auxiliaries with Archdeacon Jermin, it was decided to send a delegate to the Racine Conference, July, 1920. All



of the branches of the Northern Archdeaconry, and five Missions contributed towards the entire expense. Mrs. Charles E. Edinger, of East Tawas, was sent, three others also attending. This action has proven most wise, as wherever Mrs. Edinger has spoken she has inspired those who have heard her splendid addresses in behalf of Religious Education.

June 16 I spoke at a large meeting arranged by St. John's Branch, Saginaw, which was well attended not only by Saginaw women but by those from Bay City and Midland.

In August I was invited to speak upon the Racine Conference at an Auxiliary Meeting at Bay View, Michigan. The sixty ladies present represented many dioceses.

September 27 I again spoke on the Racine Conference at a very large and enthusiastic meeting at Trinity Parish, Bay City.

October 11 and 12 I attended the House of Church Women at Grand Rapids.

A conference with Archdeacon Jermin and the presidents of local branches was held in Trinity Parish Rectory, Bay City, in November, and plans regarding study classes and methods of work were freely discussed. Delegates came from both parishes in Bay City, St. John's and St. Paul's, Saginaw, Midland, Gladwin and West Branch. I cannot urge too strongly the advantage of these group meetings, since through the Archdeacon's co-operation representatives from the smaller places meet with us, whom we would otherwise never know. Thus we are afforded an opportunity to freely discuss our difficulties, often to our mutual benefit.

November 30, at the Archdeaconry Meeting held at West Branch, the entire afternoon's program was given to woman's work, the Vice-President presiding. Three excellent talks were given by Miss Julia M. Fish on the work E. Y. P. A., Miss Elizabeth Yardley on the Church Service League, and Mrs. Charles E. Edinger on the Religious Training of the Child. A conference with lively discussion was held the following morning at the Rectory.

April 5 I attended the Archdeaconry Meeting at East Tawas. Quite a delegation went up from Bay City. Everything conspired to make it a splendid meeting. We were most happy to have our Bishop's wife, Mrs. Williams, with us and to hear her tell in delightful fashion of her experiences in England while in attendance at the Lambeth Conference.

It was encouraging to have delegates present from Au Sable and Alpena. The talks by Miss Yardley and Mrs. Edinger were excellent. Reports from Midland, with a membership of thirty-two, West Branch, not yet organized, but doing good work which is really Auxiliary work, Trinity and Grace, Bay City, as well as from Saginaw and Cheboygan all showed good work being done. Study classes had been held in more places than ever before, and Au Sable requested literature and thought seriously of trying to organize.

During the year thirty-five letters have been received and forty-eight written. Year Books have never been in such demand before. I disposed of fifty and could have used several more if I had had them.

More women in the smaller places have sought to understand the work, and we are very grateful for the sympathetic support we have had from the clergy.

## Report of Missions and Church Extension Committee

Since the General Convention of 1919 of the Church, the importance of the Woman's Auxiliary is now greatly enhanced by the action of the Presiding Bishop and Council. This means that any department carrying out the work of the council has the privilege of calling upon the Woman's Auxiliary for aid.

The support of missions at home and abroad and the extension of the Church were primarily for what the Auxiliary was formed fifty years ago—and now it has just become a department of the enlarged scope of work the Auxiliary is called on to do. During the last year the work has been carried on in the usual way in the Diocese, which is divided into three Archdeaconries, viz.: Detroit, in which there are 27 churches, and 8 missions; Southern, 31 churches, 17 missions; Northern, 11 churches, 24 missions; making 69 churches and 49 missions and a total of 118 churches and missions and 61 branches of the Auxiliary. During the last year Emmanuel Mission has been formed, in Detroit, and an Auxiliary organized, and there are several more missions ready to be formed.

Three missions have been organized in the Southern Archdeaconry, viz.: at Rosedale, Deckerville, and Ferndale, and St. Timothy, South Jackson, but no other branches.

In the Northern Archdeaconry there have been none formed, but several about ready, and we hope to hear of them soon.

Out of town visits have been made during the past year by members of the committee to St. Jude's at Fenton; All Saints', at Pontiac; Christ Church, at Flint; Grace at Port Huron; St. Andrew's at Ann Arbor; St. James' at Birmingham; St. Luke's at Ypsilanti, and Trinity at Fort Wayne, Indiana.

Several members of the Auxiliary were present at the March meeting of the Diocesan branch of the Woman's Auxiliary of Los Angeles, California, and report a most interesting meeting, and our president, Mrs. Stevens, has made several trips to attend meetings in New York in behalf of the work at the Auxiliary Executive Committee.

The members of the committee who have assisted in this work are Mrs. Stevens, Mrs. Craig, Mrs. Atkinson, Mrs. Brady, Miss Hendrie, Miss Armstrong, Miss Thomas, Miss Maurice, Mrs. Mitchell, and Mrs. Vallat.

The committee hope that in the near future a woman worker or secretary will be secured who will give her entire time to the work, but the members are always glad to go to the Parishes when called on.

### Report of the Program Committee

## Report of the Solicitor for the Spirit of Missions

We have made a slight gain over last year in this work, and are looking forward to a still better year in the one to come. The Woman's Auxiliary have credit for thirty-eight new subscriptions and sixty-three renewals sent to the diocesan solicitor and forwarded by her, or sent direct to the Missions House by parochial solicitors, and reported to the diocesan solicitor.

The following parishes have solicitors who are working in co-operation with the diocesan solicitor: Detroit, Ascension Mission, Christ Church, St. Andrew's, St. Columba's, St. Joseph's, St. Matthew's, St. Peter's and Trinity. St. John's, Royal Oak; St. John's, Midland; St. Paul's, Saginaw, and Trinity, Bay City.

A meeting of solicitors was held in St. John's Parish House on the afternoon of February tenth and we have had some very encouraging results as the outcome of that meeting.

During the last year I have visited St. Matthew's, Detroit; St. John's, Royal Oak; and Ascension, Detroit, branches of the Woman's Auxiliary in the interest of the Spirit of Missions.

Have written eighteen letters to the Spirit of Missions Publishers, and three letters and twenty-one post-cards to parochial solicitors and Auxiliary women, and have received eleven letters and post-cards from the Missions House and twenty letters from solicitors and Auxiliary women.

We have a new permanent offer from the publishers of the Spirit of Missions which is a rebate of fifteen cents on all new and all renewal subscriptions which come through the Woman's Auxiliary, provided the fifteen cents on each subscription is placed in the United Thank Offering Fund. This ruling supersedes the former offer of twenty-five cents rebate on new subscriptions.

## Report of the Little Helpers

May 1, 1920, to December 31, 1920

Again it is my privilege to report to you the continued growth of The Little Helpers of this Diocese. As our gifts are given in the springtime there will be no financial report at this time. We have had two new branches started, one in St. Philip and St. Stephen's and one in Grace Church.

The loving Saviour called three of our Little Helpers unto Himself:

Wilbert Robert Wilkinson, July 9, 1920—St. Philip and St. Stephen's.

James Meakin, August 6, 1920—St. Mary's.

Lillian Maxine Eansor, October 16, 1920—Trinity.

"Never more to know sorrow, pain or death,  
Buy joy and peace and life for evermore."

In the passing of Mrs. Sarah B. Allen, The Little Helpers lost a dear and beloved friend. When The Little Helpers was a new society and their resources were small, Mrs. Allen encouraged them with her interest, prayers and annual gift of money. May she who loved little children so fondly find rest in the region of the living where the light of His countenance visits and shines continually.

It was always a privilege for me to attend The Little Helpers' meetings at St. Joseph's Church. Mr. Faude loved The Little Service. He told me, "It was a service of inspiration to him, Christ's wee lambs coming to Him with their gifts of love and thanksgiving, for the truth of Christ's words 'Except ye become as little children,' seems so transparently clear at that time." It was Mr. Faude's custom to close the service with an extemporaneous prayer for The Little Helpers. Last year it seemed as if he gathered all The Little Helpers into his arms and presented their young lives into His Father's keeping, beseeching God that He would lead and guide them in the path that ends at the Mercy's Seat. The prayer affected me deeply, that I asked Mr. Faude afterwards if I had received the right impression. "Yes, that was what I meant." As we look back, we believe that he realized that it might be the last time he would officiate at such a service. So he dedicated their young lives to the service of the Master whom he loved and served all the days of his life.

It was with deep sorrow that we received the sad tidings of the death of little Red Moon, our Indian brother who entered into life eternal from High Hills, Shirley, Va., June 23, 1918. Born Feb. 16, 1902, near Whiterocks, Utah, losing his mother a few hours after his birth, Red Moon was adopted by Miss Lucy U. Carter, the faithful and devoted missionary to the Ute tribe of Indians. Very soon we heard of him through Mrs. Elizabeth Locke Stevens. Mrs. Stevens had just lost her only child, Charles Locke Stevens, and her tender heart, wrung with its own sorrow, thought of the motherless boy. In 1904 we arranged with several of the Diocesan heads of Little Helpers to have the Little Helpers care for Red Moon. For years they did, and we hoped as we read the letters from Miss Carter, telling of his beautiful character that some day he might be a leader, a priest, to his people. At the age of 14 his health began to fail; he went to Virginia where for two years all that love and medical care could do, was done, every wish of his heart being satisfied except his restoration to health. That God only could bestow, he was well aware, saying often, "God knows best. Lord help me and I know He will." He loved the matchless stories of Holy Scriptures. Though his body was weak and racked with pain, yet his faith failed not, being to others also a strength and inspiration, even unto the end. He was laid to rest in the quiet cemetery of old Westover Church.

May we not feel that his crown, won through patient bearing of his bitter cross, will shine with brighter lustre and a greater glory. May we not gain comfort from the thought that he, who was called away before he could choose



his life's work here, has been summoned to an even higher service in our Father's mansion, being one of that redeemed throng of the vision of St. John who, "behold and lo, a great multitude, which no man could number, of all nations and kindreds, and peoples, and tongues, stood before the Throne and before the Lamb clothed with white robes and palms in their hands. These are they which came out of great tribulation and have washed their robes and made them white in the blood of the Lamb. Therefore are they before the Throne of God and serve Him day and night."

Our hearts are full of interest and enthusiasm for the San Juan School at Farmington, New Mexico, for the Navajo Indian children. In giving to the school we will feel that we are doing a wee bit to right a terrible wrong. The blackest page in the history of our country is our treatment of the Indian. As Owen Wister says: "This land belonged to the Indian until we came and shoved him back, back, back. We took his fertile land and running water and gave him land where neither wood nor water exist, no crops will grow, no human life can be supported. We prate "All men are endowed by their Creator with certain inalienable rights, life, liberty and the pursuit of happiness." Did America give the Indian these? No, the Indian has not been fairly treated. Now a small opportunity is given to us to help right this wrong to these down-trodden people by helping them to help themselves. In the name of one of the most faithful soldiers of the Cross of Christ, Mary E. Hart, of sweet and blessed memory, I beg of you women of the Auxiliary, not only from a Christian privilege, but a patriotic duty, to hasten, by your gifts of money and of prayers, the building of this school for Indian children.

Mrs. Effie M. Potter, Treasurer of The Woman's Auxiliary of the Diocese of Western New York, and special Treasurer of The Mary E. Hart Memorial Fund, writes that \$2,222.38 has been given. \$5,000.00 will pay for the school, but not all the furnishings.

San Juan Indian Mission,

My Dear Mrs. Potter:

Four years ago, when I came to help start this blessed work, I saw the need of a school as well as a hospital, to which we could bring some of these wandering Indian children, existing only on the edge of the desert reservation. The Indian school is 35 miles away and it cannot accommodate more than several hundred at most. There are at least 1,500 children of school age who are receiving nothing from government nor missions, but now our church has accepted the challenge to champion the cause of these worthy gentle Navajos. We have begun to lay the foundations for a great work, but the undertaking was precarious and difficult, and the work ahead of us will not be without its difficulties and discouragements. We must fight the ignorance, the paganism and the indifference of the Navajos themselves. Also the indifference and opposition of many 'who profess and call themselves Christians. Yes, many white people living here, who see the wretched condition of these long-neglected people, question the wisdom of giving them a chance. It is this attitude, taken by the white people, that has proved a stumbling block, but we have not stumbled over it.

Fortunately we have been given the strength and the courage to open the way, and please God it will not be closed. We shall go from strength to strength, and be given our heart's desire for our poor Indians. My dream of the school is fast coming true, and I shall share the joy of its fulfillments, I hope, with the many missionary hearted people in the east and nearer. The knowing that the young people and the little helpers are contributing to the Indian children's need touches my heart to the depths. God bless them, God bless us every one.

### Report of the Director of the Junior Auxiliary and the Church School Service League

The work of the Church School Service League this year has been largely along the lines of reorganization, in helping the parish branches to organize and in the reconstruction of our Diocesan organization.

We have now an extension committee composed of one member from each Archdeaconry who will be responsible for furthering the work in her Archdeaconry, and together they will plan how best to help the Schools to organize and carry on the work, and five Field Secretaries to plan and carry out the work in the five fields of Christian Service, the Parish, the Community, the Diocese, the Nation, and the World.

Questionnaires were sent out to the Church Schools in the Diocese to see what service work was being done by the children. We did not receive replies from a very large percentage, but in eleven Schools we found that one thousand children are organized for week day work under seventy-five leaders, and their gifts, not including the Lenten Mite Box Offering, were \$4,500.36.

When all our Schools have as many children at work as there are in these eleven Schools what a vast amount of good can be done by the children, and how many more will be trained to fulfill their obligations to their church, and in Christ's Service.

A new offering for the children has been authorized by the Department of Religious Education in New York, called a Birthday Thank Offering which, in this Diocese, is in charge of Miss Nellie McAuley.

"The Birthday Thank Offering" is an offering made by the boys and girls, young people, officers and teachers of the Church School Service League, on the Sunday nearest his birthday, or on Whitsunday, the birthday of the Church; the amount given may be the number of either cents, nickels, dimes or dollars corresponding to his years. This offering will take the place of the United Offering for the children, and is an offering that appeals to them.

It is recommended that the offering be presented in each parish on Whitsunday, and offered at a Special Service at each General Convention. It was further proposed that during each Triennium some interesting object, chosen because of its special appeal to young people, should be presented to the Church Schools as the object of their offering. The offering of the next two years



will be sent to Alaska to Bishop Rowe, to be used for a new engine and repairs on the "Pelican," his launch that has carried him and Archdeacon Stuck on so many errands of mercy to the Indians.

This offering will be collected in the various Schools on Whitsunday and will be presented at the Bishop's Festival Service at the Cathedral on June 12th.

The officers of the Church School Service League stand ready at all times to be of any assistance that they can to the leaders of the Diocese in starting new branches or helping in any way. We wish to urge all leaders of children's work to attend the conferences each month, where all topics relative to this work will be discussed, and work for the different blocks planned before the beginning of the blocks. These conferences are held so that all leaders may bring their problems there and discuss them with the other officers.

### **Report of the Recording Secretary of the Junior Auxiliary and the Church School Service League**

During the past year the officers and leaders of the Church School Service League have met eight times with an average attendance of eleven.

One general meeting was held in November at St. John's Parish House. The meeting was led by Rev. H. H. Fox, who spoke to the children about his work in the new mission field to which he had been recently appointed. At this meeting the children presented their Christmas gifts which were sent to the Oneida Indians.

The first regular meeting was held at the home of Miss Maurice. At this meeting plans for the year were discussed. We were very fortunate in having Deaconess Routledge at our meeting. The Deaconess told us about her work in the Philippines. She is in charge of a day school and church school. Miss Routledge made a plea for surgical dressings, clothing, medical supplies, folding organ, vocal records, and a new sewing machine. At the April meeting of the leaders and officers, St. Joseph's Junior reported that they had sent a new sewing machine equipped with all the newest attachments to Miss Routledge.

The other meetings were all held at St. Paul's Cathedral House on the third Wednesday of each month. The leaders met at four o'clock and after a short business meeting adjourned to a class in Manual Training and Hand Work led by Miss Sill. This class proved most helpful to all the leaders and was well attended. After this class a supper was served to the leaders and Church School teachers. At the supper hour we were very fortunate in having most interesting speakers, each with a vital message for the Church School teachers. The speakers were Dean Rogers, Bishop Williams, Rev. C. E. Webb, Rev. J. H. Lever, Rev. R. S. Chalmers of St. Mark's, Toledo, and Dr. Geo. Gunnell of Trinity Church, Toledo.

The Mission Study Institute was held in connection with that of the Woman's Auxiliary on January 28, 29, 30th. The books for the different ages were:

- Cycle II—Down the Garden Path.
- Cycle III—The Honorable Miss Love.
- Cycle IV—His Star in the West.
- Cycle V—Alaska.

At the general meeting on May 7th the pledges for next year will be made.

## Report of the Educational Secretary

For the Year May, 1920—May, 1921



In summarizing the Mission study work of the past year, I wish to report about thirty classes held in fifteen churches, using eight different text books, with twenty-five leaders and about three hundred and eighty children. I have not included in this number three E. Y. P. A. classes reported to me. The classes included boys as well as girls in the majority of parishes—the ages being from six to twenty with the ages eight to twelve predominating.

It is gratifying that so many leaders (twenty-five) have been connected with these classes. This indicates a growth of confidence on the part of the leaders to do this work, and it also indicates that twenty-five leaders studied missions. Fourteen leaders enrolled in the Junior classes of the Annual Women's Auxiliary Institute for Mission study, held in January. There were three Junior classes at this Institute:—"Down the Garden Path"—and other stories for children of Cycle II, led by Mrs. Robert Livingstone; "The Honorable Little Miss Love," led by Mrs. Thos. Weber; and "Alaskan Missions," led by Miss Elizabeth Thomas. Though the number attending was small, it represented some new fields. Four girls from Jackson attended classes; and two G. F. S. candidates' associates.

Although the number of children in Mission study classes seems large, it is not large enough. Some of our church schools have more than three hundred pupils enrolled, yet three hundred and eighty is the total number in Mission study classes in the whole diocese. It is interesting to note here that Grace Church, Bay City, had the largest number of children in study classes—that number being eighty-one (but including young people). One leader writes, "We are using 'Christian Nurture' in our church school, which provides a certain amount of Missionary study, especially Course 11." These facts are generally true and are making our whole missionary work more vital and more stable, as the Church School Service League develops more completely in the Diocese and in the individual parishes, our week-day Mission study and other Educational work must keep pace—making a vital connection with the Christian Nurture instruction by supplementing and developing it more thoroughly than can be done in one hour on Sunday, and furnishing motive for service in the mission field. Our mission study Institute must be brought into relation with the Religious Education Normal School, in order that we may do this, and it must be conducted on new lines to meet new needs and develop new interests. We need the help of all the leaders to solve these problems.

## Report of the Episcopal Young People's Association and Young Woman's Auxiliary



The formation and development of parish branches throughout the Diocese has not been of a rapid growth, but from reports received the need of this work is greatly felt, and in many instances definite plans are being considered looking toward organization.

Seven new branches have been formed during the last six months.

Our two branches of the Y. W. A., St. John's and St. Joseph's, under most capable leadership, have presented reports full of inspiration. Activities represent special box work, and many forms of service covering the five fields.

One of the great assets of our Young People's Work is intelligent co-operation, and because of this, systematic and vigorous enterprises have been undertaken.

As will be seen by the Treasurer's report, a balance of \$141.36 was paid on the "Incubator" Fund, completing the pledge of \$1,000.00.

There were twelve young people from the Michigan Diocese that attended the 1920 Racine Conference, eight of the number were the Association's chosen delegates. St. Joseph's Y. W. A. sent their own delegate.

That the Conference Program provides one of the greatest opportunities to touch the young life of the Church, made its appeal, was shown in the desire for immediate action upon the return of the delegates, and an eagerness to interpret their better understanding of stewardship.

At the close of a three months' campaign the goal was not only reached, which was the raising of a \$500 pledge toward the Maintenance Fund for the property of Racine College, but branches more than fulfilled their pledges to the amount of \$175. It was decided to turn this amount over to the Racine Conference Fund for sending delegates in 1921.

The new undertaking clearly defined now that the need for this organization has demonstrated its value to the Church, has been in serving and maintaining the widely aroused interest.

The Michigan Diocese is looked upon as a pilot because of its experience in Young People's organized work.

The Association has been represented by the Executive Secretary at important conferences in Indiana, Milwaukee, Racine and at Cleveland.
