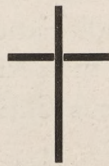

## CONSTITUTION



### ARTICLE I.

#### NAME

This Association shall be called the Michigan Branch of the Woman's Auxiliary to the National Council.

### ARTICLE II.

#### OBJECTS

The objects of this Association are to unite the branches in a common interest; to promote the cause of Missions and Church Extension, Religious Education and Christian Social Service; to collect funds for these various purposes; to encourage the formation of new branches. Work must be done, each year, in the five fields of service, the Parish, the Community, the Diocese, the Nation and the World.

### ARTICLE III.

#### MEMBERS

All baptized women of the Diocese who desire to be members will be so regarded.

### ARTICLE IV.

#### OFFICERS

The Officers of this Association shall be a President, seven Vice-Presidents, one for each Archdeaconry, two in charge respectively of Education and Supply Department, a Recording Secretary, a Corresponding Secretary, a Treasurer, a Treasurer for the United Thank Offering and the Correspondent of the Church Periodical Club, who with the Director of the Church School Service League shall form the Executive Committee.

### ARTICLE V.

#### MEETINGS

Section 1. The annual meeting shall be held during the week of the Diocesan Convention.

Section 2. Regular meetings shall be held monthly from September to May, inclusive.

Section 3. Other meetings shall be held at the discretion of the Executive Committee.

### ARTICLE VI.

#### QUORUM

Five members shall constitute a quorum at an executive meeting, and fifteen members at regular or annual meetings, but at no time shall the lack of a quorum at a regular meeting prevent those present from proceeding with the program of the day.

### ARTICLE VII.

#### AMENDMENTS

This constitution may be amended at any annual meeting of the Association by a two-thirds vote of all members present; the proposed amendment having been submitted in writing at a previous meeting.

By-Laws may be adopted, amended or repealed at any regular meeting by a two-thirds majority vote.



## BY - LAWS



### ARTICLE I.

#### ELECTIONS AND APPOINTMENTS

Section 1. All officers shall be elected by ballot at the annual meeting and shall continue in office for one year or until the election of their successor.

A majority of all votes cast shall be necessary for an election.

Section 2. In case of the absence, resignation or death of an executive officer, her place shall be filled by the Executive Committee, such action to stand until the next annual meeting.

Section 3. Each regularly organized branch shall appoint two delegates to every meeting of the Association, that each branch may be represented, but all the members shall have an equal vote on all questions except the Annual Elections, when the APPOINTED DELEGATES ALONE shall vote.

Section 4. At the annual meeting preceding the Triennial Convention of the Protestant Episcopal Church, five delegates and five alternates shall be elected to the Triennial meeting of the Woman's Auxiliary.

The five receiving the highest number of votes shall be delegates and the five next highest shall be alternates.

### ARTICLE II.

#### PLEDGES

Section 1. At the January meeting each branch shall signify in writing the amount it will give during the following year, to be paid through the Treasurer of the Woman's Auxiliary.

Section 2. As it seems only reasonable that each branch shall share in the expenses of the society, all branches shall contribute as liberally as possible to the General Expense Fund, the minimum for any branch being one dollar a year.

### ARTICLE III.

#### DUTIES OF OFFICERS

Section 1. The President shall preside at all meetings and shall have general supervision of the work of the Auxiliary.

Section 2. The Vice-Presidents shall in order of their succession preside in the absence of the President and assume all duties pertaining to the office.

The Vice-Presidents in charge of the Archdeaconries shall endeavor to promote the formation of new parish branches and to help and strengthen those already existing.

The Vice-Presidents in charge of Foreign and Domestic Missions, Education, and Supply Work, shall inform the parish branches through correspondence, visiting, or providing speakers, of the needs of work in their respective departments.

Section 3. The Recording Secretary shall keep the minutes of all meetings, and prepare and edit the Year Book.

Section 4. The Corresponding Secretary shall give notice of all meetings, both of the Auxiliary and of the Executive Committee, and shall conduct the general correspondence of the Society.

Section 5. The Treasurer shall receive, disburse and keep account of all moneys received in each department of the work, except the United Thank Offering, and shall attend the meetings of the Auxiliary, reporting receipts and disbursements at the same.



Section 6. The Treasurer for the United Thank Offering shall receive all contributions from the branches and under the direction of the Executive Committee endeavor to arouse and increase an interest in the same.

#### ARTICLE IV.

##### FISCAL YEAR

The fiscal year of the Association shall be from January 1st to December 31st.

#### ARTICLE V.

##### COMMITTEES

##### EXECUTIVE COMMITTEE

Section 1. All matters relating to the general welfare of the Society shall be referred to the Executive Committee. It shall appoint Standing Committees, which shall co-operate with it.

Section 2. Seven Standing Committees shall be appointed by the Executive Committee each year after the annual meeting.

A Committee on Missions and Church Extension, a Committee on Religious Education, a Committee on Christian Social Service, a Committee on the Box Work and Bureau of Supplies, a Program and Publicity Committee, a Finance Committee and a Hospitality Committee.

The Committee on Missions and Church Extension shall promote missionary intelligence and missionary activity among the women of the Diocese and shall superintend the work of arranging for meetings in different parts of the Diocese in the interest of forming new branches and strengthening the old ones.

The Committee on Religious Education shall arrange for Mission Study Classes throughout the Diocese and give all information regarding the work.

The Committee on Christian Social Service shall co-operate in the work of Christian Americanization, Hospital, Institutional and any other form of Christian Social Service.

The Committee on the Box Work shall supply lists of boxes obtained from the Church Mission House to parishes wishing them; shall have charge of the preparation of any general Diocesan Box and present the combined annual box report of all the parishes. This Committee shall maintain a Bureau of Supplies.

The Program and Publicity Committee shall make a plan for the meeting of the Association during the year, provide speakers subject to the advice of the Executive Committee, be prepared to advise parish branches who may desire to have assistance in arranging their yearly programs and do all necessary publicity work.

The Finance Committee shall have charge of the raising of all special funds, unless some special committee has been appointed, and shall be charged with any other similar work requested by the Executive Committee.

The Hospitality Committee shall arrange for the entertainment of speakers and delegates attending the various meetings.

#### ARTICLES VI.

##### ANNUAL REPORTS

Each officer and chairman shall present a typewritten annual report, also providing a copy for the use of the Recording Secretary.

## ADDRESS OF THE PRESIDENT

On May 16th, 1924, when you elected me to the Presidency of the Woman's Auxiliary, you paid me, I shall always feel, one of the greatest honors that can be given a woman of our Church. The five, or, to be exact, four and one-half years have been full of the joy of service in the endeavor to fill that position. I had much to learn and I have found myself continually wishing that I had been more adequately prepared.

In reviewing these past years, I would first speak of the unfailing loyalty of my co-workers, the members of the Executive Committee and Chairmen of Committees. They have given untiringly of their time in attending meetings and have always shown a willingness, not only to carry on their own duties, but to add to their already heavy tasks when the need arose. The thanks of the entire membership is their due, for without their united co-operation the work accomplished could not have been done.

It has been a great help and happiness to visit from time to time the various branches, to know their leaders better and to meet all the members, my great regret being that I have not gone to every branch, although, with one exception, I have accepted every invitation I received.

I often ask myself this question: Has the Auxiliary grown in Michigan and what could be done to help that growth? We cannot look at back reports and not know it has, although not nearly as fast as we would all wish. We have gained several new branches but have lost some old ones. Looking back to the year book of 1922, I find we had 54 branches and we have today 61. It is to be hoped that those branches we have lost will at some time reorganize or at least carry on the principles of the Auxiliary in some of their organizations. Some parishes, and I am particularly sorry to say, some of the clergy seem to feel that the Auxiliary will hamper the work of the Parish. Of course, we know that this is not the case, for it is the wish of our organization to help in the five fields of service, of which the Parish is of first importance. In two years we shall have our fiftieth anniversary. Is it too much to hope that by that time every Parish and Mission will have a Woman's Auxiliary?

There is no doubt that the Auxiliary has not nearly reached its ideal and, in looking to the future, I would have you think of a few of the possibilities which I have felt would help to make it more nearly reach that ideal.

First, as I have said before, a branch in every Parish and Mission, —and this has been accomplished in some dioceses. Chicago, for instance, and what others do, we surely can do. While I know of the splendid work of Guilds, I do not feel that they in any way take the place of the Auxiliary in fulfilling our obligation as women to the National Church. This calls for education and I am sure cannot be accomplished by the Educational Committee alone, splendid as it is, but needs the help of everyone. We should all think Auxiliary, talk Auxiliary and live Auxiliary. Its growth is the responsibility of every member.

We certainly cannot be intelligent members unless we take the Spirit of Missions and READ. It should have a far greater subscription list than it now has. Every branch should have one woman devoting her time to interesting new subscribers.



We should have better co-operation between the Diocesan and Parish branches. By this I mean each branch should be regularly represented at the Diocesan meetings, and should it not be the duty of every president to be there herself and see that there is always someone from her branch besides? These should not only be represented but should carry back to their branches a full report of these meetings. We have, from time to time, talked of asking for yearly reports from branches, which it seems to me would be very helpful and is done in many dioceses. At the conference tomorrow afternoon, I hope we may have a good discussion about this and that you will all express yourselves freely.

We all know what fine work has been accomplished by our Chairman for Supply Work, but even in this we should grow, for there are many opportunities of enlarging. Only this last year we have added a sub-committee to take care of altar supplies. Other sub-chairmen could carry on other phases of the work, for it would be too much to add to this already hard worked chairman. A store closet where supplies could be cut, thus helping to meet the demands of our church institutions, would be a splendid addition.

Our Social Service work has really only just begun but is full of possibilities. I have sometimes felt that if we could choose one definite piece of work, perhaps we would get better results. This is done by the New York branch, which carries on a splendid piece of work on Ellis Island. Through the efforts of Mrs. Marquis, the Prayer Partnership Plan has been started. I say started because it has been almost impossible to learn just how many of the branches have taken it up. Mrs. Royce, one of our prayer partners who was at the Hillsdale Conference last summer, spoke so feelingly of the help this was to her. She said: "If you women at home could only realize what a power of strength in my discouraged moments is that feeling that at home there are women thinking of and praying for me." I wish that every branch would form a prayer partnership group. It is so little to ask for those who are doing so much.

And so I could go on with suggestions for the strengthening of the whole organization through its various departments, (its welfare is very deeply implanted in my heart), but I am sure that you who love its work too will rally to its support in the years to come so that it may become what it should be,—the great woman's organization of the Church. In closing, I want to thank you all for having given me the privilege of helping in this service of love and work for the Master. It has not been an easy task and I would that I had been better able to perform it.

## ANNUAL REPORT OF THE RECORDING SECRETARY

Another period has ended in the history of the Woman's Auxiliary, Diocese of Michigan.

Let us, therefore, briefly review some of the things which this organization accomplished during the year 1927:

The forty-eighth annual meeting of this society was held in St. Paul's Cathedral, Detroit, on Monday, January 21st and Tuesday, February 1st, 1927.

On Monday afternoon a number of annual reports were read and the election of officers for the ensuing year was held. The session closed with an address by Mrs. Wright B. Haff, Secretary of the New York branch of the Woman's Auxiliary.

A Corporate Communion was held on Tuesday morning, the Rt. Rev. Alfred A. Gilman, D.D., Suffragan Bishop of the Missionary District of Hankow, being the Celebrant, assisted by Dean Johnson and the Rev. Allan McAvoy of the Cathedral staff.

This service was followed by the second session of the annual meeting.

At this time Mrs. Frederic B. Stevens presented the Auxiliary with a beautiful silk banner and explained the symbolism of the embroidered design.

Annual reports were continued and the Bishop of this Diocese, the Rev. Herman Page, D.D., gave his annual address.

Tuesday afternoon was given over to a conference for the Auxiliary workers, led by Mrs. James McDonald.

Since the annual meeting, seven meetings of the Executive Committee, nine monthly meetings, two Corporate Communions, a Communion Service for the Executive Committee and a Quiet Morning during the Lenten season have been held.

The attendance at the monthly meetings has continued to be very good, an average of one hundred and nine being present. The largest number attending a single gathering was two hundred and fifty at the annual meeting in January and the smallest number recorded was eighty-six at the March meeting in the Church of Our Savior, Detroit.

Two Mission Study Institutes were held, the first on January 29th, at which a class on Rural Work was conducted by Mrs. Wright B. Haff of New York, who proved to be an admirable leader on this subject.

The second Study Class was held on Oct. 11th, this taking the place of the one usually held at the time of the Annual Meeting in January.

This class was led by Mrs. William L. Torrance of Detroit, who made the subject, "The Church Awake," most interesting and instructive.

The United Thank Offering has reached the sum of \$11,027.45, this being \$2,320.64 more than at the corresponding time in the last Triennium.

The Corporate Gift, which is being raised by the women for special objects, has been efficiently cared for by Mrs. William L. Clements,



who has given much of her time in visiting the branches of the Auxiliary and speaking in the interest of this gift.

The best thanks of the Auxiliary should be given to Mrs. Thomas C. Stirling, United Thank Offering Treasurer, and to Mrs. William L. Clements, chairman of the Finance Committee, for their faithful and valuable service to this society.

It was with deep regret that the officers and members of the Diocesan Auxiliary heard that our president, Mrs. William T. Barbour, had refused a renomination as head of this organization.

May we not at this time express to Mrs. Barbour our very sincere thanks and appreciation for the unfailing interest and help in many ways in carrying on the work of the Woman's Auxiliary, in the Diocese of Michigan.

## ANNUAL REPORT OF THE VICE-PRESIDENT OF THE NORTHERN ARCHDEACONRY

Your Northern Archdeaconry Vice-President began her activities for 1927 by attending the Annual Convention. With the exception of the meetings held in February and March, she attended all meetings of the Executive Committee and the monthly meetings of the Diocesan Auxiliary.

During the Lenten Season she had a Mission Study Group, using for the text that most interesting book, "Beyond City Limits." Subsequently reviews of the book were given in four different parishes, to groups of women who had not attended classes.

Upon invitation, visits were made to several parishes, where talks were given on "The Message," "The Corporate Gift," "The Mission Study Class," and "The Woman's Auxiliary to the National Council."

Pursuant to a plan of the Chairman of the Department of Missions in September, letters were sent out to every parish and mission in the



Archdeaconry, asking the privilege of sending some one to talk to their woman's organizations about the auxiliaries. The replies from the clergy and presidents of societies were very cordial, and many pleasant and, we hope, fruitful contacts were made.

Quite the largest undertaking was the visit to the Northern Mission Field of the diocese, where we were privileged to accompany the Rev. Mr. Hole, missionary in charge, or his assistant, Miss Elliott, on a week's trip through this territory, which comprises Trinity Parish, Mackinac Island, St. James, Cheboygan and the Missions at Onaway, Hagensville, Long Rapids, Lachene and Hillman. These charges are all widely separated, and one must visit them himself to realize the miles of travel entailed in making one visit to each point.

In closing my report, may I assure those whom I serve in the capacity of Vice-President of the Northern Archdeaconry, that I am always ready and willing to do anything I can to promote the aim of the Woman's Auxiliary—the spread of Christ's Kingdom among women.

## ANNUAL REPORT OF THE VICE-PRESIDENT OF DOMESTIC MISSIONS

We received from the members of four boys' fraternities in Detroit the sum of \$125 for Mrs. Wilkins in her work among the mountaineers of Ivanhoe, Virginia. This money was part of the proceeds from a dance given by these four fraternities—the "Big Four." Many of our own boys aided in this effort.

In June letters were sent to 48 parishes asking for contributions in money and clothing for relief of the flood sufferers in Mississippi. Thirteen of these parishes graciously responded to the call by sending boxes valued at a total \$938.55, and in money to the extent of \$154.00. The total for this response was \$1,092.55. Bishop Bratton of Mississippi, expressed his deep appreciation for this splendid help.

At the last executive meeting of the Auxiliary, it was decided to respond to an appeal for help from the flood sufferers in the Diocese of Vermont. The offerings contributed by the Auxiliary at the Convention meetings on January 30 and 31, 1928, are to be used for this cause.

The total value for boxes sent and gifts in money for the year 1927 is \$1,217.55.

## ANNUAL REPORT OF THE VICE-PRESIDENT OF EDUCATIONAL WORK

The Educational Committee experienced unusual activity this year in that it organized two Institutes—one in January as has been its custom for the past fifteen years and also one in October. The latter took the place of the January Institute of 1928. It was found that an institute preceding the Convention formed too long a period for the delegates.

In January the subject considered was the Rural Problem, using the textbook, "Beyond City Limits" by the Rev. F. D. Goodwin. Mrs. Wright B. Haff, of Pelham, N. Y., as leader, was most helpful and inspiring.

During the following Lenten season approximately twenty classes were conducted throughout the Diocese upon the Rural Problem—a subject which brought the Church's Mission very close to our doors. For the first time, we believe, a concrete project was suggested to the study classes which was, besides a general interest in our rural work, to send a delegate to the Woman's Rural Conference in Madison, Wis. As a result, a fund of seventy-three dollars was contributed by the following 13 parishes:

As it was impossible at the time to find a woman available who was in a position to both give and receive benefit at such a conference, it was decided to send a man. Through the suggestion of Archdeacon Ramsay, Rev. Charles E. Edinger was chosen. The choice was a most happy one from all standpoints.

From the thirty-one reports returned out of the fifty-four blanks sent out, it was learned that beside the above classes several used the Bible for their study and two continued with Latin America.

A class in Beyond City Limits reported from St. Luke's Church, Ypsilanti, conducted by their Junior Guild is a suggestion for other churches. How many branches of the Woman's Auxiliary are interesting young women of from 25 to 35, married or unmarried, in a study of the Mission of our Church. These young women are usually shy about associating too openly with those of more mature age. However, if they are encouraged to take up among themselves some of the subjects of our study they might discover new contacts with the life of the Church.

The Fall Institute was held under the excellent leadership of Mrs. William L. Torrance, whose enthusiasm always remains fresh and inspiring. As a proof of this, this Institute stood out above all others many years in the number of new leaders added to our list. Mrs. Torrance also represented this Diocese at the Educational Conference in Racine last September.

The subject for this year, "A Church Awake," a study of the vital elements of the Gospel, by Dr. William C. Sturgis, is primarily inspirational and so is recommended to all who are looking for renewed zeal and a more spiritual point of view in their Church activities.

It is hoped next fall to hold Institutes in two or three parts of the Diocese if the demand is sufficient.

In addition to our study classes we must not forget that programs throughout the year have also great educational value, even though it be but readings from the Spirit of Missions and a study of the Program of the Church. Epiphany Church, Detroit, reported reviews of several novels in connection with their rural study. We offer this as a suggestion.

In closing, we wish to pay a tribute of thanks to our retiring president, Mrs. William T. Barbour, for her ever ready and gracious co-operation in all of our educational efforts.

## ANNUAL REPORT OF FINANCE COMMITTEE

At any annual meeting the interest is not maintained by lengthy reports. I shall never forget the deafening applause accorded one financial secretary who, when called upon for a report, said, "There are no finances, so I can give no report," and sat down. By everyone her report was voted the best of that enormous program, but I am not in like situation, so am glad to tell you about our status on the Corporate Gift, even at the risk of being voted a bore, for I know statistics are a bore and many of you are not interested in the Corporate Gift. But when I tell you you do not know what moment your name or rather that of your parish may be mentioned, I believe you will be interested to learn where you stand.

The Corporate Gift has been explained to the following churches in Detroit in personal calls: St. Matthias, Christ Church, Ascension, Epiphany, St. John's, St. Joseph's, St. Mary's, St. Paul's Cathedral, Grace, St. Albans, St. Andrew's, Memorial, Trinity, St. Peter's, St. Philip's, St. Stephen's, and St. Thomas. Outside of Detroit: Christ Church, Adrian; Christ Church, Cranbrook; Christ Church, Dearborn; St. James, Grosse Ile; St. Paul's, Jackson; Grace, Mt. Clemens; Grace, Port Huron; St. Paul's, Port Huron; St. Paul's, Flint; Christ Church, Flint; St. Paul's, Saginaw; St. Stephen's, Wyandotte, and St. Luke's, Ypsilanti. Total, 29. Other churches in the Diocese have not been visited because it has been impossible to get a date.



Checks have been received from St. Andrew's, Ann Arbor; Grace, Bay City; Trinity, Bay City; Christ Church, Cranbrook; Christ Church, Dearborn; Christ Church, Detroit, Christ Church, Flint; St. John's, St. Joseph's, St. Matthias, St. Paul's Cathedral, Messiah, St. Albans, St. Thomas, all of Detroit; St. James, Grosse Ile; St. Paul's, Jackson; All Saint's, Pontiac; Grace, Port Huron; St. John's, Royal Oak; Calvary, Saginaw; St. Paul's, Saginaw; St. James, Brightmoor; Halfway; Trinity, Detroit; St. Stephen's, Wyandotte.

There has been sent by the Diocese of Michigan to the National Treasurer, \$1,846.38 of the \$2,500 we hope to send.

The National Treasurer of the Corporate Gift has received \$78,000, approximately, of which she has sent \$58,000 on to the National Treasurer of the Church, leaving \$20,000 in the Corporate Gift treasury and \$22,000 yet to be collected, a very good showing, but as we are asked to redouble our efforts, knowing the last thousands are the hardest to get, I beg of you to respond to this call as our Lord has prospered you.

## ANNUAL REPORT OF CHURCH PERIODICAL CLUB

In making a report of the Church Periodical Club it is impossible to give any adequate idea of the work accomplished.

The Club has always worked in the five fields of service. During the past year reading matter has been sent to every missionary district.

At Christmas over one hundred books were sent by individuals to missionaries and shut-ins and most appreciative letters have been received.

Quantities of books have been sent to form libraries in rural communities both in the diocese and throughout the country. There is a great need for these libraries, especially among the mountaineers of the South. Can we not interest more of our Church Schools and young people's societies in this work? In one Church School every class sent a book to St. Margaret's School in Tokyo, Japan; another sent to Fort Valley High and Industrial School in Georgia.

In each book was placed a book plate bearing the name of the donor.

In answer to an appeal from Alaska, a member of St. Paul's Church, Jackson, sent a set of the Harvard Classics.

The Woman's Auxiliary of Christ Church, Detroit, gave a traveling library in memory of Mrs. Belle Holland Brady. This library was sent to Onaway, Michigan, to be in charge of Miss Ethel Elliot.

There have been six meetings of the parish secretaries. To these secretaries I wish to express my appreciation of their fine co-operation and splendid work and may I take this opportunity to thank all who have contributed in any way to the Club? Without your interest and help this work could not be carried on.

Three hundred and sixty current periodicals have been sent regularly to some given address by two hundred and twenty persons.

Four hundred and ninety Bibles, Prayer Books and Hymnals. Over one thousand books, eight thousand odd papers and magazines, nine thousand five hundred cards and pictures, sixteen hundred miscellaneous articles, including pictures, games and records.

Twenty-two institutions in this diocese have been aided.

## ANNUAL REPORT OF THE CHURCH SCHOOL SERVICE PROGRAM

Another year is finished and we find that more boys and girls are working in the fine fields of Christian service than were doing so last year, not only working but praying, studying about and sacrificing for others.

Last spring the head of the National Church School Service Program asked the boys and girls of our diocese to provide Christmas presents for 1256 Indians, for two Chinese missions in California, for children in some mining camps in Utah and for some Mexicans in a mission in New Mexico and also to send \$100.00 to Japan to purchase Christmas gifts for the children in one of our missions there.

Miss Helen Edwards was responsible for the Christmas box work this year and she wrote to every church school in the diocese telling them what our program was and asking them if they would like to have a share in carrying it out, with the result that by October 1st more schools were asking for assignments than she had assignments for, showing that it is wise to get your quota early and avoid the last minute rush. Some schools were disappointed that they could only send toys and clothing to Indians, two gifts, a joyful and a useful one were sent to each person, or 2,512 presents in all, and the appreciative letters received show that our efforts made Christmas a joyful day for many in far away, isolated places; the letters and Christmas greetings seemed to be as welcome as the gifts.

As soon as the Christmas boxes were sent, which was about Thanksgiving time, we began planning for Christmas cheer for people here at home. Early in the fall Miss Marion Baker, our secretary for the Community Field, went with me to see the Rev. Mr. Pierson at the City Mission, to see how our Church Schools could help in his Christmas work. We found that there were many ways that the children could assist by sending gifts to and singing carols at the hospitals, furnishing Christmas dinners, clothing and gifts for needy families, etc. Most of the schools in Detroit and a number in the diocese did Christmas work in the community, sending gifts from white gift and mangle services to the hospitals, bountiful Christmas dinners, clothing and toys to needy families. Most of this work was assigned to the schools by Miss Balch, who is connected with the Detention Home and in touch with investigated court families, so we were able to help a number of these cases, which was much appreciated by Miss Patten.

The Church School Service Program is now conducting classes or conferences every month at the Saginaw Normal School, the Flint School, and the Detroit Normal School for Teachers' Training. At the latter we have a conference which acts as a clearing house for the Diocesan officers and Parish Supervisors; this is held at 4:00 o'clock, at the first class period. In the evening two work classes are conducted, one for leaders of boys and one for leaders of girls. At the second hour there is a class on Methods of Carrying Out a Service Program. Through these classes the Diocesan Supervisor of the Service Program gets in touch with those wishing help in planning their work and is able to advise them about it and sometimes to meet with their teachers and help them to organize. Last week I went to Brightmoor to tell the Church School teachers there about the service program and had a very pleasant and profitable conference with the Rector and Mrs. Ditchburn and their teachers.



At the January Detroit Normal, St. Matthias, C.S.S.L., gave a simple pageant called the "Spirit of Service," under the direction of Mrs. Elizabeth Bissell.

The pageant was symbolic of the League. There was a prologue and epilogue and two episodes. In the first Christianity comes to the spirit of Service for aid. Service calls her spirits of Sturdy Work, Gifts, Fellowship and Prayer to do her bidding. In the second episode the spirits of Community, Diocese, Nation and World and Mother Church-Parish come also to Service for help.

Service gives her helpers to aid each one in the work they do.

This little play made very clear the Spirit of Service and is simple enough to be used by any church school group. Copies of the play may be secured from Mrs. Andrew Gill, 2012 West Grand Blvd., Detroit. We think plays and pageants should be encouraged as part of the service activities of a school, as it makes the field more real to the children and gives them an opportunity to shine in a way they love.

The children of St. Paul's Cathedral also gave a pageant, "The Pilgrims and the Book Beloved," at the Lenten Offering Presentation Service last May, which was very beautifully done.

The Lenten Offering of the Church Schools for 1927 was \$6,778.42 and the Birthday Thank Offering was \$415.00.

Christmas Box Work, Lenten Offering and Mission Study are four activities that all schools carrying out a Service Program are asked to take part in.
