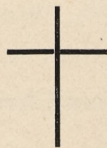

CONSTITUTION

ARTICLE I.

NAME

This Association shall be called the Michigan Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

OBJECTS

The objects of this Association are to unite the branches in a common interest; to promote the cause of Missions and Church Extension, Religious Education and Christian Social Service; to collect funds for these various purposes; to encourage the formation of new branches. Work must be done, each year, in the five fields of service, the Parish, the Community, the Diocese, the Nation and the World.

ARTICLE III.

MEMBERS

All baptized women of the Diocese who desire to be members will be so regarded.

ARTICLE IV.

OFFICERS

The Officers of this Association shall be a President, seven Vice-Presidents, one for each Archdeaconry, two in charge respectively of Education and Supply Department, a Recording Secretary, a Corresponding Secretary, a Treasurer, a Treasurer for the United Thank Offering and the Director of the Church Periodical Club, who with the Supervisor of the Church School Service League shall form the Executive Committee.

ARTICLE V.

MEETINGS

Section 1. The annual meeting shall be held during the week of the Diocesan Convention.

Section 2. Regular meetings shall be held monthly from September to May, inclusive.

Section 3. Other meetings shall be held at the discretion of the Executive Committee.

ARTICLE VI.

QUORUM

Five members shall constitute a quorum at an executive meeting, and fifteen members at regular or annual meetings, but at no time shall the lack of a quorum at a regular meeting prevent those present from proceeding with the program of the day.

ARTICLE VII.

AMENDMENTS

This constitution may be amended at any annual meeting of the Association by a two-thirds vote of all members present; the proposed amendment having been submitted in writing at a previous meeting.

By-Laws may be adopted, amended or repealed at any regular meeting by a two-thirds majority vote.

BY-LAWS

ARTICLE I.

ELECTIONS AND APPOINTMENTS

Section 1. All officers shall be elected by ballot at the annual meeting and shall continue in office for one year or until the election of their successor.

A majority of all votes cast shall be necessary for an election.

Section 2. In case of the absence, resignation or death of an executive officer, her place shall be filled by the Executive Committee, such action to stand until the next annual meeting.

Section 3. Each regularly organized branch shall appoint two delegates to every meeting of the Association, that each branch may be represented, but all the members shall have an equal vote on all questions except the Annual Elections, when the APPOINTED DELEGATES ALONE shall vote.

Section 4. At the annual meeting preceding the Triennial Convention of the Protestant Episcopal Church, five delegates and five alternates shall be elected to the Triennial meeting of the Woman's Auxiliary.

The five receiving the highest number of votes shall be delegates and the five next highest shall be alternates.

ARTICLE II.

PLEDGES

Section 1. At the January meeting each branch shall signify in writing the amount it will give during the following year, to be paid through the Treasurer of the Woman's Auxiliary.

Section 2. As it seems only reasonable that each branch shall share in the expenses of the society, all branches shall contribute as liberally as possible to the General Expense Fund, the minimum for any branch being one dollar a year.

ARTICLE III.

DUTIES OF OFFICERS

Section 1. The President shall preside at all meetings and shall have general supervision of the work of the Auxiliary.

Section 2. The Vice-Presidents shall in order of their succession preside in the absence of the President and assume all duties pertaining to the office.

The Vice-Presidents in charge of the Archdeaconries shall endeavor to promote the formation of new parish branches and to help and strengthen those already existing.

The Vice-Presidents in charge of Foreign and Domestic Missions, Education, and Supply Work, shall inform the parish branches through correspondence, visiting, or providing speakers, of the needs of work in their respective department.

Section 3. The Recording Secretary shall keep the minutes of all meetings, and prepare and edit the Year Book.

Section 4. The Corresponding Secretary shall give notice of all meetings, both of the Auxiliary and of the Executive Committee, and shall conduct the general correspondence of the Society.

Section 5. The Treasurer shall receive, disburse and keep account of all money received in each department of the work, except the United Thank Offering, and shall attend the meetings of the Auxiliary, reporting receipts and disbursements at the same.

Section 6. The Treasurer for the United Thank Offering shall receive all contributions from the branches and under the direction of the Executive Committee endeavor to arouse and increase an interest in the same.

ARTICLE IV.

FISCAL YEAR

The fiscal year of the Association shall be from January 1st to December 31st.

ARTICLE V.

COMMITTEES

EXECUTIVE COMMITTEE

Section 1. All matters relating to the general welfare of the Society shall be referred to the Executive Committee. It shall appoint Standing Committees, which shall co-operate with it.

Section 2. Seven Standing Committees shall be appointed by the Executive Committee each year after the annual meeting.

A Committee on Missions and Church Extension, a Committee on Religious Education, a Committee on Christian Social Service, a Committee on the Box Work and Bureau of Supplies, a Program and Publicity Committee, a Finance Committee and a Hospitality Committee.

The Committee on Missions and Church Extension shall promote missionary intelligence and missionary activity among the women of the Diocese and shall superintend the work of arranging for meetings in different parts of the Diocese in the interest of forming new branches and strengthening the old ones.

The Committee on Religious Education shall arrange for Mission Study Classes throughout the Diocese and give all information regarding the work.

The Committee on Christian Social Service shall co-operate in the work of Christian Americanization, Hospital, Institutional and any other form of Christian Social Service.

The Committee on the Box Work shall supply lists of boxes obtained from the Church Mission House to parishes wishing them; shall have charge of the preparation of any general Diocesan Box and present the combined annual box report of all the parishes. This Committee shall maintain a Bureau of Supplies.

The Program and Publicity Committee shall make a plan for the meeting of the Association during the year, provide speakers subject to the advice of the Executive Committee, be prepared to advise parish branches who may desire to have assistance in arranging their yearly programs and do all necessary publicity work.

The Finance Committee shall have charge of the raising of all special funds, unless some special committee has been appointed, and shall be charged with any other similar work requested by the Executive Committee.

The Hospitality Committee shall arrange for the entertainment of speakers and delegates attending the various meetings.

ARTICLE VI.

ANNUAL REPORTS

Each officer and chairman shall present a typewritten annual report, also providing a copy for the use of the Recording Secretary.

ANNUAL REPORT OF THE PRESIDENT OF THE WOMAN'S AUXILIARY

The meeting held May 27th at Grace Church, Port Huron, I attended with much pleasure. At a special luncheon and meeting at Grace Church, Mt. Clemens, I spoke of the Triennial. The meeting Sept. 30th was held at St. James Church, Birmingham. Here the attendance was again very gratifying. The speaker was the Rev. Aristides Villafane, of Porto Rico, who was introduced by Mrs. James H. McDonald. He made a splendid appeal and a gift of money was voted by the Woman's Auxiliary for his work. At the meeting held October 28th at Christ Church, Detroit, the speaker was Bishop Abbott of Lexington. Dr. Elliott of St. Luke's Hospital, Tokio, Japan, gave a short talk. The wife of the Bishop of Lexington, Mrs. Abbott, a devoted Woman's Auxiliary member, also spoke.

On November 25th, we had the pleasure of meeting at St. John's Church, Royal Oak. Program was in charge of Mrs. Pottle, chairman of Social Service.

One important and successful change in our schedule has worked out very well, viz: holding the Executive Meetings on the morning of the regular monthly meetings, a more convenient arrangement for the members of our board from out of town, as well as the board members residing in town, thus enabling everyone to attend the luncheon and meeting, with their minds well concentrated on the work and with a seemingly greater enthusiasm.

The first meeting of the Parish Presidents of the Woman's Auxiliary, together with the Diocesan Board of the Woman's Auxiliary, was held Oct. 28th at Christ Church, Detroit. The recognition by the Diocesan Auxiliary of the value of the Parish work fosters loyalty. These meetings should be held two or three times during the year so that our groups may function more effectively.

It has been requested that the Corporate Communion, heretofore held on a day before the regular September monthly meeting, be held on the morning of the regular September meeting. The attendance at the Corporate Communion held at the Church of the Messiah last September 21st was very small. Every arrangement was perfectly prepared.

We believe that we cannot successfully have the two occasions in one month at the beginning of the year.

We all recall the Rally Dinner held at the Church of the Epiphany, with a great deal of pleasure. Bishop Page, Mrs. Edna Biller, of Taylor Hall, Racine, Wis., and Rev. Snowden of the National Council, delivered their worth-while messages to a large audience.

"The 5th Province has fallen into line," quoting Miss Frances Field Bussey, "and has organized a Provincial Woman's Auxiliary, in place of a Provincial House of Church women" and we, the Woman's Auxiliary, must be as effective and as helpful as possible.

The development and evolution of both the Woman's Auxiliary and the House of Churchwomen has interested me very much.

It seems most essential that each body should be in closer touch with the functions and activities of the other organization. All women desire the saving of time, effort, energy and expense, and wish to enlarge the women's work in the Diocese and further its progress. Sometimes a oneness of program strengthens the whole program. Unfortunately, time did not permit me to attend the monthly meetings of the House of Churchwomen. Had I been more free, I should have made a particular point of this. I should have advocated an open policy of full understanding and better co-operation for both organizations through friendly and open discussion. The women of the Diocese would be strengthened and I believe they are in favor of some action to unify the work of both bodies.

Careful selection of delegates by Auxiliary Parish Branches is essential namely, delegates to the Annual Meeting, delegates to represent the Woman's Auxiliary at the Convention of the House of Churchwomen at conferences and in Triennial.

A letter of Jan. 1st from Miss Elizabeth Matthews, President of the Woman's Auxiliary, to the National Council, Province of the Midwest, states: "It is a shame that any Diocese in our own Province should fail to send delegates." She offers council and assistance in financing a delegate and she hopes to discover that every Diocese in our Province is represented during this year's Conferences, referring especially to the Woman's Auxiliary Conference which Miss Lindley is holding at Taylor Hall, May 2nd to May 7th. An item printed in "The Witness" speaks of the 57th Annual Meeting of the Woman's Auxiliary of the Diocese of Long Island, with more than six hundred members present.

One of the important recommendations made to the Diocesan Auxiliary by the Executive Committee during the year is that the Chairman of Religious Education be considered a Diocesan Director of Religious Education. In addition there shall be appointed by the Executive Committee three educational secretaries, one from each Archdeaconry, who have been recommended by their respective Archdeaconry Vice-Presidents. These three secretaries shall work under the direction of the Diocesan Director of Religious Education.

I feel deeply grateful for the prompt response and acceptance by the members of the nominating committee and wish to express my appreciation.

We mourn the death of our Presiding Bishop, the Right Reverend John Gardner Murray, who for four years was President of the National Council; therefore, President of the National Woman's Auxiliary during these years. Quoting Miss Lindley: "It is impossible to express all he did for us." His death brings deep sorrow to the members of his Church and to his host of friends. We all know that we can show appreciation and gratitude for such leadership.

We mourn the death of Miss Edith Maurice. This is a distinct loss to the Diocese. She did much to make the Church's children friends by her sympathetic sincerity and leadership. The spirit of friendship is to be coveted.

We have felt the incompleteness of our Board without a Chairman of Religious Education and are challenged to share the responsibility of seeking and finding women who will hold office with a willingness to serve the Woman's Auxiliary. Behind seeming indifference lies the fundamental kindness of the human soul. It simply needs again to hear the command: "Go into all nations and preach the gospel of Brotherly love."

I have enjoyed the work of the Woman's Auxiliary and hope to keep the contact far into the future.

"No enterprise for the Kingdom of Christ is too tremendous for helpful women to work and pray for, no bit of service too humble for helpful women to do, provided it has the great objective." The 17th Century prayer of Bishop Hackett is still needed in the 20th Century. "Lord, lift us out of private-mindedness and daily create that atmosphere of a happy temper and generous heart which alone can bring Great Peace."

"May the love of Him who gave His Son that we might be saved fill our hearts. If this work is God's will, let us undertake it in the belief that we can do all things through Christ which strengtheneth us."

One in September, written in the interest of the United Thank Offering, and copies were sent to the clergymen in the Northern Arch-Deaconry, as well as to the Auxiliary Presidents. The other letter sent in December, contained information regarding the annual pledge, the approaching Annual Meetings, and other items it seemed necessary to put before the Parish groups.

Assuring the chair and the assembled delegates here of my continued interest in the work of the Woman's Auxiliary and my willingness to help in any way I can, I respectfully submit this, my annual report.

The Vice-President of the Foreign Field submits the following report, regretting that absence from the city prevents my attendance at the Annual Meeting.

I have attended all but three of the Diocesan Monthly Meetings and as Custodian of the banner, have displayed it at all of the out of town meetings.

~~\$136.00~~ ~~\$13,600.00~~ from the Rufus W. Clark Memorial Fund was sent for the second year to Bishop McKim to aid Japanese students studying for the ministry; and the sum of \$1,069.00 has been sent to various Foreign Missions. This, however, is less than half given to Domestic Missions, and I would call the attention of the different branches to this fact, asking them to raise the sum of their pledges to the Foreign Field so that the great discrepancy may be remedied, and more money for this very important work of the Auxiliary be available.

This year, in addition to the regular pledge, the different branches have contributed \$4,038.58 to the building fund of St. Luke's Hospital, Tokio, Japan.

In the Foreign Field many interesting and important things are taking place. The great St. John's University at Shanghai has celebrated its fiftieth anniversary. A half century which has educated many noted men in the Religious and Political world and the last academic year was remarkably successful, coming as it did after fifteen months of inactivity. China will feel the loss of that veteran missionary, Rev. S. Harrison Littell, who has accepted the Bishopric of Honolulu. Native Bishops and Clergy are being consecrated and ordained in both China and Japan. In far off Liberia the prayer for a Doctor has been answered, and Bishop Campbell has a physician for his hospital.

We read of new missionaries going out and old ones returning after furloughs—so the work is going on, hindered as it is by reduced appropriations and all of the other things, which make the task of a missionary full of discouragement and trial; only needing the help of those who stay at home, by prayers and money to carry on to a glorious finish the command of our Lord and Savior, Jesus Christ, Go ye into all the World.

A call for a layette from a Parishioner in Fenton was answered by some young girls in St. Paul's Cathedral, and twenty-seven garments were sent.

An urgent plea to aid Mrs. Wilkins in her work at St. Barnabas Mission, Ivanhoe, Va., came in April. Due to the ignorance and superstition of the mountaineers, her problem is very difficult and discouraging.

The Holy Rollers have a strong following in the community and even say it would be a blessing if the school was burned.

She needed \$250.00 to pay her teachers that work might continue. There are 90 children in the school.

ANNUAL REPORT OF THE EDUCATIONAL WORK

The beauty of not holding an official position is that one need not give a report. Instead, I have been asked to give at this time some of the immediate plans of the Educational Department of our Woman's Auxiliary.

In one way it seems too bad that there has been no Educational Secretary during the past year. Perhaps, though, it has been a pleasant relief not to have somebody prodding you on to new efforts. Or it may be that the new encumbent will find particular encouragement from the fact that you are all eager for direction.

However, Religious Education, like Tennyson's immortal Brook, goes on forever, regardless of whether or not an Educational Secretary rides on its babbling crests. Already inquiries are coming into the Diocesan office regarding study classes so we know that the interest is still alive.

I would like to pause at this point to thank the Presidents and all the members of the Executive Committee for their kindly courtesy in inviting me to attend all their meetings and other nice affairs the past year, though I had no official place there.

The subject for study this year is "The World Mission of Christianity," which is based on the discussion of problems which came before the Conference held in Jerusalem in the spring of 1928. These problems—such as Industrial, Racial, Rural, etc., were of world wide interest. How Christianity might be used in their solution was discussed by delegates from about fifty countries—many of these countries being non-Christian, though the native delegates from them were all Christian. This point in itself seems to give a thrilling interest to our study of these problems.

Mrs. Harper Sibley, who is to be one of our speakers tomorrow, was one of the American women delegates, so her talk will be of particular interest to all Auxiliary women. It is urged that you all be there to hear her.

Beginning the following week it is planned to continue from her talk with a series of three sessions to be given on successive Wednesdays, the first being Feb. 12, from 11-12:30. At these sessions a study and discussion of the text-books based on the Jerusalem Conference will be taken up. When we tell you that the leader will be Mrs. Wm. L. Torrence, we are sure that no further recommendation for the course will be needed. These classes are for leaders and any others interested.

Two text-books will be necessary. One "Roads to the City of God," tells the story of the conference. The other "World Mission of Christianity," sets forth the problems and recommendations of the conference. Other reference material will be provided on a printed program.

As it has been thot that there may be some parishes and missions who have never made a study of the "Mission of Christianity," and therefore may not be prepared to study the subject assigned to us this year, a simpler course will be provided at the same time. The leader will be Miss Alice Alexander. As Miss Alexander was the one who introduced Mission Study into this Diocese, you may be sure that she is well qualified to help any one to interest groups of women in this fascinating work.

Now we urge you to do three things: First, purchase the text books; Second, attend Mrs. Harper Sibley's talk tomorrow; Third, be on hand for the first session of the Diocesan study class next Wednesday, Feb. 12th, from 11-12:30 in the Cathedral House.

There is one closing suggestion. Our Church Schools are to study one phase of our study this year—The Industrial Problem—their theme being "Our World at Work." If you are so fortunate as to have young people leaders in your particular parish, peek in on their classes for pointers on how to make your women's classes more interesting. Also peek in on some of the Church School Sunday Services during Lent. We believe that you will receive, in some cases at least, many pleasurable and worthwhile suggestions.

ANNUAL REPORT OF SOCIAL SERVICE CHAIRMAN, WOMAN'S AUXILIARY, DIOCESE OF MICHIGAN

Madame Chairman:

I cannot give a report of the work done this year, as I only received eleven reports and only four of them were from the Detroit branches. I am sorry as reports are not only a record of what has been done but we may get many ideas from the work others are doing. Also when the National Council sends a questionnaire out, as they recently did, it would be a simple matter just to refer to the chairman of each department for the information. So I do hope during the coming year the Presidents of each Parish branch will see that all reports called for will be promptly sent in.

Will tell you a little of what I gleaned from the reports—There were nearly 300 presents given to the girls on probation from Juvenile Court at Christmas. The value in money would run close to \$400.00.

Parties, money, canned goods and clothing have been sent to Williams House.

Thanksgiving and Christmas basket have been sent out.

In St. Joseph's Church they have kept a grocery shelf and as men have come for work or help have been paid in groceries, given money only for car fare.

A great deal of clothing has been supplied the needy.

City Mission has been helped with money, clothing, papers, etc.

Hospitals have been visited and flowers and fruit have been given the sick and shut-ins.

In Cheboygan a member of the Auxiliary has assisted the Physician in the care of medical and surgical cases where there is no nurse in attendance.

Others have helped the local charitable institutions.

St. Paul's Cathedral has had a very busy year. They have sent out 793 articles of clothing, have expended \$983.14 and with the \$500.00 given Williams House makes a total of money spent \$1,423.14 for Social Service in 1929.

Your chairman has visited four Auxiliaries and furnished speakers for three.

I have been asked for suggestions for things to do in Parishes outside Detroit. Of course each community has its own problems. You always have the sick and needy and most communities have institutions to help, not only in money but in personal services. Williams House and the City Mission belong to you as well as to Detroit. Most of the girls in Williams House come from out in the state. I am sure if you cannot get charity sewing we could send some from Detroit.

Social Service does not mean just sewing for the Institutions, but we must visit them and see the work they are doing. The Community Union has arranged for group meetings in them and many will serve you a lunch at a nominal cost. It is hoped that next year many branches will avail themselves of this opportunity to see the work at first hand.

This all tends toward a better understanding of our institutions and their co-operation with other communions is one way of promoting Christian Unity.

REPORT OF THE CORPORATE GIFT

February 4th, 1930.

It would scarcely seem necessary to give a report of the Corporate Gift at this meeting, in view of the very comprehensive review of all women's work in the Diocese, summed up on the chart which was compiled from reports of all parishes by heads of different committees.

However, I should like to give you a very abridged and condensed statement of the Corporate Gift at this time in the Diocese of Michigan.

Will you kindly bear in mind our quota, as given to us by the National head of the Corporate Gift for the year 1928 and for the year 1929, is annually \$1,314.00 and it is absolutely necessary for each branch to meet its quota in order to attain the total for which we are asked. You will notice many branches are blank in the Corporate Gift column, a very few plus and more are minus, but the total brought the gift to the mark set for it.

The checks sent were due Epiphany (January 6th) 1929 and 1930. The gift for 1928 was not complete until August 1929, but as checks were received they were forwarded to the Diocesan Treasurer and by her to the National Treasurer.

If you will pardon a few statistics—August 29th, we had given \$1,431.80, a surplus for the year of \$117.80. So far this year checks sent in have amounted to \$560.50, or a total for the two years of \$1,972.30, leaving a balance to be given this year of \$753.50.

There have been several checks received since the figures went to the chart compiler—among them checks from St. Andrew's, Detroit, St. Paul's, Port Huron, and St. Luke's Ypsilanti.

Some churches have gone over their expectation this year, so if every church meets its expectation we shall be able to close the Corporate Gift with flying colors. If many fail to reach their goal, we must for the first time fall behind.

You understand from what others have told you, our efforts for the last year of the Triennium 1930-1931 will be for the Advance Work of the Church. Bishop Page will decide upon which of several objects of the Advance Work submitted to him by the National Council, as Michigan's share, will be the privilege of the Woman's Auxiliary to assist.

REPORT OF THE CHURCH PERIODICAL CLUB

The Church Periodical Club is an organization to supply reading matter to our clergy, missionaries and other persons so situated that they cannot readily obtain it otherwise. The work is much the same each year.

Three hundred sixty current periodicals have been sent to some given address by two hundred and eighty persons; two hundred forty Bibles and Prayer books; seven hundred fifty books.

Eight thousand odd magazines; ten thousand cards and pictures; ten thousand games; records, and miscellaneous articles.

Twenty-six institutions in this Diocese have been aided.

Four meetings of Parish Secretaries have been held.

At the meeting in October, Archdeacon Haggar was present. He suggested several ways in which we might help the missions under his care. Magazines and books have been sent to our Field workers.

Mrs. Edinger writes that through the help of the Church Periodical Club, they all have circulating groups of books from place to place and that the books are much appreciated and enjoyed.

At Christmas nearly two hundred books were sent to missionaries and shut-ins by individuals.

ANNUAL REPORT OF THE CHURCH SCHOOL SERVICE PROGRAM OF THE DIOCESE OF MICHIGAN, 1929

February 4, 1930.

The Church School Service Program of the Diocese, under the leadership of Miss Edith Maurice, carried on a very interesting, active and far reaching program of service, for the year 1929.

The Diocesan organization followed the lead of the National office and discontinued the use of the annual report sheets so it is not possible to give a detailed account of Parish activities, but the indications have been that more of the Parishes throughout the Diocese are including the service projects as a part of their Parish Program.

Meeting of the leaders of the C. S. S. P. have been held in connection with the Church Normal school. At this time outlines of service are prepared by the secretary of one of the Five Fields of Service.

A Mission Study Institute was held at St. Andrew's Church House on Feb. 9th, 1929. The purpose of the Institute was to prepare the leaders to lead group study-groups during Lent, with the children of their own Parish. The fields studied were Porto Rico, Hawaii and the Phillipine Islands. These were the fields assigned to this Diocese for their Christmas Box work. During the time in which these gifts were being prepared, Father Villifane, of Porto Rico, spoke at one of the leaders' meetings, of the missionary work of the Church that is being carried on in Porto Rico.

One thousand, five hundred and thirty-six gifts were sent by the boys and girls of this Diocese to the boys and girls of the fields assigned.

One of the interesting projects for the Diocese was the "Paint for the Northern part of the Diocese." \$115.00 was raised and paint was provided for churches that had long been in need.

The Lenten Offering, Birthday Thank Offering and Little Helpers Offerings are the three offerings of the children of the Diocese that are the responsibility of the C. S. S. P. These offerings are incorporated in the Service program as educational opportunities as well as opportunities for personal giving.

The object of the Birthday Thank Offering for this Triennium is the children's ward of St. Luke's Hospital, Tokio, Japan. The total of the offering for the year 1929, as reported on Nov. 12th, was \$231.33.

The total of the Lenten offering for the season of Lent, 1929, was \$8,749.02.

These offerings have been presented at a service held on Whitsunday afternoon.

At a recent meeting of the Executive Group of the C. S. S. P. a resolution was drawn up and sent to the Department of Religious Education recommending that "a plan for presenting these offerings be developed that would give equal emphasis to the B. T. O. and the Lenten Offering."
