Please see that all notices of meetings sent out by the Corresponding Secretary are printed in Church Bulletins and read by your Rector at the Church Services.

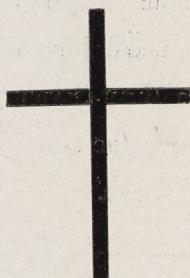
The fiscal year of The Protestant Episcopal Church ends December 31st of each year.

CONSTITUTION

ARTICLE I.

NAME

This Association shall be called the Michigan Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

OBJECTS

The objects of this Association are to unite the branches in a program of the church for worship, study, service and fellowship; to promote definitely the cause of Missions and Church Extensions, Religious Education and Christian Social Service; to collect funds for these various purposes; to encourage the formation of new branches. Work must be done, each year, in the five fields of service, the Parish, the Community, the Diocese, the Nation and the World.

ARTICLE III.

MEMBERSHIP

All baptized women of the Diocese who desire to be members will be so regarded.

ARTICLE IV.

OFFICERS AND EXECUTIVE BOARD

Section 1. The following executive officers shall be elected at the Annual Meeting: The President, three Vice-presidents, representing the Detroit, Southern and Northern Districts, the boundaries of which shall be defined by the Executive Board; a Recording Secretary; a Corresponding Secretary; and a Treasurer.

Section 2. The following officers shall be appointed annually by the President with the advice and consent of the other executive officers: A United Thank Offering Treasurer, an Educational Director, a Director of the Church Periodical Club, a Prayer Partner, a Director of Supply Work, a Solicitor for the Spirit of Missions and a Treasurer and Custodian of the Golden Book of Remembrance.

Section 3. The Executive Board shall consist of the Bishop and the above officers, together with the Chairmen of the Standing Committees as named in the By-Laws, the Diocesan Presidents of the Girls' Friendly Society, Daughters of the King, Altar Guild and St. Barnabas' Guild for Nurses, and of any other Diocesan organization for women recognized by the Bishop, and the Convention Chairman.

Section 4. The Executive Board shall have oversight and direction of all work for the Church done by the Women of the Diocese not otherwise provided for.

ARTICLE V.

MEETINGS

Section 1. The annual meeting shall be held during the week of the Diocesan Convention and in the same city.

Section 2. Regular meetings shall be held monthly from September to May, inclusive, excepting December.

Section 3. Special meetings may be called by the Executive Board.

ARTICLE VI.

CONVENTION OF THE WOMEN OF THE DIOCESE

Section 1. Coinciding with the Annual Meeting there shall be held the Annual Convention of the Women of the Diocese, which shall be non-legislative, for the purpose of considering the women's work of the Church in the Diocese and the world, of passing on to the parishes suggestions for strengthening establish projects and stimulating new work, and of giving an opportunity for interchange of ideas.

Section 2. All churchwomen of the Diocese shall be eligible to attend the convention and to participate in its discussion.

Section 3. Voting power shall be given to four delegates from each parish and two from each mission upon presenting their credentials to a committee appointed for that purpose. The method of election of such delegates and a like number of alternates shall be determined for itself by each parish and mission. If no other provision be made, the Rector or Minister in charge shall appoint. Voting power shall also be given ex-officio to the members of the Executive Board. Each Diocesan organization for women recognized by the Bishop shall be entitled to elect two representatives with voting power.

Section 4. At this Annual Convention there shall be elected by majority ballot a Convention Chairman to preside at the next Annual Convention and have charge of the arrangements and program.

Section 5. Each parish and mission shall pay a convention fee annually on a sliding scale of from \$1.00 to \$10.00. This shall be payable by January 1 of each year to the Treasurer of the Woman's Auxiliary of the Diocese to be kept in a separate account for convention expenses or for any other purpose authorized by the Convention.

ARTICLE VII.

QUORUM

Ten members shall constitute a quorum at an Executive Board meeting, and fifty members at regular or annual meetings, but at no time shall the lack of a quorum at a regular meeting prevent those present from proceeding with the program of the day.

ARTICLE VIII.

AMENDMENTS

Section 1. This constitution may be amended at the Annual Meeting of the Association by a two-thirds vote of all members present. Proposed amendments must be submitted in writing to the Recording Secretary, read at a regular meeting preceding the Annual Meeting, and referred to the Executive Board for consideration.

Section 2. By-Laws may be adopted, amended, repealed, or suspended at any regular meeting or Annual Meeting by a two-thirds vote.

BY-LAWS

ARTICLE I.

ELECTIONS AND APPOINTMENTS

Section 1. The Executive Officers shall be elected by ballot at the annual meeting and shall continue in office for one year or until the election of a successor.

The Executive Officers shall serve not more than three consecutive terms.

Section 2. A majority of all votes cast shall be necessary for an election.

Section 3. Vacancies in elective offices may be filled by the Executive Board voting thereon by ballot.

Section 4. Delegates to all meetings of the Auxiliary shall be elected in the manner prescribed by the Constitution for the election of delegates to the Annual Convention, but all members present may vote on questions other than the Annual Elections.

Section 5. The President shall be a delegate ex-officio to the Triennial Convention of the Woman's Auxiliary to the National Council and the Meetings of the Women's Auxiliary of the Providence. At the Annual meeting preceding these conventions four other delegates and five alternates shall be elected. The four receiving the highest number of votes shall be delegates and the five next highest shall be alternates. Vacancies in the delegation shall be filled by the President or Vice-President or in her absence by the delegates present.

Section 6. The President shall appoint a Chairman of Tellers who shall select her own assistants and with them shall prepare and have full charge of the ballots.

ARTICLE II. PLEDGES

Section 1. Before the Annual Meeting each branch shall have signified in writing the amount it will give during the following year, to be paid through the Treasurer of the Woman's Auxiliary.

Section 2. As it seems only reasonable that each branch shall share in the expenses of the society, all branches shall contribute as liberally as possible to the General Expense Fund, the minimum for any branch being one dollar a year.

ARTICLE III. DUTIES OF OFFICERS

Section 1. The President shall preside at all meetings; shall have general supervision of the work of the Auxiliary; shall appoint all special committees unless otherwise directed by the Auxiliary or the Executive Board, and shall be ex-officio member of all committees without the right to vote.

Section 2. The Vice-Presidents of the Detroit, the Southern and the Northern Districts in order of their succession shall preside in the absence of the President and assume all duties pertaining to the office, and shall endeavor to promote the formation of new parish branches and to help and strengthen those already existing.

Section 3. The Recording Secretary shall keep the minutes of all meetings of the Woman's Auxiliary and of the Annual Convention and shall prepare and edit the Year Book under the Supervision of the Executive Board.

Section 4. The Corresponding Secretary shall give notice of all meetings, both of the Auxiliary and of the Executive Board, and shall conduct the general correspondence of the Association.

Section 5. The Treasurer shall receive, disburse and keep account of all moneys received in each department of the work, except as otherwise provided, and shall attend the meetings of the Auxiliary, reporting receipts and disbursements.

Section 6. The United Thank Offering Treasurer, the Educational Director, the Director of the Church Periodical Club, the Prayer Partner, the Director of Supply Work, and the Solicitor for the Spirit of Missions shall perform the duties of their offices according to the laws and practices of the National organizations with which they are connected.

Section 7. The Custodian and Treasurer of the Golden Book of Remembrance shall receive and record the names to be commemorated and the accompanying gifts. This book was given on the occasion of the Fiftieth Anniversary of the founding of the Michigan Branch of the Woman's Auxiliary by Mrs. Frederic B. Stevens, President from 1908 to 1923, and is to contain the names of all women, living or dead, regardless of church affiliations, whom it is desired to hold in remembrance. The gifts shall constitute a fund to be accumulated until it reaches the amount of \$2,000.00, after which the interest shall be used as directed by vote of the Michigan Branch of the Woman's Auxiliary.

Section 8. All officers upon retiring from office shall deliver to their successors, or the Executive Board, all moneys, accounts, records, papers or other properties of the Association in their possession.

ARTICLE IV.

COMMITTEES

Section 1. The Standing Committees shall be as follows: Parish, Diocesan and Domestic Field, Foreign Field, Social Service, Program and Publicity, Finance, Hospitality, Nominating, Credential and Work With the Isolated.

Section 2. These committees, except that on Work With the Isolated, shall be appointed and the number of members decided by the President with the advice and consent of the Executive Board.

Section 3. The Committee on the Parish shall represent all parish guilds, societies and individual women of the Diocese not affiliated with National or Diocesan organizations; shall give them the support, co-operation and fellowship of this Association and shall promote the work of women in their several parishes and the improvement in the organization of such work, realizing that without spiritual life and activity in the parish there can be no strength in the wider fields of service.

Section 4. The Diocesan and Domestic Field, Foreign Field, Religious Education and Social Service Committees shall promote intelligence and activity in their several fields among the women of the Diocese. The Religious Education Committee shall have charge of the Elizabeth Fiske Locke Stevens Memorial Library and shall appoint the librarian.

Section 5. The Program and Publicity Committee shall make a plan for the meetings of the Auxiliary during the year, provide speakers subject to the advice of the Executive Board, be prepared to advise parish branches who may desire assistance in arranging their yearly programs and do all necessary publicity work.

Section 6. The Finance Committee shall have charge of the raising of all special funds unless a special committee has been appointed, and shall be charged with any other similar work requested by the Executive Board.

Section 7. The Hospitality Committee shall arrange for the entertainment of speakers and delegates attending the various meetings.

Section 8. The Nominating Committee, of which the Bishop shall be a member ex-officio shall prepare a list of nominees for all elective offices for the Annual Meeting and Convention. This list shall be delivered to the Chairman of Tellers in time to permit the printing of ballots. This shall not prevent the voting for candidates not so nominated.

Section 9. The Credential Committee shall receive the credentials of delegates, and furnish them with ballots and information.

Section 10. The Committee on Work With the Isolated shall be appointed in such manner as the Bishop may direct and shall endeavor to bring the message and fellowship of the Church to those who may be unable to receive the regular ministrations of a parish or mission.

ARTICLE V.

FISCAL YEAR

The Fiscal Year of the Association shall be from January 1 to December 31, inclusive, but the Executive Board may authorize the accounting of any special fund on a different basis.

ARTICLE VI.

ANNUAL REPORTS

Each Officer and Chairman shall present a typewritten annual report, also providing a copy for the Recording Secretary. Copies of all such reports shall be sent to the Bishop.

ARTICLE VII.

Closing the convention will be a pageant, put on by the Girls' Friendly Society, which I am confident will send us home with fresh enthusiasm and inspiration for our "carry-on" work as devoted and intelligent churchwomen.

PRESIDENT'S ANNUAL REPORT OF THE WOMAN'S AUXILIARY

When the program for the work of 1935 was adopted, it was built to give us a vision of "If we be His disciples—What then." During the year we have striven to urge the women of the Diocese to realize the responsibility of Christian citizenship, to realize the changing relationships of peoples of different races and to incorporate more fully the teachings of Christ in our lives. With these unified, the efforts of all will be stimulated and blessed.

Your president deeply appreciates the trust you have shown in the leadership of the Board and your own hearty co-operation. There is never any friction of any kind and each officer has been more than willing to perform her duties to the best of her ability. They are always ready to help you and the attendance at the Board meetings has been most gratifying.

The programs for all meetings have been so splendidly planned and with such fine speakers that each one we attend seems even better than the preceding. We feel all the women are learning more of the whole work of our church and feeling the personal responsibility in the effort.

Your president has attended the Board meetings of Williams' House, The Detroit City Mission Guild and the Detroit Council of Church Women, and has visited Trinity, St. Joseph's, St. Marks in Detroit, and Parishes and Missions in Ferndale, Grosse Ile, River Rouge, Hillsdale, Bay City, Adrian, Jackson and Ann Arbor. For the first time a group attended an Auxiliary meeting in Windsor of the Women of the Anglican Church. We hope in the future to have many more friendly contacts with our friends across the Border.

The delegates attending the meeting at Brent House in Chicago and the Provincial meeting in Rock Island received much interesting information from the leaders attending, and from discussions and contacts made. In Chicago there were ninety women from the Fourth, Fifth and Sixth Provinces. Miss Lindley gave us a description of what an Auxiliary woman should be—she should express the desire to work in every phase of the work of our church and should pray, work and support the National Church. Through these efforts one helps build a Christian Nation and the great motive to "Help Others" becomes world-wide.

From a recent letter may I also quote the following suggestions made by her?

I. Are we getting from and putting into The Forward Movement all that we might? She is impressed by its increasing influence and sees more opportunities for giving and receiving through it.

II. Are we taking advantage of the interest there is in social work, not only to increase that interest but to see that it takes its place in the Mission of the Church?

III. Are we taking forward steps in international and inter-racial relations? What are we doing to lead to Christian thinking and action?

IV. Is special interest being taken in the work among the isolated and church finances?

V. We need to make even better programs for our diocesan meetings—make them less crowded, cutting out long minutes and reports and finding ways of serving meals which will allow the women of the parish where the meeting is held to attend the meeting instead of working in the kitchen. Miss Lindley also calls attention to the World Day of Prayer on the first Friday in Lent, February 28th. May I urge strict attention be paid to letters sent the Parish presidents from Diocesan officers. Much confusion will be avoided if the answers are sent to the proper person.

Parishes desiring Auxiliary (Diocesan) meetings should send their request in immediately as few dates are available. The publication of the Year Book is delayed each year as lists of officers do not come in promptly—please see that this item is cared for.

Regional meetings of the Auxiliary are planned in order that women away from centers may have the work brought to them and explained. They are important and interesting and we hope for fine attendances next year. Have your women take back and read reports to those unable to attend.

The quiet day at Cranbrook with all its beauty and devotional service was an experience never to be forgotten—let us hope even a greater number will enjoy this privilege this year.

The outstanding gathering of the year—The Pine Lake Conference—has grown to such proportions that it will be necessary to make proper plans concerning reservations. We regret the disappointment of many who could not attend the last meeting and hope to avoid such another experience. The services with Arch-deacon Hagger, Mr. Lane Barton of Flint and Mr. — Forsythe of Birmingham, the speakers, Mrs. Charles Williamson of Chicago, Mrs. Ned Henry and Mr. Forsythe, with music by Mrs. Brock and an interesting talk and pictures of South America, made the conference most interesting and inspirational.

The supply department has been most successful, and the Good Friday offering from this Diocese, the largest it has ever been, but the United Thank Offering, much less than it should be. May we all use our Blue Boxes as true expressions of blessings bestowed upon us and let each woman consider it her duty and privilege to have at least one woman who has never used her box before share in this privilege and duty.

Your programs contain the reports of your work and they are to be read and reported on when you return to your Parish or Mission.

Let us personalize The Forward Movement and through using the proper directions of the pamphlets for the daily Bible readings, stimulate our Church life—let us increase our efforts in every phase of our church life and so, "Have a purpose in life, and having it, throw into your work such a strength of mind and muscle as God has given you."

ANNUAL REPORT OF THE EDUCATIONAL DIRECTOR

The second objective of one auxiliary this year was, "To develop a keener interest and greater understanding of our changing relationships to the people of the different races and creeds both at home and abroad." To try and fulfill this, Mrs. Baeslack had laid the foundation for the study books, "Suzuki Looks at Japan" and "Orientals in American Life," and the study in Lent was fostered by a one-day institute led by your Director and addressed by Archdeacon Hagger, who presented his talk from the background of his Japanese visit.

The Institute closed with a play staged most beautifully by a group led by Mrs. Castle of St. Joseph.

The study book for 1936 is "That Other America," by John A. Mackay. The interest in it was created first by a talk and pictures shown by Prof. Altenburg at the Conference held at Pine Lake. Following this, Mrs. E. A. Silverthorn, General Director of the Department of Missionary Education in the Presbyterian Church, led a two-day Institute on the subject on Sept. 26th and 27th. Surely if we are trying, as President F. C. Grant says, "to work out a way of life upon the earth, whereby all men everywhere can share to the fullest limits of their capacity in the good things of God, as members of an Everlasting Kingdom," we can begin at no better place than here at home among peoples of our own Continent of whom we know so little.

During the six sessions of the Normal School we had classes in "That Other America." Prof. Altenburg, teacher at Junior College, and Miss Mina Fillingham, teacher in the Southeastern High, spoke on South America. Mrs. James McDonald told of her personal experiences among the missionaries of Porto Rico, the West Indies, and Mrs. Peter Dolese of her Mexican travel. The first and last periods were led by your director.

We are also including in our Lenten courses a short study of Peace. It seems to me that we can only bring about "good will" between races and creeds by education, and no parish group is too small not to accept the challenge and try to add their bit to the translating of their good will into the language of our daily life and toward their neighbors.

Your director spoke on Religious Education at the Church of the Epiphany, and at St. John's; also conducted the mission study class at St. Columba's.

ANNUAL REPORT OF THE GOLDEN BOOK OF REMEMBRANCE AND SPECIAL FUNDS

All but three months of six years have elapsed since we began compiling the Golden Book of Remembrance; during this period two hundred and fifty-nine names have been recorded.

The individual who looks at this statement will make his own mental comment: Some will consider there has been a meager showing of names inscribed; others may say quite astonishing progress has been made. This is, of course, a matter of opinion.

But, regardless of the judgment as to rapid or retarded growth; at all times much will depend on the enlisted interest, and as manifested in bringing the usefulness of the Book of Remembrance to the attention of others, and of that of the working force, The Golden Book of Remembrance Fund.

Most of us are acquainted with the cause of the setback to our agreed upon plan, namely, having two thousand dollars on hand before any interest money could be used for the mission field.

Surely the attainment of this goal looms very large in importance, especially when these moneys become personalized by the names of the many who have served and are serving so devotedly and zealously in the cause of missions, and are inscribed within the pages of The Golden Book of Remembrance.

So for the year 1936 may this belief be held and observed, "that a name added, means a gift carryng on."

GIRLS' FRIENDLY SOCIETY REPORT FOR 1935 DIOCESE OF MICHIGAN

The membership of the Girls' Friendly Society has increased the past year. Three new branches have been formed and four have been reorganized. The Society would be able to add greatly to its membership if there were more women in our churches willing to become leaders. Many children are anxious to be candidates for membership, but it is a difficult matter to find suitable leaders. We have many fine older girls who are capable of doing this work, but owing to economic conditions are employed. Many are married having young children and are needed in their homes, and as children and younger girls must hold their meetings in the afternoon, we find it difficult to carry on the work without more leaders.

As President, and knowing the value of the training we can give our church girls, as well as girls of probably no church affiliation, I am asking the women of the church who love girls, and are willing to train for leadership, to offer their services for this fine work for the youth of the Diocese. One can hardly read a magazine or listen to a radio speech without being moved by the appeal made by judges, educators, and religionists asking the churches to do something for the children and youth of America. Every speaker and worker stresses the necessity for religious training. We must meet this need or our beloved country will become atheistic and communistic.

Realizing the great need for trained and inspired leaders, the Girls' Friendly Society has held conferences, conducted classes, and lecture courses. Especially outstanding was the one on "Christian Citizenship" at the Detroit Normal School. The Younger Girls' Conference, under the direction of the Department of Religious Education, G. F. S. co-operating, used the program theme, "The Life of Christ." This was well planned and carried out under the splendid leadership of the Rev. George St. John Rathbun and Mrs. Rathbun. About forty girls were enrolled. The Girls' Friendly Diocesan Organization gave \$58.00 to send girls to this conference. The Girls' Friendly Teen Age girls choose for their conference theme, "Finding God through Work, Play, Nature and Worship." This program was planned and carried out by the members under the leadership of Violette Kennedy, Chairman of Younger Girls. The attendance was fifty-six from different branches throughout the Diocese. The committee for the Older Girls' Conference, under the leadership of Erie Rose, planned their program with many special speakers on "Changing Attitudes toward other Races." This subject proved so interesting classes were continued every month throughout the entire season. These Conferences were all held at Holiday House. Ninety-five dollars was appropriated from diocesan funds to send girls to all three conferences, and several girls raised funds to send their own girls. Through the generosity of Mrs. Frederic B. Stevens, a permanent scholarship has been given to send a representative to Cranbrook each year.

A model branch meeting and demonstration classes was held at St. Andrew's Parish House, October 5th, from ten to four-thirty o'clock under the leadership of Mrs. Walter Hargrave, Chairman of Membership. Over 200 attended and great interest was shown by those present. Especially worthy of mention was the morning service. This was opened by Rev. Gordon Matthews and conducted by girls from the branches of St. Stephen's, Wyandotte, and St. Mark's, Detroit. A monthly lecture course, covering a period of five months, and planned by Mrs. George Severance, was very well attended. The subject of the Symposium was "The Temple of God." The girls wrote their own worship services which preceded the lectures. This course made a great impression on the lives of the girls and women.

Our Society met its National Mission quota and co-operated with the Woman's Auxiliary in the Mission and Christmas Box Work. Layettes and clothing to the value of \$215.00 were sent to Pikeville, Ky., and Honolulu. Sixty-seven dollars was sent toward the National G. F. S. object, St. Faith's School, Yangchow, China. Mr. Schwartz of Wyandotte, gave as a memorial for his wife, Nellie Richards Schwartz, a scholarship of \$50.00 for the education of a girl in St. Faith's. Erie Rose sold linens worth \$110.00. These linens were made by girls in All Saints' School, Bontoc, P. I., and the money to be used for scholarships in All Saints. Eighteen dollars was sent to the G. F. S. All Saints National Memorial Fund and \$75.00 was sent to the House of the Holy Child, Manila, Philippine Islands. Alice Alexander, Chairman of Missions and Service to the Church, carried on an educational program, speaking at six branches and planning mission study classes in others. Under her guidance many fine books were reviewed and impromptu dialogues and short plays were given.

The Society did a great deal of social service work, every branch contributing liberally for new clothing, food, Thanksgiving and Christmas baskets. Donations of canned goods were sent to City Mission, Page House and Williams House. The Arnold Home was visited by one branch, each person receiving a gift and a lovely entertainment given. Parties were given at many institutions. The Diocesan Social Service Fund was used for clothing and food for needy families and girls, and two women remained for several weeks at St. Luke's Convalescent Home, the guests of the Girls' Friendly Society. Space will not permit a full report of the amount of social service done by the Society and its members.

Through the kindness of Mr. and Mrs. Henry Ford, a garden party was held at their Estate. The receipts were over \$800.00, which enabled us to send many women and girls for much needed vacations to Holiday House, Rest Cottage and Bird's Nest. These vacation houses were overcrowded all season. The number of guests exceeded 2,500, besides numerous picnics and other outdoors activities. The Holiday House extended hospitality to Bishop Page for the Clergy Conference, to Archdeacon Hagger for the Field Workers' Conference and the Woman's Auxiliary Conference, also a number of conferences for men held by Rectors of the Diocese. Many college, professional and private parties were held.

The Autumn Market was held in September, Mrs. Elmer Spindler, Chairman. We want to thank all our friends for helping to make the market such a financial success.

The Diocesan Organization entertained three hundred candidates at a party held in Epiphany Parish House.

The Annual Contest, held Friday and Saturday, March 8th and 9th, in St. John's Parish House, is becoming one of the outstanding diocesan projects. Much interest was shown by the parents and friends of the girls and the entire building was crowded by spectators throughout Saturday, the day of the exhibition. The work done by the girls shows a continued improvement and there were about 2,600 entries in the departments of Fine Arts, Domestic Arts, Photography, Posters, Handicraft, Miscellaneous Art Objects and Branch Projects. Both the member and candidate shields were won by St. Stephen's Branch, Wyandotte. The member cup was won by Ellen Blue of St. Cyprian's, Detroit, and the candidate cup by Joyce Johnson of St. Stephen's, Wyandotte.

The Annual Picnic was held at Pine Lake with over 500 attending. All spent a very pleasant day enjoying the races, program, and the pageant given by St. Paul's Memorial Group.

The Society gave a program depicting a Japanese branch at work, play and worship at the Annual Women's Convention of the Diocese. This was directed by Mrs. Walter Hargrave.

The Annual Worship Festival Service, given in St. Paul's Cathedral, Sunday, April 28th, was a very beautiful and impressive service. Tableaux and pageantry, depicting the "Story of the Cross," with over 75 in the cast, was directed by Mrs. Hargrave. The splendid choir of the Cathedral, under the leadership of Francis McKay, rendered suitable music. Mrs. Herman Page, Chairman of Worship, wrote special prayers for this service. The Very Rev. Kirk B. O'Ferrall welcomed the Society to the Cathedral in his usual kindly manner and conducted the service preceding the pageant. A large number of the Clergy attended, and how pleased the branches were to have their rectors interested and willing to be there. We regret that Bishop and Mrs. Page were unable to be present and they were greatly missed. This service was the largest we have ever had, the Cathedral being filled to capacity.

Our quota for the National Organization, toward defraying the expense of salaries of field workers, secretaries, and general expenses, was paid by contributions to the Contributors Plan. We wish to thank all our members and friends who so generously helped us to raise this quota.

The Society was bequeathed a legacy of \$200.00 by Mrs. Henry M. Campbell, also a small legacy was left by May Case Marsh.

We are looking forward to a finer and better year in 1936. Choosing for our motto, "Vision," monthly lectures on this subject will be held from January to May under the leadership of Mrs. George Severance. Will you pray that the Girls' Friendly Society of the Diocese of Michigan will be a power for Christ in this coming year?

DIOCESAN ALTAR GUILD

During the year 1935 the Diocesan Altar Guild has held three regular meetings and the annual meeting in November preceded by Corporate Communion, Archdeacon Hagger being the celebrant, one open meeting held in Flint, as well as a half hour program during the annual convention—at both the last two meetings the motion pictures of Altar Guild work as it is done at St. Paul's Cathedral and St. Timothy's Mission, Detroit, were shown. This is the new film of the Diocesan Altar Guild of Michigan and is available for any group at a small rental fee. All of these meetings have been very well attended, showing the great interest there is in the work and the desire of members of the Church to know more about the Communion Service and work of Altar Guilds. This film has been shown at the following churches: St. Paul's, Pontiac; Christ Church, Cranbrook; St. Matthias, Bay City; Hillsdale; Wyandotte; St. Paul's Cathedral Altar Guild; and St. John's, Royal Oak.

I have visited nine Churches or Missions to speak or show the film, answered many questions about Altar Guild work and equipment; also two visits have been made to help organize Altar Guilds.

The Altar Guild has recently had made three card board figures, fifteen inches high, representing the three orders of the Ministry, Bishop, Priest, and Deacon, complete with all their vestments. This idea was worked out by a member of the Diocesan Altar Guild of Massachusetts and that organization was kind enough to allow the Michigan Guild to adopt the same idea. These figures are very helpful in teaching the names and uses of the various vestments and are intended for classes in Altar Guild work, especially in connection with the Junior Altar Guild Manual, recently put out by the Massachusetts Guild—so complete and so clear that it is to be highly recommended for use by both Junior and Senior Guilds.

The Corresponding Secretary reports 251 post cards, nine letters, and eighty copies of the annual report sent out. There are now eighteen active members and twenty corporate members in the Guild.

Report of the CHAIRMAN OF DIOCESAN AND DOMESTIC FIELDS January 1935—January 1936

Through the splendid co-operation and work done by the Field Secretaries, under the able leadership of Archdeacon Hagger, our Diocesan Auxiliary work has made wonderful progress, in spite of continued hardships.

From the Field Workers Secretaries Fund, we were able to present fifty dollars to each of the six Field Secretaries, in appreciation of their good work.

From another fund we gave fifteen dollars to Archdeacon Hagger to aid in his work.

In the spring, we sent letters to all churches and missions in the Diocese, asking for food showers for the City Mission, Page House and Williams House.

The response was gratifying in every way, for each Home reported more responded this year than before and they were so happy to get so many good things. About 57 answers were received out of 75 churches and missions.

We wish to thank all who answered and took part in this appeal, for we know the great need in these splendid Homes.

During the year, your chairman attended the Regional Meeting at Bay City, the Conference at Brent House in Chicago, Pine Lake Conference, Ordination Services at Jackson and each Diocesan monthly meeting; also spoke on Missions at a meeting at Trinity Church, Detroit.

DOMESTIC FIELD

In the Domestic Field, several Missionary Districts report improvements and progress, and indications of a District-wide revival of Church and Christian life.

From the Rufus W. Clark Fund we sent \$119.00 to Alaska and \$20.00 was donated by the Auxiliary members to help a girl from Virginia.

Deaconess Shaw from All Saints' Girls' School, Bontoc, Philippine Islands, has been sending a friendly quarterly letter telling of the work of the school. We have been glad to get these letters, as they give us such a better understanding of the work done in this field and the great need of that work.

At Christmas, the Deaconess sent a picture of their Creche. We thank her so much for her kind letters, as we know how busy she must be in her work.

With more people turning toward Christianity and the Church work, during the past year, we can only pray for help and guidance to keep spreading the Gospel in all the world.

SOCIAL SERVICE

During the year 1935, the same splendid spirit which has characterized the work of the social agencies of the diocese in other years, has been manifested.

The Board of Directors of Williams House, with Mrs. Walter Morley as chairman, and the Guild of Women of The Detroit Episcopal City Mission and Page House, with Mrs. George Barnes as chairman, have been most zealous in all their efforts.

The City Mission has had a busy year. A great many men came to stay, upon the closing of McGregor Institute in July. Thousands of meals were served, some for ten cents, which paid for all food bought.

Beds, bedding, and other necessary equipment was purchased, in order to care for the increased number of men.

Taylor Hall has cared for the "down and outers," who are classed as Grade B, and the Grade A men are taken care of at Mariners Institute.

The staff has continued to make the institutional visits at hospitals, detention homes, jails and other places, also to give personal interviews to hundreds of men needing help.

Page House has been exceptionally busy with the good work of caring for homeless girls and women, and all beds have been filled. A Christmas party was one of the high lights of the year, given under the direction of Mrs. George K. March and Mrs. R. C. Jamieson.

The Guild of Women sponsor three events during the year; the membership drive during Lent, a Garden Party in the summer, and a card party in the fall. This year, the amount raised is very near \$1,000.00.

There has not been an empty bed in one and one-half years at Williams House; every need has been met and there is good health in general, says Miss Wolbert, in her annual report.

The work of the standing committees of the Board of Directors was ably planned and executed, and much thanks is due them, as well as to the Corresponding Secretary, Mrs. Frank J. Weber, for the hundreds of letters which she writes during the year.

Through Mrs. Kales, special gifts were received, which together with help from the diocese, the Community Fund, and pledges from parishes and missions, enabled Williams House to carry on, and finish the year with a balance. The loyal co-operation of Miss Wolbert and her staff was a great factor in the successful operation of the Home.

Thanks are due to the teachers of the vocational schools for their helpful services; to the many organizations for showers of canned goods and vegetables, to the Church Periodical Club, to the Needlework Guild for the new articles, to Sanders for their weekly gifts of baked goods; to the groups of girls and women of the parishes and missions for the Friday night parties; to everyone who has helped to make the year happy and successful. Perhaps those groups who have not visited Williams House, and given the girls a party, will do so in 1936; they will be well repaid for their efforts.

Through the kindness of Mrs. Henry Ford, fuel for the Home has been supplied, as well as many household provisions; and the Henry Ford Hospital furnishes the services of Dr. Menagh and nurses for the clinic conducted at Clara Cottage. For these generous acts, Williams House is very grateful.

Is it not worth while to maintain this splendid Home, in which numberless girls are given the love and wise guidance they have missed in their own homes? The many letters and remembrances received by Miss Wolbert from those who have lived there, are a sure testimony to this fact.

"Who is Christ? He who fed the hungry, clothed the naked, visited the sick, And where is Christ? Where? Whoso shall receive a little child in My name receiveth Me. And who are Christ's? Everyone that loveth is born of God."

ANNUAL REPORT OF PROGRAM CHAIRMAN

At the beginning of the year 1935, the Program Committee formulated as its aims and objectives the following:

1. To bring to women of the Episcopal Church a realization of the responsibilities of Christian citizenship.
2. To develop a keener interest in, and greater understanding of, our changing relationship to the peoples of different races and creeds, both at home and abroad.
3. To develop a realization of the need for incorporating more of the teachings of Christ into our practical philosophy of life.
4. To unify the efforts of the great body of women of the Episcopal Church of the Diocese of Michigan toward growth along these three paths:
 - a. Christian Citizenship.
 - b. Christian Missions for this age.
 - c. Christian Philosophy of Life.

During the seven monthly meetings, the Quiet Day, and the Pine Lake Conference, the programs and speakers have emphasized one or more of these objectives.

In addition to the twelve o'clock meetings under the leadership of chairman of various departments of women's work, there have been enthusiastic group discussions on such parish problems as the training of leadership, the stimulation of the interest of younger women in parish and diocesan work, and the necessity for more interesting parish programs. These discussions have revealed a lively interest on the part of parish leaders in ways and means of improving the organization life of the parish, showing that the Diocesan Auxiliary is being used as a source of real help.

One new activity attempted this year was the Quiet Day at Cranbrook, on June 17, which was successful despite the pouring rain. The theme of the day was "A Christian Philosophy of Life," and was interpreted through meditation and music. Bishop Herman Page, the Rev. Hamilton Aulenbach, the Rev. Gilbert Appelhof, Jr., and Mrs. Herman Page were the speakers, while music interpretations were furnished by the Ferndale Madrigal singers, and Mr. John Edwards, organist. It proved to be truly a "day of rest, of beauty, of re-creation."

The Pine Lake Conference outgrew its accommodations this year, and under the able leadership of Mrs. C. S. Williamson, President of the Provincial Auxiliary, was once more a source of inspiration and joy.

February 25, 1935—St. Paul's Cathedral, Detroit. Speaker: Dr. D. A. McGregor. Topic: "A World Mission for Christianity."

March 25, 1935—St. John's Church, Detroit. Speaker: Rt. Rev. George Craig Stewart, Bishop of Chicago. Topic: "The Mission of the Church."

April 29, 1935—St. John's Church, Royal Oak. Discussion: "What Can a Parish Do to Stimulate the Interest of Younger Women in Its Program?" Mrs. Milton J. Robb, Leader. Demonstration of a young woman's group in action by St. Lucia's Guild of St. Paul's Cathedral.

May 15, 1935—Trinity Church, Bay City. Regional meeting.

May 27, 1935—St. Luke's Church, Ypsilanti. Speakers: Brent House Conference Delegates. Topic: "A Conference on Leadership Training." Moving Picture, "Gypsies of the Crops."

RELIGIOUS EDUCATION

Interesting opportunities enjoyed by your Director of Religious Education during 1935 have been:

1. Preaching from the pulpits of three of our Churches on Sunday—first at a Lenten Service at St. John's in the evening; second, as preacher at St. Joseph's at the 11 o'clock service, the occasion being the graduation and promotion of boys and girls of the Church School; and third, a similar occasion at St. Andrew's.

2. A trip to Europe, privately financed, but almost one month of which was on Diocesan time. This has been a great inspiration for the whole work of Religious Education in the Diocese.

3. Attendance in October on meetings of the Provincial Synod as member of its Department of Religious Education. The new publication of the Provincial Department Flashes is edited by members of this Department and sent free of charge to every Priest in the Province.

The Rev. D. A. McGregor, Ph.D., Executive Secretary of the National Department of Religious Education was in the Diocese in February, 1935. Miss Mabel Lee Cooper, Secretary for Teacher Training, will be with us from January 15th through 24th. She, like Dr. McGregor, will reach all of the Normal Schools and speak to several parish and regional institutes, to one annual parish meeting, and one parent-teachers group.

Institutes at St. Mary's, Detroit, and Church of the Epiphany, Detroit, have followed somewhat the lines of a preaching mission, as suggested by Bishop Page. They have focused the whole parish on Religious Education, and are bearing fruit in spiritual strength and wide growth. A similar Institute takes place in January in the combined parishes of Christ Church Chapel, Grosse Pointe, and Christ Church, Detroit.

The Cranbrook Summer Conference, under the chairmanship of the Rev. R. E. Charles, was unable to accommodate all who wished to come, and the Younger Girls Conference, under the Rev. and Mrs. George St. John Rathbun, had a capacity enrollment. The Detroit Normal School has never been so strong, letters coming in from many sources commending the program. The Saginaw Valley, Flint, and Jackson Normal Schools show excellent strength.

The Vacation School Manual, the "Master's Way," was used throughout our own Diocese, and went out into many other Dioceses. The new Manual, "Stories By the Wayside," on the Parables of Jesus, is in course of construction, under the Chairmanship of Archdeacon Hagger and with the able help of the Rev. Charles C. Jatho.

The Round Table Fellowship, under the chairmanship of the Rev. I. C. Johnson, appealed to men, women, and young people. The new chairman, the Rev. Warner L. Forsyth, has interesting plans for this year's session. The sessions come in Lent. The dates are March 2, 9, 16, 23, and 30—five Mondays in March.

Many people in the Diocese would be surprised at the number of boys and girls pouring into our Church Schools. In several the enrollment is crowding the 500 mark. Michigan ranks seventh in the American Church in the number of teachers and in the number of pupils in its Church Schools. The National Department has attempted an analysis of the educational background of the teaching staff of Church Schools in the Episcopal Church, selecting our Diocese as one of six as a basis. They found 24 per cent of teachers men, 76 per cent women; 32 per cent parents; 25 per cent college graduates, 16 per cent had part college training; 10 per cent Normal graduates, 10 per cent school teachers; 37 per cent high school graduates—an encouraging record of preparation for teachers of our boys and girls, in religion.

Perhaps no more inspiring experience can be had than attendance on one of the regional Festival Services when the Church Schools meet with the Bishop and present their offerings—their Lenten Offering, their Birthday Thank Offering, and their offering to their Bishop for work throughout the Diocese.

One feature of this year's Christmas giving has been that many missions in our Diocese who have received in the past, have joined the ranks of the giving parishes. A fine Committee, with the Rev. Ralph B. Putney as chairman, develops the educational phases of giving in the Church Schools of the Diocese.

The Rev. J. Francis Sant is chairman of Young People's Work in the Diocese.

CHURCH SCHOOL SERVICE PROGRAM

Giving as an offering to God, the desire to do one's part in the support of the work of the Church, the bounds of giving from the parish to the needs of the Church throughout the world—all begin in the Church School, in the life of the child. The Church School Service Program is to help stimulate giving in the Five Fields of Service, and to make this giving meaningful.

A new worker from your own group, Mrs. Ned Henry, will have charge of the World Field, which has to do chiefly with the Lenten Offering. Mrs. Henry is already beginning to give this field her rare gifts of imagination, of consecration, and of good sense. She is beginning plans for the Lenten Offering which in 1935 amounted to \$5,151.95.

The Fields of the Diocese and the Community considerably overlap, and Miss Luretta Sanders, Diocese, and Mrs. C. Granville Sharpe, Community, have combined in their efforts to bring happiness to the boys and girls of Mrs. Edinger's field in northern Michigan, Miss Robinson's field around Alpena, Miss Dennis' field in Lapeer, Otter Lake, and Dryden, and Miss Greedus', Miss Kemp's and Mrs. Stephens' fields in Metropolitan Detroit. One needs to know the whole Diocese well, to know the limits of this giving as well as receiving for it extends throughout the Diocese. An interesting development of this year's giving has been that many formerly receiving missions have joined the ranks of givers, and new objects had to be discovered as recipients. Because of this new outlook our schools were able to help the Diocese of Marquette.

The gifts had much value and beauty, too. Vegetables and fruits and canned goods from rural communities, beautiful cones from Mrs. Edinger's field, lovely greens—these gifts in kind were desirable and appropriate. Several Church Schools helped with Church School material, which will help missions carry on throughout the year.

The Birthday Thank Offering, under Miss Nellie McAuley, like the Woman's United Thank Offering, is over and above all other gifts, and goes to the Children's Ward of St. Luke's Hospital, Shanghai, China.

Two hundred and twelve magazines have been sent regularly to some given addresses by ninety-seven persons. Five hundred and twenty-five books, six hundred tracts and pamphlets, five thousand Christmas cards, one thousand miscellaneous articles, thousands of odd magazines too many to count have also been sent.

Twenty institutions in the Diocese have received aid.

As usual, at Christmas many new books were sent by individuals to missionaries and shut-ins.

Membership in the American Social Hygiene Association has been given to Williams House.

Five subscriptions to the Spirit of Missions have been sent to the Detroit Public Library for use in the Main Library and several of its branches and one subscription to the Churchman for the Main Library. These subscriptions were asked for by the Library and it reports that the magazines are in constant use by both children and adults.

During the year, one Parish branch has given its church new Prayer Books. Another has repaired the Hymnals for the church.

There are twenty-five active Parish branches. I wish it were possible to tell of the work of all these branches. It may seem that this work is unimportant, but truly its influence reaches to the utmost parts of the world.

There have been four meetings of the Parish Secretaries. I wish to express my appreciation to these Secretaries for their loyal support and interest in the work. I also wish to thank all who have contributed to the work of the club.

REPORT OF THE DETROIT BRANCH OF THE GUILD OF ST. BARNABAS FOR NURSES

Our Detroit Branch was organized twelve years ago, Bishop Warren L. Rogers, at that time Dean of St. Paul's Cathedral, Mrs. Frederick Haines and Mrs. Theodore H. Eaton being largely responsible.

Their very keen and devoted interest in the nurses of Detroit Hospitals, both graduates and pupils bore abundant fruit. They seemed to realize that the nurses needed more spiritual and social contacts. They met and talked over plans and soon the Detroit Branch was organized, Dean Rogers being our first Chaplain, Mrs. Frederick Haines the first President and Mrs. Eaton our first Entertainment Chairman.

From that time we have had monthly meetings either at St. Paul's Cathedral or St. John's Church, preceded by religious services and usually by a supper served in the Church House.

In May of each year on the Sunday evening nearest May 12th, the birthday of Florence Nightingale, we have had a very beautiful service in St. Paul's Cathedral, the pupil nurses of all the Training Schools of Detroit participating. This service has also been the Baccalaureate service for the graduating classes as well as for all nurses in Detroit and vicinity, 600 nurses attending in 1935.

The Guild in America was first organized in Boston in 1886. There are now 39 branches in the U. S. A. and a membership of 2,499. The aims of the Guild are religious and social. It promotes friendliness to other nurses, and to strangers and women outside the nursing profession, the spirit of Christian service, ideals and opportunity for worship, and a better understanding between the public and the nurse. We have a Chaplain, Priests Associate, and a membership of Lay Women. The dues are nominal, \$1.00 being the admission fee and dues for both nurses and associates.

Our monthly services are generally conducted by our Chaplain; sometimes by the Priest Associates. These services were conducted each month of the year except during July and August when we have no meetings.

In June we made our usual pilgrimage to Cranbrook where Dean Marquis has always conducted our service. This year Bishop Page gave us a very helpful address. This service is always followed by a pilgrimage through the lovely church and grounds, a Carillon program being given for us at five o'clock after which we had a picnic supper, and last year was no exception.

We gave a card party at the Woman's Hospital in the Fall and a Feather party at Harper Hospital to raise funds for our Christmas work and to help defray expenses of delegates to the convention in Kenosha. Four members and one associate attended this convention, which was most interesting, helpful and enjoyable.

A beautiful Christmas service was held in St. Paul's Cathedral conducted by Dean O'Ferrall, our Chaplain.

The nurses of the Ford Hospital Chorus, 50 of them, conducted by Mr. Charles Frederick Morse, sang with us in the Cathedral and later, around the Christmas tree, sang beautiful carols all evening. This was a rare treat and much enjoyed by all of us. We had a beautiful tree, a gift for each one who came and a very happy time together.

All ill nurses in Hospitals and Sanitariums in Detroit and vicinity were remembered with cards and gifts.

The Detroit Branch has contributed to the work of Miss Hicks in Porto Rico, Miss Simpson in China and to Miss Breckinridge in the mountains of Kentucky. Flowers have been sent and calls made upon all nurses who were ill that we knew about.
