PRESIDENT'S ANNUAL REPORT

May I say to you, as we are gathered together for this Fifty-eighth Annual Convention of the Woman's Auxiliary, how very much I have appreciated your interest and support, as well as your patience as I learned the many details of the work, during this my first year in office. Also, may I thank you for giving me the opportunity of serving as your President. It has seemed to me a most interesting year as well as a very busy one. The fact that the work has gone so well is because of your enthusiastic cooperation and the very splendid assistance of the Board.

Our Constitution states that the purpose of this Auxiliary is "to unite the branches in a program of the Church for worship, study, service, and fellowship; to promote definitely the cause of Missions and Church Extensions, Religious Education, and Christian Social Service; to collect funds for these various purposes; to encourage the formation of new branches. Work must be done each year in the five fields of service—the Parish, the Community, the Diocese, the Nation, and the World." A sincere effort has been made to carry out this purpose by means of services, a well rounded program, the pledges and special offerings.

I wish it were possible to mention in detail the splendid work done by all the Officers and Chairmen. You may read their interesting reports in the printed program and as you read you will realize and appreciate the work that has been done by the women in the Diocese under the direction of these Chairmen. It is hoped that Parish Auxiliaries will cooperate, and work even more closely with these Diocesan Chairmen as time goes on. To them your thanks and mine are due.

The News Letter was started as an experiment in an effort to keep Parish Auxiliaries informed about Auxiliary and Church work in general and for an interchange of ideas. This I hope it has done in some small measure during its short existence. It is planned to continue the News Letter during the year Nineteen Thirty-eight.

The Leadership Training Class, held in connection with the Diocesan Normal School, was tried for the first time this year. These classes were conducted by well qualified leaders. It is possible these classes may be carried on a second year.

The Woman's Auxiliary this year had a definite part in the program of the Cranbrook Summer Conference with five afternoon meetings. It was gratifying to have these meetings so well attended. To Miss Thomas, Diocesan Educational Director, I wish to express appreciation for her cooperation with the Auxiliary in including these classes in the Educational program of the Diocese.

The Rev. Benedict Williams conducted a beautiful and spiritual Quiet Day at Christ Church, Cranbrook. This service was not nearly so well attended as it might have been. The Quiet Day of Prayer, with special intercessions for Peace, was held on Armistice Day. This day might well be given more thoughtful attention by all women.

The Pine Lake Conference was well attended and a source of great inspiration as well as promoting a fine spirit of fellowship. Many thanks are due the Girls' Friendly Society for the splendid arrangements made for our entertainment.

May I urge, particularly in view of the resolutions passed at the 1937 Triennial in relation to young people's work, that Auxiliary Women become more familiar with, and show greater interest in, the Girl's Friendly Society and other organizations of young people, as well as in the field of Religious Education. The training of these young people is most valuable if there is to be a strong Woman's Auxiliary in the future.

The outstanding event of the year has, of course, been the Triennial. Its well planned program, the interesting and instructive exhibits, and the opportunity of hearing great speakers, all combined to make the Triennial of inestimable value.

This report would not be complete were mention not made of the two great conferences, "Faith and Order" and "Life and Work," revealing as they did the growth of the ecumenical spirit and the advance in the willingness to listen and learn shown by the delegates. These conferences received marked attention at the convention.

The theme of the Triennial meeting of the Woman's Auxiliary, "Fellowship in Faith and Work" seemed to your Program Committee to have within it such possibilities that it was adopted as the theme for this Diocesan Convention. It is hoped that everyone, as she listens to the speakers or takes part in the discussion groups will find much help and inspiration for the coming year.

For the future is it too much to hope that every Parish Auxiliary will endeavor to study the outline prepared by the Committee on Findings at the Triennial and recently sent to each Auxiliary President? From this outline may be planned programs for the next three years, keeping the thought always in mind of the differing interests of the individual. Because of the very broad program that is possible, all may find something of interest and a way to serve. Can we not consider seriously what church women can do as individuals and as groups about such vital problems as War and Peace, Christian Unity and Co-operation, Industrial Problems, the Missionary needs of the Church, at home and abroad?

From Dr. Suter's service of preparation printed in Forward—Day by Day I quote the following: "A Society free from jealousy and distrust, joyfully serving God through all the relationships of life." May we all believe in this vision and work to make it a reality. The Women of the Church can be a great force for good wherever they are found.

"God grant us grace and power to carry on the work of this great organization of women."



ANNUAL REPORT OF EDUCATIONAL DIRECTOR

Through Miss Marston's inspiration at the Convention of 1937 your chairman formed a committee consisting of Mrs. J. C. Spaulding, Mrs. Perry Hill, Mrs. B. R. Platt, and Mrs. Edwin Lord.

This committee has done most valuable work in promoting study in the women's group. The study for this year was "Africa, and The Negroes in the U. S. A."

I especially want to report the work in Visual Education done by Mrs. Lord, who showed her picture of the Negro work to at least 2000 people, visited 38 churches either in the interest of women, young people, or children. It is a fine contribution, and she stands ready again this year with two films, one of Rural America, and the other on International Values in Religion including pictures on the Moslem World.

Mrs. Spaulding conducted a class in the Institute, at the Normal School spoke in 11 parishes and missions, and conducted a study course on "Woman's Work."

Mrs. Platt contributed an exhibition of articles from Liberia, spoke on Africa in 5 churches. She has studied under Dr. Sherman in Cincinnati and is ready to teach classes on "Moslem World."

Mrs. Perry Hill led a session at Cranbrook on "Program Planning", a session at Normal School on "Leadership", and is available for both subjects as well as "Peace" and "Book Reviews".

Mrs. Otey Berkeley contributed to the classes at Cranbrook by presenting the work of the "Daughters of The King".

Mrs. Burke, the wife of the Doctor at Hudson Stuck Hospital, Ft. Yukon, Alaska, make a splendid contribution to the subject of missions at one session at Cranbrook and at several teas.

The thanks of this committee go out to Bishop Creighton for his session at the Normal School on "Rural America", and also to Archdeacon Hagger for his addresses at Cranbrook, the Normal School and the Institute. Mr. Hagger stands ready always to help in missionary study.

Your chairman has had charge of the Day Institute in January; has attended all the Board Meetings but two; has spoken at St. Joseph's Church, St. Christopher's Mission, St. Columba's Church and Grace Church; has conducted classes at the Normal School and at the Cranbrook Summer Conference. She attended a two-days Conference of Educational Secretaries in Chicago in May; received the honor of being delegate to the Triennial Convention in Cincinnati, and was present at every session of the Woman's Auxiliary. As a result of the Program Planning in Cincinnati, during the next three years the study should be directed towards "Peace," "Christian Unity" as presented at Oxford and Edinburgh, and on "Social Problems".

I hope the women of this Diocese will take notice of these suggestions.

Annual Report of the Church Periodical Club January 1, 1937—January 1, 1938

This year the most important event for the Church Periodical Club was the meetings which were held in Cincinnati last October at the time of the General Convention. Each Diocese is entitled to send two delegates to these meetings.

The delegates from this Diocese were the Diocesan Director and Mrs. C. B. Coe, Secretary of St. Andrew's Church, Ann Arbor.

The meetings were most interesting and helpful.

Missionaries from all parts of the world expressed their appreciation of the work of the Church Periodical Club. At the business meeting Mrs. Otto Heinigke who had been the National President of the Church Periodical Club for many years presided. At this meeting Mrs. David C. Larcomb of the Diocese of Southern Ohio was elected the National President.

January 10, 1938 marks the Fiftieth Anniversary of the Church Periodical Club.

The Presiding Bishop has designated Sunday, January 9th, for special recognition of the Church Periodical Club.

In this Diocese the Woman's Auxiliary at the Epiphany Tea have most kindly offered to celebrate this event.

During the year 1938 it is hoped to increase the Endowment Fund to fifty thousand dollars. The slogan being "Fifty Thousand Dollars for Fifty Years."

The interest from this Fund is used to buy books.

To mark the fiftieth anniversary, the Fifth Province has voted to send books to Brent House in memory of Mrs. Mortimer Fargo, the founder of the Church Periodical Club. Each Diocese in the Province is asked to give ten dollars.

One hundred and eighty-five magazines have been sent regularly to some given address by seventy-eight persons; 1100 books including Bibles and Prayer books; 2400 odd magazines; 1100 cards; 1500 miscellaneous articles.

There have been four meetings of the Parish Secretaries.

I wish to thank the Secretaries for their interest and cooperation. Also to thank everyone who in any way has contributed to the work of the Club.

**ANNUAL REPORT OF ALTAR GUILD SOCIETY OF THE
DIOCESE OF MICHIGAN**

During the past year the Altar Guild Society of the Diocese of Michigan has held four regular meetings.

In February, 1937 the resignation of Mrs. Donald Stevenson as President was accepted with deep regret, Mrs. Stevenson having been elected to the Presidency of the Woman's Auxiliary of the Diocese. Since the organizing of the Altar Guild seven years ago, Mrs. Stevenson had been its President.

Through her untiring efforts, and interest, the Guild has become known throughout the Diocese. She has the sincere appreciation and gratitude of all for the contribution she has made to the Church and Missions in this work during her Presidency.

The Altar Guild is not attached to any parish. It is an independent organization under the direction of the Bishop of the Diocese, and is concerned—when asked—in helping to supply proper linens, vestments, for Altars in our Missions and small parish churches who are without assistance and would like to be helped.

Through the membership dues we have been able to respond to many appeals which have come to us. The Chairmen of Committees of Altar linens and Altar supplies have answered requests from Archdeacon Hagger, also from smaller parishes in the Diocese.

Many questions have been answered, advice given regarding proper Altar hangings, linens, also choir and clergy vestments.

In connection with the Detroit Diocesan Normal School held in the fall, The Diocesan Altar Guild arranged for a series of six talks on the work of the Altar Guild—with the following subjects:

1. Church and its furnishings.
2. Altar vestments and their care.
3. Clergy and Choir vestments, and care.
4. What an Altar Guild is, and does.
5. Junior Altar Guild.
6. Pilgrimage through St. Pauls Cathedral.

Following each of these talks questions were asked and discussions followed, which proved interesting and helpful to all. At the time of the Cranbrook Summer Conference in June an interesting pilgrimage was conducted through Christ Church for those attending the Conference, and interested in Altar Guild work.

During the past summer, death removed from us Miss Mary Weber.

It was a shock to all, and a great loss to the Guild. Miss Weber was a devoted, loyal member, and had been an untiring worker in the Guild since its organization.

It is the earnest desire of the Guild to increase its membership. At the present time there are twenty-five active members and 17 corporate.

We would like to interest many more parishes and missions to become members and interested in the work.

The object of the Guild is to be of service and educational help in every way possible to our parishes and missions in the Diocese.

To increase their interest and devotion in the significance and meaning of the Altar Guild Service. Whether Diocesan or Parochial, it is the most sacred of all church work.

Devotion to our Lord Jesus Christ is its inspiration, and its sole object is His Glory.

Mrs. Edwin N. Lord has carried on a fine work with a group of boys and girls at the Michigan Home at Lapeer, climaxing her efforts with a trip to the home the day before Christmas carrying gifts and assisting Mr. and Mrs. Charles F. Stephens with a party.

Mrs. William T. Barbour has sent Sunday School leaflets every week to 53 children. The money for these leaflets, the postage, and the postage on the Archdeacon's letters has been given from the income of the William S. Sayers Memorial Fund of the Woman's Auxiliary. This amounted to \$50.00 in 1937.

The Chairman attended a meeting at the Cranbrook Conference at which the Archdeacon spoke on Rural Work, went to a class on Rural Work at the General Convention and conducted a normal class session at the Detroit Normal School using the book, "Forward—into Rural America." **ANNUAL REPORT OF THE CHAIRMAN OF DIOCESAN AND
DOMESTIC FIELDS JANUARY, 1937—JANUARY, 1938**

This year, as in all past years, under the capable leadership of Arch-deacon Hagger and the Field Secretaries, the work in the Diocese of Michigan has made steady progress.

From the Field Workers Secretaries Fund, Fifty Dollars was provided to help finance a survey in the rural field, and the result was very gratifying.

From the Sayres Fund, Forty-two Dollars was used for Scholarships to Cranbrook. Three Field Secretaries won these Scholarships and had the splendid opportunity of attending the Summer Conference at Cranbrook.

Fifty Dollars was used from the Sayres Fund for postage, leaflets and letters for Work Among the Isolated.

To help pay for our new Field Secretary, One Hundred Dollars was provided from the Sayres Fund.

Your Chairman had the pleasure of taking part on the programs at the following Churches; St. Andrews, Detroit; St. Colomba, Detroit; St. Philip's and St. Stephen's, Detroit; St. Martin's, Five Points; and St. Matthias, Detroit.

She went with Mrs. J. C. Spaulding and Mrs. E. R. McCormick to St. Louis, Michigan to help in organizing the work among the women in that District. She attended the Thumb-River Convocation at Port Huron and spoke on Women's Work in the Church, also took part on the program at the Pine Lake Conference.

DOMESTIC FIELD

Many who were at the Cranbrook Conference and heard Dr. and Mrs. Burke tell of their splendid work in Alaska, suggested that a Christmas box be sent to their Alaska Mission.

In July, a letter was sent to 50 women who attended the Conference and in response \$54.00 was sent to your Chairman to be spent on this Christmas box. Books, toys, dolls, games, tops, beads, crayons, blocks, aeroplanes, spelling boards, printing sets, dishes, paper dolls, puzzles, paints and educational toys were sent. Since the box was sent, \$2.00 and three little girls dresses have been sent to Mrs. Burke.

Your Chairman wishes to thank all who so promptly sent money, also for the great pleasure given to her in selecting the gifts for this Christmas box.

ANNUAL REPORT OF SOCIAL SERVICE

Madam President and Members:

Your Social Service Chairman deems it a great privilege to have had the opportunity during the past year, of taking a small part in this worthy branch of our Church work, and of coming into closer contact with the splendid directors.

Williams House under Miss Wolbert's devoted guidance; Page House in the capable hands of Miss Coyne; and the City Mission with Mr. Backhurst as its inspired leader, have despite many difficulties and problems, flourished and spread their spiritual and material comfort to ever increasing members.

The Board of Williams House with its President Mrs. Morley have shared Miss Wolbert's happiness in a houseful of 32 girls. The age level of the girls is younger now, so they are kept for a longer period of time, seeking positions when finishing school or vocational training. Many parties and festive occasions have been enjoyed, but there is still need of more entertainment. The vacations at Walpole Island were beneficial and the redecorating and reupholstering done in the house, much appreciated. At Easter when nine girls were confirmed it was due to the generous response of the various Auxiliaries that the girls could appear in attractive Spring costumes.

The many contributions of money, food, clothes and necessities have made it possible for Williams House to continue on its small financial budget; but this year at the suggestion of the Diocesan Executive Council, an increased budget, due to rising costs, was presented to them for their consideration.

For some time it has been felt that the location of Williams House was unsatisfactory, and recently a committee was formed, with Mrs. Perry Hill as Chairman to investigate a new house. This committee reports marked progress.

The true significance of this work can best be appreciated by considering a recent report of Miss Wolbert's in which she said that in the 16 years of the existence of Williams House, 3,000 girls had lived there and 1,000 had been contacted. Of these, hundreds have returned to visit, full of appreciation and thankfulness for the love and encouragement which enabled them to become independent citizens or happy wives and mothers.

The highlight of the year was a talk by Helen Western, an old Williams House girl, on a years leave of absence from China, where for seven years she has been with the South China Boat Mission, doing a wonderful work at Tsen-Tsen, alone, among 10,000 natives.

Page House presents a little different picture, but also a busy happy one. With Mrs. Becker, the Guild President, we have heard each month of the joys and sorrows of older, lonely women and of their appreciation of books and clothes and delicacies. Miss Coyne has told us of the holiday festivities and of letters of thanks she has received, from temporary guests who have found Page House a welcome haven in a strange city. During the year the building has been equipped with fire-escapes; and showers have been installed in the basement.

The Guild's activities have been confined to a delightful bridge tea at the Church of the Epiphany in October. The money raised (around \$200.00) was added to that of the Membership Fund Drive and enabled the Guild to pay the \$1,000.00 pledged to Mr. Backhurst, with a balance in the bank.

With Mr. Backhurst as the tower of strength at Mariners Inn the results are almost incredible. Thousands of discouraged and hungry men have been fed and provided with beds, some paying a small fee. Jobs have been found for hundreds and temporary jobs for many more. Recently a new type of man has come to the Inn. The old man with a little pension. Mr. Backhurst is desirous of establishing a comfortable home for these men to be called "Snug Harbor" where they can finish their days in peace and security.

Mr. Backhurst extends his help and encouragement also to institutions, hospitals and missions, making calls and holding services and remembering them at Christmas. Each year Churches, and groups of other denominations are becoming more interested in the Mission, and are eager to assist in this work.

If it were not for the whole hearted cooperation and material assistance of the Church Auxiliaries, of the Churches, clubs and friends, this service could not go forward and we wish to thank each and every one of you for her part in it. But do not allow your interest to stop there. If you would understand true Christian Social Service, if you would see what has been accomplished by these inspired and faithful leaders, for these men and women, in leading them from despair or loneliness or misguided ways, to usefulness; visit these real homes—attend a service at Mariners Church, where hundreds of men of all colors and creeds lift their voices in praise and thankfulness, and you will come away with a feeling of renewed spirituality and true Christianity.

ANNUAL REPORT OF GIRLS' FRIENDLY SOCIETY OF THE DIOCESE OF MICHIGAN

Object of the Girls' Friendly Society—"To unite for the glory of God, in one fellowship of prayer and service the women and girls of the Nation to uphold the Christian standard of honor and morality."

With this object before us the girls and women of the Girls' Friendly Society of the Diocese of Michigan have gone forward with confidence in carrying out the ideals of the Society.

The organization has worked diligently in all diocesan projects—viz., Festival Service, Contest, Ford Garden Party, Picnic and Autumn Market. Three very successful conferences and a leader's training class were held during 1937.

In the parishes we have given generously, and helped with bazaars, church suppers, pageants, and church programs. A great many of our girls are teaching in the church schools, singing in the choirs, and serving in the Altar guilds, in fact, cooperating in all diocesan and parochial organizations, especially with the women's organizations. All the layettes in the mission boxes of the Woman's Auxiliary were made by the Girls' Friendly girls. The value of these boxes amounted to \$183.22, and with the special gifts and Christmas boxes, which were sent, our gifts amounted to well over \$300.00.

Food, clothing and gifts were given to the Williams House, Page House and the City Mission, also many forms of entertainment have been provided for the girls at Williams House. Clothing and food were given to the needy and at Christmas time hundreds of gifts were distributed in the parishes, hospitals, institutions and homes.

Through the Ford Garden Fund many girls and women were given rest and recreation at our Vacation Houses at Pine Lake, many of whom were recommended by doctors in our hospitals.

In the branches interesting classes are conducted in arts and handicraft, and the girls are given an opportunity to enter and exhibit these articles in the Annual Contest, which is held for the purpose of finding talent among the members and to assist in developing same. St. Cyprian's Branch received the greatest number of points and was awarded both the members shield and the candidates shield this year; the members cup was awarded Alice Williams, St. Cyprian's, and the candidates cup was awarded Jo Ann Mason, St. Philip and St. Stephen.

Through the seven convocations sponsored by the Diocesan Field Department, and held throughout the state, the Girls' Friendly Society have made many new contacts, and we are now organizing eight new groups. We also cooperated with the Department of Religious Education through the Cranbrook Conference and the Normal School, and with the Woman's Auxiliary, who have been so wonderful to us in every way possible. The cooperation of these two organizations was recommended at the Triennial, but we can safely say that such a project is well launched in this diocese, and might be an example for other dioceses to follow.

The Girls' Friendly Society offers opportunities for the development of character and for friendship through a flexible program based on the interests and needs of girls today. It promotes balanced programs of worship, study, recreation, social service and service to the Church in the parish and in the mission field. An interest in and understanding of the issues of the world today as they effect young people are emphasized.

ANNUAL REPORT OF PROGRAM CHAIRMAN

At the Provincial Conference in Madison, Wisconsin, October 1936, delegates were urged to go to their dioceses and plan programs that would tell of the universality of our Church. Delegates were urged to remember that each parish has five fields of service; and that no parochial nor diocesan program is complete that does not link together firmly these five fields.

With that in mind your program committee has tried in this past year to bring you speakers and subjects that would be of interest to all women of the church. May the committee at this time thank Bishop and Mrs. Page, Bishop and Mrs. Creighton, various members of the clergy, the speakers, the Executive Board, and many others who have given of themselves so generously to make this 1937 program possible.

The Quiet Day at Cranbrook under the leadership of the Rev. Mr. Benedict Williams was truly a day of prayer and meditation.

The theme of the Pine Lake Conference was "Christian Faith and Fellowship". Archdeacon Hagger began the session with a challenging opening service; the Rev. Mr. Ernest Piper brought findings from the conferences at Oxford and Edinborough; Bishop Creighton gave a stirring picture of "A Vision for Missions"; and the Rev. Mr. I. C. Johnson told vital facts of "Michigan—Our Diocese". Mrs. Edwin Lord presented the Lenten Study Books. The Rev. Mr. R. W. Woodroffe, Jr., was the celebrant at the Holy Communion Service. Mrs. Donald Stevenson, president of the Diocesan Auxiliary, presided.

Our benevolent work consisted of aid given missionary nurses; and gifts and visits to sick nurses in local Hospitals.

The Florence Nightingale Service was attended by about 450 nurses in uniform and the Speaker was Right Rev. Bishop Creighton.

Our chief enterprise was the starting of a philanthropic fund to be used for the benefit of Christian women in the Nursing profession. \$351.15 was raised during the year for this purpose.

ANNUAL REPORT OF THE DIOCESAN EDUCATIONAL SECRETARY

Religious Education in the Diocese of Michigan has been greatly stimulated by the fine Institutes and Seminar conducted by the National Department at the General Convention in Cincinnati. Many of our clergy and lay people were present and much help and inspiration derived from these sessions. The whole Convention as a major drive will influence our program for much good.

Normal Schools and Teacher Training Centers.

Two leaders have come to us as the result of contacts at the Convention both helping in courses at the Detroit Normal Schools—Miss Hilda Shaul, Diocesan Director of Religious Education of the Diocese of Southern Ohio, and Mr. John Garrison, Director of Religious Education of Christ Church, Winnetka.

The Detroit Normal School reached its highest peak in attendance over a period of many years, reaching almost 400 people. Its teacher-training section, leadership, training of women, the section for Young People, the advanced class on the Prophets led by Professor Waterman, as well as other groups, made it the strongest in many years.

Other Normal Schools under the Diocesan Department have continued in the Saginaw Valley and in the Flint Districts.

Parish Schools led by St. Paul's, Lansing, and Calvary Church, Saginaw, have shown great strength. Parish Institutes such as that held at St. Joseph's have helped teachers and others in background and methods in teaching.

Round Table Fellowship.

For the first time in many years the Round Table Fellowship was held at St. Paul's Cathedral. It had an enrollment of 581 people. We were privileged to have Dr. Preston M. Slosson as our main leader, assisted by an unusual leadership of clergy and lay men. Professor Slosson will again lead in the Round Table of 1938 which will again meet at the Cathedral on **Mondays in Lent March 7, 14, 21, 28, and**

April 4.
Cranbrook.

In addition to the Bishops, Clergy and lay men of our own Diocese, Dr. Grafton and Mrs. Burke of Ft. Yukon, Alaska, brought inspiration and new vision to the largest number of delegates ever attending the Cranbrook Summer Conference. **The dates for 1938 are June 26 to July 2.**

Younger Girl's Conference.

A capacity group of girls from 12-16 met at the G. F. S. Holiday House at Pine Lake, under the Chairmanship of Canon C. W. Hughes and Mrs. C. Granville Sharpe and assistants. **The date of the Conference for 1938 will be June 25 to July 1.**

C.S.S.P.

Chairman, Canon C. W. Hughes as Chairman of the Church School Service Program reports \$991.49 as the total of the Bishop's Advent Offering, 1500 gifts to boys and girls throughout the nation and as many to those in our own diocese. The Lenten Offering was \$5750.60, the Birthday Thank Offering over \$800.00.

Convocations.

The Director attended five of the Convocational meetings of the Field Department.

Parent-Teachers.

St. Andrew's, Ann Arbor, and St. Alban's, Highland Park, have had parents and teachers meetings.

Visual Education.

Work has been begun by the Committee on Visual Education under chairmanship of the Rev. Donald Crawford.

Vacation School.

Forty-three schools reaching 1593 boys and girls were held under direction of Archdeacon Hagger, Chairman, and his fine committee. The Manual, King's Kingdom, was developed by this committee.

Church School Picnic.

Mr. Clarence Warne Wilson, Chairman, is now a Commissioner of the Department. Picnic of 1938 to be held **Bois Blanc, June 28th.**

CONSTITUTION

ARTICLE I

NAME

This Association shall be called the Michigan Branch of the Woman's Auxiliary to the National Council.

ARTICLE II

OBJECTS

The objects of this Association are to unite the branches in a program of the church for worship, study, service and fellowship; to promote definitely the cause of Missions and Church Extension, Religious Education and Christian Social Service; to collect funds for these various purposes; to encourage the formation of new branches. Work must be done, each year, in the five fields of service, the Parish, the Community, the Diocese, the Nation and the World.

ARTICLE III

MEMBERSHIP

All baptized women of the Diocese who desire to be members will be so regarded.

ARTICLE IV

OFFICERS AND EXECUTIVE BOARD

The following executive officers shall be elected at the annual meeting: The President; not less than three Vice-Presidents, representing districts, the boundaries of which shall be defined by the Executive Board; a Recording Secretary; a Corresponding Secretary; and a Treasurer.

Section 2. The following officers shall be appointed annually by the President with the advice and consent of the other executive officers: A United Thank Offering Treasurer, an Educational Director, a Director of the Church Periodical Club, a Prayer Partner, a Director of Supply Work, a Solicitor for the Spirit of Missions and a Treasurer and Custodian of the Golden Book of Remembrance.

Section 3. The Executive Board shall consist of the Bishop and the above officers, together with the Chairmen of the Standing Committees as named in the By-Laws, the Diocesan Presidents of the Girls' Friendly Society, Daughters of the King, Altar Guild and St. Barnabas' Guild for Nurses, and of any other Diocesan organization for women recognized by the Bishop, and the Convention Chairman.

Section 4. The Executive Board shall have oversight and direction of all work for the Church done by the Women of the Diocese not otherwise provided for.

ARTICLE V

MEETINGS

Section 1. The annual meeting shall be held during the week of the Diocesan Convention and in the same city.

Section 2. Regular meetings shall be held monthly from September to May, inclusive, excepting December.

Section 3. Special meetings may be called by the Executive Board.

ARTICLE VI

CONVENTION OF THE WOMEN OF THE DIOCESE

Section 1. Coinciding with the Annual Meeting there shall be held the Annual Convention of the Women of the Diocese, which shall be non legislative, for the purpose of considering the women's work of the Church in the Diocese and the world, of passing on to the parishes suggestions for strengthening established projects and stimulating new work, and of giving an opportunity for interchange of ideas.

Section 2. All churchwomen of the Diocese shall be eligible to attend the convention and to participate in its discussion.

Section 3. Voting power shall be given to four delegates from each Parish and two from each Mission upon presenting their credentials to a committee appointed for that purpose. The method of election of such delegates and a like number of alternates shall be determined for itself by each Parish and Mission. If no other provision be made, the Rector or Minister in charge shall appoint. Voting power shall also be given ex-officio to the members of the Executive Board. Each Diocesan organization for women recognized by the Bishop shall be entitled to elect two representatives with voting power.

Section 4. At this Annual Convention there shall be elected by majority ballot a Convention Chairman to preside at the next Annual Convention and have charge of the arrangements and program.

Section 5. Each parish and mission shall pay a convention fee annually on a sliding scale of from \$1.00 to \$10.00. This shall be payable by January 1 of each year to the Treasurer of the Woman's Auxiliary of the Diocese to be kept in a separate account for convention expenses or for any other purpose authorized by the Convention.

ARTICLE VII

QUORUM

Ten members shall constitute a quorum at an Executive Board meeting, and fifty members at regular or annual meetings, but at no time shall the lack of a quorum at a regular meeting prevent those present from proceeding with the program of the day.

ARTICLE VIII

AMENDMENTS

Section 1. This constitution may be amended at the Annual Meeting of the Association by a two-thirds vote of all members present. Proposed amendments must be submitted in writing to the Recording Secretary, read at a regular meeting preceding the Annual Meeting, and referred to the Executive Board for consideration.

Section 2. By-Laws may be adopted, amended, repealed, or suspended at any regular meeting or Annual Meeting by a two-thirds vote.

BY-LAWS

ARTICLE I

ELECTIONS AND APPOINTMENTS

Section 1. The Executive Officers shall be elected by ballot at the annual meeting and shall continue in office for one year or until the election of a successor.

The Executive Officers shall serve not more than three consecutive terms.

Section 2. A majority of all votes cast shall be necessary for an election.

Section 3. Vacancies in elective offices may be filled by the Executive Board voting thereon by ballot.

Section 4. Delegates to all meetings of the Auxiliary shall be elected in the manner prescribed by the Constitution for the election of delegates to the Annual Convention, but all members present may vote on questions other than the Annual Elections.

Section 5. The President shall be a delegate ex-officio to the Triennial Convention of the Woman's Auxiliary to the National Council and the Meetings of the Women's Auxiliary of the Providence. At the Annual Meeting preceding these conventions four other delegates and five alternates shall be elected. The four receiving the highest number of votes shall be delegates and the five next highest shall be alternates. Vacancies in the delegation shall be filled by the President or Vice-President or in her absence by the delegates present.

Section 6. The President shall appoint a Chairman of Tellers who shall select her own assistants and with them shall prepare and have full charge of the ballots.

ARTICLE II

PLEDGES

Section 1. Before the Annual Meeting each branch shall have signified in writing the amount it will give during the following year. to be paid through the Treasurer of the Woman's Auxiliary.

Section 2. As it seems only reasonable that each branch shall share in the expenses of the society, all branches shall contribute as liberally as possible to the General Expense Fund, the minimum for any branch being one dollar a year.

ARTICLE III

DUTIES OF OFFICERS

Section 1. The President shall preside at all meetings; shall have general supervision of the work of the Auxiliary; shall appoint all special committees unless otherwise directed by the Auxiliary or the Executive Board, and shall be ex-officio member of all committees without the right to vote.

Section 2. The Vice-Presidents of the Detroit, the Southern and the Northern Districts in order of their succession shall preside in the absence of the President and assume all duties pertaining to the office, and shall endeavor to promote the formation of new parish branches and to help and strengthen those already existing.

Section 3. The Recording Secretary shall keep the minutes of all meetings of the Woman's Auxiliary and of the Annual Convention and shall prepare and edit the Year Book under the Supervision of the Executive Board.

Section 4. The Corresponding Secretary shall give notice of all meetings, both of the Auxiliary and of the Executive Board, and shall conduct the general correspondence of the Association.

Section 5. The Treasurer shall receive, disburse and keep account of all moneys received in each department of the work, except as otherwise provided, and shall attend the meetings of the Auxiliary, reporting receipts and disbursements.

Section 6. The United Thank Offering Treasurer, the Educational Director, the Director of the Church Periodical Club, the Prayer Partner, the Director of Supply Work, and the Solicitor for the Spirit of Missions shall perform the duties of their offices according to the laws and practices of the National organizations with which they are connected.

Section 7. The Custodian and Treasurer of the Golden Book of Remembrance shall receive and record the names to be commemorated and the accompanying gifts. This book was given on the occasion of the Fiftieth Anniversary of the founding of the Michigan Branch of the Woman's Auxiliary by Mrs. Frederic B. Stevens, President from 1908 to 1923, and is to contain the names of all women, living or dead, regardless of church affiliations, whom it is desired to hold in remembrance. The gifts shall constitute a fund to be accumulated until it reaches the amount of \$2,000.00, after which the interest shall be used as directed by vote of the Michigan Branch of the Woman's Auxiliary.

Section 8. All officers upon retiring from office shall deliver to their successors, or the Executive Board, all moneys, accounts, records, papers or other properties of the Association in their possession.

ARTICLE IV

COMMITTEES

Section 1. The Standing Committees shall be as follows: Parish, Diocesan and Domestic Field, Foreign Field, Social Service, Program and Publicity, Finance, Hospitality, Nominating, Credential and Work With the Isolated.

Section 2. These committees, except that on Work with the Isolated, shall be appointed and the number of members decided by the President with the advice and consent of the Executive Board.

Section 3. The Committee on the Parish shall represent all parish guilds, societies and individual women of the Diocese not affiliated with National or Diocesan organizations; shall give them the support-cooperation and fellowship of this Association and shall promote the work of women in their several parishes and the improvement in the organization of such work, realizing that without spiritual life and activity in the parish there can be no strength in the wider fields of service.

Section 4. The Diocesan and Domestic Field, Foreign Field, Religious Education and Social Service Committees shall promote intelligence and activity in their several fields among the women of the Diocese. The Religious Education Committee shall have charge of the Elizabeth Fiske Locke Stevens Memorial Library and shall appoint the librarian.

Section 5. The Program and Publicity Committee shall make a plan for the meetings of the Auxiliary during the year, provide speakers subject to the advice of the Executive Board, be prepared to advise parish branches who may desire assistance in arranging their yearly programs and do all necessary publicity work.

Section 6. The Finance Committee shall have charge of the raising of all special funds unless a special committee has been appointed, and shall be charged with any other similar work requested by the Executive Board.

Section 7. The Hospitality Committee shall arrange for the entertainment of speakers and delegates attending the various meetings.

Section 8. The Nominating Committee, of which the Bishop shall be a member ex-officio shall prepare a list of nominees for all elective offices for the Annual Meeting and Convention. This list shall be delivered to the Chairman of Tellers in time to permit the printing of ballots. This shall not prevent the voting of candidates not so nominated.

Section 9. The Credential Committee shall receive the credentials of delegates, and furnish them with ballots and information.

Section 10. The Committee on Work With the Isolated shall be appointed in such manner as the Bishop may direct and shall endeavor to bring the message and fellowship of the Church to those who may be unable to receive the regular ministrations of a parish or mission.

ARTICLE V

FISCAL YEAR

The Fiscal Year of the Association shall be from January 1 to December 31, inclusive, but the Executive Board may authorize the accounting of any special fund on a different basis.

ARTICLE VI

ANNUAL REPORTS

Each Officer and Chairman shall present a typewritten annual report, also providing a copy for the Recording Secretary. Copies of all such reports shall be sent to the Bishop.

ARTICLE VII

ORDER OF BUSINESS
