SECRETARY'S REPORT.

Dear Friends of the Auxiliary:

Another Annual Meeting finds us with increased numbers and enthusiasm. Three new branches have been added to our list: Tower, St. Peter and Rockford.

In the following branches there has been an increase of gifts: St. Paul's, Duluth; the Cathedral, Faribault; St. John's, Janesville; Grace, Holy Trinity and St. Mark's, Minneapolis; Christ Church, Red Wing; the Church of the Good Samaritan, Sauk Centre; Ascension Church, Stillwater; St. James' Church, St. Paul; St. Paul's Church, Winona, and St. Mary's, Merriam Park; St. Paul's, Belle Creek; St. Mary's, Tower; and Church of the Holy Communion, St. Peter; reports are especially to be noted.

In the sum total there is only a small increase over last year, but then the lines have been drawn more closely upon what constitutes Auxiliary work.

Missionary meetings were held in January, addressed by Miss Sybil Carter, at St. Paul's, Gethsemane and All Saints' in Minneapolis; St. Mary's, Merriam Park; St. John the Evangelist, St. Paul's and Christ Church, St. Paul. In spite of severe weather and much illness these meetings were large and interesting.

On May 6th the President called a general meeting of the Auxiliary at Christ Church, Red Wing, to appoint officers for the Convocations as follows:

Mrs. D. M. Baldwin, vice-president Southern Convocation; Miss Sybil Carter, vice-president Northern Convocation.

On May 10th a meeting was held at St. Mark's Parish House, Minneapolis, which was addressed by Miss Carter, Mrs. H. P. Nichols and Mrs. Alden, urging quarterly meetings for the study of the "Literature of Missions."

At this meeting a committee was appointed to prepare a programme for the first general meeting to be held in November.

On June 24th, a meeting was held in St. Paul's Sunday school room, Duluth; over sixty women were present, who were addressed by Mrs. Ward, president of the Chicago Branch, Miss Carter and Mrs. Ware of Breck School at Wilder, Minnesota. These meetings will doubtless result in giving an impetus to the Auxiliary work in Minnesota, and with the increase of Diocesan officers, we hope to visit all the small parishes.

In this large Diocese we have this year but few Junior Branches reported. Every member of the Auxiliary should take an interest in bringing our young people in touch with the Mission work of the Church. Existing societies are not asked to change their names or methods of work, but simply to report their Mission work through the Auxiliary.

Dear friends and officers of Parish Branches, will you not help us, that another year we may have a Junior Branch and a Librarian for the Church Periodical Club in your Parish?

CONSTITUTION.

ARTICLE I.

This association shall be called the Minnesota Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

The object of this association shall be to unite all the Parishes in the Diocese, in the different branches of Missionary work: Foreign, Domestic and Diocesan.

ARTICLE III.

Any Parish may become a member of this association by the payment of one dollar annually.

ARTICLE IV.

The annual meeting shall be held in either St. Paul or Minneapolis in the autumn of each year, as shall be appointed, for the election of officers, and for the transaction of such other business as shall properly come before the meeting.

ARTICLE V.

SECTION 1. The officers shall be two Presidents, and Secretary and Treasurer.

SECTION 2. The duty of the President shall be to preside at all meetings, to arrange for the organization of Parochial branches, and to have general charge of the work.

SECTION 3. The duty of the Secretary shall be to keep a correct record of the meetings, and to conduct the necessary correspondence.

SECTION 4. The duty of the Treasurer shall be to receive and disburse funds, under direction of the President and Secretary, and render account of the same at the annual meeting.

ARTICLE VI.

Each Parochial branch shall submit a report of the year's work to the Secretary of the Diocesan branch, to be read at the annual meeting.

ARTICLE VII.

Each Parochial branch may be represented at the annual meeting by four delegates who shall be entitled to vote.

ARTICLE VIII.

The Constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present.

BY-LAWS.

I.

The election of officers at the annual meeting shall be by ballot.

II.

Special meetings may be called by the President at such time and place as she may designate, for the purpose of stimulating interest in the work.

III.

The regular order of business for the annual meetings shall as follows:

1. Offices of devotion.
2. Reading of the minutes of last meeting.
3. Report of officers and committees.
4. Election of officers.
5. Miscellaneous business and addresses.

IV.

These By-Laws may be amended at any meeting by vote of a majority present.
