## PROCEEDINGS:

The Woman's Auxiliary of the Diocese of Mississippi held its Twenty-first Annual Council in the Mission of The Incarnation, West Point, April 17-19, 1912.

### MINUTES

#### Of the Junior Auxiliary's "Open Meeting," 17th April, 1912.

The annual Open Meeting of the Juniors, over which the Bishop always presides, was held in the Chapel of the Incarnation, at West Point, Mississippi, on Wednesday afternoon, April the seventeenth, 1911. Four branches were represented, namely:—Aberdeen, Columbus, Laurel, Meridian.

The special Junior service was said by the Bishop, after which the branch-reports were read. The summary of these reports was given in a message from Miss Flora Walthall, Diocesan Secretary, who was unavoidably prevented from attending this meeting.

The reports of the Secretary and the Treasurer, who was also absent, were read and approved. It was encouraging to note that all pledges for the year have been paid in full. Besides the rules of study, and of giving for missions, we have the rule of prayer, and the Bishop took this last for the subject of an earnest and inspiring talk.

A resolution was passed expressing the regret of the Juniors at the absence of our beloved secretary, Miss Flora Walthall.

The Bishop closed the meeting with prayer.

Morning Prayer read by Mr. Sykes, after which the Council was called to order by the President, Mrs. Theodore DuBose Bratton.

The Council was without a secretary on account of the removal of the former Secretary, Mrs. George Myers, from the Diocese. The President appointed Miss Maganos to act as Secretary Pro Tem.

## ROLL CALL.

On account of the flooded condition of the State, only 9 Branches were represented, namely:

Aberdeen, Columbus, Jackson, Laurel, Meridian, Raymond, Vicksburg, Christ Church, Vicksburg Holy Trinity, West Point.

## PRESIDENT'S ADDRESS.

*The Bishop, Clergy, Members of the Woman's Auxiliary:—*

It gives me pleasure to welcome you here to-day, some of you for the first time, to the Annual Council of the Woman's Auxiliary. It is our purpose to review the work of the past year, discuss new methods of work, urge the necessity of going forward and to ask your co-operation in the efforts needed.

## FIRST REVIEW OF THE WORK.

Let us for our encouragement glance at the Auxiliary as a whole, and take courage in the fact that the apportionment, so well known to us all, the \$100,000.00 suggested by the Board of Missions to the Auxiliary in 1901, was paid for the first time in 1911, and, as Miss Emery puts it in the 40th Annual Report, \$15,000.00 more. The United Offering of 1910 was the largest ever gathered at any previous tri-ennial, \$243,000.00. There has been a remarkable increase in the number of Mission Study Classes. It is a matter of great rejoicing to the whole Auxiliary, and indeed an event of the year, that a Junior Diocesan Officer has offered herself to the Mission Field. In the Fourth Missionary Department (The Department of Sewanee), The Auxiliary in response to a call from the Senior Bishop met in Knoxville, 39 delegates being present, representing eleven Dioceses and Missionary Districts, Mississippi and Kentucky being the only ones in the Department unrepresented. The object of the call was to form a Departmental organization for the furtherance of the common work and for the benefit of the advice, counsel and inspiration to be derived from regular meetings. These meetings are to be held at the time of the Department Council meeting. Each Diocese is to be represented by four delegates duly elected at the Annual Diocesan meeting. A Provisional Constitution and By-Laws are referred to each Diocese for consideration. It becomes our duty to consider Mississippi's obligation to the Departmental organization of the Woman's Auxiliary.

The Diocese this past year has had a visit from Deaconess Parkhill, of Southern Florida. She gave an inspiring address to the Auxiliary of St. Andrew's, Jackson, and to the women of St. John's, Pascagoula.

There has been a generous, and almost universal, response to the plan proposed at the last Annual Council that the Auxiliary Branches should co-operate in raising a fund to support a theological student. In this way the Auxiliary has lightened the burden of our Bishop and helped a worthy cause.

The regular meeting of the Diocesan Officers was held February 5th, in Christ Church, Vicksburg. While there Miss Jones and I addressed the joint Branches of Trinity and Christ Church. We were delightfully entertained by the Christ Church Auxiliary at a luncheon given in their very attractive Parish House. I have also visited and addressed the Coast Missions; St. Peter's, Gulfport, being most central, the Rector kindly arranged for delegates and interested Church women to meet me there. The day was a very delightful one, there being in attendance delegates from Pass Christian, Mississippi City, Bay St. Louis and Long Beach.

They all stayed for luncheon so generously provided by the Auxiliary and served at the Rectory. I have also addressed the Auxiliary at St. Andrew's, Jackson, and Trinity, Yazoo City. While on the Coast, I met with the Juniors at Pascagoula, and induced the Parish Guild to take the United Offering Boxes until they were ready to become more fully identified with the Auxiliary.

The increased interest in the Study of Missions is a result of the forward step taken at the last Council in electing an Educational Secretary. It was my privilege during the Lenten season to lead an Auxiliary Study Class. I heartily recommend "The Conquest of the Continent" as being most helpful and inspiring. It is the book of the year for Mission Study Classes!

#### NEW METHODS OF WORK.

Why new some one may be asking? We wish to-day standing upon the threshold of a new Auxiliary year to ask ourselves how we are to help our Rectors and Parishes to meet their apportionments for General Missions? The Auxiliary no longer has a separate apportionment. The Board has increased the amount for each Diocese so unless the Auxiliary increase her apportionment we will do but little towards helping the increased obligation. The answer is a simple one, and it is that we work to double the individual membership of the Auxiliary. I am satisfied that the Auxiliary is established in all of our Parishes and Missions strong enough to have the organization with some few possible exceptions. How then are we to grow? What is the best way to advance Auxiliary work in Mississippi?

#### THE EFFORTS NEEDED.

Again I suggest the campaign which was recommended by Miss Emery. The plan of work was clearly defined and has been successful wherever it has been faithfully tried. One Branch in Mississippi after making the canvass writes of fifteen new members, another eight and others of three and four. The Church has named her lifework of extension, Missions. She has enrolled her women as helpers. Let us not be slow to give them every reason why they should become active in the Missionary work of the Church and sharers in the *joy* they must find in doing it. We know not how many are waiting to be asked. Let us return to our homes with the purpose of interesting others. Let us answer the question what can *I* do to advance Auxiliary work in Mississippi?

I would, in conclusion, suggest that we stress the importance of the one cent a day being conscientiously given as a thank-offering to God for daily blessings. How many of our members know that the United Offering is the one cent a day or its approximate equivalent 5 cents a week? The United Offering is now supporting 200 women workers at home and abroad in the Mission fields. It is paying the Bishop of Alaska's salary. It is putting buildings, schools, and homes for our women in the distant Mission fields. Should the Church women in Mississippi, about three thousand, be induced to give the one cent a day and become United Offering members of the Auxiliary through the proposed campaign of personal work, the United Offering in three years given by this Diocese instead of being \$800.00, as it was last triennial would be \$30,000.00. Think of it, and tell me if you are not willing to put forth the efforts needed to go forward in Auxiliary work in our beloved Diocese. Let us trust one another more, working heartily together, praying in the Lord Jesus Christ and so do our part to bring on the time when the earth shall be filled with the knowledge of the glory of the Lord as the waters cover the sea.

During February blank reports were sent to the Branches and they were all urged to have their representatives here. In all cases except two these blanks were filled out and returned or replied to by the letters submitted in their places.

It is a great pleasure to report a new Branch at Cleveland, organized by Mrs. Collins.

## REPORT OF SECRETARY OF JUNIOR AUXILIARY.

*To the Annual Council of the Woman's Auxiliary in the Diocese of Mississippi, at West Point, Miss., April 17th, 1912.*

Reports of work done during the year just closed have been received from fourteen Parish branches of the Junior Auxiliary, at Aberdeen, Bay St. Louis, Biloxi, Columbus, Holly Springs, Jackson, Laurel, Meridian, Natchez, Pascagoula, Pass Christian, Port Gibson, Christ Church, Vicksburg, and the Church of the Holy Trinity, Vicksburg. From Greenville and Grenada, though the Treasurer's report shows a remittance from each, no reports have been received. The branches at Hermanville, Oxford, Port Gibson, Winona and Woodville, have dropped out of existence for the present at least, although at Hermanville we have still "one Junior", who, with her faithful mother, formerly leader of the branch, has helped to meet our pledges for the year, as have two other former members, with their mother, living at Carpenter, Miss. The branches in the Church of the Holy Trinity, Vicksburg, in Trinity Church, Pass Christian, dormant for some time have been revived, with earnest leaders, and every prospect of good work. Christ Church branch, Vicksburg, was reorganized and has been at work, the older and younger members forming separate circles or sections, with good results. This is the only branch to report any definite mission-study, the "Conquerors of the Continent" being the text-book, While Christ Church, Holly Springs, is reported as among the number of parish branches, yet our faithful leader there has been unable to effect any regular organization, and cannot report a definite number of members, though continuing undauntedly at work.

From the reports sent in, I find that the Juniors gave during the year 1911-1912, in money, \$332.75; in boxes, \$68.00. We closed last year with a deficit in our pledges; this has been fully paid, and all pledges for the year just ended are paid, although we can scarcely consider that we have done all we might well do for General and Diocesan Missions. The Treasurer's report shows disbursements for the Patton Scholarship, \$77.95; for the Bratton Scholarship, \$53.55. The apparent excess is on account of last year's deficiency. Very few Christmas gifts were sent, in comparison with previous years, as no work of this kind was assigned us by the Church Missions House. However, gifts were sent by several branches to various points, as shown in the branch-reports, aggregating in value \$68.00.

I am sorry that there is only one Mission-Study class reported, that already mentioned as held by Christ Church Branch, in Vicksburg. Yet I hope that other branches have received a very considerable amount of missionary instruction, in less definite ways, and that another year may show a different condition of things.

From the Church Missions House has come an inquiry as to what we have done in Mississippi towards carrying out the resolution adopted at the Cincinnati Tri-ennial Meeting, that a special effort should be made during the years between 1910 and 1913 to enlist branches of young women and older girls in the Junior Auxiliary, with the understanding that at the time of the next Tri-ennial they should be graduated into the Woman's Auxiliary. I have had to report that nothing has been done. Is it too late? May not Mississippi join in this work? Attention was called to it at the 1911 meeting, in Greenville, but seemingly without result. Miss Lindley suggests that it might be possible to find some young woman who would act as an assistant to the Diocesan Secretary in endeavoring to arouse interest and secure results in this matter.

It seems to me that there are a few practical suggestions that might well be made, and one of these is that the branches try to make remittances to the Diocesan Treasurer quarterly, or at least semi-annually. At present the handling of the various funds for our scholarships, etc.,

must be crowded, practically all of it, into the last week or ten days preceding the Annual Council.

I again recommend that all funds, for whatever purpose, be sent through the Diocesan Treasurer's hands, which would serve to prevent much confusion and many delays. Reports of such remittances would of course be made by the secretary or the leader of the branch to the rector, for his Council report, and the parish would receive due credit.

I urge greater emphasis on Mission Study; more definite teaching as to Prayer; and a systematic effort for increase in number of branches and in membership.

I call attention to the fact that to our Mississippi Juniors has been assigned the task of supplying with Christmas gifts for 1912 the adherents of the Sunday-School of Christ School, Arden, North Carolina, in the District of Asheville. Detailed information is to be sent to each branch. This is one of the most interesting and successful of our mountain missions, with its Sunday-School of grown men and women, as well as children and young people, its splendid boarding-school for mountain boys, its hospital, its wood-working shop. We should feel it a privilege that we are asked to supply something of Christmas cheer for these mountaineers, so needy and yet so well "worth while".

It is a great happiness to report that since Easter several of our branches have already begun earnestly their new year's work. We remember that we are pledged for this new year, \$50 for the Bishop Bratton Scholarship at St. Mary's on the Mountain; \$70 for the Robert W. Patton Scholarship at St. John's University, Shanghai. We must work for General Missions; for Diocesan Missions; for the United Offering; we can never work too persistently nor give too largely; for "the field is the world". Again we ask the support and co-operation of the Woman's Auxiliary, of the clergy, and of our people generally. ## CONSTITUTION

### ARTICLE I.

NAME. The Name of this Association shall be: "THE MISSISSIPPI BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS.

### ARTICLE II.

OBJECT. The object of this Association is to carry out and extend in the Diocese of Mississippi the three great aims of the Woman's Auxiliary, namely: Daily prayer for Missions, the study of Missions and systematic giving for Missions. The object of the Association may also be generally stated as that which is expressed in its name, namely: To help in every possible way in the missionary work of the Church, as conducted by the Board of Missions.

### ARTICLE III.

MEMBERSHIP. Any baptized woman in the Diocese of Mississippi may be a member of this Diocesan Branch of the Woman's Auxiliary, and any baptised young person or child a member of its Junior Auxiliary or Babies' Branch.

### ARTICLE IV.

OFFICERS SECTION 1.—The officers of this Diocesan Branch shall be the Bishop, a President, a Secretary, a Treasurer, a Custodian of the United Offering, a Secretary of the Junior Auxiliar, a Treasurer of the Junior Auxiliary, and a Secretary and Treasurer of the Babies' Branch.

These Officers shall also constitute the Executive Board of the Diocesan Branch.

SEC. 2.—The Secretary of the Junior Auxiliary, the Treasurer of the Junior Auxiliary, and the Secretary and Treasurer of the Babies' Branch shall be appointed by the Bishop, and shall hold office for one year, or until the next Annual Meeting. All other executive Officers shall be elected by the Diocesan Branch in annual meeting assembled, and shall hold office for three years, or until the Annual Meeting next before the General Triennial Meeting of the Woman's Auxiliary.

SEC. 3.—In the election of officers, all nominations must be written, and must be deposited in ballot box before the election, all elections must be by ballot. A majority of the votes cast shall be necessary to a choice; if there be no election on the first ballot, subsequent ballots shall be upon the two names receiving the highest number of votes.

SEC. 4.—Every vacancy in an elective office shall be filled by the Bishop by appointment until the next Annual Meeting.

## ARTICLE V.

MEETINGS. SECTION 1.—There shall be an Annual Meeting of the Diocesan Branch. Every executive Officer of the Diocesan Branch, the President of each local Woman's Branch, the Leader of each Junior Branch, and the Secretary of each local Babies' Branch shall be ex-officio Delegates to this Meeting. In addition, every local Woman's Branch or Junior Branch having a membership of twenty or less shall be entitled to one Delegate, with one additional Delegate for every ten members after the first twenty.

SEC. 2.—The Executive Board shall meet at least twice a year. Three officers shall constitute a quorum.

## ARTICLE VI.

AMENDMENT. SECTION 1.—This Constitution may be altered or amended by a two-thirds vote of the whole number of Delegates at any Annual Meeting, *provided* notice of such proposed Amendment shall have been given at the previous Meeting, or communicated in writing to the Secretary, and by her to each local Branch, at least thirty days before the Annual Meeting.

SEC. 2.—In questions of constitutional amendment, each Junior Branch is entitled to one vote.

---

B Y - L A W S

1.—The Executive Board shall, subject to the action of the Annual Meeting, direct the active work of the Diocesan Branch, and shall have power to adopt By-Laws for the Diocesan Branch.

2.—The Bishop shall be recognized as the official head of the Diocesan Branch, and the final court of Appeal in all matters of doubt. He shall appoint Officers of the Junior Auxiliary and Babies' Branch, and shall fill by appointment any vacancy in any elective office.

3.—The President shall call meetings of the Diocesan Branch and of the executive Board, and preside over such meetings. She shall exercise a general supervision of the work, and further it in every way by her interest and advice, and especially by an address at the Annual Meeting.

4.—The Vice-President shall, in the absence of the President, preside over the meetings of the Diocesan Branch and of the Executive Board. She shall co-operate with the President in promoting intelligence and interest in the work. She shall seek especially to interest isolated Churchwomen and enlist their assistance in the Auxiliary work, where such women are unable to join a local or Parish Branch.



5.—The Secretary shall keep the minutes of the executive Board and of the Annual Meeting, as well as of any special meetings that may be held, and shall make an accurate record of same in a suitable minute-book. She shall conduct all correspondence of the Diocesan Branch, except as otherwise provided for. She shall endeavor to keep in touch with the general work of the Woman's Auxiliary, and shall pay especial attention to the subject of Mission study, and to methods and means for promoting this part of the Auxiliary's work. She shall make a full report to the Annual Meeting, and for this purpose shall be furnished with a full data by the other executive Officers. She shall supervise the preparation and publication of the printed Annual Report of the Diocesan Branch.

6.—The Treasurer shall receive, record, disburse, and keep account of all money distributed, except that for the United Offering, and shall make an annual report of same to the Annual Meeting.

7.—The Custodian of the United Offering shall receive and keep in bank all gifts for this purpose, shall promote this interest by correspondence or otherwise, shall report each year to the Annual Meeting, and forward the Tri-ennial Offering.

8.—The Secretary of the Junior Auxiliary shall supervise the work of the Junior Branches, and shall seek to promote the interest of this department, extend its organization, and strengthen its work. She shall report in full to the Annual Meeting.

9.—The Treasurer of the Junior Auxiliary shall, under the direction of the Secretary of this department, correspond with the Junior Branches concerning matters of finance, money gifts, dues and pledges; shall receive, record, disburse, and keep account of all money distributed; and shall make an annual report of same to the Secretary of this department, in advance of the Annual Meeting.

10.—The Secretary and Treasurer of the Babies' Branch shall promote the interest of this organization by correspondence or otherwise, and shall receive, record, disburse, and keep account of all funds of this department. She shall report in full to the Annual Meeting.

11.—The Eves of St. Andrew's Day and of the Festivals of the Epiphany, the Annunciation and the Transfiguration shall be designated as days of special prayer for Missions and for the work of the Auxiliary in Mississippi and elsewhere.

12.—No Parish or local work may be considered Auxiliary work, or reported as such to the Officers or to the Annual Meeting.

13.—Each Branch shall pay yearly to the Diocesan Treasurer, for contingent expenses, the sum equivalent to fifteen cents (\$0.15) for each member of the Branch. This shall be the first payment following the Annual Meeting. In the case of Junior Branches, payment shall be made

to the Treasurer of this department, but from the fund thus created the Treasurer of this department shall pay to the Diocesan Treasurer a just share of the cost of printing the Annual Report.

14.—These By-Laws may be altered or amended by a majority at any Annual Meeting. New By-Laws may be adopted by the Executive Board at any meeting of such Board, *provided* said new By-Laws are not in conflict with any previously existing.
