## PRESIDENT'S ADDRESS.

Woman's Auxiliary Council, 1915.

The Bishop, Members of the Woman's Auxiliary, the Junior Department:

In speaking an affectionate welcome to you here present at this, our Twenty-fourth Annual Council, I miss the face of one long accustomed to be with us on such occasions. In all the twenty-four years of our existence I understand she was never absent from one of our Councils. I cannot help believing that her spirit is not far from a work that she gave so willingly of her time and thought to, while here upon earth and that in the Blessed Home where Saints immortal dwell, she is praying that His kingdom may come and His will be done on earth as it is in Heaven. She left us an example of faithfulness unto death and how sure we may feel that hers is the crown of everlasting life. I refer to our highly esteemed United Offering Treasurer, Miss Eliza Fox,

May light perpetual shine upon her!

Women of the Auxiliary, I ask your co-operation in making it worth while to be here. All Auxiliary Councils should be a basis for future endeavor, as well as for mutual help and inspiration. "Direct us, O Lord, in all our doings and further us with Thy continual help." The encouraging features this past year have been a revival of some dormant branches, several United Offering Branches formed in the Missions, and one or two entirely new organizations. Along with this I find a disposition on the part of many to obtain information and do things more in accordance with plans made for us by those in charge at the Missions House. The Study Classes I have reason to believe were vastly better than in previous years and now that the Correspondence Course is offered and has been successfully tried, I hope that many of our Parish leaders will be induced to take it, as by this means they can conduct the classes with greater facility. This, with the Auxiliary hand-book, which I take great pleasure in recommending to every branch, should bring about good results in future years. While we have reason to be thankful for any advance and to look favorably upon the encouragements, still I must ask you this morning if you think we can longer be satisfied with the slow growth, and with our less than thirty Branches of the Woman's Auxiliary in the Diocese of Mississippi?

We are now approaching our twenty-fifth anniversary. The time has surely come when we must bestir ourselves and reach out for a larger membership, and more organizations. Our Extension Committee has not met with the responsiveness that should have been given them. Let us consult with that committee and find out some feasible plan by which the growth of the Auxiliary will, if possible, be insured during the coming Auxiliary year. Earnest, prayerful thought should be given this most vital matter and every possible effort made to reach our Missions which have yet no organization.

Our "Silver birthday" could well be celebrated by bringing many of our church women to understand the need we feel for them in the Auxiliary work. If we only brought in one woman for each year to unite with us in this call to service and privilege, how much more precious in His eyes than gold or silver or precious stones? If there is one thing, more than another, which we hear discussed in all Auxiliary Circles and Councils it is the Diocesan Apportionment.

Someone may be asking why? The answer seems very obvious, for the Board of Missions to whom we are Auxiliary, has, after greatest care and thought, put forth what is known as the "Apportionment Plan," and through which it is asking the church to come forward with the very least that the Missionary Work of the Church can be even approached. It should be the part of every Auxiliary woman to know what the Diocesan Apportionment is—What part of this her parish apportionment is? And from our Bishop to find out just what he thinks the Woman's Auxiliary should raise, as an Auxiliary, of the \$5,007 that we must meet as a Diocese.

Last year the Auxiliary raised \$623.44. Is that a sufficient part for us to assume? I think we should do more as workers for this in our Parishes and Missions, never feeling satisfied with anything we do as long as the Diocese is not paying the apportionment. Who is there among us without influence? Why not put forth an earnest effort this coming year to help our Rectors get their parishioners interested in raising the Diocesan Apportionment? We can help by telling others about it and being always informed, so as to put the duty and privilege conclusively. The Board of Missions should not seem such an unreality when our own Bishop is a member and attends it four times a year. It must be a humiliation to him that our Diocese is not meeting with the Church's call. We have 5,727 Communicants, who gave of the \$5,007 apportioned the Diocese, \$2,856, a little over one-half the amount asked for by the Board of Missions.

This is the standing we have as a Diocese 1913-1914. It has commonly been said that when the women of the Church take up an enterprise and set their minds to its accomplishment that success is sure to follow. What more glorious undertaking for the Auxiliary in Mississippi than that of removing such a stigma from our Diocese as an unpaid apportionment of less than \$1 per communicant? We can do it if we try. Because of failures, such as ours, the Board found themselves meeting a deficit of \$400,000 and hence the "Emergency Letter" sent out by Miss Emery to every Branch of the Woman's Auxiliary. I trust that those of you present received the message sent to your Branch by the Secretary of this Diocese. If any one should understand this emergency which the Church is calling us to meet to-day, it is the Woman's Auxiliary. We are asked to pray for this need, especially at our Communions, and to set aside one day in which we make a gift of love and self-denial, which shall be an amount equal to at least one day's wage, or income. Let us respond cheerfully to each of these calls, being more than willing to give up something for the Blessed Christ and His work. I hereby appoint April 23rd as self-denial day for the Woman's Auxiliary in the Diocese of Mississippi.

Let us make a worthy offering to the Emergency Fund and do it through self-denial and love for the dear Master. One-half the world still waits the answer to our Captain's Command:

"Go, teach, baptize, preach everywhere  
Jesus and the Resurrection."

**MINUTES.**

The Twenty-fourth Annual Council of the Woman's Auxiliary to the Board of Missions in the Diocese of Mississippi, was held April 13-15, 1915, in St. Paul's Church, Columbus.

TUESDAY, APRIL 13—7:45 P. M.

The opening service on Tuesday night at 7:45 was conducted by the Bishop, the Rt. Rev. Theodore DuBose Bratton; the Arch-deacon, the Rev. G. Gordon Smeade, and the Rector, the Rev. W. S. Slack. The sermon was preached by the Rev. William Bratton, of Indianola.

WEDNESDAY, APRIL 14—10 A. M.

Corporate Communion of the Auxiliary, celebrated by the Bishop assisted by the Rector, Mr. Slack.

WEDNESDAY, APRIL 14—11 A. M.

Diocesan Officers Conference to hear letter read from Miss Emery. President appointed committee to act upon the letter. Miss Emery's letter and committee's report on same to be found elsewhere.

WEDNESDAY, APRIL 14—11:30 A. M.

Business session.

Convened in the Parish House. After a few minutes of silent devotion the meeting was opened with prayer, led by the Bishop. The President of the Woman's Auxiliary, of Columbus, introduced Mrs. Bratton and welcomed the delegates to Columbus. The President, Mrs. Bratton, responded with a short talk, "Reciprocity," to be the keynote of the meetings. She then made her address to the Council.

Letter read regarding the Emergency Fund, the suggestion coming from the Church Missions House that each woman give one day's income aside from her regular offering for Missions to help this emergency. The President appointed April 23 to be observed as Self-Denial Day in the Diocese.

Noon-day prayer for Missions.

Roll call, to which twelve Branches answered from the Woman's Auxiliary, and six from the Junior Auxiliary.

Reports read from Recording Secretary; Vice-President; Treasurer; United Offering Custodian; the Secretary of The Spirit of Missions; the Secretary of the Juniors; the Treasurer of the Juniors; the Secretary of The Little Helpers. No report from Educational Secretary.

Secretary instructed to publish through the Church News the Financial Obligations of the Branches, also when and where to send them.

Discussion arose to abolish the present duplicate receipt method sent in to the Treasurer. The result of the discussion: To retain present system, it being the least complicated of several methods.

RECESS.

---

Reopened at 2:30 P. M.

Proposed amendments to the Constitution from the Junior Auxiliary as per notice given at the Twenty-third Annual Council were read and a general discussion as to whether these proposed Amendments would result in good for the Juniors. It was feared the adoption might tend to separate the Woman's Auxiliary and the Juniors. It was the general opinion that this difficulty was not possible in Mississippi. Motion made and seconded to adopt the following Amendments.

ARTICLE III. Amend by striking out the words "or Babies' Branch." (Note, that the "Little Helpers' Society," formerly the "Babies' Branch," is a part of the Junior Auxiliary.)

ARTICLE IV. Amend Section 1 by substituting for the words, "a Secretary of the Junior Auxiliary, a Treasurer of the Junior Auxiliary, and a Secretary and Treasurer of the Babies' Branch," the words, "A President, two Vice-Presidents, and a Secretary and Treasurer of the Junior Auxiliary."

Amend Section II by striking out the entire section and substituting therefor the following:

"Section II. Executive officers, except those of the Junior Auxiliary, shall be elected by the Diocesan Branch in annual meeting assembled, and shall hold office for three years, or until the Annual Meeting next before the General Triennial Meeting of the Woman's Auxiliary. The Diocesan officers of the Junior Auxiliary shall be appointed by the Bishop; provided, that a meeting of the Junior Auxiliary at which five or more parish branches are represented may, upon the Bishop's permission, elect Diocesan officers of the Junior Auxiliary as provided for in Section I, such elections to be confirmed by the Bishop; and such officers whether elected or appointed shall hold office for a term such as hereinbefore provided for other executive officers."

ARTICLE V. Amend Section 1 by substituting for the words "each local Babies' Branch" the words "each local branch of the

Little Helpers' Society." Add to Section 1 the following: "At any Annual Meeting, if the representatives of Junior Branches exercise the privilege of electing the Diocesan officers of this Department, such representatives shall not participate in the nomination or election of other Diocesan officers; provided that this shall not apply to leaders of Junior Branches who may also have been duly designated as delegates from Senior Branches." Carried.

Letter read from Mrs. A. S. Bartlet regarding an organizing or Educational Secretary for the Dioceses of the Province of Sewanee. Discussion as to the great need of such an officer, also the practicability in this Diocese of employing this Secretary. Motion made and seconded regarding such a Secretary. Voted no.

Nominations for four delegates and four alternates to Provincial Synod which meets at Sewanee on October 19, 1915, were called for.

Miss Virginia Jones offered the following resolution which was adopted. The resolution urges the putting of "first things first" and was adopted by the Woman's Auxiliary of South Carolina, at its last Council:

**"Whereas**, amid the many social diversions and club duties of our daily life, there is a growing tendency to give little heed to the precedence of those organizations which call to us in the name of Christ, **be it**

**Resolved:** That we, the members of the Woman's Auxiliary of this Diocese in Council assembled, do go on record as asserting the determination on our part to put first things first, and to refuse to consider the claims of other organizations, when they conflict with our bounden duty and service."

After passing resolution relating to "putting first things first," it was moved and seconded that the President appoint a committee to write to each Branch and call special attention to the resolution just passed. Carried.

Miss Jones appointed.

Adjourned until 10 a. m., April 15.

#### THURSDAY—10 A. M.

Reopened the Council with prayer.

Minutes of previous day read and approved.

Branch reports read.

Motion offered by Miss Walthall to abbreviate, or omit the publishing through the Journal of the Officers' Reports; abridge Branch Reports; omit Constitution. No vote.

Miss Walthall withdrew previous motion and offered the following substitute:

Moved that the executive officers be instructed to eliminate all unnecessary matter from the report. Seconded and carried.

The Chairman of the Committee on Auxiliary Extension read the following report which was adopted:

Madam President:

Your Committee on Extension would suggest:

1. That the Educational Secretary give a part of her time to traveling through the Diocese, for the purpose of increasing interest in the Auxiliary and forming new Branches.

2. That if the former is impracticable, a Committee on Extension be formed, whose duty it would be to endeavor to form Branches through correspondence. This committee would also urge upon all Auxiliaries, the importance of sending delegates to Council Meetings, Summer Conferences and Study Classes, and the advisability of having Convocation Meetings.

**IN MEMORIAM TO MISS ELIZA W. FOX.**

---

In the death of Miss Eliza W. Fox, the Woman's Auxiliary to the Board of Missions has sustained a great loss. For nineteen years she served well and faithfully as Treasurer. A church woman through inheritance and trained from childhood in its faith and practices, she instinctively gave to it of her best.

When the Woman's Auxiliary was organized at Natchez by Bishop Thompson, Miss Fox was appointed its Treasurer by the Bishop. We all know how well and faithfully she served. The society being in its infancy the greater part of her administration called forth a great degree of energy and tact, especially during the orphanage of the Auxiliary the two years we were without a Bishop.

After the alteration of the constitution and the officers were elected by its members, she gladly laid down its responsibilities, but when the office of United Offering Custodian was created Miss Fox was unanimously elected custodian which office she accepted as it was less arduous than that of Treasurer.

When she was called from the church Militant to the church Triumphant she was filling that office, having served the Auxiliary as an officer from its organization until with her time was no more.

**Therefore Be It Resolved:** That in the death of Miss Eliza W. Fox The Woman's Auxiliary in the Diocese has met with an irreparable loss, and that she has well earned the promise of our Lord to those who faithfully serve Him.

"Be ye faithful unto death and I will give thee a crown of life."

Invitation to the Council to meet in Laurel next year, received through Mrs. Gardiner. Moved and carried to accept.

## MISS EMERY'S LETTER.

April, 1915.

MY DEAR MRS. BRATTON:

Would it be possible at the Annual Meeting of the Mississippi Branch to set on foot the following plans:

1. That the Educational Secretary be empowered to form a committee who shall discover and arrange for the most promising young women they can secure, to go for definite training, (one or two if possible), to each of such Church institutes or summer conferences as shall be held this summer within the Province.

To secure one or two experienced leaders to go with the Educational Secretary herself to such other conferences within the Province as may be recommended by the Educational department of the Board of Missions.

2. That a committee of young women to whom no responsibility has been given heretofore, be appointed to plan for meetings to be held this summer at summer resorts within the Diocese.

3. That two financial committees, one on the ordinary money gifts of the Auxiliary and one on the United Offering, be appointed to take into account the financial condition of the Branch and submit a plan to the Executive Committee to be approved and set on foot as soon as possible.

4. In your Diocese there are 5,727 communicants. We will consider that one-half of these 2864 are women. Without considering the other women who are not communicants, but who join in Auxiliary work, what amount of money do these contribute towards the apportionment and specials through the Treasury of the Board of Missions? Last year \$202.35, or an average of 7 + cents. Is that a satisfying evidence of keen interest.

The share of the Diocesan Branch in the United Offering of 1913 was \$1,190.10, an average of 41 + cents for each of these women communicants—that is, of 12 + cents a year. Is that also satisfactory?

We know that by far the larger number of women communicants were not included in these gifts. We want to strengthen the interest of present givers, and to win the interest of those not now interested. What will your committee propose to accomplish this.

5. A fourth committee which we would desire before all others, might help the Auxiliary to resolve itself during these summer months, into a committee on prayer. That its members in their private prayers and in their communions ask God's blessing on every plan and effort. That they ask friends to offer these prayers. That little groups make united intercessions. That we pray, not only for our part of the work, but for the workers in the field and the peoples who are waiting for the message. Thus our love for them shall grow and shall move our hearts to take joy in our service in their behalf.

Please let us know what you can do about this.

Regarding Miss Emery's letter, the Committee reports as follows:

Suggestion 1. The Committee recommends that the matter of securing young women for Institutes and Conferences, be left to the

Educational Secretary, but that it be recommended that each member of the Auxiliary be urged to disseminate interest and information as to these Conferences.

Suggestion 2. Is not feasible in the Diocese of Mississippi. That regarding Suggestions 3 and 4, we have nothing to suggest beyond present plans.

The Committee most cordially approves of Suggestion 5, and asks that it be recommended to the various Branches.

JUNIOR AUXILIARY—YEAR 1914-1915.**

---

The Junior Auxiliary has no new Branches to report this year in Sections II and III, nor any loss of Branches previously reported.

Effort has been made to secure throughout the Diocese a clear understanding of the plan of organization in the three sections, and of the special importance of developing Section III as fully as possible without delay. Mrs. Kuehnle and Miss McQuiston were appointed as a committee to work for this purpose, but Miss McQuiston's absence from the Diocese left Mrs. Kuehnle to act alone. Her work has been earnest and faithful.

The young women's Branches in Natchez, Aberdeen and Jackson have made a good record for the year, the Natchez Branch being particularly active and earnest.
