Watch over them, we beseech Thee, for good; give Thine angels charge concerning them, and let Thy Holy Spirit rule in their hearts, and prosper all their works to the glory of Thy Holy Name; through Jesus Christ our Lord. Amen.

## PRESIDENT'S ADDRESS.

*The Bishop, Members and Friends of the Woman's Auxiliary, and its Junior Department:*

I bid you an affectionate welcome to the Twenty-fifth Annual Council of the Woman's Auxiliary in the Diocese of Mississippi. The Auxiliary—looking backward—the Auxiliary looking forward—is what I shall ask you to consider with me this morning. The value of a past, is that it enables us through experience, large and varied, to plan for a better future. Let us then see what has been worth while in an organization of women banded together for a quarter of a century whose purpose has been to assist the Board of Missions in their great work of a world's evangelization. The Auxiliary had its beginning in our Diocese with three or four women appointed Diocesan officers by their beloved Bishop in 1891. The two or three gathered together with the Father's promise to be in the midst of them has developed into the present Branch of the Auxiliary with its newly reorganized Junior Department. Something like thirty Branches of the Auxiliary with a proportionate number of Juniors and Little Helpers are now actively at work in the Diocese. The United Offering has grown from \$49 in the first year to nearly \$1200 in 1913. The 1916 offering so soon to be made will doubtless show a proportionate increase. Study Class work is now becoming an established custom in some of our parishes during the Advent and Lenten seasons. Contributions to almost every cause for Missions have been made from time to time by the different Branches including the box work and amounting to thousands of dollars in all these past years.

The foundation has been well laid for our future development. It is not, however, concrete results that I am thinking about this morning as we take this backward glance, but something of far greater value to our organization. What have we stood for in our parishes? Have we worked and prayed for the Missionary Spirit to grow and grow until every woman and girl had taken some part in the Missionary activities of the Church? Have we been sufficiently informed to answer the objections to Mission? Have we been so earnest about the Father's business that those who saw our work would wish to come with us? Has the world's need been our inspiration? Have we kept in touch with those who have answered the call to go; especially those faithful women, representing us in far-away distant lands? Have we prayed that someone from our own beloved Diocese will make the gift of self and carry the message? Have we mothers and Auxiliary women used every means to influence and train our children and young people to care about these things? Have we realized what an asset the Junior Auxiliary is, our permanency and future usefulness depending largely upon them? The splendid outline of work put before the Juniors of 1916 by the Junior Officers bespeaks an efficiency from which we have a right as a Woman's Auxiliary to expect a tremendous uplift.

Seeing then, dear friends, where we stand after a period of twenty-five years, let us turn our thoughts, to the Auxiliary—looking forward. The Educational Department to my mind is the weak place in our organization. Let us begin our forward movement by making some provision for a traveling Secretary. It may not be possible for us to do more than to secure the service of someone who will be willing to devote a few weeks each year to visiting and organizing the Auxiliary among our scattered Church people and in the small Missions. We need someone who can give the vision. Letters and literature help, but that is not sufficient. Mississippi is not in

line with her sister Dioceses in this department of her work. Again, in our forward march let us make a determined effort to increase the United Offering. We must see how our members are responding as compared with this time three years ago. I confidently expect an increase, because I believe the time has come when the United Offering joined with the United Prayers of our members cannot fail to bring results. May the time be not far distant when the gift of life will be made by someone in Mississippi!

Should the Auxiliary see fit to respond to two important suggestions coming directly from a Committee approved by the Board of Missions, I shall feel no doubt about the advance forward in the new era upon which we are entering. The Board suggests to the individual members of the Church that they make an offering of one day's wage, or income, and that it become a yearly habit. This, if adopted, will enable the Board to strengthen and extend the Church's work. I should like to see the Mississippi Auxiliary accept this plan and set aside some special day in which we are gathered together in our different Parish Branches to pray for the spread of Christ's kingdom and to make the offering of One Day's Income. The Committee of which Miss Emory is Chairman, asks that we look upon it as a hopeful sign that the Church is ready to go on to larger things and that we pray individually and with others that God's blessing will rest upon it.

Second, the Board of Missions is anxious to have the fund for the new St. Luke's Hospital, Tokio, completed. They feel that St. Luke's should take precedent over every other Special. A gift of \$100,000 has been promised to the Endowment Fund when the Hospital is completed. That the President and several of his cabinet as well as the Japanese Ambassador attended a meeting in Washington about the proposed Hospital is an indication of its distinct International value and of the friendship it is promoting between Japan and America. The Junior Department has undertaken the Children's ward, the Mississippi Juniors doing their share towards the amount needed.

The Woman's Auxiliary has done something towards helping in this vast undertaking and I hope will continue to do so. What a privilege and opportunity this affords us. It was He the Great Missionary who left His Father's home and came to save not us alone, but a world. As we value our life in Him, our beautiful religion, our Church privileges, let us share them with our fellowman, our brothers and sisters in far-away Heathen lands. Let us give of our substance as God has prospered us.

It has been my privilege, dear fellow Officers and members of the Auxiliary, to work along with you for the past ten years. As we enter upon a new period, I feel that my time as your President must end. There are other and younger women among you who must now take up the task. It is with deep gratitude that I recall the unfailing courtesy and consideration shown me by my fellow Officers. My heart is full of gratitude to God and to them for the assistance, sympathy, and readiness with which they have answered every call to service. The past years in which I have had the co-operation, confidence and sympathy, and in many instances, warm affection of the Women of the Auxiliary will ever remain as among the most treasured of my life. The work itself has been a privilege. It has done much to deepen my interest in the Father's business and to help my individual life. May we all learn from day to day how best to serve Him and to do our part in extending Christ's Kingdom. Nothing has been more helpful to me than the Officers' conference each year. The Auxiliary—looking forward calls for a reconsecration of ourselves to the work, now made so dear to our hearts because of these past years of privilege and opportunity. Let us go into the work with renewed courage, energy and devotion. Above all let us go into it with God and with a determined effort to make it better known. Who can estimate the value of personal work to an organization of this kind. It is work of that character which

the Auxiliary needs. We may confidently expect extension when we use to the full, ourselves, to show others the way. We thank our Heavenly Father for these past years in which we have shared the Missionary work of the Church. We ask His pardon for all we have unworthily done and Grace to persevere until we have reached the mark of our high calling in Christ Jesus.

### SECRETARY'S REPORT.

*The Bishop, Madame President and Women of the Auxiliary:*

During the year that has just closed, I have had fewer letters to write than at any time since I have served as your Secretary. This is partly due to the fact that I have used the columns of the Church News when I wanted to reach you, and again the work in the various Branches seems to be smoother. I have written seventy-eight (78) letters, and thirty-six (36) postals. The yearly reports have been received from twenty-three Branches. There have been three new United Offering Branches organized this year, one at Terry, one at Hernando, and one at Inverness.

A called meeting of the Diocesan Officers was held in Port Gibson in February, at which time our admirable program was arranged. The Officers are very desirous to secure the yearly reports of the Auxiliary prior to the year 1912, in order to file them with the Secretary. Anyone having such copies will notify the Secretary and oblige the Officers.

The four years of service that I have given to the Woman's Auxiliary of the Diocese have been years of pleasure and gain to me. I have received many more benefits than I have been able to give.

THE TWENTY-FIFTH ANNUAL COUNCIL OF THE WOMAN'S AUXILIARY convened in St. John's Church, Laurel, May 3rd., eleven a. m. Corporate Communion celebrated by the Bishop, assisted by the Rev. Wm. Mercer Green.

11:30 A. M.

Business session in the Parish House. Opening prayer led by the President. Introduction of Miss Lindley of the Church Missions House by the President. A welcome from the Bishop. Counsel also welcomed by the President of the Laurel Branch. Roll call to which the Branches from Biloxi, Columbus, Greenville, Jackson, Laurel, Meridian, Natchez, Pass Christian, Port Gibson, Vicksburg, Christ Church, and Wilczinsky answered present. Roll call of Junior Auxiliary: Columbus, Section I; Laurel Section I and Section II; All Saints' College, Section II; Meridian, Section II and Section III; Natchez, Section II (Bp. Brent Aux.), Section II (Bp. Bratton Aux.), Section III (Bp. Rowe Aux.); Pass Christian, Section II and Section III.

President's Address read. Miss Emery's letter read. Vice-President's verbal report made. Secretary's report read. Treasurer absent. Report read by Miss Virginia Jones. Reports read from the Custodian of the United Offering and the Diocesan Representative of the Spirit of Missions. Report from the President of the Junior Auxiliary made. Vice-President of Section III Junior Auxiliary read report; also Treasurer of Junior Auxiliary's report read. Recess from one to two thirty P. M.

2:30 P. M.

Council called to order at 2:30. Secretary of the Church League of the Baptized absent. Report read by Miss Tiblier, delegate from Pass Christian. Branch reports made by delegates from Biloxi, Greenville, Columbus, Jackson and Christ Church, Vicksburg. Vice-President's report of Section I, preceded by reading the names of the Memorial Circles. Council stood while names were read.

Conference on Extension led by Mrs. Joseph Kuchnle of Natchez. Various discussions as to most effective manner of organizing different sections

of the Auxiliary. Leaders who are able to give heart and time to each department, being the keynote of successful organization and its results. Conference closed after an hour's interesting discussion.

*4:30 P. M.*

Special session led by Miss Lindley of New York. An inspiration to be present and hear from her some of the same worries and troubles that she has as President of a local Branch, that others have as Parish Officers. 5:30 adjourned.

*Wednesday 8:00 P. M.*

Evening prayer read by the Bishop assisted by visiting clergy. Sermon on the Twenty-fifth Anniversary of the Woman's Auxiliary, preached by the Rev. Wm. Mercer Green.

*Thursday 9:30 A. M.*

Morning prayer read by the Bishop.

*10:00 A. M.*

Council re-opened with prayer led by the President. Roll call. Discussion as to whether Junior Leaders should be members of the Woman's Auxiliary. Referred to Miss Lindley. Explained by her that all Junior Leaders should be connected with the Woman's Auxiliary though detached for the time being for Junior work. Concensus of opinion that all leaders are of necessity Woman's Auxiliary members. Miss Emery's letter re-read by request.

*New Business.*

Explanation on "Nominations" made as Constitution requires nominations by written ballot.

*New By-Laws Read by Miss Virginia Jones.*

New By-Laws made necessary on account of Amendments to Constitution adopted in 1915. Moved and seconded to adopt By-Laws as read. Discussion as to adoption. Motion withdrawn to adopt By-Laws as a whole. Moved and seconded to adopt each new By-Law separately. Carried. Moved by Miss Virginia Jones to omit By-Laws Section II as unnecessary. Seconded by Mrs. Jno. Jones and carried. By-Law Section III read. Moved to adopt change. Seconded. Carried. By-Law Section V. Moved to adopt as corrected. Seconded. Carried. By-Law VI, and all others concerning changes made necessary by adoption of new Constitution and reorganization of Junior Auxiliary read. Motion by Miss Walthall to adopt these changes. Seconded. Carried.

Moved by Mrs. Kuehnle: That the amendments presented to the Council be referred to a committee. That this committee send a copy of them to Secretary in time for her to send copies to each Branch at least thirty days before the next Council in accordance with Article VI, Section I of the Constitution. Seconded. Carried. The amendments were not read in detail but the purpose of each was explained.

Committee appointed: Mrs. Joseph Kuehnle, chairman; Miss Gertrude Howard and Miss Virginia Jones.

Literature on St. Luke's Hospital sent out by Church Missions House discussed. Each delegate requested to take home some of this literature

and read same at Branch meeting. This literature concerns a method to raised money, but more primarily an interest in this International Hospital.

Discussion called for as to plans to raise money for this Institution—"Tea Party"—plan considered a good one. Motion regarding St. Luke's Hospital: That the Auxiliary be asked to make St. Luke's Hospiatal Fund a definite object. The manner of raising funds to be left to the individual Branch. Seconded. Carried.

Discussion on abridgement of the Annual Report gotten out by the Secretary. This discussion an annual one for the past several years. Motion by Miss Jones to omit the minutes of the Council from printed report. Seconded. Vote: Ayes, 6. Nays 15. Motion by Miss Virginia Jones. Tabulated report to be made and inserted into Annual Report. All separate Treasurers' Reports to be omitted. Seconded. Carried. Motion by Miss Virginia Jones, seconded. To omit the names of the Memorial Circle from Report. Voted No.

Noon-day prayer led by Miss Lindley. Conference on Mission Study led by Mrs. Welch of Laurel. Words of praise from Miss Lindley as to the leaders she had listened to at this Council. Competent and efficient, if not expert leaders among Mississippi women. Attendance at Summer Conference urged. One at Gulfport, the other at Blue Ridge, June 27th, July 6th. Miss Lindley to be present at the latter. President thanked Mrs. Welch for her splendid leadership of this Mission Study conference.

Recess from one until two thirty.

2:30 P. M.

Council re-opened with prayer. Question box opened, Miss Walthall presiding. Questions asked and answered for thirty minutes.

## MISS EMERY'S LETTER.

CHURCH MISSIONS HOUSE.

WOMAN'S AUXILIARY.

April, 1916.

MY DEAR FRIEND:

This last meeting before our Triennial is important. At the General Convention the whole Auxiliary stops to weigh itself, its purposes and its deeds, to discover how it may make a real advance. Send your representatives to its meetings prepared to be real helpers in the serious work it has to do, for it is a serious work. The times in which we meet are serious, and without faith and love might be appalling. We need to see and to feel as never before.

Across the water this spring our fellows in the woman's work in the S. P. G. are setting us an example. Many of us this last year have given time and strength and means to the aid of sufferers because of war—if we in this country, how much more they in theirs—and yet this May they are keeping their fiftieth anniversary, and planning a distinct advance. And how?

First, they are sending out a reminder of the two great wars in this year of our Lord, 1916. We pass their message on to you:

*THE MATERIAL WAR.**THE SPIRITUAL WAR.*

Twenty million soldiers are placed in physical peril.

Fifty times twenty million of people are in spiritual bondage and death.

One million were killed in the first six months of the war.

Two million people die every month in heathen lands.

It costs about £700 to kill a man.

It costs to give the Gospel to the world about 8 s. per person.

The cost of the European war is over £10,000,000 daily.

Expended in spiritual war about £7,000,000 annually.

The fighting strength of the armies is over 20,000,000.

The total missionary force 12,000 men and 12,000 women.

Develops hatred.

Promotes friendliness.

Is destructive.

Is constructive.

Settles nothing finally.

Tends to establish Christ's enduring Kingdom and to put an end to all war.

In view of these startling facts our fellow-workers are calling their associates to a pilgrimage of prayer. They hope to find in diocese after diocese those who will be leaders in prayer, bringing people to repentance and then to a fresh devotion. Will it not be possible in your diocese to plan that next year each Parish Branch shall have its period of repentance for its own shortcomings, intercessions in behalf of one another for all who

in Parish or Diocese do not share their interest, for all throughout the world that they may be drawn to God?

We hope during our Triennial to give more time to prayer than ever before. Will you not send your representative prepared to learn with us how to pray, that they may return to lead you in our great effort throughout the whole Auxiliary to make this coming year a year of prayer?

## CONSTITUTION.

---

### ARTICLE I.

NAME. The Name of this Association shall be: "THE MISSISSIPPI BRANCH OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS."

### ARTICLE II.

OBJECT. The object of this Association is to carry out and extend in the Diocese of Mississippi the three great aims of the Woman's Auxiliary, namely: Daily prayer for Missions, the study of Missions and systematic giving for Missions. The object of the Association may also be generally stated as that which is expressed in its name, namely: To help in every possible way in the missionary work of the Church, as conducted by the Board of Missions.

### ARTICLE III.

MEMBERSHIP. Any baptized woman in the Diocese of Mississippi may be a member of this Diocesan Branch of the Woman's Auxiliary, and any baptized young person or child a member of its Junior Auxiliary.

### ARTICLE IV.

OFFICERS. SECTION 1.—The officers of this Diocesan Branch shall be the Bishop, a President, a Secretary, an Educational Secretary, a Treasurer, a Custodian of the United Offering, a President, two Vice-Presidents, and a Secretary and Treasurer of the Junior Auxiliary.

These Officers shall also constitute the Executive Board of the Diocesan Branch.

SEC. 2.—Executive Officers, except those of the Junior Auxiliary, shall be elected by the Diocesan Branch in annual meeting assembled, and shall hold office for three years, or until the Annual Meeting next before the General Triennial Meeting of the Woman's Auxiliary. The Diocesan Officers of the Junior Auxiliary shall be appointed by the Bishop; provided, that a meeting of the Junior Auxiliary at which five or more Parish Branches are represented may, upon the Bishop's permission, elect Diocesan Officers of the Junior Auxiliary as provided for in Section I, such elections to be confirmed by the Bishop; and such officers whether elected or appointed shall hold office for a term such as hereinbefore provided for other executive officers.

SEC. 3.—In the election of officers, all nominations must be written, and must be deposited in ballot box before the election, all elections must be by ballot. A majority of the votes cast shall be necessary to a choice; if there be no election on the first ballot, subsequent ballots shall be upon the two names receiving the highest number of votes.

SEC. 4.—Every vacancy in an elective office shall be filled by the Bishop by appointment until the next Annual Meeting.

#### ARTICLE V.

MEETINGS. SECTION 1.—There shall be an Annual Meeting of the Diocesan Branch. Every executive Officer of the Diocesan Branch, the President of each local Woman's Branch, the Leader of each Junior Branch, and the Secretary of each local Branch of Little Helpers' Society, shall be ex-officio Delegates to this Meeting. In addition, every local Woman's Branch or Junior Branch having a membership of twenty or less shall be entitled to one Delegate, with one additional Delegate for every ten members after first twenty. At any Annual Meeting, if the representatives of Junior Branches exercise the privilege of electing the Diocesan Officers of this Department, such representatives shall not participate in the nomination or election of other Diocesan Officers; provided that this shall not apply to leaders of Junior Branches who may also have been duly designated as delegates from Senior Branches.

SEC. 2.—The Executive Board shall meet at least twice a year. Three officers shall constitute a quorum.

#### ARTICLE VI.

AMENDMENT. SECTION 1.—This Constitution may be altered or amended by a two-thirds vote of the whole number of Delegates at any Annual Meeting, *provided* notice of such proposed Amendment shall have been given at the previous Meeting, or communicated in writing to the Secretary, and by her to each local Branch, at least thirty days before the Annual Meeting.

SEC. 2.—In questions of constitutional amendment, each Junior Branch is entitled to one vote.

---

#### BY-LAWS.

---

1.—The Executive Board shall, subject to the action of the Annual Council, direct the active work of the Diocesan Branch, and shall have power to adopt By-Laws for the Diocesan Branch.

2.—The President shall call meetings of the Diocesan Branch and of the Executive Board, and preside over such meetings. She shall exercise a general supervision of the work, and further it in every way by her interest and advice.

3.—The Vice-President shall, in the absence of the President, preside over the meetings of the Diocesan Branch and of the Executive Board. She shall co-operate with the President in promoting intelligence and interest in

the work. She shall seek especially to interest isolated Church women and enlist their assistance in the Auxiliary work, where such women are unable to join a local or Parish Branch.

4.—The Secretary shall keep the minutes of the Executive Board and of the Annual Council, as well as of any special meetings that may be held, and shall make an accurate record of same in a suitable minute-book. She shall conduct all correspondence of the Diocesan Branch, except as otherwise provided for. She shall keep in touch with the general work of the Woman's Auxiliary. She shall make a full report to the Annual Council, and for this purpose shall be furnished with a full data by the other Executive Officers. She shall supervise the preparation and publication of the printed Annual Report of the Diocesan Branch.

5.—The Treasurer shall receive, record, disburse, and keep account of all money distributed, except that for the United Offering, and shall make a report of same to the Annual Council.

6.—The Custodian of the United Offering shall receive and keep in bank all gifts for this purpose, shall promote this interest by correspondence or otherwise, shall report each year to the Annual Council, and forward the Triennial Offering.

7.—The Educational Secretary shall promote by correspondence and visits, where possible, the extension of the Auxiliary. She shall give attention to the subject of Mission Study, and to methods and means for promoting this part of the Auxiliary work. She shall report to the Annual Council.

8.—The President of the Junior Auxiliary shall supervise the work of the Junior Department, and shall seek to promote its interest, extend its organization, and strengthen its work. She shall report in full to the Annual Council.

9.—The Vice-Presidents of the Junior Auxiliary shall promote the interest of this organization by correspondence or otherwise, the First Vice-President to have charge of Section III of the Junior Auxiliary, the Second Vice-President to have charge of Section I of the Junior Auxiliary. They shall report to the President of this department before the Annual Council.

10.—The Secretary and Treasurer of the Junior Auxiliary shall, under the direction of the President of this Department, correspond with the Junior Branches, and shall receive, record, disburse, and keep account of all money distributed. She shall report to the Annual Council.

11.—Saint Andrew's Day and the Festivals of the Epiphany, Ascension and the Transfiguration shall be designated as days of special prayer for Missions and for the work of the Auxiliary in Mississippi and elsewhere. The Conversion of St. Paul shall be a day of corporate communion for the Branches throughout the Diocese.

12.—No Parish or local work may be considered Auxiliary work, or reported as such to the Officers or to the Annual Council.

13.—Each Branch shall pay yearly to the Diocesan Treasurer, for contingent expenses, the sum equivalent to fifteen cents (0.15) for each member of the Branch. This shall be the first payment following the Annual Council. In Junior Branches, payment shall be made to the Secretary and Treasurer of this department, but from the fund thus created the Treasurer of this department shall pay to the Diocesan Treasurer of the Woman's Auxiliary a just share of the cost of printing the Annual Report.

14.—These By-Laws may be altered or amended by a majority at any Annual Council. New By-Laws may be adopted by the Executive Board at any meeting of such Board; *provided* said new By-Laws are not in conflict with any previously existing.
