## TENTH ANNUAL REPORT.

*To the Rt. Rev. Daniel S. Tuttle, D.D., Bishop of Missouri,  
and Members of the Woman's Auxiliary:*

So fast the days come and go, and one Auxiliary year succeeds another, that it is only by a close reading that we find that with the same box-packing, the same missionary pledges and missionary interests that these years are not all alike, that each one has its special interests that gives it a place of its own. But when we look over the ten years which to-day round an epoch in our history, as we have recently done in the Missions Class, we can see that these years have wrought such changes in the interest, in the spirit of our work, that by no member of the Auxiliary could our tenth year and our first, or our fifth, be mistaken for each other.

Since our report, a year ago, our Branch has been divided, and the Woman's Auxiliary in West Missouri has sprung forth grown into existence. Through your kindness I attended its first meeting with Miss Emery, and assisted in its organization last June. The greatest interest was manifested throughout, and I realize more fully how much more could be done and how much more might have been done, if the officers could go about the Diocese and give a more personal interest in the work. It seems to be the only way now for us to look for a greater growth, and I have you to thank for the pleasure and privilege you gave me.

The figures in this report are flattering, as they have been before from year to year, and we have gone forward in spite of.

our division, but in one way we have over-estimated our strength. Last May we pledged \$250 for the Church Missions House in New York. Pledges for \$145 were made at our meeting, and it was expected that the remainder would be forthcoming during the year, but we seem to have forgotten that and taken up other specials, and now, while we have given more money, much more than ever before, we find our first pledge unfinished. In every other way we see progress. The Mite Boxes have brought in more, so that we have a balance in the treasury of \$15 from them, after paying \$200 for our scholarship at the School of the Good Shepherd. The Bishop Robertson scholarship has been met by the Alumnae of the school, and two or three special gifts, two notes of \$500 each have been paid on the debt on All Saints' Church; \$100 has gone to Japan for a new school; a scholarship taken in St. Mary's Orphanage, China; \$100 sent to Nashotah; \$100 to the Diocese of the Platte; our pledge of \$50 paid for Diocesan Missions, and \$25 sent to the Bible House for Foreign Missions. Holy Innocents', Oak Hill and St. Paul's, South St. Louis, have been helped in renovating their Church buildings, and that best gift of a rectory has gone to one of our Missionaries. These have been the specials this year, and all our former work and pledges have been kept up. At our meeting last fall, Miss Carter praised us for one thing wherein we differed from any Auxiliary she had ever known, the praise was deserved, and may we go on to claim it more and more, "that we are the only Auxiliary that gives more in money than in boxes." Yet there are some feeble parishes that would gladly work for boxes, but have no money to buy materials, and perhaps another year can solve the problem of providing materials when they can be procured in no other way.

Besides Miss Carter, we had for our honored guest at our General Meeting the Bishop of West Missouri, and during Lent we had a rest for our souls and a strengthening of our spiritual



life in a Quiet Day given by the Rev. Theodore Riley of Nashtotah. Perhaps the greatest interest of the winter in Auxiliary lines has been the class for the Study of Missions, which was held once a month at the Bishop's house. In this age of women's clubs, and in this city where they are well established for every branch of study, it took its rank among the foremost of them. One general paper was read at each meeting on the subject for the day, and six sub-topics had special shorter studies, so that seven women were each month thoroughly equipping themselves in some line of missionary study. Many of the papers bore the highest literary merit, and we can safely say that the forty-two women who contributed these papers, as well as that many more who listened to them, take a more intelligent interest in the Church's work than they ever did before. The first practical result of the class has been the Ada Paschall Davis scholarship in St. Mary's Orphanage, Shanghai, pledged for five years, through which one little girl baby may grow up in China to owe her knowledge of the Ministry of the Reconciliation to a little Christian maid in Missouri.

In closing, we would urge what was brought before you at the General Meeting last autumn, the need of an emergency fund. We have to look to our honorary memberships, representatives' dues and the offertories at our meetings, as the only sources of unappropriated money, and if from time to time our treasury could be strengthened by gifts, both large and small, our work could be greatly increased. Twice we have been called upon in cases of dire necessity, and twice our treasury has had no unappropriated funds. We know that the prostrating heat drives all who can leave away from the city, but we do not know what weary work it is to those to whom the appeal comes, to go to the home of one of our members after another and find it closed, when they know that upon them depends the relief of

the temporal wants, in the home of one of our Missionaries where the shadow of death is hovering. I do beg you not to leave this work another year to any one who may happen to be at home to do it.

CONSTITUTION OF THE MISSOURI BRANCH  
OF THE  
WOMAN'S AUXILIARY.

---

*Adopted May 25, 1888.*

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but by united and sympathetic action to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary, and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society; provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary and Treasurer, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

ARTICLE VII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

ARTICLE VIII.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

- i. Certification of her appointment by her Rector, or her election by the Parish Society to be such representative.
- ii. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

ARTICLE IX.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary member of the Board of Managers. These Honorary Members shall be entitled to seats but not to votes, and shall not be counted in making a quorum.



ARTICLE X.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be on the Friday following the Diocesan Convention.

ARTICLE XI.

One of the said meetings shall be also a general meeting of the Society. And shall be directed by the Bishop of the Diocese.

ARTICLE XII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIII.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XIV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York; and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board, shall receive and disburse all moneys sent to the Society for any Branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### ARTICLE XV.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### ARTICLE XVI.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
