## TWELFTH ANNUAL REPORT.

---

*To the Right Rev. D. S. Tuttle, D. D., Bishop of Missouri,  
and Members of the Woman's Auxiliary:*

If the day should ever come when missionary boxes are no longer needed, when our Missionaries are so well provided that no outside help is required, when guilds meet with busy brains, instead of busy hands—in short, when the first work of the Auxiliary is no longer a part of it, Missouri will stand very near the front as having made the money gifts the first feature of her work. Each year has seen an increase in our money report, but this year sees a decided decrease in our list of boxes. Boxes may not be the best help, but while they are being sent let them be good ones, and let us have our full share in that work which is so immediately under the Auxiliary direction. Our mode of working means a very just report. While we may over-estimate our boxes, and our gifts are apt to increase in value in just the proportion as we see them needed by others, the money can only have its face value, and when we report \$5,319.99 out of \$7,226.16 to be in money there cannot be many fictitious figures in our counting. We report one thousand dollars more than last year, but the increase has been from special gifts rather than from parish work. Indeed,

at one time it looked as if we would fall below the figures of several years past until a generous churchwoman sent the beautiful gift of \$1,000 for Missions in China. May manifold blessings be hers for the blessings her wealth gives to others. Another large gift has come. By the will of our late Vice-President a legacy of \$500 was left to the Missouri Branch of the Auxiliary. It is one of the very few legacies ever left to the Auxiliary, but it is an example to every member, whether she has much or little to leave, to make her Auxiliary work perpetual. Surely she rests from her labors, but her works follow her. It has been determined by the Board of Representatives that this fund be used in a special memorial gift to St. Stephen's Mission.

All the regular pledges of the year have been met, the two scholarships at the School of the Good Shepherd paid, our pledge of \$250 completed to the Church Missions House in New York, \$100 given to the Enrollment Fund at the Triennial Offering in Baltimore and a third \$1,000 paid on the All Saints' debt. This \$3,000 reduces the debt to \$6,000, the amount to which our late Bishop of the Diocese promised to those granting the loan that it should be reduced at an early day, and that was the sum it was the first intention to raise, but the real assistance it has proved to our colored people in the sympathy and upholding which they have not failed to see in this work has made it advisable in every way to continue it, and we have pledged another \$1,000, the first \$500 of which is due in July. A special effort must be made for the Mite Boxes, for we depend upon them to support one of our scholarships of \$200 per year, while this year the boxes have only brought in \$178. We fortunately had enough in our treasury

of unappropriated funds to meet the payment. Our general treasury must not be lost sight of. Our pledge of \$75 for Diocesan Missions and our expenses for printing and postage come from this, and we have only the representatives' dues with occasional gifts to replenish it.

At our autumn meeting Bishop Gilbert told of his work among the Scandinavians, and it was quite a Minnesota day, for our other visitor was Miss Carter, who told the story of her lace-workers. Seventy-five dollars was pledged for the support of two Indian girls in her home and a generous union box from all the parishes has been sent for the Hospital store-room. Mr. Pott came for our January meeting. The interest he aroused is well told in our gift of \$1,285.00 for his work.

The Missions Class met monthly during the winter. The attendance was not as large as might have been hoped, considering the excellence of some of the papers; but they have come before larger audiences, as several parishes held weekly missionary meetings during Lent, when a number of the papers were read, and a practical interest in all missionary subjects has been the result.

It was the privilege of a few of our women to attend the Auxiliary Triennial in Baltimore. The power and influence of that beautiful service has been felt throughout the land. It is customary for a united offering to be made at that meeting from all Branches of the Auxiliary. At the officers' meeting held in Baltimore it was determined to place before the Auxiliary, as the object of the United Offering in Minneapolis in 1895, the endowment of a Missionary Episcopate; this will need \$66,000.

When we realize that this endowment will save the Board of Missions \$3,300 each year, and will forever provide a Bishop for one of our dioceses, to carry such blessings as only a Bishop in this Apostolic Church of ours can carry, we surely will not fail to do our part.

CONSTITUTION OF THE MISSOURI BRANCH  
OF THE  
WOMAN'S AUXILIARY.

---

*Adopted May 25, 1888.*

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary, and Treasurer, to be chosen at the annual meeting.

#### ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society; provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

#### ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

#### ARTICLE VII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

#### ARTICLE VIII.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

#### ARTICLE IX.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

#### ARTICLE X.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be on the Friday following the Diocesan Convention.

#### ARTICLE XI.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### ARTICLE XII.

The meetings shall be held in any Church or Chapel designated by the President.

#### ARTICLE XIII.

Special meetings may be called by the President at the request of any five of the Managers.

#### ARTICLE XIV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York; and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board, shall receive and disburse all moneys sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### ARTICLE XV.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### ARTICLE XVI.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
