## THIRTEENTH ANNUAL REPORT.

---

*To the Right Rev. D. S. Tuttle, D. D., Bishop of Missouri,  
and Members of the Woman's Auxiliary:*

It would be strange indeed if our missionary work had escaped the troublous times which this year have menaced us financially at every turn. If the Auxiliary's sole object was to send money and boxes to missions, we might feel that we had retrograded, but fortunately prayers and interest and education in missions, while they do not appear in any written report, yet show themselves in many tangible ways, and in each of these we can certainly see progress. The increased attendance of our representatives at the meetings, and their earnestness in carrying on all the different lines of work are proofs of progress that cannot be overlooked. In spite of hard times our women have given generously. Almost every parish, and it has been particularly noticeable among the smaller ones, has held its own and many have gone ahead of last year. It must be remembered that last year we had two unusual gifts. The legacy of our late Vice-President, and the thousand dollar gift for China.

We report one line of our general work as ended. Our part of the payment of All Saints' debt is completed. Not only have

we given \$4,000.00 in four years to the colored work in our midst, but a feeling of sympathy and kindly interest has been engendered between the members of that parish and of the others working for it. We are only giving up the work now because with the increase of the value of property, the Bishop feels that this work can sustain itself, while we may render to another mission the same timely aid we have given All Saints'. As a proof that there was no lack of interest, when the last note was paid, it was found that we had \$51.75 more than was needed. This has been placed in bank to be used at the discretion of the Bishop towards the interest on the remaining debt.

St. Stephen's Mission is the new work we have undertaken, and we have pledged \$1,000.00 for the coming year. We can readily raise it. It is earnestly hoped that every name on the list of All Saints' subscribers, will be transferred to that of St. Stephen's, and much the same method of contributing will probably be adopted. The needs of St. Stephen's are unquestioned, the success under God lies with the Church people of St. Louis. Surely none of us will shirk our part of it, knowing, as we do, that great as their needs are, St. Stephen's representatives, as was the case with All Saints', work with us in the Auxiliary Board and never fail to have a part in any work we undertake.

Our President has made two missionary journeys in the Diocese, and established a branch in Jefferson City and re-organized the work at Hannibal, which heretofore has been largely individual, and which promises work in the coming year.

Another valuable adjunct to our work has been found in the Cathedral Guild of St. Mary for Ecclesiastical Embroidery. While not especially established for Auxiliary work, it has given material aid in the making of priestly garments and adornments for the sanctuary.

One of our representatives, Mrs. Mackay of Palmyra, has laid down the burden of pain which she so patiently bore and has entered "into the joy of her Lord." Not many of us had the privilege of knowing her, as she could only come to our annual meetings, but in her own parish the loss will be very great.

All of our regular obligations have been met, the scholarships, diocesan pledge, and we had a part in the great Thanksoffering made by the women for the Missions House. They practically showed their joy by sending out and sustaining two women missionaries to China and Alaska.

We have had the privilege of visits from the Archbishop of Zante, Bishop Hale, Bishop Brooke and Bishop Barker, the last named coming for our Quiet Day. And each Bishop's purse grew a little heavier with the signs of our appreciation of his zeal and earnestness. It is a little message of love we have sent to the foundation shaken little isle in the Mediterranean, to the miner's camp of Western Colorado, to those who most truly compose our Domestic Missions, the Indians, and to our neighbor, the Bishop of Cairo. Truly we must realize that the field is the world.

The Missions Class held its regular sessions at the Schuyler Memorial House. There was some variation from our old methods in having two afternoons conducted by Bishops. The work in Oklahoma was the subject of Bishop Brooke's talk and Bishop Hale spoke on the Greek Church and our mission work in Greece. The class is a distinctive feature of the work in Missouri, and has proved a source of education and inspiration to us all.

The appeals have been many and we have met every one. From sufferers from fire and flood, from pestilence, and for the relief of the suffering bodies of men. We have aided in the building of a new surgical ward in St. Mark's Hospital, Salt Lake, and, as a sign of better things to come, we have in the last month given \$150. towards the current expenses of St. Stephen's. But a word of caution is necessary lest we forsake the old work for the new. While we have readily aided in all these appeals the contents of our mite boxes have greatly decreased. This year we only report \$122, a falling off of nearly one hundred dollars since our first year.

The United Offering is growing, though we yet lack a great deal to complete the \$1,000, which we hope will be Missouri's part.

The Noonday prayer, which is so urged by the Board of Missions, has certainly gained favor among us, and more and more are learning at noon tide, to close our eyes to the light of day, to behold the Sun of Righteousness while our hearts send up the cry, Thy Kingdom Come.

Greater by far than the financial loss of the year is that we are to sustain in the resignation of our faithful treasurer. It is only a keen sense of the undue tax it would be upon her already much occupied time, that at all reconciles us to giving her up. Her graciousness has made it a privilege to each one of us to work with her, while her careful reports and well kept books tell better than any words of ours, how great the loss will be.

CONSTITUTION OF THE MISSOURI BRANCH  
OF THE  
WOMAN'S AUXILIARY.

---

*Adopted May 25, 1888.*

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary, and Treasurer, to be chosen at the annual meeting.



#### ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society; provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

#### ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurer of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

#### ARTICLE VII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

#### ARTICLE VIII.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

#### ARTICLE IX.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

#### ARTICLE X.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be on the Friday following the Diocesan Convention.

#### ARTICLE XI.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### ARTICLE XII.

The meetings shall be held in any Church or Chapel designated by the President.

#### ARTICLE XIII.

Special meetings may be called by the President at the request of any five of the Managers.

#### ARTICLE XIV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York; and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### ARTICLE XV.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### ARTICLE XVI.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
