## FOURTEENTH ANNUAL REPORT.

---

*To the Right Rev. D. S. Tuttle, D. D., Bishop of Missouri,  
and Members of the Woman's Auxiliary:*

"The woman who sets ten other women to work does more than the one who does the work of ten women." So says our Bishop, and it would seem in going over the parish reports that in this year, when the financial depression has been felt even more than a year ago, that the women of the Auxiliary have surely set other women to work, and at the same time some have done the work of ten themselves. Twice ten of them, under one who does the work of many, have raised \$1,000, the amount of our pledge for the current expenses of St. Stephen's for the year. But lest we take too much credit to ourselves, it must be understood that the Auxiliary members in the Mission raised one-tenth among their own people.

All our pledges have been met for the year. Our advances have been in establishing a branch of the Church Periodical Club, which has already met with success under the direction of Miss Allen and Mrs. Thomson. Seventy-two magazines and papers are now regularly passed on to give the same pleasure in other households that the subscribers have had. A Missionary Reference Library has been started, with its headquarters in the Diocesan Library at the Schuyler House. It is an humble

beginning of what may in time be a valuable adjunct to the work. Here will be kept the missionary periodicals, the publications of the Missions House, and papers that can be gathered, for use at missionary teas, or readings at Guild meetings. To make it the power and help it ought to be, some money must be raised and gifts of suitable books will be most welcome.

New branches have been formed in Louisiana, Prairieville and Clarksville, and in the Girls' Friendly Society, and work systematically begun with the mite boxes and in an interest in the United Offering, which has been proved in the gift of two shining gold pieces from the Girls' Friendly.

With the thought of giving a more definite idea of membership in our branch of the Auxiliary, we have had this year a membership card, containing the noonday prayer for missions, the list of meetings for the year, a space for the members name, which is filled out by the parish Secretary, and a text for guidance in our work. From the parishes reporting the distribution of these we think that about 500 have been given out to "women who, by their prayers, labors or gifts, aid in the Auxiliary work."

It was determined at our last annual meeting to purchase the organ then in use in the church of the Holy Communion, for St. Stephen's, using the legacy of our Vice-President, Mrs. Lackland, for it. The purchase has been made and the organ stored away, against the time, which we hope is not far distant, when this mission will have its own abiding place, when the remainder of the legacy will be sufficient to put the instrument in order and in its proper place.

Through your kindness the President and Secretary had the privilege of attending the Missionary Council at Hartford. An inspiration it was to them for missionary zeal, and through them we hope to you as well.

Our spiritual life has been quickened and our intelligence broadened for our work, by visits from Bishop Hare at our autumn meeting; the President of the Chicago branch, Mrs. Ward, at our January meeting; by the Rev. Mr. Davis, who conducted one of our Mission Classes, and the Rev. Mr. Tuckerman, who conducted the Quiet Day, and our Bishop, who gave the instruction at the service held in conjunction with the Quiet Day in New York, May 22d.

Outside our regular gifts in boxes, scholarships and Diocesan pledges, we have set before us the United Offering for the Triennial meeting in Minneapolis next October. We have worked systematically for nearly three years, but it is feared that some women have themselves given the three dollars they pledged themselves to try to raise each year instead of letting others have a part with them. The time is very short now, and we will soon be scattering for the summer and unless we make haste a few of us, 200 perhaps, will keep that privilege all to ourselves instead of letting every woman whom we can reach help us to make what we said the gift should be, a United Offering of the women of the Church. Some of our gifts have represented actual toil to earn the amount that could not otherwise be spared, and some of the penny-a-week savings have cost a greater sacrifice than many of us are willing to make. Is

\$1,000 too high a standard to set for Missouri's share? Only a little over \$500 have been sent in thus far, and there must be many blessed with a goodly portion of this world's goods, who either have not as yet had this presented to them, or else are waiting to gather up a larger gift before the time draws nigh.

Our Auxiliary is growing, perhaps not this year in figures. We have gone back a very little. The reason is plain. Retrenchment has been the rule everywhere, and parish claims have been great, but we are learning more each year, and the day has gone by when people ask what the Auxiliary is. They know it is composed of the women who are made responsible by their Rectors and Guilds for a large part of the missionary work outside the parish bounds, the four women who set the forty women to work in their parish, and who humbly ask each day, "That we may do all such good works as Thou hast prepared for us to walk in."

CONSTITUTION OF THE MISSOURI BRANCH  
OF THE  
WOMAN'S AUXILIARY.

---

*Adopted May 25, 1888.*

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary, and Treasurer, to be chosen at the annual meeting.

#### ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society; provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

#### ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurer of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

#### ARTICLE VII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

#### ARTICLE VIII.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

#### ARTICLE IX.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

#### ARTICLE X.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be on the Friday following the Diocesan Convention.

#### ARTICLE XI.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### ARTICLE XII.

The meetings shall be held in any Church or Chapel designated by the President.

#### ARTICLE XIII.

Special meetings may be called by the President at the request of any five of the Managers.

#### ARTICLE XIV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York; and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### ARTICLE XV.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### ARTICLE XVI.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
