FIFTEENTH ANNUAL REPORT.

To the Right Rev. Daniel S. Tuttle, S. T. D., Bishop of Missouri, and Members of the Woman's Auxiliary:

In making the fifteenth annual report of the Missouri Branch of the Woman's Auxiliary, one is conscious of the monotony of repetition. The oft-repeated story grows wearisome. We can only hope to avoid it because we are telling of God's blessings, which are new every morning, with a zeal that never flags and an enthusiasm that never tires. One secretary has well expressed what we have all felt when she said, "As there is no monotony to us in the order of the universe, the natural succession of days and nights, so there should be none in the spiritual order, the reasonable service of men and women in the household of God."

Our blessings and our privileges have been multiplied this year. No wonder there is a great stride forward in the work. The General Convention meeting in the West made it possible for fifteen of our women to attend, and fifteen women have come back with a knowledge of the work and an enthusiasm that can only come from contact with other minds that are doing successfully the work we are striving to do. No woman who has ever attended the Triennial meeting of the Auxiliary would ever willingly forego another. She learns there the spiritual side of our practical work, with an ever-increasing thankfulness for the privilege of having a share in the hastening of the Kingdom. No woman who saw that great United Offering laid on God's altar that glorious autumn day in St. Paul, will ever say that the

work is monotonous, and a report would have to be dull indeed for her not to be interested in hearing what the women will next undertake.

As you all know, we contributed \$1,175 towards that Offering. We went far beyond what the most sanguine of us had hoped for, and it was said to represent a larger proportion of our women than that of almost any diocese. A systematic plan has been arranged for the gathering of the offering for 1898, which we hope every woman will adopt. The object is the education and support of women missionaries, and must appeal to every one of us.

Those of you who did not attend the Triennial had a very good part of it at our autumn meeting when the Bishop of China, the Bishop of Delaware and the Secretary of the Board of Missions, Dr. Langford, were our guests. Later on, the Bishop of Alaska came to us on his way to that new country. We looked to help him and give him courage, but rather, both he and Bishop Graves, leaving home and kindred and all that we hold dear, came to us and departing left a blessing behind them. Recently the Bishop of North Dakota has been with us. It was not a propitious time for a meeting, being Easter week, but he preached in several of the churches, giving an account of his missionary field. Notice has been drawn to the fact that, by some oversight, North Dakota is the only missionary jurisdiction that has not been helped by our branch of the Auxiliary. Personal gifts from individual members Bishop Walker has had, but it is hoped that this oversight will be rectified at our meeting to-day.

The Rev. Mr. Forrester conducted one of our Missions classes, and threw much light upon what has heretofore been a very dark subject to most of us, the work in Mexico. Our Presi-

dent's recent visit there will arouse a still deeper interest in all who can hear her speak of her journey. There is a hope that Mrs. Tuttle will write a little sketch of what she heard and saw of the Church in Mexico.

With the deepest gratitude we report that our Quiet Day was given by the Rev. Mr. Davis of the Cathedral. The clergyman who had been invited to conduct it, two days before the appointed time telegraphed his inability to come on account of illness. At first there seemed nothing to do but to abandon the day, but most generously Mr. Davis acceded to our request to supply the place, and gave us one of the most helpful, spiritual days we have ever had. And we have discovered that we need not always seek abroad for help, but can find it at our own doors.

A circular from the Missions Home, in March, announced the solemn fact that five of our sister officers in the Auxiliary had entered into rest since the beginning of the new year, and urging upon the branches the necessity of increasing the interest in the junior work, in order that when our busy brains and hands are quiet there may be trained workers ready to take our places. After mature deliberation among the officers it has been decided that with the Missionary Host, an older organization than even the Woman's Auxiliary, it would not be well at this time to start another enterprise. At the quarterly meeting in April it was suggested that the Auxiliary recommend to the officers of the Missionary Host the adoption of some teaching in regard to the Missions of the Church on the Sunday upon which the offering is made, or at least quarterly. Such instruction to be given by the Rector, Superintendent or some one appointed by him. It would broaden the motive beyond money getting, and awaken in the child mind an interest in the heroes of the Church.

An admirable set of papers is now being published by the Auxiliary to meet this very demand. They could be used as an outline for this instruction and also for advanced Sunday-school classes or guilds. Our President has subscribed for these and will gladly furnish them to any school or class that will take up the study.

We have spoken of an increase in our work; the reports of parishes and special treasurers will tell you more of this. There has been a vast increase in interest, knowledge and enthusiasm. This has partly been gained through a closer contact of the officers with the parish guilds. Through the courtesy of the Dean of the Northern Convocation the Secretary has made two journeys in the diocese, at the time of the autumn and spring Convocations, and every town but one where there is a branch of the Auxiliary has been visited, and a meeting held for the women. It is the only way we can further the work in the diocese. So far the expenses have been met personally or by the Convocation, and yet it seems as if that should come from our general treasury. Our parish representatives in the country pay the same dues as those in the city, and yet we have all the privileges of meetings for consultation and the inspiration from visiting speakers. It is possible for only a very few to travel to the city for our meetings, for our diocese is large and the distances great. Can we not arrange for the coming year that one officer shall visit our distant branches once during the year? By planning a visitation something on the order of the Bishop's, several places on one line of railroad can be reached in one journey, thus lessening the expense.

Thanks are due the officials of the Burlington and the Wabash roads for their kindness in giving half-fare tickets. Good meetings were held everywhere; the clergy were most cordial, and

the hospitality of the church people unbounded, while the growth in intelligence in the work can hardly be estimated. All the officers have had a part in this work. The President has visited six guilds and established a new branch at Rolla, the Custodian of Mite Boxes two guilds, the Treasurer of the United Offering two, the Secretary nineteen.

There has been manifested an increasing care for a reverent worship, in our boxes containing this year, one solid silver communion service, one set of altar linen, two surplices, four stoles, one altar cloth, one altar service book, one set of vestments and one cassock.

All our regular pledges have been met, and \$871.67 has been given to those who have come to us during the winter to help our work. A word of caution might be said lest the tendency to forsake the old work for the new grow upon us. The United Offering is most interesting, and as a general work appeals perhaps more strongly to us than the mite boxes. But we are pledged to our \$200 for the scholarship, and grave fears have been felt lest we should not meet it, and it is only by calling upon the general treasury that we have made up the amount.

There seems no better time to speak of a very practical subject than this. It is in regard to the making out of reports. It is a matter of deep regret that there should be such misunderstanding in regard to them. Some could be obviated by a careful reading of Article III., of our Constitution, which says that one of the four Representatives shall be the Corresponding Secretary. No one else can so well understand what constitutes Auxiliary work, and these four are the only ones known to the Secretary and Treasurer, with whom there must always be some correspondence. Then a care in both taking and giving receipts

for all money for Auxiliary objects, and a file of these receipts kept till the time of making up the reports, and still further a careful reading of what the report calls for and the proper place in the blank in which to insert it. It is the most painful, as well as the most arduous task the Secretary has, to correct the reports of women who in years, experience or efficiency are her superiors. In the month of May she becomes your evil genius, and pursues you at all times, with what must be to you the merest trifles, yet she in her turn must report each one of these items to the General Secretary, and the reflection falls upon the whole branch, as well as upon her if she fails in her part. Promptness too, must be kept in mind. And when the many notes and postal cards are received, will you try to remember that just as often it is to say that the Secretary has added some forgotten item, which increases your report, as to say she has stricken off one that seemed beyond the Auxiliary lines.

The work is no child's play. Bishop Nichols knew that, when he told us in St. Paul at our Triennial that "it takes love, and patience and faith, but it gives all three."

CONSTITUTION OF THE MISSOURI BRANCH
OF THE
WOMAN'S AUXILIARY.

Adopted May 25, 1888.

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary, and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society; provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurer of Special Funds, and the Parish Representatives. Nine shall constitute a *quorum* for the transaction of business.

ARTICLE VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary, and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings to appropriate funds in the hands of the Treasurer.

ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.

3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York; and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

ARTICLE XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
