## SIXTEENTH ANNUAL REPORT.

---

*To the Rt. Rev. Daniel S. Tuttle, S. T. D., Bishop of Missouri,  
and Members of the Woman's Auxiliary:*

With the horror, and almost the storm clouds themselves, of the never-to-be-forgotten 27th of May still hovering over us, we held our last annual meeting May 29. About one hundred women, impelled thither many of us with the hope that some organized help could be given to the members of our Churches in distress, gathered for the Holy Communion, and to ask help and guidance for the work. And so this year's report gives, besides the boxes for our Missionaries and the usual Missionary gifts, the report of the money for the restoration of our Churches and material help for our friends in their necessity. A committee was formed with one woman from each parish, and for three weeks constant work was done among the sufferers. Each parish report gives the amount of money donated and the value of new clothing, and besides this about 1000 bales of half-worn clothing, were distributed through appointed helpers at St. Stephen's, St. John's, Mount Calvary, the Bethesda Home and St. Mary's Church, East St. Louis. The cases were all investigated, and we know the help was given where it was needed, and in many cases the love and tact shown by the distributors and the gentle dignity of those who were ministered unto made the work a real privilege and blessing. It sometimes takes a crisis to bring out the best in human nature, and the readiness

with which every call was responded to, and the cheerful self-forgetfulness with which the women either went through that stricken district in those long, sultry days, or else prepared garments for others to distribute, proved the love and loyalty of these women to their Master, "Who went about doing good." Our President, with her busy and ready pen, sent letters to friends in the East telling of the distress, and in reply she had \$1,300 to divide among the stricken Churches towards restoration. Several hundreds of this came from sister branches of the Auxiliary, from Chicago, \$100, from Connecticut, \$350, from Massachusetts, \$200. The fund was divided as follows: Mount Calvary, \$600; St. John's, \$600; All Saints', \$100. As a Branch of the Auxiliary, we are glad to publicly express our gratitude for this material help, as well as for the expressions of sympathy we received.

Although at our annual meeting our thoughts were particularly for our suffering friends, \$200 was pledged for two of our city missions, St. Philip's and Epiphany, and \$100 for work in North Dakota, one pledge for the last coming from the branch at Mt. Calvary, whose church building no longer existed.

Our winter's work has been in the usual lines. Columbia has been added to our list, so that this year every parish in the diocese has been at work, and the mission at Canton has also been added. We can therefore grow but little hereafter, as far as branches are concerned, but very much in increased interest and activity. Another scholarship, known as the Anna B. Hayman scholarship, in honor of a faithful teacher, has been begun at Bishop Robertson Hall, through Miss Jaminet. We have become responsible for the support of two Mexican girls, at All Saints' Hospital, Indian Territory.



They are from the Orphanage in the City of Mexico, and are to take the course for trained nurses and afterwards to return to their native city to carry on their work. After an earnest address at our January meeting by Dr. May Forsythe, Superintendent of this Hospital, at South McAlester, I. T., a gift of \$200 was sent for her work, and the same amount sent to Miss Carter's lace school at Leech Lake, under Miss Colby, which had been destroyed by fire in the winter.

The Special Treasurer's reports are all encouraging, though our general treasury has been taxed a little more heavily than before for the scholarship, which is partly paid by the Mite Boxes. We had only \$152 this year, against \$171 last year. The interest in the United Offering is unflagging. Running as it does for only three years and being the one work in which all the dioceses unite, gives it a place that nothing else can encroach upon. This year's offerings have exceeded last and we are always sure of increased interest the year the offering is made. Our greatest work has been the \$1,000 for St. Stephen's Current Expenses. All praise and gratitude is due the parish collectors for making it possible for us to redeem the Auxiliary pledge. Of their faithful service we have had the best proof. The hope of a permanent home for St. Stephen's in the near future will put the pledge on a different basis after the coming year, or may make it no longer necessary, but it has been of such inestimable help that we can but hope it will be continued as long as it is needed.

The Church Periodical Club continues its good work of supplying reading matter to our missionaries. With the luxury of libraries in our midst we can hardly imagine the pleasure of a new book or magazine to those who are away from books and book-loving people, and how can the missionary

keep abreast with the times without these aids or the money to buy them? This work is in the hands of an efficient committee and we recommend it to you all.

Our solicitor for the *Spirit of Missions* has added twenty-seven names to the subscribers' list, which must be a great help to our work. The recent numbers of this magazine have been most interesting and the reading of it can not be looked upon as a duty but as a real pleasure.

Three Missions Classes have been held; the attendance not always commensurate with the time and thought expended upon the papers, but those in charge of the Parish Missionary Teas have pressed the good women into service and the papers have been re-read at several of them. The officers hold themselves in readiness to visit parish branches and give missionary talks or explain the work whenever it is desired. Over thirty such visits have been made this year in and near the city. It has not been possible to reach any of our more distant branches. As a Branch we were all fortunate enough to hear Miss Emery at our autumn meeting and gather the help and inspiration she always gives.

Our spiritual life was quickened by the Quiet Day conducted by Bishop Gailor. Our Quiet Day has become one of our greatest privileges in this age when the active life so crowds out contemplation.

This year has given us the Hand-book of the Auxiliary, compiled by Mrs. Twing, with a history of the Auxiliary for the twenty-five years of its existence. It is full and suggestive and must be most valuable to all Auxiliary workers, and its moderate price puts it within the reach of all.

The weakest point of our work this year has been the non-attendance of our parish representatives at our meetings. In



the roll call it is most disheartening to have a long silence follow so many of the names. It seems as if it might be a lack of interest that deters them, and it makes the responsibility of pledges fall heavily upon the representatives who are in their places. A little more care perhaps, in appointing the representatives might help out. The thought that we have been selected to lead the other women in our parishes in missionary work and intelligence may impress the responsibility of our office upon us, and make us eager to grasp every opportunity for adding to our little store of such knowledge. The Missionary Councils and General Conventions are our greatest schools for this education. It seemed unfortunate that only two of our women were able to attend the last Council which met so near us in Cincinnati. Next October it meets in Milwaukee, again very near us, and it is hoped that more women will avail themselves of the privilege of it.

The summary of the year's work is given below and the parish reports show how varied the work has been, though the figures have fallen a trifle below those of last year. How hard the year has been most of us can testify, but at no time has a more loving loyalty been given to all our undertakings, and the results are not ours—they belong to God.

CONSTITUTION OF THE MISSOURI BRANCH  
OF THE  
WOMAN'S AUXILIARY.

---

*Adopted May 25, 1888.*

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary, and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society; provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurer of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

ARTICLE VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings to appropriate funds in the hands of the Treasurer.

ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary,

ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.



2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.
4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies, Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

ARTICLE XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
