SEVENTEENTH ANNUAL REPORT.

*To the Rt. Rev. D. S. Tuttle, S. T. D., Bishop of Missouri,
and Members of the Womans' Auxiliary:*

Another year I have the honor to report to you the missionary work of the women of the Diocese of Missouri.

At the great meeting of the Society for the Propagation of the Gospel, held in London last summer, one of the English Bishops prefaced his remarks by saying, "In the forward movement of this age few can fail to note the growth in idea and application of Woman's Mission and Work in the Kingdom of our Lord." He continues: "Twenty-two years ago I read a paper somewhat in a tone of apology and vindication for the right and necessity of women to be duly represented in the Mission field of the Church. Now it is everywhere recognized that a mission can not be fully organized, even in its early days, without women on its staff of workers." That the work of women is thus recognized is a help and encouragement to every woman who has a part in building up our mission work, to spread the Light of the Gospel throughout the world. In our American Church, the Board of Missions, was quicker to perceive the power of woman's work, and for twenty-seven years our women have worked systematically for

missions under the title of the Woman's Auxiliary. For seventeen years the women of Missouri have carried on the organized work in our diocese. The growth has been slow, perhaps, but steady. There has never been a backward step. Once or twice some large special gift has augmented our treasury, but the parish work has been a steady, quiet growth. We had misgivings this year that the peculiar trials that sickness had brought to many of our parishes would lessen our gifts, and there have been no large gifts, one hundred dollars being the largest, but the success of systematic effort has been proved. Aside from the cyclone fund, for which we made a special report, our gifts are about one hundred dollars in excess of last year. The praise for this is justly due and gladly given to the parish representatives on whom the responsibility largely falls.

Some details of our year's work are here given:

We have had addresses this year at our meetings from Dr. Langford a year ago to-day, and Bishop Brooke and Mr. Francis at our autumn meeting. Our own Bishop has given us his valuable time, not only for our meetings, but conducted our Quiet Day, for which we are most grateful.

Three general Missions Classes have been held this year. We aim, now, to keep abreast with missionary and Church intelligence through this channel. Our topics this year were the "Missionary Council in Milwaukee," the "Lambeth Conference," which afternoon was conducted by our Bishop, and the "Woman's Meetings in London held in connection with the Conference." This was conducted by our President, who brought home many valuable reports and made the afternoon not only instructive but delightful with the personal touches added to the proceedings of these meetings. Mrs. Tuttle's paper, as well as those on the Council, have been repeated in

Parish Guilds. Thirty visits have been made and talks given at Missionary Teas by those who had papers at the classes. These Missionary Teas are a helpful institution, and we commend them to all parishes where the missionary spirit needs to be strengthened. They bring the women together for a social gathering while they learn about some special line of our missionary work, and bring a small but steady revenue to the parish treasury. And, what is best of all to us officers, it brings us into closer relation with the parish workers.

In January we saw our cherished hope realized in the permanent home for St. Stephen's Mission. Our mid-winter meeting was held there, and we had a little glimpse of what its usefulness can be in its enlarged quarters. But it will take much money to carry it on, and our \$1,000 is needed more to-day than when St. Stephen's was in small rented rooms. Go to St. Stephen's, every woman of the Auxiliary, either to a service, or sewing school, a mothers' meeting or an evening class for young women, and perhaps the \$1,000 we pledge annually for the work may come a little more readily. Daily the peal of bells makes almost the only sweet sound in this crowded, busy section of our city. It is a daily call to a higher life, a little louder sometimes, perhaps, than the voice of conscience. These bells have been placed in St. Stephen's by the Woman's Auxiliary, having been purchased with the legacy of our late Vice-President, Mrs. R. J. Lackland, and are a memorial to her.

For nearly three years we have sent in Birthday, Memorial and Thank Offerings, which are to make up the United Offering of the women at the Triennial Meeting in Washington, October 6th. Unfortunately we do not know exactly how many women have contributed, but there must be some who have not, for the sum only reaches, as yet, \$800. Surely to all of us

have come some blessings in these three years, and will not every Church woman in acknowledgment of one blessing make an offering to this fund? It goes to train and support our women missionaries. If the call has not come to each of us to go ourselves to the work, the responsibility is no less ours in sending others. Let every woman desire to have a part in what is to be a United Offering of the women of the Church and send her gift before September 1st.

At the request of the Rural Dean, the Secretary attended the convocation at Hannibal, in April, and continued her missionary journey to Palmyra, Monroe and Louisiana. Each of these places is bravely working for the Auxiliary in spite of home needs pressing heavily. In the midst of such a missionary field as Missouri, we must often hear the cry for Home Missions longer and louder than any other. Missouri has always received help from abroad, but we must bear in our hearts that the field is the world, and that "as we enter into the works of other men, so other men will enter into ours." It has been said "there are Missions of *recovery* as well as Missions of *discovery*." Our own diocese comprises the two. Many counties are as yet without a service, while in our midst, in our own city work, particularly Missions of recovery, must always go on. Towards this end we have worked and given. We have made many hearts happy in repairing the little Church of the Holy Comforter at Montgomery City, which, after being closed for two years, is now to be re-opened. We have aided the good work at Oak Hill by contributing \$186 towards building a much needed guild room. On Ascension Day the hospitable women at Holy Innocents' invited all the parish representatives to a Missionary Tea in the new rooms, and to listen to a paper by the Rector, the Rev. Mr. Cornell, on the early work of Bishop

Kemper, of this diocese. A large number availed themselves of the invitation and we had a delightful afternoon. It is not often that we are able to see such direct results for good as this gift has brought, the blessing is, therefore, more ours than those whom we aided.

It is with deep regret that we record for the last time the Bishop Robertson Scholarship, which was begun twelve years ago by a graduate of Bishop Robertson Hall, our former Vice-President, Mrs. Cushing, and has been sustained by the Alumnae for some years. It has been an aid to our Bishop in enabling him to offer to a missionary this supplement to a meagre salary, the education of one of his daughters. It has given five young women the opportunity to make themselves self-supporting, and it has kept a name before us which should be dear to every Church woman in Missouri. We earnestly hope the Alumnae may see fit to take up this work again. The pecuniary assistance to their *Alma Mater* is not to be lost sight of, and it will be in every way the greatest loss we have ever had. The five year scholarship at St. Mary's Orphanage, Shanghai, has been completed.

Our gifts have gone into every branch of Auxiliary work. Alaska, Mexico, the Indian, the Negro, our Missionary jurisdictions, our own Diocese, as well as the lands beyond the sea, have been aided by the women of Missouri. Much of this has come from the intelligence born of Auxiliary teaching, much more from the prayers which our women offer daily for the coming of the Kingdom. To our individual prayers we may trust that an added blessing is given in the intercessions for Missions which are offered daily at noon at the Cathedral. Once a month the Auxiliary Officers at their Conference attend this service. Almost every day some member of the Auxiliary adds her petitions to those of the priest. In every way we

endeavor to emphasize the spiritual side of the work. If the prayers are offered, the intelligence and interest aroused, the gifts will follow. More and more earnestly must we breathe the prayer—

“Oh, make Thy Church, dear Savior,
A lamp of purest gold,
To bear before the Nations
Thy true Light as of old.
Oh, teach Thy wand’ring pilgrims
By this their path to trace,
’Till clouds and darkness ended
They see Thee face to face.”

CONSTITUTION OF THE MISSOURI BRANCH
OF THE
WOMAN'S AUXILIARY.

Adopted May 25, 1888.

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

ARTICLE VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.

2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.
4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions, and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies, Missionary intelligence, and to endeavor in every way to increase an interest and prayerful interest in Missions.

ARTICLE XVII.

This constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
