## EIGHTEENTH ANNUAL REPORT.

---

*To the Rt. Rev. D. S. Tuttle, S. T. D., Bishop of Missouri, and  
Members of the Missionary Branch of the Woman's  
Auxiliary:*

It was our Bishop who said in the opening sermon before the General Convention in Washington, that "Missions were the elementary alphabet as well as the grandest epic poem of the Church." It would be well, then, that every endeavor be made that Churchmen should have the key to this knowledge, to help them to progress beyond this alphabet, which must always be monotonous. If we look back to our childhood days, we may recollect that nothing has ever been so hard to master as the alphabet. Once passing beyond that, with new combinations of letters, there seems no end to the variety to fill our minds, and some are fired with ambition to read, and occasionally one to write, the grand epic poems of the world. If we get beyond the rudiments of the alphabet of Missions, just such new interests await us. The lives of some of our Missionaries are the epic poems, which are only written in the Lamb's Book of Life, and who would not desire to know more of them?

The members of the Auxiliary Missions Classes are striving to get beyond the rudiments of the alphabet of Missions. It was a joy in the Auxiliary meetings in Washington, to know that our Missouri classes were regarded as the most successful. There was no topic of which our officers were oftener asked to tell than this. Our programmes have been sent to many



Dioceses, and many Parish, as well as Diocesan, Classes have been inaugurated on our lines. We cannot help wishing there might be a better attendance at our own classes, and yet we hope that the work and care of preparation of papers is repaid, because many are reached in the repetition of the papers before the Parish Guilds. Our Missions Classes seem to stamp our individuality as a Diocesan Branch.

Last October, the United Offering which represented our thank-offerings for mercies in the three years past, was taken to Washington, and laid upon God's altar at the grand Triennial Service. That meeting stands for inspiration and intelligence in Missions beyond anything the American Church has yet seen. Our gift of \$1,238.84 helped to make that great one of \$84,000.00 to send trained women workers into our missionary fields. We hoped that with that gift some woman might offer *herself*, the highest and best gift. Since then, several have entered our training schools, with the purpose of becoming Missionaries. Comparisons are not agreeable, and yet have their force. Bishop Graves stated last October, that the sects had sent 600 women into the field in China. Shall we not hang our heads to know that we have sent *six*?

The question of the continuance of the Bishop Robertson Scholarship again confronts us. When it was abandoned, a year ago, by the Alumnae of Bishop Robertson Hall, two of our members from the Church of the Holy Communion made themselves responsible for it, except \$50.00 pledged by the Alumnae. The memory of Bishop Robertson is too dear to our hearts for us to lay aside this work, small though it is, that bears his name. Will you see to it that it is carried on?



During the winter, there was some anxiety lest the Mite Boxes might fall behind so seriously as to affect our Auxiliary Scholarship. They came in well at the last, showing a systematic method of filling them, and reached the sum of \$185.18, and it is probable that if a little more care had been taken in gathering them up, there would have been no difficulty in our having the full \$200.00 by May 1st.

Our greatest problem each year, is to devise some plan by which the fund for St. Stephen's current expenses may be raised, without waiting for an alarm at the end of the year, that it cannot be met. We always do meet it, and from about the same sources. We thought we had gone forward a step when we paid our first hundred last June; but then came months of waiting before any more was paid. Perhaps the treasurer of the Missionary Board is too lenient with us. The word of the Auxiliary is so good that he advances it, and waits our pleasure to reimburse his treasury. Another year, might we not arrange to have certain Parishes pay their pledges in certain months, or half in summer and half in winter. It would mean going over the books very carefully to apportion this, but it would obviate much trouble, and save us from confronting the quarterly meetings with this fund always in arrears. Our confidence in the special treasurer assures us it will always be paid, but we are not helping her to do it as we might.

Since our increased responsibilities have come towards the Spanish speaking people, the presiding Bishop made a request that the work among them be pushed with more earnestness. A circular letter was issued in New York, asking that a special officer be appointed to represent this work in the Auxiliary. Miss Parker has been appointed by the Bishop for this Diocese.



St. Louis being called the business gateway to Mexico, shall we not make it a spiritual gateway as well?

In the year past, three of our Parish representatives have entered into that "rest that remaineth for the people of God," Mrs. Ingraham of Grace Church, Mrs. Delano of Ironton, and Mrs. Boswell of the Church of the Redeemer. Shall we not think for ourselves, and in this, hear the Master's warning, "Be ye also ready."

In recounting our blessings, shall we not think first of those who have come to help us this year. Bishop Atwill, Bishop Morrison, and, last, Bishop Rowe. These have long ago forgotten the drudgery of the alphabet of Missions. What a realizing sense of the divine guidance of the Church must we feel in the wise choice of Bishop Rowe for Alaska, and the opportune season at which he was sent. He will be one of the heroes in the epic poem of American Missions. For our spiritual refreshment, Dr. Stone, of Chicago, gave a most helpful Quiet Day, and *eighteen* of our Missouri Church women attended the Woman's Auxiliary Triennial Meeting, in Washington.

A great blessing is in store for us; let us prepare to receive it. In October next, the Missionary Council is to be held in St. Louis, the first general Church gathering we have ever had. It will mean such inspiration and knowledge as we have never dreamt of. Clear away every obstacle in your power that might deter you from attending every meeting, open your houses to receive the guests that are coming to us, the Bishops, many Clergymen, and Diocesan officers of the Woman's Auxiliary. Learn their methods and experiences, and by their intelligence in Missionary matters, and by their love of the work, "Study to show ourselves approved unto God, workmen that need not to be ashamed."



In closing may I be pardoned a personal word. For the second time in eighteen years I shall not be with you for the Annual Meeting. My thanks are yours for the God speed you have given me, in the care and promptness with which many of you have filled out your blanks, as well as for the loving words which accompanied so many of them. They have made me thankful for the privilege of being your Secretary all these years, and for the bond of personal interest it has engendered with many of you. You will, therefore, be patient with any errors that may have crept in, in these hurried last days, as well as with my persistent endeavors sometimes in tracing the exact lines of certain gifts.

Mrs. White, our Treasurer, having kindly offered to carry on my work during the summer, I would ask that all correspondence be addressed to her till September 15th, next.

My heart and my thoughts will be with you, and my prayers for your welfare and guidance. May I ask that at this meeting, and for the week following, you will bear me in your hearts, and commend me to the care of a loving Father through the perils of the great deep.

The method for gathering the United Offering adopted by our Branch of the Woman's Auxiliary, is as follows:

"That every Churchwoman be asked to make a thank offering on her birthday, or any family anniversary she may choose, the amounts to be sent to the Representative in her Parish, who acts as Treasurer. Quarterly returns should be made to the Treasurer of the United Offering."

CONSTITUTION OF THE MISSOURI BRANCH  
OF THE  
WOMAN'S AUXILIARY.

*Adopted May 25, 1888.*

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

ARTICLE VII.

There shall be an Executive Committee, composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.



ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.

3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York, and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies, Missionary intelligence, and to endeavor in every way to increase an interest and prayerful interest in Missions.

#### ARTICLE XVII.

This constitution may be altered or amended at any annual meetings by a two-thirds vote of the members of the Board of Managers present.
