NINETEENTH ANNUAL REPORT.

*To the Rt. Rev. D. S. Tuttle, S. T. D., Bishop of Missouri, and
Members of the Missouri Branch of the Woman's
Auxiliary:*

The nineteenth year of our Auxiliary opened with brighter prospects probably than any preceding one. The Parishes were all at work, we pledged a larger amount of money for different objects than ever before, and we looked forward to the Missionary Council being held among us. But before any pledges were redeemed, and before the long-desired Missionary Council brought the fire and zeal we had felt the need of, the guiding hand in our work was stilled. All that our President was to us, and to the Auxiliary at large, we can hardly appreciate. Her strong personality made her a power everywhere. Through her the Missouri Branch was brought to a place of rank in the general work, and made a unit of working force in itself. The expressions of sympathy sent to us from the sister branches of Cairo, California, Kansas, West Missouri, Delaware, Maryland, and Virginia, as well as from the general Auxiliary, and the Missionary Study Committee, of which she was a member, testified to her influence beyond the Diocese, and we here express our appreciation of all their loving words.

But to those of us who worked daily with her in the Auxiliary in Missouri, the loss was a personal one. Beneath her activity there was a nature filled with manifold and beautiful gifts. Her gracious hospitality, her judgment and executive ability, her unselfish thoughtfulness of the happiness of

others, her gracious bearing towards all sorts and conditions of men, her devout and reverent Christian faith—these are the qualities which those who knew her best will best remember and make the memory of her life an inspiration for the highest Christian womanhood.

It is, therefore, our desire that the Auxiliary testify our appreciation of the privilege of Mrs. Tuttle's life among us by fitting memorial to her. A committee has been appointed, consisting of Mrs. Simmons, Mrs. White, Mrs. H. N. Davis, Mrs. A. B. Gregory, Mrs. P. C. Maffitt, to take this up as special work, that, to those who come after us, the brightness of her life may still shine.

To another of Christ's faithful soldiers has the crown of victory been given. The Rt. Rev. Mahlon N. Gilbert, Bishop Coadjutor of Minnesota, entered into life eternal on March 2d. At our January meeting, we renewed our pledge of the two previous years for his work at Birch Coolie, and while the money had not been sent, he knew it had been promised, and expressed his gratitude for our gift. His unselfish, noble life and cheerful faith, we had the privilege of knowing, and we can only be thankful that year by year we had aided him in carrying on his work.

With the influences of these lives, the Auxiliary has gone on in its work. We have extended our help into more territories than ever before. The Missionary Council brought us face to face with many of our Missionaries, and made their work a more living factor by their own belief in it. The Rev. Mr. Ingle of China, the Rev. Mr. Gring of Japan, and the Rev. Mr. Hunter of St. Augustine's School, Raleigh, presented their claims to the Auxiliary, and we gave to each \$100 for the work to which they were giving their lives. To the work in Mexico, \$150 has been sent, and hereafter, through our special officer

for that work, an annual pledge will be made at one of our quarterly meetings. Fifty dollars were sent for Indian work under Bishop Gilbert, at Birch Coolie, and \$100 for the beginnings of work in the Philippine Islands, and \$100 given to Bishop Johnston's work in Western Texas, and \$100 for work in Iowa.

In our own Diocese, Ironton, Clifton Heights, and Epiphany Mission, St. Louis, has been helped. Probably the brightest day in our year was that of the consecration of the Church of the Good Shepherd, St. Louis. The rector in charge having written that the Parish owed its first hope of building a new church to the generosity of the Auxiliary—it will be remembered that last year \$718 were given by its members. The Auxiliary officers and a number of the members were present at that service.

It has been with regret that we have heard that the Alumnae of Bishop Robertson Hall felt it impossible after this year to aid in carrying on the Bishop Robertson Scholarship. Two years ago they announced their inability to keep up the Scholarship. Two members of the Church of the Holy Communion then assumed \$150, the Alumnae paying the remaining \$50. Now two members of the Alumnae have promised personally to secure \$75 towards it, so this work is assured for the coming year.

Our Mite Boxes have brought us \$215.58. A little care in returning them promptly would help greatly. A lesson might be learned from one box-holder. Each year there is a record in the Mite Boxes reading "Newcastle, Delaware, \$3.65." A churchwoman there asked to become a member of the Missouri Auxiliary by paying a penny a day. Year after year, without any solicitation, without any reminder, this cheque comes to us in April. I think we may profit by this thoughtful care.

The St. Stephen's \$1,000 has been paid, and with less effort, because our Treasurer was able to pay \$100 in June, and a second \$100 in September, instead of waiting till the winter months for it all. May we hope that the Parish Treasurers of this fund will see that part of their pledge for this is redeemed during the summer.

The United Offering is apt to lag a little in the intermediate year. The largest amounts for this are always given the last year. As it is made up of thank offerings for blessings, we hope that the gift sent to San Francisco in 1901 will not fall short of our former ones, for "His mercies fail not."

Our Missions Class has been one of the hardest branches of the work to carry on this year. Under no circumstances must we let it be given up. Many of our women feel that they will hear the papers at their own Missionary teas, and so do not attend, but unless the Class is attended, these very papers will not be written, and the parish guilds will be the sufferers, as well as the Auxiliary. We have helped to establish classes in too many other dioceses to feel that we can give up our own. We all need the inspiration that only knowledge can bring.

In this work, where so much energy and thought must be given to ways and means. it is doubly sweet to us to have a day set aside when we are to go apart and rest awhile. The Bishop of Iowa gave us a most helpful Quiet Day. Rehearing, as he did, the questions of the baptismal office, brought a realization of our responsibilities, as well as our shortcomings.

Our success is due this year to our giving the co-operation our Vice-President asked for when the responsibility of the work was placed in her hands. This next year will be harder. We have our own work to plan; our own knotty questions to

solve or decide. It will only be by each feeling that her individual responsibility is greater than ever before ; by realizing that her failure means failure for all ; by standing shoulder to shoulder in any work undertaken, and by perfect loyalty to the work can we expect to succeed. It has been loyalty to our President for twelve years that has brought our Auxiliary to what it is. Part of her work will have been in vain if her spirit of loving service passes from among us.

O blest Communion, fellowship divine!

CONSTITUTION OF THE MISSOURI BRANCH
OF THE
WOMAN'S AUXILIARY.

Adopted May 25, 1888.

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

ARTICLE VII.

There shall be an Executive Committee, composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York, and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies, Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

ARTICLE XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
