## TWENTIETH ANNUAL REPORT.

---

*To the Rt. Rev. D. S. Tuttle, S. T. D., Bishop of Missouri, and  
Members of the Missouri Branch of the Woman's  
Auxiliary:*

We complete this year the second decade in the life of the Missouri Branch of the Woman's Auxiliary. For twenty years we have gone steadily on, with some discouragements and many blessings. It behooves us to look over the ground a little to find not only where our success lies, but to see our weakness and find a remedy for it. The figures of our reports as we look over them are a cause for thankfulness; there are no backward steps. Generous, loving hearts sustain every effort we make and no appeal has ever been made to deaf ears. And yet I have said there is a weakness. Money is not the only, nor is it the first, aim of the Auxiliary. Intelligence and interest come first, the gifts are but the result. "How can we increase this interest in the parish" is the question which comes before every Diocesan branch. Your Representatives are appointed in every Parish and our Constitution says that "they are to attend the regular meetings of the Board and carry back to their Parish societies missionary intelligence and endeavor in every way to increase an earnest and prayerful interest in Missions." Do you realize, my sisters, what a privilege is yours? Out of several hundred women, perhaps, in your Parish, you have been appointed to be the link between the general organization and your branch. There is something lacking here, for when the roll is called, out of 115 names, less than half is the largest number present this year. Some of our Representatives, even in our city parishes, have not attended a meeting this year.

In visiting one of our smaller branches I heard a resume given by a Representative, of our January meeting, that was spirited and interesting throughout and that Parish report shows an increase in offerings which must be largely due to this source. We would recommend that it be the duty of one Representative in each Parish to see that every guild is provided with an account of each meeting. That would increase the attendance, perhaps, at our quarterly meetings. We find that our congregations are made up of the same faithful women. They do not increase as they should and it is probable that most of our pledges are redeemed by these same faithful ones. Are our offerings general, does each woman have the privilege presented to her of giving a little to the different pledges, or are the amounts made up by a few?

Besides hearing the Missionaries at our meetings and in this we have been most fortunate, for there is hardly a Missionary Bishop whose face and voice are not familiar to us and whom we have not been able to cheer by a little practical help, we have another source of information that is much neglected. An earnest reading of our missionary magazine, *The Spirit of Missions*, is recommended. The last few numbers have been as thrilling as any adventures that would delight a school boy.

Who could read without a thrill Bishop Rowe's modest account of his one thousand-mile walk this winter over unbeatén tracks of snow, on snow shoes, alone in the Arctic winter save for the presence of his Saviour? Who could keep back the tears as we read of his lameness which he makes light of, and of the bitter cold? Miss Dean, of Circle City, writes that when he reached there they did not know him. "The frost and ice had made a sort of halo about his face and head, the sort of halo an Alaskan saint ought to wear." If this account were published in secular papers, how the crowds would throng to

see this hero. We have had him with us twice; we have heard his cheery voice and looked into his keen eye. Do we realize what a privilege has been ours? If we read *The Spirit of Missions* we will see that there are heroes, yes, and saints, too, in all our mission fields. Miss Crummer, who was with us in February, told to only a few, her experiences last summer in China.

We must acknowledge then that one weakness is lack in attendance at our meetings. Can we not try to double it before our twenty-fifth anniversary comes to pass?

To particularize in regard to our work is part of the Secretary's duty. We find that our representatives have faithfully fulfilled all their pledges, all our obligations have been met. There has been a falling off in some parishes in the contributions to St. Stephen's, which have been made up by specials. This work is supported by the diocese, and it is hoped that every parish will feel a responsibility in carrying it on. Failure of a few means either increased work for some, or failure for all. Could we see St. Stephen's fail because we had not done our part towards its support?

We find that only 19 branches use the Mite Boxes. The little blue box is familiar to you all, but do you realize the good that comes from the systematic giving to them of a penny, or nickel, or dime every week. A daughter of a missionary in the diocese is given from two to three years at Bishop Robertson Hall to equip her for self support. Honor has come to the Auxiliary through some of these scholars. Two of them have taken the training at St. Luke's as nurses, and their standing was admirable in every respect. They have not only supported themselves, but have greatly aided their families. One of them took the highest honors at Bishop Robertson Hall, and is now a successful nurse in our city. The other, Miss Sallie R. Hunt,

entered into life eternal last October, leaving behind her a record from patients and physicians for judgment, for faithfulness, for Christian integrity, which any of us might envy. These boxes should not lack when we know what they are doing for the young girls in our own diocese.

Our Missions Class took up the study of China for the year, with an increased attendance. A valuable addition was made to our Missionary library of the best new books on China. The library fails in its use by the persons borrowing the books keeping them beyond the given time. Two weeks is the utmost limit, and as they are largely books of reference, a much shorter time will often suffice. An additional enjoyment to the afternoon has been a social half hour at the close, with a cup of tea. It has broken up the formality of the Missions Class, and given the time and opportunity for the officers to see and arrange meetings with parish branches, as well as giving them a personal acquaintance with the parish workers.

The work in Mexico we have made a part of our annual work. A report from our Vice-President, the officer in charge, will be made at the January meeting and pledges taken for it, which shall not be less than fifty dollars, from the diocese.

The correspondent of the Church Periodical Club reports establishing branches in Kirkwood and Rolla.

Our Quiet Day was conducted by the Bishop-Coadjutor of Chicago, and our other guests have been Bishop Edsall, the Rev. Mr. Guerry, who spoke for Dr. Lloyd at our January meeting, and Miss Crummer. Surely our privileges have been many.

In October next, at San Francisco, will be made the great Triennial Offering of the Woman's Auxiliary, the United Offering to which we have been giving for the past three years.

In our diocese, we ask for birthday and memorial gifts, but the great object of the whole Auxiliary must not be lost sight of, that it is a Thanksgiving for our privilege of working for Missions for the past three years. As we read of our missionary heroes, we must all want to have a part in it.

In the report of ten years ago, we find a suggestion for an Emergency Fund, upon which no action was ever taken. As was then said, we have to look to our representatives' dues, our honorary members, and our offertories as our only sources of unappropriated funds in the treasury. Our pledges for Diocesan Missions, and our necessary expenses consume all of this. There arise, occasionally, cases of absolute necessity, illness, and even death in the homes of our missionaries. We have no way to meet these emergencies except by letters to guilds and individuals, and the guilds meet but half the year. We have to state the case in full, when we shrink from making public the affairs of any one. Can any plan be devised to meet these emergencies, to carry comfort and help when it is most needed?

You have heard this morning the report of the committee appointed a year ago to select an object as a memorial for our late President. The endowment of a bed for a missionary at St. Luke's Hospital. The first gift came from West Plains, in the diocese of West Missouri, \$25, from a Mission we had helped three years ago. This work needs no urging. It finds a response in the heart of every woman who ever came in contact with Mrs. Tuttle. It will serve to show to others her influence upon the Woman's Auxiliary in Missouri.

At the annual meeting of the Woman's Auxiliary, held May 31st, 1901, the following report was presented and approved by a rising vote:

REPORT OF THE COMMITTEE ON THE "HARRIET M. TUTTLE MEMORIAL."

A meeting of the committee on the "Harriet M. Tuttle Memorial" was held at the residence of Mrs. Simmons, on Saturday, May 4. At this meeting it was resolved that the Woman's Auxiliary of Missouri should endeavor to raise the sum of \$6,000 for the purpose of endowing a bed in the new St. Luke's Hospital, to be known as the "Harriet M. Tuttle Memorial Bed," to be more especially reserved for the use of any missionary who may have need of hospital care.

It is earnestly hoped that every woman in the Diocese may have her part in this memorial of our much-beloved president.

It was suggested that in each parish one woman be appointed to promote interest in this matter and receive gifts for this purpose, reporting such gifts to the General Treasurer once every quarter. Such gifts may be repeated indefinitely, until the entire amount is completed.

Several gifts were made towards this Memorial at the time of meeting of this committee.

It is especially recommended that the women of this Auxiliary take this matter up and raise the needed sum of \$6,000 without any delay whatever.

## CONSTITUTION OF THE MISSOURI BRANCH

OF THE

# WOMAN'S AUXILIARY.

*Adopted May 25, 1888.*

### ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

### ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

### ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

### ARTICLE IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

### ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

#### ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

#### ARTICLE VII.

There shall be an Executive Committee, composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

#### ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

#### ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her appointment by her Rector, or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

#### ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York, and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

ARTICLE XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
