THE TWENTY-THIRD ANNUAL REPORT
OF THE
MISSOURI BRANCH OF THE WOMAN'S AUXILIARY

*To the Right Reverend D. S. Tuttle, S. T. D., Bishop of
Missouri, and Members of the Missouri Branch
Woman's Auxiliary:*

As we look back upon the past year of our Auxiliary life, two facts of greatest importance confront us, both of which have their bearing upon our work. The head of our diocese has received the highest dignity which the church has within her gift and has become the presiding—or as he himself modestly expressed it—the senior bishop of our American church. So, for the first time in its history, the great Missionary Society has at its helm one who has himself known the privations, the dangers, and also the rich rewards of a missionary life. And we who, as our name declares, are helpers of that society, cannot but have our zeal and enthusiasm quickened and increased by working under his direct guidance. As a memento of the event and as a token of our affectionate loyalty, we have undertaken a new scholarship and given it our bishop's name. This scholarship has been placed at Anvik, Alaska, and with another new scholarship known as the Carroll M. Davis scholarship, not yet assigned, are credited towards the \$560 which is Missouri's part of the apportionment of \$100,000 asked of the General Auxiliary by the Board of Missions. Even in the minds of the officers there is sometimes a mistiness as to what are "specials" and what are "designated offerings." These last two scholarships are designated offerings as are our annual pledges for General and Foreign Missions, and our gifts toward the sal-

aries of any workers in the field. "Specials" are a necessity as well, as they are the dependence of Missionary Bishops for growth in their work.

The other event which has been in our thoughts for many months and which is at last realized is the World's Fair. From the four quarters of the earth, even as St. Peter beheld them in prophetic vision, have come the races of men and have been gathered within a few miles. Surely a greater object lesson for missions could never have been devised. Few of us may ever have the privilege of seeing the work of our church in China, or in the Philippines, or among the Indians of the far West; but here we may meet Christian Chinese, who can tell us of the wonderful work done by Bishop Graves and by the saintly man who so lately went to his rest in far-away Wuchang. And we remember thankfully that one of our pledges was for a memorial to Bishop Ingle and another was for the life insurance for the head master of Boone School, the anxiety for which burdened his last days and was the subject of his last letter to the Board. So, at our annual meeting today, another pledge will be made for a memorial—to one of Missouri's own beloved sons, Bishop Leonard of Utah. And so the foreign and domestic fields are closely linked together in our work. At the Fair, too, we may see, with far other feeling than that of curiosity, sons of the King who have not yet entered into their heritage,—the Moro and the Igorotte, and in strange contrast to these may hear the familiar Prayer Book services rendered in the Sioux tongue every Sunday by an Indian clergyman ordained by Bishop Hare.

Not many squares away rises the new and beautiful St. Luke's Hospital, and we are glad to know that the endowment fund for a room which is a memorial to our late beloved President, Mrs. Tuttle, lacks but two hundred dollars of completion.

In Church work, as in Nature, there is no standing still. Even to pause in onward movement means retrogression. So it is good to record that a movement is on foot to organize a diocesan branch of the Junior Auxiliary. Too long has Missouri lagged behind in this matter, while our neighbors have been quick to realize the tremendous power that lies in the willing hands and feet and in the loving hearts of children. If the Kingdom of Heaven be of such, who so likely to extend that glorious sway as they?

The meditations of our Quiet Day, to which we have learned to look for help and refreshment, were this year given by Bishop Olmsted of Colorado. Other guests who have been an inspiration at our meetings are Bishops Funsten of Boise and the Rev. Mr. Merrill, the latter our faithful priest from the Oneida Reservation. So great was the inspiration caused by Mr. Merrill's visit that we have sent him our general Lenten box, largely filled with hospital supplies and the most generous box we have ever packed. Contributions came from twenty parishes. Two parlor meetings have been held. At one the Rev. Mr. Roots told of his Chinese work; at the other Dr. Lloyd inspired us with our responsibility and privilege in the United Offering, which offering we must all bear in mind will be made on Oct. 6 in Trinity Church, Boston.

Long ago Dr. Langford pointed out the fact that the promise of our Lord to be with His Church to the end of the world was only one clause of a sentence of which the co-ordinate one was the command to teach and baptize all nations, and that we have no right to claim the promise until we have done our utmost to fulfill the command.

The United Offering.

At the last Triennial meeting of the Woman's Auxiliary it was resolved:

"That the United Offering of 1904 be given to the Board of Missions, for Woman's work in the Domestic and Foreign fields, including the training, sending and support of women workers, this to be interpreted to include Brazil, Hayti, Cuba and Mexico. It is also to be understood that the resolution includes the care of sick and disabled women workers."

The method of giving thank offerings on birthdays or some family anniversary has been followed for several years with us. It is now proposed to make the plan more definite by asking every church woman in the diocese of Missouri, who is willing to make an offering once a year to this object to give her name, address and the date on which she will give the offering to the treasurer of the United Offering in her parish. These names and dates are to be sent to the General Treasurer of the United Offering, who will have an Anniversary Book of the diocese in which the name of every woman will be written who personally promises to follow the plan. The earnest co-operation of every woman in the diocese is asked in this work.

The success of the plan depends almost wholly on the faithfulness and interest of the parochial officer, who has this work in charge.

Quarterly returns should be made to the treasurer of the United Offering.

Envelopes have been provided for these offerings and may be had on application.

Three hundred and forty-nine names have been enrolled from 26 Parishes and Missions. Contributing \$500.51. Previously reported \$224.94. Total, \$1,111.06.

Harriet M. Tuttle's Memorial.

At the annual meeting of the Woman's Auxiliary, held May 31, 1901, the following report was presented and approved by a rising vote:

Report of the Committee on the "Harriet M. Tuttle Memorial."

A meeting of the committee on the "Harriet M. Tuttle Memorial" was held at the residence of Mrs. Simmons, on Saturday, May 4, 1901. At this meeting it was resolved that the Woman's Auxiliary of Missouri should endeavor to raise the sum of \$6,000 for the purpose of endowing a bed in the new St. Luke's Hospital, to be known as the "Harriet M. Tuttle Memorial Bed," to be more especially reserved for the use of any missionary who may have need of hospital care.

It is earnestly hoped that every woman in the Diocese may have her part in this memorial of our much-beloved president.

It was suggested that in each parish one woman be appointed to promote interest in this matter and receive gifts for this purpose, reporting such gifts to the General Treasurer once every quarter. Such gifts may be repeated indefinitely, until the entire amount is completed.

Several gifts were made towards this Memorial at the time of meeting of this committee.

It is especially recommended that the women of this Auxiliary take this matter up and raise the needed sum of \$6,000 without any delay whatever.

CONSTITUTION OF THE MISSOURI BRANCH
OF THE
WOMAN'S AUXILIARY.

Adopted May 25, 1888.

ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object is not to change the work of any Parish, but by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

ARTICLE IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

ARTICLE VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.

2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

ARTICLE XII.

One of the said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

ARTICLE XV.

1. The President shall call meetings and preside over them.

2. The Vice-President shall take the duties of the President in her absence.

3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York, and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

ARTICLE XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
