THE TWENTY-FIFTH ANNUAL REPORT  
OF THE  
**MISSOURI BRANCH OF THE WOMAN'S AUXILIARY**

*To the Right Reverend D. S. Tuttle, S.T.D., Bishop of Missouri,  
and Members of Woman's Auxiliary.*

It is said that happy countries have no history. In gathering together the facts of our own placid existence for twenty-five years the same statement may be made. Yet this seems a proper milestone from which to review the past, while many of us are still here who saw the work started and have helped to make it what it is, and also that we may tell those who come after.

The Convention Journal of 1881 reports that Bishop Robertson appointed a secretary to organize a branch of the Woman's Auxiliary in Missouri.

This gave her authority to send out her first letter, a circular, to fifty-three clergymen of the diocese asking their approval and co-operation to organize parish branches. Five replies were received. Two disapproved of the project, two promised help later on, and only one, the Rev. Dr. Schuyler of saintly memory, entered heartily into the plan. The outlook was discouraging for diocesan unity. Yet the first annual report shows 13 boxes sent by four parishes and valued at \$866.13. There were no money contributions. The parishes working the first year were Christ Church, now the Cathedral, Holy Communion, St. George's and Mt. Calvary.

In the next year three more parishes joined our ranks, and we made our first money contribution—\$12 towards the salary of Miss Riddick, a missionary in Japan. In those dark ages there were people who did not believe in foreign missions.

So this was quite a triumph. I believe that that spirit has departed forever, and to-day there could hardly be found an Auxiliary woman who would not be ashamed to say that God's children of any nation or color were not to be uplifted and that we had no responsibility in doing it.

In 1884 a visit from Mrs. Twing, the honorary secretary of the Auxiliary, roused a general interest, and we ventured to organize more fully as a diocesan branch, with four regular officers: Mrs. C. F. Robertson was elected president; Mrs. E. A. Manny vice-president; Mrs. Clement Seaman, treasurer, and the same secretary. The next two years saw changes in nearly all the officers. Mrs. Perrine became president, succeeded by Mrs. Wickham; Miss Anne B. Branch, now Mrs. Cushing, served as vice-president for the next four years, and began the Bishop Robertson scholarship, which has been kept up ever since, while she has ever since been one of our most helpful and inspiring members. In 1886 parish representatives were first appointed. The names of Mrs. W. J. Lewis and Miss Cousland are the only ones appointed at that time that have appeared in every report since. Miss Cousland's work dates even farther back, for two years earlier a society of children in the Cathedral, known as the "Gleaners," of which she was president, report their work, but her name was not mentioned, unfortunately.

We have had seven vice-presidents, three of whom have been called to a higher service during their term of office: Mrs. John W. Harrison, Mrs. Rufus Lackland and Miss Rebekah Parker. Mrs. R. M. Wilson and Miss Cora Hofman served one year each as treasurer, to be succeeded by Mrs. Laura Speck. For seven years she filled the office perfectly, and it was only a realization of her closely occupied time that reconciled us to accepting her resignation. In 1894 her successor, Mrs. T. Ewing White, was elected to the office she now holds.

In 1885 we turned for the first time to the need of spiritual development for ourselves as equipment for the work. Emulating Pennsylvania, the first branch to have a Quiet Day, we ventured in a modest way to have not a whole day but a

service of spiritual instruction by the Rev. C. C. Grafton, now Bishop of Fond-du-Lac. This service was held in St. Luke's Chapel from 2 to 5, and that the little chapel was crowded was a source of delight. Two years later, out of this small beginning grew our Quiet Day, and for eighteen years this has been one of the strongholds of our work.

In this same year we lost our first spiritual leader ; Bishop Robertson laid down his burden, and Bishop Tuttle came from the missionary field to assume it. We have been singularly fortunate in having had two Bishops who, in spite of large claims, have given us freely of their time and counsel.

With our new Bishop there came his helpmeet, who, as our president, brought the Missouri Auxiliary to the front rank among the dioceses. Not altogether in a financial way, for our reports had always shown a steady increase and our offerings are still very modest; but an active, intelligent spirit who knew the work from experience, not hearsay, brought an enthusiasm which kindled all hearts. Not only in Missouri was Mrs. Tuttle's power appreciated. The Auxiliary at large felt her influence, and at any general meeting the opinion of Missouri held a sway far out-ranking our work. For twelve years we had that strong, consecrated leadership, and we still feel the impress of it, and on her lines Mrs. Simmons has carried on the work.

Much of our Auxiliary work has of necessity been in our own city. In 1890 the debt on All Saints Church, our Church for colored people, pressed heavily, and Mrs. Wm. H. Thomson undertook the work of reducing it. By systematic giving, in four years we paid \$4000. By that time the parish could assume the remainder and we turned our attention to the support of St. Stephen's. This we carry on with Mrs. Thomson still acting as special treasurer. Our \$1200 a year pays part of the running expenses; but to see it expand, much more is required. It needs repairs and larger space. We cannot increase our pledge, but individual and parish gifts could greatly increase a work that even now is known throughout the country as a Model Settlement work.

Our mite boxes have for years supported a second scholarship

at Bishop Robertson Hall for the daughter of a missionary of the diocese. Our Missions Classes, in which we were pioneers, carried on for fifteen years, show a fidelity to the old ways ; while scholarships in almost every field, our co-operation in every line of work undertaken by the general Auxiliary, and our United Offering tell how the work has grown beyond the missionary box.

In permanent gifts there stands a marble altar in the Church at Las Vegas, New Mexico, in loving memory of Bishop Dunlap who went from Missouri to take up that arduous work. Miss Emery's desk, where all the Auxiliary work originates, bears a brass plate telling that it was provided by the Auxiliary of Missouri. A beautiful marble font in North Dakota was a gift of the Cathedral little society of "The Gleaners." In St. Luke's Hospital in this city an endowed room for the use of a missionary and a perpetual scholarship in St. Margaret's School, Boise, Idaho, are our memorials to Mrs. Tuttle. The Rebekah Parker scholarship in Mexico keeps alive the work carried for so short a time by our vice-president, while the bells at St. Stephen's chime the memory of Mrs. Rufus Lackland, another vice-president, who has left the only legacy our Auxiliary has ever had. May they not voice in us a desire to remember the Auxiliary in our own wills and thus let our work go on after we are at rest ?

From our first contribution of \$12 for Japan we now support a native teacher at \$100 ; while our thank-offering for our twenty-five years' service is the support of an Auxiliary Deaconess at Holy Cross Mission. We are pledged to \$100 a year, and the rest is raised by one of our members and reported through us. Of our Junior work, under the vice-president, Miss Lewis, we have just reason to be proud. Its growth in two years has been phenomenal. The Babies Branch is its nursery.

A long list confronts us as we look at the names of former representatives who have gone to a higher service. In the past year two have been taken. Mrs. Minor of Louisiana we know only by name ; but she with one other woman have kept that parish on our list even when no services were held there. Mrs. M. E. Grey of Holy Innocents we all knew ; her influence and

her example extended far beyond the bounds of her parish. It was she who inaugurated the plan of the small parishes raising the funds for their pledges before each meeting, which has so increased the amounts and secured such prompt payment. For many years she worked with us and she will be greatly missed.

In closing, may it not be interesting to look at the aggregate of figures for this quarter of a century? It seems incredible, that starting with the encouragement of one rector and the promise of two more, that in these years we have sent 1,081 boxes valued at \$38,529.95, and in money \$78,959.03, making a total of \$117,488.98.

When the diocese was divided in 1891 our gift to west Missouri was eleven organized working branches. What magnificent figures we might have had if every parish had only worked with us. The discouragements of the first year have often been repeated when we have utterly failed to interest some of the parishes. Of the city I do not speak; even every mission has its part; but there was a hope that at this meeting every parish in the diocese would report a working branch. So there is a little feeling of sympathy to-day for any one who has not had a part in this service. It takes patience and faith and love, but it gives all three. Try it, and in one of the new branches may be found the woman who wants to be a missionary, and then the secretary who writes the records for the next quarter of a century will be able to report both these aims realized.

## Object of the United Offering of 1907.

*Resolved*, That the United Offering of 1907 be given to the Board of Missions, for woman's work in the Domestic and Foreign fields; including the training, sending and support of women workers, also the care of such workers when sick and disabled; this to be interpreted to include Brazil, Haiti, Cuba and Mexico; but that a sum not exceeding \$10,000 be devoted to some building, or extension of the same, preferably connected with woman's work, to mark the United Offering of 1907, and to be begun in that fiscal year, such building to be approved by the Board of Missions on the recommendation of the General Secretary and the Secretary of the Woman's Auxiliary.

The method of giving thank offerings on birthdays or some family anniversary has been followed for several years with us. It is now proposed to make the plan more definite by asking every church woman in the diocese of Missouri, who is willing to make an offering once a year to this object, to give her name, address and the date on which she will give the offering to the treasurer of the United Offering in her parish. These names and dates are to be sent to the General Treasurer of the United Offering, who will have an Anniversary Book of the diocese in which the name of every woman will be written who personally promises to follow the plan. The earnest co-operation of every woman in the diocese is asked in this work.

The success of the plan depends almost wholly on the faithfulness and interest of the parochial officer, who has this work in charge.

Quarterly returns should be made to the treasurer of the United Offering.

# CONSTITUTION OF THE MISSOURI BRANCH OF THE WOMAN'S AUXILIARY.

*Adopted May 25, 1888.*

## ARTICLE I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

## ARTICLE II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

## ARTICLE III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

## ARTICLE IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

## ARTICLE V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

## ARTICLE VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

#### ARTICLE VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

#### ARTICLE VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

#### ARTICLE IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

#### ARTICLE X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

#### ARTICLE XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

#### ARTICLE XII.

One of said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### ARTICLE XIII.

The meetings shall be held in any Church or Chapel designated by the President.

#### ARTICLE XIV.

Special meetings may be called by the President at the request of any five of the Managers.

#### ARTICLE XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.

3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### ARTICLE XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### ARTICLE XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
