THE TWENTY-SIXTH ANNUAL REPORT
OF THE
Missouri Branch of the Woman's Auxiliary.

*To the Rt. Rev. D. S. Tuttle, S. T. D., Bishop of Missouri,
and Members of the Woman's Auxiliary:*

Last year we closed our books of twenty-five years of service as a Diocesan Branch of the Woman's Auxiliary. We have begun a new chapter now with a new quarter of a century, making our aim to have a branch in every parish and mission in the Diocese, and may this come in a much shorter time than it has taken to form the 38 branches we reported last year.

In addition to our usual pledges we have done special work this year. Last May we made the largest pledge ever made by the branch. We could hardly hope to have anything that would appeal to us more strongly than the Bishop Tuttle Church House at Boise. Our gift of \$1,000.00 not only commemorates Bishop Tuttle's work in the West, but our gratitude for his unfailing interest and assistance in our work. May the House be speedily completed while he may see its usefulness and while those who were his fellow workers may repeat with joy the name of the man who in his early manhood and in the early days of the Church in the West was their guide, counsellor and friend.

As a proof that our women have only to know of a need to do their part towards supplying it, just a week after our Annual Meeting we had a visit from Deaconess Wile returning to Honolulu. Her work there among the Japanese, her

scheme of selling square feet of the building lot she is trying to buy, as well as her wonderful personality, gave to the meeting an unusual enthusiasm. Missouri can claim long lines of that lot as her own real estate. Much of this came in memorial gifts which insures a lasting interest in the work.

Nor did these two special pledges complete the summer work. Through the loving energy of a former vice-president, Mrs. Cushing, a gift from all the parishes was made at the autumn meeting to the secretary to commemorate her twenty-five years of service. This fund was to be given to any missionary work she might designate. The choice has been given to the building of a little Chapel among the Virginia Mountaineers. In building this we have covered every aim as set forth for Auxiliary work. It is not only the first Church, but the first building we have ever put up and carried through as a branch. I can think of no greater privilege than to build an altar to our God, and this blessing you have made possible for me. Henceforth, St. John's Church, Blackwell's Hollow, Virginia, will represent a Western Diocese in the oldest settlement in the country, while a tablet will tell that it is the gift of Missouri Auxiliary women in loving loyalty to one of its officers. May its ministrations be blessed always.

The United Offering will be made next October in Richmond, in the same old Diocese where the first church services on the new continent were held. The men of the Church are to make a thank-offering at this 300th anniversary, and are not we loyal Church women anxious that our own thank-offering for the privilege of working for Missions be augmented this year. There are many women who have never given to this and who do not realize that we women at home train, send out and support all the women workers of the Board of Missions. The list of workers can only grow in proportion as our gifts increase and *they* do not grow in proportion to the need of them. You will have till next September to claim a part in our offering at Richmond, where we

commemorate that service at Jamestown, where on Whitsunday, 1607, the day after their landing, under an arbor made of boughs and on a rude altar protected by a torn sail, the Holy Communion was first celebrated in our land. The Jamestown colony brought its priest from England. Out of this grew England's great Missionary Society, the Society for the Propagation of the Gospel. Our aim is to follow our flag into new lands as well as to plant the cross of Christ in heathen ones. Besides these special gifts we have carried on all our usual pledges.

The claim of St. Stephen's, our nearest work and always one of our best, must not be overlooked. It looks to us for its daily life and the more promptly we meet the \$100.00 a month we promise the lighter will be the hearts and the burden of those who are doing the work.

The question of the Missions Classes should be seriously considered. Parochial Classes have proved so helpful that the need of a Diocesan Class is not what it was sixteen years ago. This year the attendance has been small and usually from the women best informed in the work and who come as a part of the Auxiliary duty. We were pioneers in this work and for years other Dioceses looked to us. To give up old lines that have been as helpful as the class has proved, will be a decided step backward unless we put something equally helpful in its place. Has the class this year brought new life and interest or the attendance compensated for the time and study expended on the papers?

Again, a quiet day has come and gone. It is our best inspiration, and Bishop McCormick's helpfulness leaves a debt of gratitude as well as a blessing in our hearts.

The attendance at our meetings is not as good as we would wish. It is true we have had no special speakers this year, and we all know that routine work is dull and uninteresting. On the other hand it is a venture to invite a stranger to come and not feel sure of a congregation worthy of the name to

listen to his plea. For there is always a plea. That is why we ask him. It is not that we may delight in his eloquence but that we may hear of the work that is ours as well as his. No criticism can be made of the helping. The Auxiliary purse is ever open, but your presence is what we need at every meeting.

May we begin this new quarter of a century with new earnestness, taking up the work on all lines. When John the Baptist sent to our Lord to ask if He were indeed the Christ, the reply told of His miracles. We cannot make the deaf to hear or the blind to see, but one miracle coupled with these is still ours to perform. "The poor have the Gospel preached to them." This is our work till the kingdoms of this world become the kingdoms of our Lord and His Christ.

THE UNITED OFFERING OF 1910.

At the Triennial Meeting of the Woman's Auxiliary in Richmond, in October, it was resolved:

"That the United Offering of 1910 be given to the Board of Missions for Woman's Work in the mission field, including the training, sending and support of woman workers; also the care of such workers when sick or disabled; but that a sum not exceeding \$15,000 be devoted to a building or buildings approved by the Board of Missions on the recommendation of the General Secretary of the Woman's Auxiliary; and also that to our united gifts there shall be added our united prayers that God will put it into the hearts of many faithful women to give themselves to the work of the Master in the mission field."

The United Offering is a thank-offering, made tri-ennially, at the time and place of the General Convention, by the women of the Church. It is not limited to the Woman's Auxiliary or to any organization. Any woman who has a desire to help the mission cause, or who wishes to express her gratitude for any blessing or mercy, is asked to send a gift, large or small, to the United Offering.

In this Diocese every woman who is willing to make an offering once a year to this object is asked to select her birthday, or any day which will have some special interest to her personally, and to send her name, address and date to the treasurer of the United Offering in her parish. The names are sent from the different parishes to the General Treasurer of the United Offering, who enrolls them in the Anniversary Book. **No sum** is specified, but each is to give a **freewill offering**. We should like to enroll every woman in the Diocese.

Missouri's part in the United Offering of 1907 was \$1,510.03, from twenty-nine parishes and missions. The total of the whole United Offering was \$222,353.35.

CONSTITUTION OF THE MISSOURI BRANCH
of the
WOMAN'S AUXILIARY.

Adopted May 25, 1888.

Article I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

Article II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

Article III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

Article IV.

The officers shall be a President, Vice-President, Secretary and Treasurer, to be chosen at the annual meeting.

Article V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

Article VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

Article VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

Article VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

Article IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

Article X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

Article XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

Article XII.

One of said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

Article XIII.

The meetings shall be held in any Church or Chapel designated by the President.

Article XIV.

Special meetings may be called by the President at the request of any five of the Managers.

Article XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.

3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

Article XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

Article XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
