THE TWENTY-SEVENTH ANNUAL REPORT
OF THE
Missouri Branch of the Woman's Auxiliary.

*To the Rt. Rev. D. S. Tuttle, S.T.D., Bishop of Missouri, and
Members of the Woman's Auxiliary:*

We always look for the Triennial Meeting to give a stir and impetus to our work, and there was never a greater privilege than we had in Richmond. It is always an inspiration to every woman who attends it, and while we were there we thought we could do great things for the work. But it is hard to pass on enthusiasm. Some things grow in the passing, like a snowball or an inaccurate statement, but nothing loses more than zeal after the story has been told to less interested listeners or, what is worse, listeners who are satisfied. We found in Richmond we had many things to learn. We had rather prided ourselves on our Methods, and there are few better things than Method in its place. It is a good servant but not a good master. After a while too much method means getting into a rut and that means stagnation.

In two lines it may be well to acknowledge our weakness and possibly remedy it. First the United Offering. It was an untold joy and surprise to find that over and above all other offerings the Women had given \$225,000. Each year we think we have reached the limit of the generosity of the women and still the wonder grows. The increase this year was \$75,000. It hardly seemed as if we had had a pro-

portionate growth in our part of it. The fine and graphic account of that service which your United Offering Treasurer has given should make every woman feel that any self-denial would be worth while to have a part in the next.

The other line where we felt our special weakness was in the Mission Study Classes. Pioneers ourselves in that field, newer methods have come in and we find ourselves lagging behind. The old time written paper has had its day, systematic study on educational lines under a leader has proved more successful. This year we abandoned our class. In its stead we asked Miss Lindley, of New York, to give us a ten days' course of Bible study at the beginning of Lent. We can hardly estimate what this privilege was, but a daily attendance of from 150 to 200 women speaks for itself. All through the Auxiliary we hear of Bible Classes and intercessory prayer as well as Mission Study. That first text book of Missions is the key to all the rest and should make us eager to keep in closer touch with the field. Another year should find us with an up-to-date Mission Study Class and where there is no parish Bible Class no rector would object to one being organized under the Auxiliary.

One of our first lines of work here in our diocese was the adoption of a little blue mite box for the systematic saving of pennies and small coins by which we have educated daughters of missionaries at Bishop Robertson Hall. For several years this has been running behind and our custodian has saved us from debt. This year the deficit was much larger than it had ever been and the day the reports were to close there was very little with which to pay the last term's tuition. This has been met by personal appeals. We have let newer interests crowd out this old one, but we must bear in mind that the training of Missionaries' children is one of the five fundamental points of Auxiliary work, and we beg that the parish representative in charge of the boxes will see that they are not only given out but gathered in at the proper time.

This year as one of our October pledges we have assumed a scholarship at St. Mary's, Sewanee, Tenn., to perpetuate the memory of our late President, Mrs. Harriet M. Tuttle, and her work in making the Auxiliary the power for good in the diocese which it now is.

This year we have had Archdeacon Stuck to tell of the frozen North in his own glowing terms. He represented our most northerly field, while Dr. Brown at our annual meeting took us across the equator to Brazil. His spirit of consecration, his love for his adopted country, his scholarliness, made his visit one that will never be forgotten. Deaconess Drant won all our hearts by telling of the hospital for Chinese children in San Francisco. Mrs. Swan told of the home for Incurable Children in California. Bishop Woodcock gave a most helpful Quiet Day. Many parishes have held their own Study Classes. Miss Cousland has visited many parishes to tell of the United Offering. The Secretary has tried to share with the Auxiliary branches the privilege of her visit to Palestine. With maps and pictures perhaps that land made holy because the Son of Man has trod it has become a more real and tangible place, and she hopes to young people there will be aroused a greater interest in reading the Scriptures.

To the friend, Mrs. Denison, who took her place during her long absence and undertook the arduous work of the report, the Secretary wishes to here record her gratefulness. She more than anyone else made that journey a possible thing and in no way did the Auxiliary suffer by the absence.

At the close of the General Convention on October 27th, three of your officers were present at the consecration of St. John's Church, Blackwell's Hollow, Va. In the mountain fastness it stands with its cross topped belfry a living witness to what the Church is doing for these long neglected people. Your gifts and those of other friends have made it beautiful and complete. If women only knew what a joy and interest

it has been to build a church, there would be no lack of them in the mission field and to many the gift would hardly entail any sacrifice. But to very few could more love or interest be given than you have shown in this.

A word must be said for St. Stephen's. Many do not realize what its influence is in that district. About 1,200 people pass through its doors each week, a more devout and reverent congregation cannot be found in the city, the consecration of its director we all know and yet the work cannot grow because the heat, light, janitor's service and general repairs must be met by \$100 a month which we give. We are shutting our eyes to one of the best opportunities the Church has, and we have difficulty in raising the \$1,200 as promptly as it is needed.

You will remember that at San Francisco the Board of Missions asked the Auxiliary to aim to contribute \$100,000 annually for the general work of the Board. This was apportioned among the diocesan branches relatively to their annual gifts. The full sum has not yet been reached, this year \$75,000 was given. Of this Missouri's part was \$525. I am glad to say that ours has always been paid in full. It was of course increased this year and will be until the \$100,000 is reached. We are asked for \$600. That is only a small proportion of the almost \$8,000 given. The rest helps the Board indirectly and is necessary for the enlargement of the work, but unless the Board has the money to pay missionaries' salaries and those of our missionary bishops, our work will not be needed. Our gifts to the general treasury and designated offerings come under this head, so it is well to bear in mind when undertaking any work that is to be continued to see that it is in accordance with what our name implies, help to the Board of Missions.

God has called to a higher service His servant and our fellow worker, Mrs. Jno. R. Shepley, of the Cathedral, one of our Auxiliary representatives from the early days. Gen-

erous, loyal, wise, consistent, she was in every duty and her Christian womanhood is a standard for us all.

The President of the Alabama Branch has given a charge to her women based on a selection from one of Bishop Hall's books, which shows there is some Auxiliary work for every woman and that it is all founded on Scriptural example. Let us make her words our own.

Bishop Hall, of Vermont, has drawn attention to the different lines of work for women in the Church as marked out in our earliest volume of Church History—the Acts of the Apostles. "There we have presented to us for our example, Mary, the blessed mother of our Lord, and the women in prayer with Apostles and with His brethren; Dorcas, full of good works and alms-deeds, making garments for the poor; Mary, the mother of John Mark, and Lydia exercising hospitality to the infant Church and its ministers; Eunice, teaching her son Timothy in his childhood; Priscilla with her husband Aquilla taking Apollos, 'an eloquent man and mighty in the Scriptures,' and 'expounding to him the way of God more fully;' and the four daughters of Philip, 'Virgins which did prophesy,' the first of the sister-hoods. If to these we add Phoebe 'the servant of the Church,' first deaconess, and confidential friend, messenger and succourer of St. Paul, we shall find we have seven types of service followed by holy women from the earliest days, types that no doubt will be followed to the end of time."

The Woman's Auxiliary has striven to abound like Dorcas in good works, and alms-deeds, like Mary, the mother of Mark, and Lydia in hospitality, like Phoebe in journeyings, like Eunice, Priscilla and the daughters of Philip in teaching, like Mary, the mother of our Lord, in prayer. Let us organize study classes, subscribe for and read the *Spirit of Missions*, acquaint ourselves with the labors of our mission workers in every field; increase our knowledge, increase our interest, increase our offerings; send the best and most useful boxes, and

awake to a truer knowledge of privilege and responsibility in the work common to all. Let us strive more and more to reach the full measure of our ability, to do more and better work each year, "sheltered by the Church's protecting care, governed by the Church's laws, ministered to by the Church's sacraments and teachings, and may we ever be kept steadfast upon those Churchly lines upon which the Auxiliary has been founded and ever remain true to them."

THE UNITED OFFERING OF 1910.

At the Triennial Meeting of the Woman's Auxiliary in Richmond, in October, it was resolved:

"That the United Offering of 1910 be given to the Board of Missions for Woman's Work in the mission field, including the training, sending and support of woman workers; also the care of such workers when sick or disabled; but that a sum not exceeding \$15,000 be devoted to a building or buildings approved by the Board of Missions on the recommendation of the General Secretary of the Woman's Auxiliary; and also that to our united gifts there shall be added our united prayers that God will put it into the hearts of many faithful women to give themselves to the work of the Master in the mission field."

The United Offering is a thank-offering, made tri-ennially, at the time and place of the General Convention, by the women of the Church. It is not limited to the Woman's Auxiliary or to any organization. Any woman who has a desire to help the mission cause, or who wishes to express her gratitude for any blessing or mercy, is asked to send a gift, large or small, to the United Offering.

In this Diocese every woman who is willing to make an offering once a year to this object is asked to select her birthday, or any day which will have some special interest to her personally, and to send her name, address and date to the treasurer of the United Offering in her parish. The names are sent from the different parishes to the General Treasurer of the United Offering, who enrolls them in the Anniversary Book. **No sum** is specified, but each is to give a **freewill offering**. We should like to enroll every woman in the Diocese.

Missouri's part in the United Offering of 1907 was \$1,510.03, from twenty-nine parishes and missions. The total for the Offering of 1910, May 1, 1908, from twenty-four parishes and missions is \$348.31.

CONSTITUTION OF THE MISSOURI BRANCH
of the
WOMAN'S AUXILIARY.

Adopted May 25, 1888.

Article I.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

Article II.

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

Article III.

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

Article IV.

The officers shall be a President, Vice-President, Secretary, Treasurer and United Offering Treasurer, to be chosen at the annual meeting.

Article V.

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

Article VI.

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

Article VII.

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

Article VIII.

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

Article IX.

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

Article X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to votes, and shall not be counted in making a quorum.

Article XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

Article XII.

One of said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

Article XIII.

The meetings shall be held in any Church or Chapel designated by the President.

Article XIV.

Special meetings may be called by the President at the request of any five of the managers.

Article XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.
4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

Article XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

Article XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
