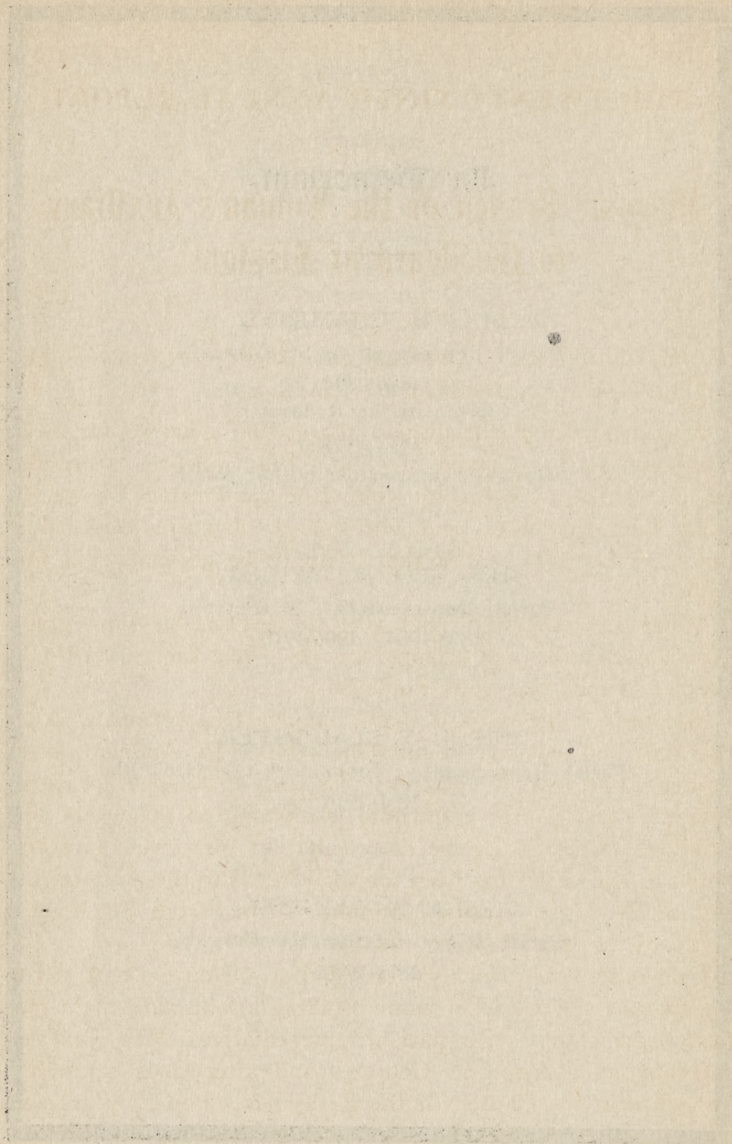

**THE TWENTY-NINTH ANNUAL REPORT**  
OF THE  
**Missouri Branch of the Woman's Auxiliary**  
**to the Board of Missions.**

---

*To the Rt. Rev. D. S. Tuttle, S.T.D., Bishop of Missouri, and  
Members of the Woman's Auxiliary:*

It is a matter of the deepest regret that I am so far away from you at this Annual Meeting. But God has so ordered it. I wanted to look into your faces and catch inspiration from your earnestness and with you lay down on God's altar our year's work and ask that it might be acceptable in His sight.

It has been a year of quiet work, some great blessings, some great losses and some disappointments. Just such a record as the life of each one of us would be.

Among our blessings is that Columbia has worked with us this year and has made a missionary box. St. Andrew's little branch, after years of inactivity, has revived its spirit in a way that we must feel is a spiritual awakening to the needs and privilege of service. One of our largest gifts from any one Guild to one object has been that of \$300.00 to the new Infirmary at St. Mary's-on-the-Mountain, Tenn., from St. Mary's Guild of the Cathedral.

Our losses count heavily. It is with a solemn sense of warning that we see our older women falling in our ranks. At our first organization with parish representatives Mrs. Jaminet was appointed from St. George's and afterwards continued her office in the Church of the Redeemer. For 17 years she was an active worker, and one of her greatest regrets in mov-



ing to another neighborhood was the necessity of relinquishing her work with us. But while health remained she was always at our meetings with a deep and generous interest. After 28 years of active and honorary membership she rests from her labors. Mrs. Geo. Wright's bright spirit has fled after many years of generous, good work at St. Peter's. Ill-health has deprived Mrs. Campbell, of Mt. Calvary, from attendance at our meetings, but in her parish she remained always interested and helpful. While the Easter lilies were still fresh the gentle soul of the Secretary of the Old Orchard Auxiliary was called without a moment's warning to its final rest. So quiet, so unobtrusive was Mrs. Slaughter that few realized what a gifted and consecrated spirit hers was. Her well-kept Auxiliary records show her faithful stewardship, her facile pen in many exquisite verses show her deeply spiritual and beautiful nature. With the names of these four women in our hearts we meekly bow our heads and reverently say: "The Lord gave and the Lord hath taken away, blessed be the name of the Lord."

Other losses besides those by death have come to us. St. Mark's branch is no more. St. James' has combined with the Church of the Redeemer. Two representatives from each parish remain as the four from the new parish. Wherever they may cast their anchors, we ask in all our Auxiliary enterprises, the co-operation of those who in this way have been dropped from our list of representatives, with a realization of our loss.

The country parishes have seemingly dropped behind. Isolated from the touch of kindred spirits, deprived from the inspiration we derive from missionary speakers and missionary meetings it is no wonder. In the nine years since an Auxiliary officer has visited any parish outside the county the personnel has changed and there is need to explain Auxiliary methods again and arouse the enthusiasm. Some have this year failed to send reports and some are kept alive by the personal gifts of two or three faithful women.



Our most hopeful work has been our Mission Study Class. The class was held for six weeks and two women from each parish were asked to attend who in their turn passed on their knowledge to parish classes. In that way ten parochial classes studied Missions in Africa, with results that were gratifying to our Educational Secretary, Mrs. White, who gave her time so unstintingly to her work.

We have had rich blessings in our speakers this year. Dr. Meyers was with us for our October meeting, telling of evangelizing among the Chinese women through the healing of their bodily infirmities. In January our speaker was one of our own members who had seen the work Bishop Restarick is doing at the Cross Roads of the Pacific, the Hawaiian Islands. It was a new experience to have such an account and Mrs. Castleman's enthusiasm most practically convincing. Last May we had pledged \$100.00 to furnish a teacher's room known as the Missouri Room in the Priory School at Honolulu, but in spite of that and the fact that our four January pledges had been promised, Mrs. Castleman prevailed on us to give a Scholarship this year to the Priory School. Mrs. Restarick's letter of gratitude was enough reward for a much larger gift.

The Rev. Geo. Craig Stuart gave us a Quiet Day that must always be counted among our best.

Our last great blessing was our meeting for Bishop Lloyd. More than ever we realized how great had been our misfortune in never having him with us before. He would have inspired higher service if we had. His earnestness and his faith strengthened ours. Every heart fairly throbbed with his appeal for the United Offering. It was to be clearer than any other motive of giving, it was beyond duty, it was deeper than responsibility, just *love* from a thankful heart. Would that all our women might have heard it, coming as it does on the eve of our next Triennial Gift. We hope for great things in our offering and we never cease to pray that some woman in Missouri may yet offer that best gift of all—herself.



This summarizes the year's work. Our figures are a little in advance over last year. In other ways we have lost rather than gained. We need a larger vision. We need larger attendance at our meetings. We need to make every branch of Auxiliary work a vital interest. We need to pray for every Mission field at home and abroad, for the separate Missions and their workers by name. We need to use the sanctuary of Missions in our spirit of Missions and to give part of every meeting to intercessory prayer and hearing something of missionary work. Then and not till then will our beautiful collect be part of our daily missionary prayer: "That we may both perceive and know what things we ought to do and may have grace and power faithfully to fulfill the same, through Jesus Christ our Lord."

"That the United Offering of 1910 be given to the Board of Missions for Woman's Work in the mission field, including the training, sending and support of woman workers; also the care of such workers when sick or disabled; but that a sum not exceeding \$15,000 be devoted to a building or buildings approved by the Board of Missions on the recommendation of the General Secretary of the Woman's Auxiliary; and also that to our united gifts there shall be added our united prayers that God will put it into the hearts of many faithful women to give themselves to the work of the Master in the mission field."

The United Offering is a thank-offering, made triennially, at the time and place of the General Convention, by the women of the Church. It is not limited to the Woman's Auxiliary or to any organization. Any woman who has a desire to help the mission cause, or who wishes to express her gratitude for any blessing or mercy, is asked to send a gift, large or small, to the United Offering.

In this Diocese every woman who is willing to make an offering once a year to this object is asked to select her birthday, or any day which will have some special interest to her personally, and to send her name, address and date to the treasurer of the United Offering in her parish. The names are sent from the different parishes to the General Treasurer of the United Offering, who enrolls them in the Anniversary Book. **No sum** is specified, but each is to give a **freewill offering**. We should like to enroll every woman in the Diocese.

Missouri's part in the United Offering of 1907 was \$1,510.03, from twenty-nine parishes and missions. The total for the Offering of 1910, May 1, 1910, from twenty-six parishes and missions and from the Juniors is \$634.31. Previously reported, \$782.78. Total, \$1,417.09.

The Junior Auxiliary held their annual meeting on May 7th, in Emmanuel Church, Old Orchard, Mo. The meeting was called to order at eleven forty-five. The Secretary of each branch responded to the roll call by reading the report of the year's work.

After the reading of the reports of the Secretary and Treasurer, and the President's address, the election of officers for the ensuing year followed.

The regular officers were re-elected. Mrs. James Wise was appointed United Offering Treasurer, and Mrs. John Waterworth was appointed Babies' Branch Secretary.

At twelve fifteen the morning session adjourned, and all assembled in the spacious parish house and were refreshed with a delicious luncheon, graciously prepared and served by the Directors and Juniors of the parish. Games and dancing and a general good time were indulged in until a quarter of three o'clock, when all



were quietly seated again, ready to listen to a most delightful talk on Japan by the Rev. James Wise. The Educational Secretary gave a report of the year's work and an outline for the study class for the coming year. Eight Directors reported having carried the study of missions in Africa to their separate branches.

Although the day was damp and cloudy, one hundred and sixty-five, of the two hundred and ninety-one enrolled, were present. Many expressed themselves that the sixth annual meeting had been a most enjoyable one. The meeting adjourned at four o'clock.

The reading of the Secretary's report showed a loss of two branches, St. Mark's and St. Peter's. We regret much the loss of St. Mark's, it was the first branch organized after your Diocesan officer took charge of the Junior work. They had done good and faithful work.

The loss of St. Peter's branch has been greatly felt, the Juniors do not like to feel that the work begun has failed, nor are they willing yet to admit that it has. Embracing this opportunity they earnestly ask of the rector and women of the Auxiliary of St. Peter's parish to lend them their aid in restoring this branch. A Director with love for young people and a warm missionary spirit is the most necessary factor.

Five new branches are reported this year, Holy Communion, Holy Cross, Trinity, De Soto, the Cathedral and St. Helen's of St. George's.

It is with gratitude that the apportionment and all pledges are reported paid.

**CONSTITUTION OF THE MISSOURI BRANCH**  
of the  
**WOMAN'S AUXILIARY.**

Adopted May 25, 1888.

**Article I.**

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

**Article II.**

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

**Article III.**

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

**Article IV.**

The officers shall be a President, Vice-President, Secretary, Treasurer and United Offering Treasurer, to be chosen at the annual meeting.

**Article V.**

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

**Article VI.**

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

**Article VII.**

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

**Article VIII.**

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

**Article IX.**

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.



#### Article X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to vote, and shall not be counted in making a quorum.

#### Article XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

#### Article XII.

One of said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### Article XIII.

The meetings shall be held in any Church or Chapel designated by the President.

#### Article XIV.

Special meetings may be called by the President at the request of any five of the managers.

#### Article XV.

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.
4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### Article XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### Article XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
