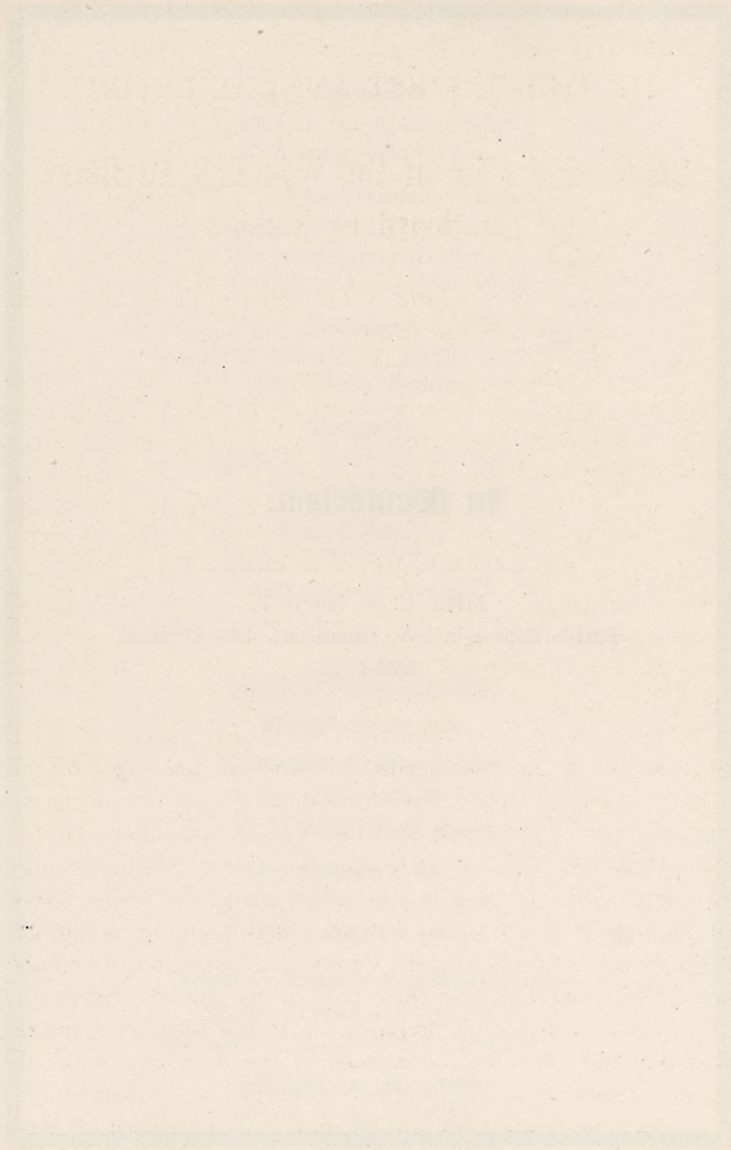

**THE THIRTY-FIRST ANNUAL REPORT**  
OF THE  
**Missouri Branch of the Woman's Auxiliary**  
**to the Board of Missions.**

---

*To the Rt. Rev. D. S. Tuttle, S.T.D., Bishop of Missouri, and  
Members of the Woman's Auxiliary:*

To our great surprise in making up the report we find our figures less than for several years. In boxes \$400.00 less, in cash \$1,000.00. Our regular pledges have been as large and as many as usual, so the loss is in special personal gifts. Last year, we had a number of visitors, Bishop Rowe and the group of Bishops who came for our autumn meeting; and the personal gifts to their work were as great a joy to us as to the overburdened Bishops. Then there is a possibility that the change made in the methods of the Board of Missions may have made a difference. We would be loath to feel that the spirit of giving was not growing each year.

Heretofore the Auxiliary has been asked to give \$100,000.00 of the sum needed to carry on the work of the Board. Now, as Dean Davis explained at our autumn meeting, our gifts are merged into the regular apportionment for the parish and diocese. It lessens the care of trying to meet two apportionments, but it also puts upon us the responsibility of helping the parish to pay its part. It is bound to strengthen the interest between Rector, Vestry and Woman's Auxiliary when the women assume their part of the apportionment.

In one parish, Old Orchard, the Every Member Canvass was put into effect by ten women of the Auxiliary with admirable results towards meeting the parish apportionment.

Since September 1st, the beginning of the Board of Missions year, we have given with the Juniors \$1,099.18, or 9 per



cent towards the sum apportioned to this diocese, as well as contributing largely in specials which must always be a necessary part of the work. Bishop Lloyd has said that if we give up specials we will break the missionaries' hearts. In many cases it is the only means of increasing the aggressive work in the field. But our first care must be to help the Board meet its obligations. Unless these specials are sent to the Board, they are not credited to Missouri. It behooves us therefore to get into line just as much as possible and work in prescribed methods.

Two of your officers attended the Auxiliary Institute in New York last year and studied "The Conquest of the Continent" under Dr. Gray. The platform for Auxiliary work is now Prayer and Study. The result of these should be the Gifts. Our Diocesan Educational Secretary has had classes for both Women and Juniors with gratifying results. The knowledge of the Church's lost opportunities in the middle west should be the incentive to go in and possess the new lands. Rural Missouri is just as much missionary ground as many a western jurisdiction, and so our home gifts must be larger proportionately than in a stronger diocese.

St. Stephen's must be cared for. Our \$1,200.00 for current expenses does not nearly cover them and personal gifts which we would gladly see go towards increasing its usefulness must go for daily needs. Holy Cross is largely under the fostering care of the Church Woman's Club. Besides our annual pledge for it a most generous gift for the new dispensary has been made by a member of the Auxiliary.

Bishop Thurston was our guest at the autumn meeting and presented the needs of East Oklahoma, which met with a ready response not only in a larger pledge than usual but in generous personal gifts. He also came for our Quiet Day, which was full of calm trustfulness and peace and gave to us a deeper knowledge of that strength which only comes in quietness and confidence.



We welcomed our new Coadjutor at the January meeting, and our pledge for his work in rural Missouri was an assurance of our loyalty to him and the needs of his work. Coming as our meeting did on our beloved Bishop's 75th birthday, it was our pleasure to mark the day with a personal gift to him more tangible than our admiration and affection for him.

For the third successive year Old Orchard mourns and we with her the death of one of her parish representatives. Mrs. C. A. Grant entered into rest last October, after a life of 81 years spent in the loving service of her Master. In late years infirmities had deterred her from the meetings, but her example and her generosity were silent influences manifested to all in her parish.

We have added to our list of working branches this year, Trinity, St. James, and Trinity, St. Charles, but we have had no reports from Louisiana or Rolla or Thayer, so there is no real increase.

In his visit last winter Dr. Grenfell spoke of the gift of life as the one talent given to all men equally. The five talents or the three were given to a few and we have no record of a man who received none. That gift of life we are responsible for. It is not to be hidden away in the earth, away from the sight and sound of human needs, nor folded away in a napkin as a thing too precious to be used. It will be multiplied through its influence on other lives. The women of the Auxiliary are feeling this perhaps unconsciously. The faithfulness of our women who have the Auxiliary work in their parishes and their desire to do the work in the best way, their promptness in the pledges, the work in the study classes, all show an appreciation of the privilege of service for the Master. One of our clergy said last year that the success of our work lay in our "united purpose and united effort." And this is largely due to our parish representatives.

More women offer for work in Labrador than Dr. Grenfell can take. Are there no women in Missouri who could



give a fortnight or a month to real missionary work at a summer camp or a holiday house. It would be an experience worth having and it might give a holiday to a tired missionary worker.

A clergyman from the east took a holiday by helping Bishop Thomas and it has resulted in his taking up work in Wyoming. A prominent woman in Detroit volunteered for a year's work in the Philippines at her own expense. It might lead to that long desired result we have dreamed of, having our own missionary in the field, who would be to us the dear far away member of our Church household. One of our own representatives has taken the work of Deaconess Anne in her absence. That gift to Holy Cross has no other mention in our report because it is above and beyond price. A letter to a mission asking if a volunteer worker would be of service brought out the reply that there are many places where a young woman who has had nothing but home training can do most acceptable work and that often the best success has been with so-called society girls.

That seems to open up possibilities for many who had hesitated from their lack of training and whose work being temporary could not allow for special training that the regular worker must have. A ready mind and willing feet and a loving heart are all acceptable offerings in the cause of Missions.

This wonderful talent of life has been put into our keeping; we know not at what moment the Lord and Giver of it may exact it from us and "it is required of stewards that a man be found faithful."

## THE UNITED OFFERING.

*Motto—"A gift from every woman in the Diocese."*

At the Tri-ennial meeting held in Cincinnati in October, the following resolution for the United Offering of 1913 was adopted:

*Resolved*, That the United Thankoffering of 1913 be given to the Board of Missions, for Woman's Work in the Mission field, including the training, testing, sending and support of women workers; also the care of such workers when sick or disabled; but that a sum not exceeding \$20,000 be devoted to buildings for the use of women workers, approved by the Board of Missions on the recommendation of the General Secretary and the Secretary of the Woman's Auxiliary.

Also, that to our united gifts there shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves to the work of the Master in the mission field, or, if they cannot go themselves, to give of their substance gladly as the Lord hath prospered them.

At the time of the last report there were one hundred and sixty women working under this great missionary thankoffering of the women.

Our *aim* is to carry out our motto.

Our *plan* is to ask every woman, who is willing to give an offering once a year to this object, to select a date which will have some interest to her personally, and to send her name, address and date to the treasurer of the United Offering in her parish. The names are sent from the different parishes to the general treasurer of the United Offering, who enrolls them in the Anniversary Book. *No sum* is specified, but each is to give a *free will offering*. Quarterly returns should be made to the general treasurer of the United Offering just before the quarterly meeting.

The amount given by twenty-eight parishes and the Juniors from May 1, 1911, to May 1, 1912, is \$758.06. Previously reported \$497.72, making a total for the United Offering of 1913 of \$1,255.78.

*To the Rt. Rev. Daniel S. Tuttle, S.T.D., Bishop of Missouri, and  
Members of the Woman's Auxiliary:*

The Juniors have seemed to reach, in the line of march, a more regular step, with nothing of especial interest to mark the year just passed. It is encouraging to know we are holding our own in the number of branches organized, and made some increase in gifts both in cash and box values.

I trust I am right in believing that the most valuable work we are doing is not expressed in figures, but in the training of young women. To-morrow we hold our Annual Meeting at Ferguson, and in behalf of the Junior Auxiliary I extend to all who are interested a hearty invitation to come and enjoy the day with us. From the small girl of eight to the young woman, you will find those whom we are endeavoring, by our prayers and labors, to train as the future workers of the Church, to appreciate the



value and opportunity of service, trusting that some of them may be the answer to our prayers that "The Lord of the harvest will send forth laborers into his harvest."

As we labor let us believe that out of our Diocese there may go young women into the world to carry the Gospel of Light into its dark places. Bishop Montgomery, Secretary of the Society for the Propagation of the Gospel, in "Mankind and the Church," says: "The most hopeful new factor in the contribution of the Church to other races will come in the twentieth century, through the ministry of women. That is, it will be new in the volume of its effort. Nothing is more cheering to the Christian statesman than the certainty that he will have in vastly increased measure this potent engine as a means of grace to the nations."

It was a deeper appreciation of the "gift of life" that led me to try and organize the younger members of the Church into the Junior Auxiliary soon after the General Convention in Boston, and what time has been at my disposal I have tried to use it towards developing this branch of the Church's work.

With my heart still aglow with love for missions and a stronger desire to work for the extension of Christ's Kingdom, circumstances which I recognize as God's leadings, make it impossible for me to continue as President.

I am grateful for having been privileged to go with the work thus far; and most lovingly and prayerfully commit it to the new President and the band of faithful officers and workers who have done more than I to make it what it is.

**CONSTITUTION OF THE MISSOURI BRANCH  
of the  
WOMAN'S AUXILIARY.**

---

Adopted May 25, 1888.

---

**Article I.**

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

**Article II.**

Its object is not to change the work of any Parish, but, by united and sympathetic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

**Article III.**

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

**Article IV.**

The officers shall be a President, Vice-President, Secretary, Treasurer and United Offering Treasurer, to be chosen at the annual meeting.

**Article V.**

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

**Article VI.**

The Board of Managers shall consist of the President, Vice-President, Secretary, Treasurer, the Treasurers of Special Funds, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

**Article VII.**

There shall be an Executive Committee composed of the President, Vice-President, Secretary and Treasurer, and the Treasurers of Special Funds, who shall have authority between regular quarterly meetings, to appropriate funds in the hands of the Treasurer.

**Article VIII.**

Each Parish with a Society or Societies working for Missions shall be entitled to four Representatives in the Board, one of whom shall be their Corresponding Secretary.

**Article IX.**

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.
2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.



#### **Article X.**

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to vote, and shall not be counted in making a quorum.

#### **Article XI.**

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

#### **Article XII.**

One of said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### **Article XIII.**

The meetings shall be held in any Church or Chapel designated by the President.

#### **Article XIV.**

Special meetings may be called by the President at the request of any five of the managers.

#### **Article XV.**

1. The President shall call meetings and preside over them.
2. The Vice-President shall take the duties of the President in her absence.
3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York, and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.
4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### **Article XVI.**

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies Missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### **Article XVII.**

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
