## THE THIRTY-SECOND ANNUAL REPORT

OF THE

### Missouri Branch of the Woman's Auxiliary to the Board of Missions.

---

#### President's Address.

It is a great pleasure to me, on this my twenty-first anniversary as an Auxiliary officer, to give a greeting to the women of the Missouri Branch of the Auxiliary, and join with them in congratulations on the work of the past year. At our fall meeting, November 7th, we were the guests of the parish of the Holy Communion for an all-day meeting, whose hospitality was all that could be desired. We had as speakers Miss Wood, of China, and the Rev. H. Percy Silver, both of whom inspired us to work in larger fields and with higher aims. One of our own number, Miss Margaret Little, told us most graphically of her missionary work in the mountains of Tennessee. By doing this she gave a worker a vacation, and her keen interest in it was charming. Our Secretary at this meeting told us of her proposed trip to the Orient, and asked that Miss Scheetz, of Grace Church, Kirkwood, would take up her work in her absence, and most admirably has she done so. We have had many letters from Miss Triplett, and have kept in touch with her in her journeyings, and we can be sure of a great treat when she returns, with all that she has seen. In January, by special invitation, we held our Quarterly Meeting at Grace-Holy Cross House, and most royally were we cared for. We had a very large meeting, Bishop Johnson taking the services and being one of our speakers, Miss Emery and Miss Lindley, of the Church Missions House, New



York City, being the others. They were most enthusiastic over two Institutes which they had lately conducted, and when they explained what an Institute was, we determined to have one of our own, and asked them to come back for it in April, which they thought they could do. We made our plans accordingly, and April 23rd, 24th and 25th will be days to be thought about and remembered. It is such a short time since our Institute I need not remind you of its inspiration and helpfulness. Three such happy days Auxiliary women cannot soon forget! The wonderful addresses and conferences must put us on a higher plane of thought and living. We were sorry Miss Emery's engagements would not allow her to be with us, but with our own Bishop and Coadjutor, Bishop Partridge, Rev. Mr. Silver and Miss Lindley, our days and minds were more than full. Our Juniors' offering to the Institute of the beautiful tableaux of "The Progress of the Kingdom" was most worthy of them, and enjoyed by all. Thanks to our officers who planned the programme, we did not have a disappointment, and did have many surprises. May it lead us to still higher ideals and aims, and to take greater interest in the work in the future! I thank all who made the Institute possible, and having reached this higher plane, let us as women of the Auxiliary close the old year with hearts full of thankfulness, and step forward into the new with an earnest determination to pray, to give, and to work for the extension of Christ's Kingdom with greater zeal and loyalty to our blessed Lord and Master Jesus Christ.

## Secretary's Report.

---

*To the Rt. Rev. Daniel S. Tuttle, S.T.D., Bishop of Missouri,  
the Rt. Rev. Frederick F. Johnson, D.D., Bishop  
Coadjutor, and Members of the Missouri Branch of  
the Woman's Auxiliary to the Board of Missions:*

In the absence of the Secretary, Miss Triplett, I have the privilege of presenting to you the 32nd Annual Report of the work of the Missouri Auxiliary. We need not feel ashamed of our year's work, for it shows an increase in gifts in every department—larger gifts in money and boxes both from the Woman's Auxiliary and from the Juniors,—increased offerings from the Babies' Branch, and the largest amount yet reported for the United Offering, though still far short of the \$3,000.00 goal set by the Treasurer for Missouri at this Triennial. Nor is this all, for there seems to have been a corresponding growth in zeal and interest, manifested by the attendance at the meetings and by the ready response to missionary needs, and it may not be too much to say that the Auxiliary has been not only "not slothful in business" but "fervent in spirit" as well, and "serving the Lord" more and more in work and study and prayer. The meetings during the year have been as follows: All-day quarterlies in November and January, monthly conferences November, February and March, the beautiful and uplifting Quiet Day conducted by Dr. Henry Lubeck, of New York, at the Cathedral February 12th, the Normal Class in Mission Study, held by the Educational Secretary on five consecutive Thursdays, in the autumn, and the Auxiliary Institute, April 23rd-25th. At the November Quarterly Meeting, at the Church of the Holy Communion, we were fortunate in having as speakers Miss Wood, of Wuchang, who told of the revolution in China, and



of the Boone University library for which she was appealing, then our Department Secretary, Rev. H. Percy Silver, and lastly Miss Margaret Little, in a vivid account of her vacation work in the Tennessee Mountain mission at "Jump-Off". The large and enthusiastic Quarterly Meeting of January, at Grace-Holy Cross House, had as its appointed speaker Bishop Johnson, and as its unexpected guests Miss Julia C. Emery and Miss Lindley, en route to New York from the Kansas City Institute. The monthly conferences, held at St. Peter's, Trinity and St. Philip's, showed steady growth in numbers and helpfulness, and proved themselves worthy of more general interest. The crowning work of the year was the three days' Institute in April, including in its last day's programme the regular Quarterly Meeting, and the faith and enthusiasm which projected the plan were justified in the practical and spiritual results of those inspiring days of counsel and conference, aided by the Juniors' impressive portrayal of "The Progress of the Kingdom." With the approval and support of our two Bishops, the assistance of many of the clergy, and of Bishop Partridge, of Kansas City, of our Department Secretary (who gave invaluable aid both before and throughout the Institute), and of the versatile Associate Secretary, Miss Grace Lindley, it could not but be a success. Several important recommendations made at the business meeting of Friday must be recorded here: (1) that the Constitution be altered or amended to provide for the election of a Second Vice-President, who shall be President of the Juniors; (2) that the Missouri Auxiliary have a Traveling Secretary, to be appointed annually by the President, and that a fund for traveling expenses be provided by pledges from parish branches; (3) that, if possible, one representative from each parish be a Junior Director, and that a report from the Junior Branch be read at each Quarterly Meeting; (4) that a committee of three be appointed to confer with Bishop Tuttle concerning Columbia, the seat of our State University, now without any provision by our Church for work among



the students. The presence of a few out-of-town members was one of the pleasures of the Institute, but the absence of many more was our keenest regret. However, we have been making a special effort this year, by correspondence and otherwise, to arouse greater interest among the women of the Diocese, and we hope in future to have some representative from each parish and mission at the general meetings.

Poplar Bluff reports a branch started there. St. Michael and All Angels' branch asked to be placed on the roll at the January meeting and is actively at work. Rolla and Thayer are again enrolled, and St. Mary's Mission will have its organization completed and its representatives at the annual meeting. On the other hand, Trinity, St. James, has failed to report, and some slumbering branches we had hoped to awaken have disappointed us. Another Institute may accomplish this.

No record of the Institute would be complete without a word of appreciation of the generous kindness of our President, and of the hospitality of St. Peter's. With a year so full of good things we have one cause for sorrow—that because of too short notice, it was impossible to have Bishop Aves, of Mexico, with us when the opportunity offered in December. We trust this will not be "the opportunity that passes not this way again".

Now a brief reference to the year's boxes: Beginning with our own St. Stephen's and Holy Cross, they have gone almost to the four corners of our land, the four general boxes to S. Dakota, N. Carolina, Wyoming and Alaska, the twenty-eight personal ones from San Antonio and the Virginia Mountains to California and N. Dakota. For the "Bishop Randall Hospital" (Wyo.) the Auxiliary owes grateful thanks to the Mallinckrodt Chemical Co. for a gift of much needed supplies. It is perhaps an error of business judgment to send heavy boxes from Missouri to Alaska, but Miss Emery sent



us the appeal, and we always find Alaska hard to resist. Our thanks are due to the Schuyler Memorial House and its forces for many courtesies in connection with the packing and shipping of the general boxes, and to the *Church News* for generous space given the Auxiliary.

In closing this report, the acting Secretary begs to acknowledge her pleasure in the work in which she has been privileged to share, and her gratitude to the women of the Auxiliary for their helpful consideration, and especially to the officers for their cordial and unfailing support and forbearance, sometimes in spite of "many and great provocations." Please continue to be in memory, as for six months you have been in reality,

"To her virtues very kind,  
To her faults a little blind."

## THE UNITED OFFERING.

*Motto—"A gift from every woman in the Diocese."*

At the Tri-ennial meeting held in Cincinnati in October, the following resolution for the United Offering of 1913 was adopted:

*Resolved*, That the United Thankoffering of 1913 be given to the Board of Missions, for Woman's Work in the Mission field, including the training, testing, sending and support of women workers; also the care of such workers when sick or disabled; but that a sum not exceeding \$20,000 be devoted to buildings for the use of women workers, approved by the Board of Missions on the recommendation of the General Secretary and the Secretary of the Woman's Auxiliary.

Also, that to our united gifts there shall be added our united and earnest prayers that God will put it into the hearts of many faithful women to give themselves to the work of the Master in the mission field, or, if they cannot go themselves, to give of their substance gladly as the Lord hath prospered them.

At the time of the last report there were one hundred and sixty women working under this great missionary thankoffering of the women.

Our *aim* is to carry out our motto.

Our *plan* is to ask every woman, who is willing to give an offering once a year to this object, to select a date which will have some interest to her personally, and to send her name, address and date to the treasurer of the United Offering in her parish. The names are sent from the different parishes to the general treasurer of the United Offering, who enrolls them in the Anniversary Book. *No sum* is specified, but each is to give a *free will offering*. Quarterly returns should be made to the general treasurer of the United Offering by the parish treasurers before the quarterly meetings.

The amount given by thirty parishes and the Juniors from May 1, 1912, to May 1, 1913, is \$911.20. Previously reported \$1,255.78, making a total for the United Offering of 1913 of \$2,166.98.

**CONSTITUTION OF THE MISSOURI BRANCH**  
of the  
**WOMAN'S AUXILIARY.**

Adopted May 25, 1888.  
Amended May 30th, 1913.

**Article I.**

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

**Article II.**

Its object is not to change the work of any Parish, but, by united and sympathethic action, to increase the interest, and to unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

**Article III.**

All baptized women of the Diocese of Missouri, who so desire, and who work for Missions in connection with their Parish organizations, shall be regarded as members of this Society.

**Article IV.**

The officers shall be a President, two Vice-Presidents, of whom the second shall be the President of the Junior Auxiliary, Secretary, Treasurer, and United Offering Treasurer, to be chosen at the annual meeting.

**Article V.**

All Parish Societies in the Diocese, who so desire, shall be considered constituent members of this Society, provided they send their reports of money collected and work done for Missions to their respective Parish Representatives in the Board of Managers.

**Article VI.**

The Board of Managers shall consist of the President, Vice-Presidents, Secretary, Treasurer, the Special Secretaries and Treasurers, and the Parish Representatives. Nine shall constitute a quorum for the transaction of business.

**Article VII.**

There shall be an Executive Committee, composed of the President, Vice-Presidents, Secretary, Treasurer, and Special Secretaries and Treasurers, who shall have authority between regular quarterly meetings to appropriate funds in the hands of the Treasurer.

**Article VIII.**

Each Parish with a Society or Societies working for Missions shall be entitled to four (4) Representatives in the Board, one of whom shall be the Corresponding Secretary, and may increase this number to five by the appointment of a Junior Director as Representative, her dues being paid to her own Treasurer.

**Article IX.**

The qualifications of a Representative which shall constitute her a member of the Board shall be:

1. Certification of her annual appointment by her Rector or her election by the Parish Society to be such Representative.



2. Payment of a membership fee of \$1.00 per year to the Diocesan Treasurer.

#### Article X.

The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to vote, and shall not be counted in making a quorum.

#### Article XI.

There shall be four meetings of the Board of Managers each year, to be held as follows: On or about the last Fridays, respectively, in October, January and April; and the annual meeting for the election of officers, which shall be held on the Friday following the Diocesan Convention.

#### Article XII.

One of said meetings shall be also a general meeting of the Society, and shall be directed by the Bishop of the Diocese.

#### Article XIII.

The meetings shall be held in any Church or Chapel designated by the President.

#### Article XIV.

Special meetings may be called by the President at the request of any five of the managers.

#### Article XV.

1. The President shall call meetings and preside over them.  
2. The First Vice-President shall take the duties of the President in her absence.

3. The Secretary shall conduct the correspondence of the Society; send notices of the meetings, and keep a record of them; keep an account of the work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the Secretary of the Woman's Auxiliary in New York, and prepare an Annual Report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention.

4. The Treasurer, under the direction of the Board or Executive Committee, shall receive and disburse all money sent to the Society for any branch of Missionary work, and for the expenses of the Society, presenting a report of same at each quarterly meeting.

#### Article XVI.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

#### Article XVII.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present.
