President's Address.

*To The Rt. Rev. D. S. Tuttle, S.T.D., Bishop of Missouri, and The
Rt. Rev. F. F. Johnson, D.D., Bishop Coadjutor, Officers and
Members of the Missouri Branch of the Woman's Auxiliary to the
Board of Missions:*

Today brings some of us to the parting of the ways. In relinquishing the honors and responsibilities to my successor, my heart is full of joy and sorrow,—joy for the privilege of serving you for fifteen years as your Vice-President, and two years as your President, in the work of the Woman's Auxiliary to the Board of Missions,—of sending the Light of the Gospel to the peoples of all nations, that all men everywhere might know that in Jesus Christ our blessed Lord our sins are forgiven and all men are brethren,—the unspeakable joy of expressing in this service our love for Him who laid down His life for us, that we might know the Father and by the indwelling of God the Holy Ghost; know that as members of His Body, the Church, we are to share in the mystery of fellowship with the Father and with His Son Jesus Christ;—sorrow that the goal was not more nearly reached, and the attainments not greater, and that I have not been to you the leader I wanted to be.

In touching this minor chord my penitent spirit is solaced with the realization that the service rendered, with its human limitations, was yet a loving one of sacrifice and praise to our Heavenly Father, and full of gratitude to you for your loving forbearance and unfailing support, dear women of the Auxiliary.

I wish to express my deep gratitude to you, Rt. Rev. Father in God, and to you my dear Bishop Coadjutor, for your advice and helpfulness extended in every way, and to you, my fellow officers, with whom it has been my privilege to labor. Whatever of success may have come in my term of office, the credit belongs to you and the members of the Auxiliary.

Your Secretary is making a most valuable gift to the Auxiliary,—the reports from the first year to the present, aggregating

thirty-six years, bound in three volumes, and minutes as published in the Church News, pasted in a book. In your behalf I extend to Miss Triplett sincere thanks for the gift and her thoughtfulness.

Your Treasurer for these twenty-four years is laying aside this work that she has executed in her own remarkable way. To Mrs. T. Ewing White I offer grateful thanks.

To the officers to be elected I extend our congratulations, and the assurance of our most hearty support and co-operation in the work they undertake.

It is gratifying to know that in the past year of strain and stress, with the demands and horrors of war pressing on every side, our report shows a small gain in our gifts to missions. But should the gain be small when the need is much greater? Are we asking too little of God and of ourselves? Is our vision dimmed? Are we yet slow to learn the use of that greatest of all instruments in the Christian's life, prayer,—that we do not see the release of the riches God has entrusted to us as stewards? These are searching questions, but they need to be answered.

Reviewing our lives in the light of the nations at war in their hour of anguish, do we find ourselves more willing to devote our lives to the great ideal in Christ's name? If not, then God's greatest challenge to the human race finds us asleep!

Let us double our gifts and consecrate ourselves to more devoted service, remembering that the real benefit in getting is giving.

Comparing our devotion to God with our country's devotion to the ideal of patriotism, we see that we are beginners in the school of sacrifice and service, whereas the Church should be the example and the leader; and she would be but for her unhappy divisions.

The Pilgrimage of Prayer in our diocese was an inspiration to many. Following that comes the plan for the War Work of the Woman's Auxiliary to be used this coming year. When this war is over, the Church must be prepared for the greatest opportunity that has ever faced Christianity. Our young men are seeing visions; they are thinking and inquiring into the deep things of life. We must seriously recognize our obligations to our brother. We must speed the sending of the Gospel to every creature. Let us pray for a deeper consecration through the indwelling and operation of God the Holy Ghost in our hearts, remembering that the coming of the Kingdom is to be accomplished "not by might, nor by power, but by my spirit, saith the Lord of Hosts."

THE THIRTY-SEVENTH ANNUAL REPORT OF THE
MISSOURI BRANCH OF THE WOMAN'S AUXILIARY.

Secretary's Report.

To the Rt. Rev. D. S. Tuttle, S.T.D., Bishop of Missouri, and The Rt. Rev. Frederick Foote Johnson, D.D., Bishop Coadjutor, and Members of the Missouri Branch of the Woman's Auxiliary to the Board of Missions:

With the shadow of war hanging low over our land we began our year with some forebodings. The calls have been so many and so compelling that we never knew before how much money there was in the world, nor how ceaselessly it could be poured forth once the need was clearly defined.

Not one cent would we lessen any of our country's claims; but the Church has sentinels upholding the Cross of Christ in distant lands, looking to us for their support and cheer as much as do our soldiers in France. Possibly it has not occurred to us that a friendly letter that did not need an answer, or a new book or even a box of candy, would be as welcome to a missionary in far off Alaska or China as to our boys "over there," for in neither case would the personal element be involved beyond the fact that they were doing our bit while we were hindered from going.

It is said the Auxiliary has no place in the war work. Perhaps not in the material kind, but we have our part. As a great praying body our power is limitless. Our practical work if indirect is no less effective. An instance is this. From time to time we have sent our general boxes to Christ School, Arden, N. C. Several times in this year's report and last occurs the item "for one day support of Christ School, Arden, N. C., \$10." Mrs. Wetmore, the principal, reports that 600 mountain boys, former pupils of the school, are in the army, in every branch of the service, including aviation. The Auxiliary has justified preparedness, in that she has trained these boys to serve their country as Christian soldiers.

Foreign Missions have never been as close to us as in these days, when the Far East has been brought into the world's crisis. God has given us our opportunity, an opportunity to prepare for the new conditions of the future, not in America alone, not in the battlefields of France alone, but in the Orient as well. Condi-

tions are framing themselves in such a way that the Orient may be compelled at no distant day to bear a more prominent place in this war. Are we doing our part to meet the emergencies of the future? The influence of Christian Missions must be strengthened everywhere if we expect Christian ideals and moral standards to prevail in peace settlements. Our Bishop has said: "It is not the mailed fist nor the moneyed power, but the Pierced Hand that sways the destiny of the race."

We have had a good year, the best in all our thirty-seven, in our gifts. We report today \$13,525.31. We have gone over the top. Since we were organized we have given \$236,036.50. A little while ago we would have felt much satisfaction in these figures, but we have been dealing in millions and billions, and perhaps this does not spell as much sacrifice as it might. Perhaps every Churchwoman has not made it her privilege to give. Our offerings are all voluntary ones. No money is raised by outside means. It is not how much must we give but how much can we give, and how many are giving that we need to know if we expect to "carry on."

We owe much to Dr. Patton's visit. He inspired us with a love and loyalty for the Church, and his campaign brought all the parishes forward in a great missionary awakening. In consequence not only are our gifts for the colored work largely increased, but the red side of the duplex envelope has become more evident; and that side counts on Missions.

Our two splendid general boxes have kept up their record. One was sent to St. Paul's Colored Industrial School, Lawrenceville, Va., the other to the Shoshone Indians. All the needed missionary boxes in the diocese were provided.

A helpful Quiet Day was conducted by the Bishop Coadjutor of Colorado, so individual that it will not soon be forgotten.

In our list of parish branches there are changes. No reports have come from Canton, Cape Girardeau, Moberly nor Monroe. We have added Jefferson City and Louisiana. Hannibal has increased its scope. In the city we have graduated branches of the Juniors. The Anna Wise Branch at Holy Communion, St. Margaret's at the Redeemer, No. 2 at St. Stephen's. We welcome the newcomers gladly to fill the failing ranks, and we hope for a new interest from those who have left us.

The gentle spirit of our first president of the Missouri Auxiliary took its flight last summer. Mrs. Charles Franklin Robertson, wife of our former Bishop, entered into rest. So long ago she served that few of the present members knew her as their

leader. Her interest in the work never ceased, but her shrinking nature allowed her to take no prominent place.

The Pilgrimage of Prayer made its circle of our land. Beautiful as Miss Emery's last gift to the Auxiliary and helpful to every woman who availed herself of its privilege, it has meant much in deepening the spiritual life in a work which of necessity deals largely with material things, but when laid on God's Altar they are sanctified.

The work is changing and new methods are coming in with a new generation taking the work over. A recent questionnaire was sent out to Auxiliary officers which carried with it much searching of spirit. Each woman realized how far she had fallen short of the ideal she represented. One question sought to discover what were the necessary qualifications for an Auxiliary officer. Years ago a bishop said that an Auxiliary officer must have faith and love and patience. This applies as well to every member of the Auxiliary. May each one of these gifts be yours in full measure.

As a precious legacy, I entrust to your care the little Church in the Virginia mountains which stands as your loving appreciation of my service.

Traveling Secretary's Report.

There are "slackers" in the Auxiliary Army as well as elsewhere. Only three out-of-town points have been visited in the entire year, and two in the city and suburbs. In Jefferson City, early in December, a branch was organized and officers elected at once. In Macon, where the Auxiliary has long existed, the Traveling Secretary had the honor of speaking, not only to some of the women, but to the clergy of the Northern Convocation also, and the pleasure of hearing them vote to have an entire Missionary Day at each Convocation meeting, in which the Woman's Auxiliary would participate. In Mexico, the third point visited, a pleasant afternoon was spent at the Rectory, but without a regular meeting. Mexico, however, has earlier in the year been highly honored in having our President, Miss Lewis, to address its Auxiliary, in lieu of the Traveling Secretary. There are great possibilities for a traveling secretary in this diocese, but they have not been realized by the present incumbent. In asking not to be reappointed to this office, she would beg the privilege of offering two alternative suggestions,—either (1) that the future traveling secretary be sent out under direction and authority of the President or Executive Committee, or (2) that the office be abandoned, and a "Traveling Fund" substituted, under which different women could be sent, at the discretion of the President or Executive Committee,

as occasion demanded. With the close of these five years the Secretary desires to express her grateful thanks to the many branches and individual Auxiliary women whose cordial hospitality and unfailing help have made her work at all times a pleasure.

Report of Educational Secretary.

Your Educational Secretary has to report study classes held in fifteen of our parishes and missions during the past year. Your Vice-President Mrs. Capen, held what might be called a normal class at St. Peter's, using Bishop Rhinelander's textbook, "The Gospel of the Kingdom," and four members of her class led this in their own parishes.

I had my own normal class with ten parishes represented, and of these three have had classes in mission stations, while nearly all have had classes in their own parishes.

I also had a most interesting and interested class of twelve at All Saints. As an expression of their interest they sent me three dollars to be used in Liberia. The general subject of our study has been Africa, and it has given us an added interest in Bishop Lloyd's wonderful trip to Liberia and made us appreciate the danger which he faced even against the advice of the Presiding Bishop and others who knew of the perils of the way.

We have disposed of 150 copies of the Church Missionary Calendar, which have kept us in touch with the general mission work of the Church. I have not been able to attend any Missionary Conferences this year, but I had the privilege of attending in Michigan last summer a class which was led by the Presi-

dent of the Southern Ohio branch of the Auxiliary, on "Missions according to the Bible." She had just returned from the Cambridge Conference and imparted much of the inspiration and enthusiasm obtained there to her class. Just here I would recommend most heartily to you the great help to be desired from these Missionary Conferences, and I very much wish that our Missouri Auxiliary might be represented by a goodly number of our Church women at one or more of these Summer Conferences, of which there will be seven in different parts of the United States. The two nearest us will be at Racine and Lake Geneva, both in Wisconsin—that at Racine will be strictly on Church lines, while that at Geneva will be interdenominational. One or more of our secretaries from the Church Missions House will be present at both of them. I have attended the one at Lake Geneva for two summers and have found it of incalculable benefit. Meeting with other diocesan officers and comparing notes with them, and getting suggestions and fresh ideas and spiritual uplift, cannot fail to be of great help in our work.

Our textbook gotten out by the Church Missions House for the next year will be "Our Church and Our Country," by Bishop Burleson, while the Junior Book will be "The Star in the West." Both of them, as the names indicate, will treat of the Church's mission in our own country. In closing let me refer you to Dr. Sturgis' message in the last "Spirit of Missions," in which he says, "Your interest in the mission of the Church is the only accurate test and measure of the abundance of your personal life in Christ."

1917-1918.

Your Correspondent begs to report that we have 109 contributors of current periodicals, 219 being sent regularly.

During the year we have sent out 24 Bibles, 40 Testaments, 4 prayer books, 4 hymnals, 345 books, 581 tracts, 6,000 odd magazines, 1,690 Christmas cards and Easter cards, 280 calendars and pictures, 45 Victrola records sent to Jefferson Barracks, 179 miscellaneous gifts, 150 of these being new gifts of books, dolls, and games, which were sent to Herculaneum for the Christmas box.

The total receipts in money for the year ending April 1st, was \$163.94; expenditures, \$112.17; balance, \$51.77.

I am happy to tell you we have had two new Librarians appointed during the year, Mrs. Jack White being in charge of the work at Mexico, Mo., and Mrs. W. C. Johnson has been appointed at Christ Church Cathedral. I do so hope she may have the support and encouragement of members and friends of the parish, as she has entered into the work most enthusiastically.

Chaplain Edwards wrote a very appreciative note of thanks to the Missouri branch of the C. P. C., saying we had been the largest contributors of books and magazines he had during his stay at Fort Sill.

PRESIDENT'S ADDRESS.

*Rt. Rev. Daniel S. Tuttle, Bishop of Missouri; Rt. Rev. F. F. Johnson,
Bishop Coadjutor, and Members of the Woman's Auxiliary:*

The Junior Department of the Woman's Auxiliary, in the Diocese of Missouri, offers you a report of the year's work, that, to the workers interested in the Junior Missionary endeavors, brings the reward for labor accomplished under trying circumstances.

Following the suggestion made at the last General Convention, held in Saint Louis, that all Junior Departments of the Woman's Auxiliary should endeavor to increase their usefulness, we have practically reorganized yours. This has meant securing many new directors and necessitated much instruction, as we tried to approximate the new junior plan. With new workers constantly begin-

ning the direction of branches, there has been an element of uncertainty as to what our report would be; but in contributions to the locations assigned us, for box work, and in our pledges of money, we rejoice that this year's statement is practically that of last year; in some parishes we have been able to establish Branches 1 and 2 with the Little Helpers, and are glad to report excellent work done among the boys in some branches.

While this is all a step forward, in the right direction, it is not enough, and the officers of your Junior Department will not rest content until the members of the Senior Department, largely the mothers or those in some way connected with the children and young people of our Church, realize that this endeavor to arouse their interest in the mission of the Church is just as vital and necessary a part of their education as anything else undertaken to make them useful and intelligent Church men and women.

We appeal to you for greater co-operation in making your Junior Department a live factor in spreading abroad a willing desire for Christian service.

We do not cease to regret the absence of our former President, Mrs. E. P. Howard; but she has been with us so constantly in her thoughts and through her gifts that much of our success, I am sure, is due to her continued regard for your Junior Department.

CONSTITUTION OF THE MISSOURI BRANCH
of the
WOMAN'S AUXILIARY.

Adopted May 25, 1888. Revised May 31, 1918.

Article I—Name.

This Society shall be called the Missouri Branch of the Woman's Auxiliary to the Board of Missions.

Article II—Object.

Its object is not to change the work of any parish, but to increase the interest, and unite all Parishes in the Diocese in the various branches of the Church's Missionary work.

Article III—Membership.

All baptized women of the Diocese of Missouri who work for, or contribute to, Missions in connection with their Parish organization, are members of this Society.

Article IV—Amendments.

This Constitution may be altered or amended at any Annual Meeting by a two-thirds vote of the members of the Board of Managers present, due notice having been given to each member.

By-Law I.—Officers.

Section 1. The Officers shall be a President, two Vice-Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Auditor, and United Offering Treasurer.

Sec. 2. These Officers shall be elected by ballot at the Annual Meeting, for a term of one year, and no one shall serve more than four years consecutively in the same office.

Sec. 3. The Executive Committee shall consist of the Officers, Special Secretaries and Treasurers, and three members elected annually from the entire membership of the Auxiliary to serve not more than two years consecutively. This Committee shall have authority between regular meetings to appropriate funds in the hands of the Treasurer.

Sec. 4. The Board of Managers shall consist of the Executive Committee and the Parish representatives, fifteen members constituting a quorum for the transaction of business.

Sec. 5. Delegates and Alternates to the Triennial Convention shall be elected at the meeting immediately preceding the General Convention. Should vacancies occur thereafter, they shall be filled by appointment of the Bishop of the Diocese.

By-Law II.—Representatives.

Section 1. Each parish may have four Representatives in the Board, one of whom shall be the President and one the Corresponding Secretary of the Parish Branch. Any Parish may have an additional Representative by the appointment of a Junior Director, who shall pay the regular dues of one dollar to the Diocesan Treasurer.

Sec. 2. Any additional branches formed hereafter in a Parish where the Auxiliary already exists shall be entitled to two Representatives.

Sec. 3. Parish Representatives shall be elected by their Parish Branches and approved by their Rectors, and shall pay an annual fee of \$1.00 each to the Diocesan Treasurer.

Sec. 4. The payment of \$1.00 per year to the Diocesan Treasurer shall constitute any one an Honorary Member of the Board of Managers. These Honorary Members shall be entitled to seats, but not to vote, and shall not be counted in making a quorum.

By-Law III.—Meetings.

Section 1. There shall be four meetings of the Board of Managers each year, as follows: On or about the last Fridays in October, January and April, and the annual meeting for the election of officers on the day following the Diocesan Convention. All of these, except that of April, shall be General Meetings, open to all, directed by the Bishop of the Diocese, and held in any Parish designated by the President.

Sec. 2. Special meetings may be called by the President at the request of five members of the Board of Managers.

By-Law IV.—Duties of Officers.

Section 1. The President shall call meetings and preside over them.

Sec. 2. The First Vice-President shall take the duties of the President in her absence.

Sec. 3. The President of the Junior Auxiliary shall be the Second Vice-President.

Sec. 4. The Recording Secretary shall take the minutes of the meetings and shall prepare an annual report for circulation in the Diocese, a review of which shall be presented to the Diocesan Convention by the President.

Sec. 5. The Corresponding Secretary shall conduct the correspondence of the society, send notices of all meetings, keep an account of work done by the women of the Diocese, as reported by the Parish Secretaries, and report this annually to the General Secretary of the Woman's Auxiliary.

Sec. 6. The Treasurer, under direction of the Board or Executive Committee, shall receive and disburse all money sent to the society for any branch of missionary work, and for the expenses of the society, presenting a report of same at each quarterly meeting.

Sec. 7. The Auditor shall examine all accounts of the Treasurer and present voucher for same.

Sec. 8. The Treasurer of the United Offering shall promote its progress by correspondence and visitation, keep a list of contributors, make quarterly or semi-annual collections and put money at interest. She shall make a report annually, and every third year prepare the Offering for presentation at the triennial.

By-Law V.—Duties of Representatives.

The Parish Representatives are to report through their Corresponding Secretary to the Diocesan Corresponding Secretary all work done for Missions; and all money raised for Missions by the women of their Parishes; also all new work undertaken for Missions. They are to attend the regular meetings of the Board, and to carry back to their Parish Societies missionary intelligence, and to endeavor in every way to increase an earnest and prayerful interest in Missions.

By-Law VI—Elections.

Section 1. A Committee on Nominations consisting of five members shall be appointed by the President at the April meeting.

Sec. 2. This Committee shall send a nominating blank to each member of the Board of Managers three weeks before the Annual Meeting, with instructions to fill out and return at a specified date.

Sec. 3. This Committee shall prepare a ticket from returned blanks, taking for each office the two names having the highest number of votes. This ticket shall be posted at the time and place of the Diocesan Convention, candidates having been notified of their nomination.

Sec. 4. The President shall appoint a Chairman and four members to serve as tellers on the day of election, these persons having been previously notified.

By-Law VII.—Amendments.

These By-Laws may be altered or amended at any meeting by a two-thirds vote of the Members of the Board present, due notice having been given each member.
