## THE FORTY-THIRD ANNUAL REPORT

of the

## Missouri Branch of the Women's Auxiliary

### President's Address

To the Rt. Rev. Frederick Foote Johnson, D. D., Bishop of Missouri, and the members of the Missouri Branch of the Woman's Auxiliary:

In looking forward to the Annual Meeting of our Missouri Branch of the Woman's Auxiliary, how could I foresee that I would not be present to enjoy the day with you. The gift of a very wonderful trip abroad is the reason for my absence, and though I shall be on the high seas by January twenty-fifth, I shall be very near to all of you, in mind and spirit.

I am finishing, too, my work with you as your President, and how shall I find the words which will, in any way, adequately express what these three years of association have meant to me? It is well that the new Constitution limits the term of office for your officers, or I should be selfish enough to want to continue to hold this position of privilege, which will always be one of my most treasured memories.

I shall not attempt to recall your achievements of these past years—you have the records—it is enough to say that each succeeding year has found us doing more and more towards fulfilling the larger plans of usefulness and helpfulness that the Woman's Auxiliary is working towards. Service is not mere activity for others and life is an awful waste without some definite aim. If there is any message that I can send you today, it is that through the Woman's Auxiliary I have gained a better understanding of what service means, and know that its aim is not only to be concerned with well doing, and wise thinking, but it develops the desire to make that service loving, skillful and practical. To fulfill that aim requires the consecration of every ounce of intelligence with which God may have endowed one. For that service means following Him throughout the world, and seeing that others share your joy with you.

To your new President I wish every success—how can there be anything else, with so many willing hands to carry forward whatever new plans the year will bring, and I can assure her the same loyalty and support that has unfailingly been given me. Help her to take up the work joyously, by showing her that we understand that God has not left His work to Angels to do, but to us, and that she can depend upon us to place His work first; then will we be true members of the Woman's Auxiliary and can say, "Lord, I pray Thee, make me a living member of Thy Kingdom, daily finding ways to serve Thee, that by word and deed I may awaken in many other women a deeper sense of their stewardship in extending that Kingdom to the uttermost parts of the earth."

## Report of Secretary

---

To the Rt. Rev. Frederick F. Johnson, D. D., Bishop of Missouri, Officers and Members of the Missouri Branch of the Woman's Auxiliary to the Presiding Bishop and Council:

As the year has rolled away since the Annual Meeting of nineteen hundred and twenty-three, not a month but has carried with it some splendid achievement by the ever-busy Woman's Auxiliary of Missouri. Throughout the year, mind and heart and hand and purse have all united in the glorious work, whose scope is the whole wide world, whose interest embraces every people, whose joy is in pressing on, strengthening the warm ties at home and reaching out farther and farther to the needy, to the distressed, to the degraded; helping, always helping, to the very limit of its means. There is no spur to accomplishment like the zeal which the Woman's Auxiliary has in such large measure.

It is in summing up the work that one often gains the clearest view of what has been done—let us, then, take a moment for this.

The Annual Meeting, January 26th, was at the Cathedral. Dean Scarett was the speaker of the day, giving a wonderful picture of Arizona and the Church's work there. Rev. Francis Bloy, the City Missionary and Canon Reese spoke briefly and were listened to for the first time by the Auxiliary with much pleasure.

The Quarterly Meeting in May was at Emmanuel Church, Webster Groves; many splendid reports were made. Mrs. Hunt, wife of the principal of the Fort Valley High and Industrial School near Atlanta, Ga., was the speaker of the day. She stressed the value of industrial training for the negro under Christian leadership.

The October Quarterly was held at the Church of the Redeemer. Two most interesting speakers added greatly to the pleasure and information of the Auxiliary—Dr. Eleanor C. Kemp of New York, who lived among the Moros for a year, and Miss Mabel R. Schaeffer, a teacher of St. Margaret's School, Tokyo, who returned to America only a month before the disastrous earthquake.

Mrs. Robt. Burkham, the Supply Secretary, has accomplished wonderful things in her Department, providing medicines, hospital necessities of every sort, bedding, clothing and boxes that brought relief and comfort and cheer to many hearts.

Mrs. Francis Eaton has been very zealous as Treasurer of the United Thank Offering, one of the important phases of the Woman's Auxiliary Work. She reports the splendid sum of \$4,431.98 for the 1925 offering.

Mrs. George Graham, Correspondent of the Church Periodical Club, is another officer whose efforts bring joy to many. Those who are sick or shut in, who are far off from community life, those who are unable to afford books and magazines and cards, all these welcome with gratitude the gifts of the C. P. C.

St. Stephen's Fund, gathered so faithfully by Mrs. Wm. H. Burritt, appeals to us very warmly; it is used for community work done in St. Stephen's. There are hundreds who monthly enjoy the benefit of this Fund and who find uplift in the community activities which it serves to provide.

Mrs. C. R. McDonald, the Educational Secretary, reports advancement along several lines of work. Two Bible Classes were held by the Rev. Edmund Duckworth, much appreciated and well attended; also normal classes developing leaders who carried on Lenten Study Classes in some of the Parishes. Mr. and Mrs. McDonald's kindly help made possible Deaconess Bedell's visit to St. Louis last Spring. During her visit the Deaconess aroused great interest in her Alaskan Mission and secured a fund to purchase much needed equipment.

Mrs. E. F. Cushing, as the Messenger, has visited country parishes, strengthening and cheering the hearts of many who might be discouraged, gathering the women together to hear of the Auxiliary work. She is also the Treasurer in this Diocese for the "Woman's Auxiliary Specials," the two houses, which are to be erected in New York and in Raleigh, each to be named the "Daniel Sylvester Tuttle Memorial," to be given by the Woman's Auxiliary during this Triennium.

The far-reaching disaster in Japan aroused the sympathy and generosity of America. A pledge of over a thousand dollars subscribed at the October Meeting shows how the ready sympathy of the Auxiliary women found large expression.

One of the beautiful gifts this year was an organ placed in the City Hospital, for Mr. Bloy's use, in memory of Miss Mary W. Triplett, who served as Secretary for thirty-five years, and to whom the Woman's Auxiliary owes much for her faithful, joyful and consecrated work.

There is no opportunity in the Secretary's report to dwell on the devotion and enthusiasm of the Executive Board, nor upon the hearty co-operation of the Representatives of the Woman's Auxiliary, who by their united efforts have reached such splendid results.

## Report of the Supply Work for the Year 1923

It gives me great pleasure to be able to report that this is the best year the Supply Department has ever had. During the year 1922 supplies amounting to \$1,154 were sent to individuals and mission stations, while during the past year supplies amounting to \$2,841, an increase of 150%, were sent. This includes the box sent last Spring to the Emerald-Hodgson Hospital, Sewanee, Tennessee, amounting to \$1,646.55, also the three personal boxes sent this Fall, one to the Rev. W. J. Howes, Rondette, Utah; one to the Rev. L. W. Blackwelder, Union, South Carolina, and one to the Rev. Douglas I. Hobbs, Rocky Mount, Virginia, amounting in the aggregate to \$818.12. Practically all the parishes and missions in the diocese have contributed to these boxes.

In addition to these boxes the bedding for fourteen beds was sent to meet the emergency in Japan. This amounted to \$236.00.

Under the able direction of Miss Annie S. Causland, the Supply Department was able to make and send to some of the Japanese clergy four surplices and thirteen stoles amounting to \$150.00.

Although this is the best year the Supply Department has ever had I feel we have only begun to touch our resources and I am certain that with a little effort each succeeding year will witness more and more work done for those less fortunate than ourselves.

## Report of Educational Secretary

For the Year 1923.

Two Bible Classes were held in the Church of the Redeemer led by the Rev. E. Duckworth. The first on "The Book of Job" averaged 75 in attendance, the second "The Interim Between Malachi and St. Matthew" averaged 50. The drop in attendance was more than offset by four Parish Bible Classes which were held at the same time. The Mission Study Classes suffered a setback in number and size, this was due to the fact that we were asked to help in the General Educational plan of the Church, our women were prepared to do this, but were called upon very little.

The Educational Department had charge of the visit of Deaconess Bedell to our Diocese and she was a source of blessing and inspiration wherever she went.

We co-operated with the Nation-Wide Campaign in the sending of the slides on Missionary fields into the Diocese. We sent twelve Bibles for use at the Orphans' home, and ten subscriptions to "The Church News" to isolated Church women; also a Missionary calendar to each of these.

Two hundred Missionary Calendars were sold through the efforts of Miss Glenn, who has always taken charge of this work.

A Normal Class for teachers has been held on "Japan" and I hope many parishes will have classes on that subject this year.

No record has been kept this year of the number of cards, letters and packages of Missionary material sent out, but they have been many.

## Constitution

### ARTICLE I—NAME.

This organization shall be called "The Missouri Branch of the Woman's Auxiliary to the National Council."

### ARTICLE II—OBJECT.

Its object is to increase the interest and unite the efforts of all women in the Diocese in the Church's Mission.

### ARTICLE III—MEMBERSHIP.

Its membership shall consist of all baptized women who pray for, work for or give to Missions.

## ARTICLE IV—AMENDMENTS.

This Constitution may be altered or amended at any annual meeting by a two-thirds vote of the members of the Board of Managers present; due notice having been given to each member.

### BY-LAW I—OFFICERS.

Section 1. The officers shall be a President, First Vice-President, Second Vice-President, Vice-President for the Northern Convocation, Vice-President for the Southern Convocation, Secretary, Treasurer, Auditor, Educational Secretary, Supply Secretary and United Thank Offering Treasurer.

Section 2. There shall be an Executive Board composed of the officers, special secretaries and treasurers, and three members at large.

Section 3. The Board of Managers shall consist of the Executive Board and the Parish Representatives; twenty-five members constituting a quorum.

Annual dues of \$1.00 for each member of the Board of Managers shall be paid to the Auxiliary Diocesan Treasurer before the first of February.

Section 4. Honorary offices with the right of vote may be created by a two-thirds vote of the Board of Managers.

### BY-LAW II—DUTIES OF OFFICERS

Section 1. The President shall preside at all meetings; appoint committees; be a member ex-officio of said committees and fulfill all such duties as pertain to her office.

Section 2. The First Vice-President shall fulfill the duties of the President in the latter's absence. She shall be responsible for all courtesies to special visitors at meetings.

Section 3. The Second Vice-President shall have charge of the special work given the Woman's Auxiliary by the Triennial Convention.

Section 4. The Third and Fourth Vice-Presidents shall be responsible for auxiliary work in the Northern and Southern Convocations.

Section 5. The Secretary shall take the minutes of the meetings; shall send all notices; carry on all necessary correspondence; and shall prepare an annual report of work done by the Missouri Branch. She shall forward said report to the Executive Secretary of the Woman's Auxiliary.

Section 6. The Treasurer, under direction of the Board of Managers or the Executive Board, shall receive and disburse all money, presenting a report of same at each quarterly meeting.

Section 7. The Auditor shall examine all accounts of the Treasurer and present vouchers for same.

Section 8. The Educational Secretary shall be responsible for the conducting of Bible and Mission Study Classes, following suggested subjects sent out by the General Educational Secretary. She shall disseminate missionary material and information; and co-operate with all agencies in the Diocese for religious education.

Section 9. The Supply Secretary shall be in charge of the supply work of the Diocese, apportioning the Parish quotas. She shall make her report to the General Secretary of the Supply Department.

Section 10. The United Thank Offering Treasurer shall stimulate interest in this phase of auxiliary work. She shall have charge of all money collected for this purpose and shall make a report at all meetings. She or her alternate shall present the offering at the Triennial.

Section 11. The Executive Board shall have authority necessary to conduct all business between meetings. It shall pass on the report of the Finance Committee and make recommendations to the Board of Managers. It shall direct the policy of the Auxiliary.

#### BY-LAW III—REPRESENTATIVES.

Section 1. (A) Each Parish is entitled to four representatives, one of whom shall be the President and one the Corresponding Secretary of the Parish Branch.

(B) Any additional Branch in a Parish is entitled to two representatives.

Section 2. The Representatives shall attend the Diocesan meetings and carry back to their branches missionary information and inspiration. They shall respond to the general pledges for their branches.

Section 3. The method of choosing representatives shall be left to each Parish Branch.

Section 4. Annual dues of \$1.00 for each representative shall be paid to the Diocesan Treasurer.

#### BY-LAW IV—ELECTION OF OFFICERS.

Section 1. Only members of the Board of Managers are eligible to cast a vote.

Section 2. The Officers shall be elected by ballot at the annual meeting for a term of one year. No officer shall serve more than four consecutive years in the same office.

Section 3. A nominating committee consisting of five members shall be chosen by the Executive Board at the December meeting, which committee shall prepare a ticket.

Section 4. The President shall appoint four members to serve as tellers on the day of election, these persons having been previously notified.

Section 5. The President shall appoint the Special Secretaries and Treasurers.

Section 6. The three members at large of the Executive Board shall be elected annually by ballot and may not serve more than two years consecutively.

Section 7. Delegates and alternates to the Triennial Convention shall be elected at the meeting immediately preceding the general convention.

#### BY-LAW V—FINANCE COMMITTEE.

Section 1. There shall be a Finance Committee composed of three members chosen by the Executive Board, two of whom shall be the President and Treasurer.

Section 2. This committee shall prepare the budget for the year's work and shall make plans for financial projects not otherwise assigned.

#### BY-LAW VI—MEETINGS.

Section 1. There shall be four meetings of the Board of Managers each year as follows: On or about the last Friday in May, October and December and the annual meeting on the day following the Diocesan Convention. These meetings, except the one in December, which is for Representatives only, shall be general meetings, open to all, directed by the Bishop of the Diocese and held in the various Parishes by invitation.

Section 2. Special meetings may be called by the President.

Section 3. The Executive Board shall hold regular monthly meetings from September to June, inclusive.

#### BY-LAW VII—AMENDMENTS.

These By-Laws may be altered or amended at any regular meeting by a two-thirds vote of the members of the Board of Managers present—due notice having been given each member.
